## **BACKGROUND**

The Approved Advanced 2006/07 Capital Budget includes funds for the replacement of concrete sidewalks because of their overall poor condition. The locations included in this tender meet or exceed the criteria for replacement.

#### **DISCUSSION**

Tenders were called on May 13, 2006 and closed on May 26, 2006. The following bids, exclusive of taxes, were received:

The scope of work for this tender includes the renewal of concrete sidewalk, concrete curb and gutter, and reinstatement at the locations listed below.

- Queen Street (E) Artillery Place to Doyle Street
- Connolly Street (W) Summit Street to Chebucto Road
- Agricola Street (E) Duffus Street to Hillside Street
- Roslyn Road (N) Glendale Road to Beresford Road

It is anticipated that work will commence within three weeks of the tender award and take 6 weeks to complete.

This is a **UNIT PRICE** contract and the cost will be dependent upon the actual quantities measured and approved by the HRM Project Manager.

There are no Local Improvement Charges associated with this work.

#### **BUDGET IMPLICATIONS**

Based on the lowest tendered price of \$147,450.00, plus net HST for a total project cost of \$152,507, funding is available in the Approved Advanced 2006/07 Capital Budget from Account No. CKU00783, Sidewalk Renewals. The budget availability has been approved by Financial Services.
