SUBJECT: Capital Budget Increase - Woodlawn Library Expansion

ORIGIN

Approved 2008/09 Capital Budget

RECOMMENDATION

It is recommended that Council:

- 1. Allocate \$444,000.00 from Operating Account B011-4703 to Capital Account CBW00977 Woodlawn Library Expansion
- 2. Approve an increase to Capital Account CBW00977 Woodlawn Library Expansion by \$444,000.00 for the transfer from Operating as identified in the Budget Implications section of this report.

BACKGROUND

In the "in-camera" report dated April 21, 2009, Council discussed a relocation/expansion of the existing Woodlawn Library location to 31 Eisener Boulevard (an old Empire Theatre). Council approved the location and the capital budget of \$1,160,000.

DISCUSSION

The original capital budget submitted for this expansion was based on recent construction costs for the new Tantallon Library, with an area approx. 12,000 square feet. The actual size of the new Woodlawn Library is approx. 17,000 square feet, resulting in increased costs for furniture, equipment, shelving, and building modifications.

BUDGET IMPLICATIONS

During the current budget year (subsequent to budget approval), there was a recalculation of the provincial funding formula resulting in an increase in provincial funding* to The Halifax Regional Library. Administration noted this and identified this as a source of revenue to address the above noted capital shortfall. Budget availability has been confirmed by Financial Services
