#### **ORIGIN**

The Approved Advanced 2010/11 Capital Budget.

### RECOMMENDATION

It is recommended that Halifax Regional Council award Tender No. 10-239, Street Planer Patching - Phase 1, Various Locations to Dexter Construction Company Limited for a Total Tender Price of \$590,476.16 (net HST included) with funding from Capital Account No. CRU01078 - Street Planer Patching - Phase 1, Various Locations, as outlined in the Budget Implications section of this report.

# **BACKGROUND**

The Approved Advanced 2010/11 Capital Budget includes funds for Street Planer Patching - Phase 1, Various Locations.

#### **DISCUSSION**

Tenders were called on March 5, 2010 and closed on March 23, 2010. Bids were received from the following companies:

The scope of work for this tender generally consists of patching of various streets.

It is anticipated that work will commence after the tender is awarded and as weather permits in the Spring and take eight weeks to complete.

This is a **UNIT PRICE** contract and the cost will be dependent upon the actual quantities measured and approved by the HRM Project Manager.

There are no Local Improvement Charges associated with this work.

# **BUDGET IMPLICATIONS**

Based on the lowest tendered price of \$590,476.16 (net HST included), funding is available in the Approved Advanced 2010/11 Capital Budget from Capital Account No.CRU01078 - Street Planer Patching - Phase1, Various Locations. The budget availability has been confirmed by Financial Services.
