SUBJECT:	Noise By-Law Exemption - 2010 Canadian Senior Baseball Championship - Beazley Field and Mainland Commons		

ORIGIN

An application (attached as Appendix A) submitted on May 26, 2010 by Paul Arsenault, chair of the host committee for the 2010 Senior Baseball Championship for exemption from provisions of By-Law N-200, Respecting Noise. The exemption is to provide time to complete play of any scheduled game past the prohibited times outlined in the by-law if inclement weather becomes a factor.

RECOMMENDATION

It is recommended that Regional Council approve the 2010 Senior Baseball Championship application for noise exemption, and permit the emitting of noise including yelling, shouting, hooting, whistling, and the use of a public address system past eleven o'clock at night. The exemption would only be required for games delayed due to inclement weather beginning August 26th and each day until the end of the tournament on August 30th. Council should also take into consideration any matters raised at the hearing and pursuant to the contents of this report.

BACKGROUND

In September, 1999 HRM Council adopted By-Law N-200, Respecting Noise. The By-Law prohibits any person from engaging in any activity that unreasonably disturbs or tends to disturb the peace and tranquillity of a neighbourhood.

Section 4 describes specific events, locations and time frames where certain activities have been deemed exempt from the provisions of the Noise By-Law.

Section 6 of the By-Law allows for any person to make an application to Regional Council requesting an exemption from any or all provisions of the Noise By-Law for which that person may be prosecuted. The By-Law states that an applicant or any person opposed to an application may be heard at a session of Council. Notice of the Council Session is required to be mailed to assessed property owners located within 100 feet of the property(ies) which is subject to the hearing.

In deciding whether or not to grant an exemption, Council is to give consideration to :

- the social or commercial benefit of the proposed activity to the municipality;
- the viewpoints of community residents;
- the proposed hours of operation of the proposed noise-emitting activity; and
- the proposed duration of the subject activity,

An excerpt from the Noise By-Law detailing the exemption process is attached as Appendix B.

DISCUSSION

The 2009 Canadian Senior Baseball Championship will be taking place in the Halifax Regional Municipality at Beazley Field in Dartmouth and the Mainland Commons in Halifax from August 26th to the 30th, 2010. Setup for the event will begin at each site on August 26th, 2010. The start times and locations of each game are attached as Appendix C of this report. The full tournament web site is located at http://www.baseball.ca/seniormen/.

According to Section 4 (Prescribed Exemptions) of the by-law, the 2010 Canadian Senior Baseball Championship is exempt from the provisions of the by-law until one o'clock in the morning:

Section 4(2)(e) states:

Prescribed Exemptions

4. (2) Notwithstanding any other provisions of this By-law, this By-law shall not apply to: (e) noises in connection with athletic or recreational activities in municipal park areas, arenas or community centres until one o'clock in the forenoon;

The applicant is requesting a noise exemption as the sound, predominantly from the public address

system, may conflict with the following provision of the By-Law, if a game must continue past one o'clock in the morning due to inclement weather:

Section 3, Part 1 states: "No person shall engage in any activity that unreasonably disturbs or tends to disturb the peace and tranquillity of a neighbourhood"

The applicant has advised that the current schedule for the tournament does not plan for any games to extend beyond 11 o'clock at night. However, weather conditions may force the play of games to extend beyond 11PM, if officials need to delay play due to inclement weather.

Inclement weather will be the only scenario where games will need to be extended.

Halifax Regional Police does not have any concerns regarding this application.

Mailing out notices of the time, date and purpose of the Council Session at which the hearing is proposed to take place to property owners within 100 feet of the designated sites identified above is complete.

Under subsections 6(3) and (5) of the Noise By-Law, Council may consider any matters it deems appropriate at the hearing and either reject an application or approve it with or without conditions.

BUDGET IMPLICATIONS

There are no budget implications.

ALTERNATIVES

There are a number of alternatives available to Council in considering this application:

- 1. Approve the application without conditions;
- 2. Approve the application with conditions;
- 3. Reject the application in it's entirety.

APPENDIX B:

Excerpt from By-Law N-200 Respecting Noise re: Granting Exemptions by Council.

Grant Of Exemptions By Council

6. (1) Notwithstanding anything contained in this By-Law, any person may make application to Council to be granted an exemption from any of the provisions of this By-Law with respect to any emission of noise for which that person might be prosecuted; and Council, by resolution, may refuse to grant any exemption or may grant the exemption applied for or any exemption of lesser effect; and any exemption granted shall specify the time period, not in excess of six months, during which the exemption shall be effective and the exemption shall be in written form and shall include such terms and conditions as Council deems appropriate.

(2) In deciding whether or not to grant an exemption, Council shall give consideration to the social or commercial benefit of the proposed activity to the municipality, the views of any residents of the municipality which may be expressed to Council, the proposed hours of operation of the proposed noise-emitting activity and the proposed duration of the subject activity.

(3) In deciding whether or not to grant an exemption, Council shall give the applicant, and any person opposed to the application, an opportunity to be heard during a Council Session and may consider such other matters as it deems appropriate.

(4) Notice of the time, date and purpose of the Council Session at which the hearing is proposed to take place shall be mailed to the assessed owner or owners as shown in the records of the Regional Assessment Office, of property located within 100 feet of the property which will be the subject of the hearing;

(5) Any alleged breach by the applicant of any of the terms or conditions of any exemption granted by Council, shall be investigated by municipal staff, reported to Council in writing and Council shall determine whether or not a breach has taken place. If a breach has taken place, Council may pass a resolution revoking the exemption, without the necessity of giving notice of rescinding motion, and such exemption shall be null and void as of the passing of such resolution.
