ORIGIN

Heritage Advisory Committee Meeting of October 27, 2010.

RECOMMENDATION

That Halifax Regional Council

- Give First Reading to the proposed amendments to the Municipal Planning Strategy and 1. Land Use By-law for Downtown Dartmouth as contained in Attachments A and B of this report, to add a new Opportunity Site and adopt new site specific policy regarding site and design issues, and schedule a public hearing; and
- Approve the proposed amendments to the Municipal Planning Strategy and Land Use By-2. law for Downtown Dartmouth as contained in Attachments A and B of the August 6, 2010 staff report, with the following amendments to Attachment A:
 - a) Pg. 13, under the heading of Development of Opportunity Site E, remove the words 'mid to high rise' from the first sentence; and
 - b) Pg. 16, under section e) (ii), change the word 'considering' to 'allowing'.

BACKGROUND

At the Heritage Advisory Committee's October 27, 2010 meeting, staff presented the proposed amendments to the Municipal Planning Strategy for Downtown Dartmouth to add an additional opportunity site and adopt new site specific policy regarding site and design issues.

DISCUSSION

In reviewing the application, the Committee put forward amendments to the proposed changes to the MPS as noted in the recommendation above. With regard to the first amendment, the heights are described in detail later in the changes, and the Committee felt it unnecessary to note 'mid to high rise' in the description of the Opportunity Site. The Committee did not take issue with the heights proposed for incorporation given the urban design measures also recommended by Staff. With regard to the second amendment, the history of the site and its relationship to the canal and water were felt to be significant heritage assets, and the Committee wished to strengthen the recognition of these assets. The Committee felt that by requiring a proponent to 'consider' restoration of a naturalized open stream bed allowed the possibility to be too easily discarded. The Committee felt that by requiring a proponent to allow the naturalization, it provided stronger wording without requiring a proponent to take action itself unless so agreed to in a Development Agreement.
