SUBJECT: Street Closure – Portion of Portland Street Right of Way, Dartmouth

#### **ORIGIN**

A request from Westwood Developments Limited ("Developer") expressing an interest in acquiring a portion of Portland Street, more particularly described as a portion of PID 40935603.

#### RECOMMENDATION

It is recommended that Halifax Regional Council:

- 1. Set a date for a Public Hearing for consideration of HRM Administrative Order No. SC-63 concerning the closure of a portion of the Portland Street right-of-way, Dartmouth, (Attachment "A"); and
- 2. Direct staff to close the portion of the Portland Street right-of-way, as shown on Attachment "B", subject to the conclusion of the Public Hearing.

#### **BACKGROUND**

Portland Street is a main through fare for commercial and residential development. The properties located in the immediate area of the subject are predominantly comprised of commercial sites.

Since the construction of Eisener Boulevard, Portland Street has been realigned and in 1986 the adjacent properties went through a redevelopment. The neighbouring sites changed hands numerous times until they were both developed as automobile dealerships and now the street right-of-way, along Portland Street, has been deemed surplus.

The Developer's intention is to incorporate the lands into the abutting commercial lots for redevelopment.

#### **DISCUSSION**

The developer has an interest in acquiring a portion of a Portland Street right-of-way, measuring 5,675 square feet, subject to Regional Council's approval of the street closure. The Developer's intention is to incorporate the lands into the abutting commercial development lots.

As an exchange of land that will be taking place, HRM will be acquiring a portion of PID 40363541 to allow for the road realignment and as well as additional right of way for an active transportation trail.

The closure of the subject property will facilitate the exchange of lands, which is subject to an approved report under delegated authority of the DCAO.


