#### BACKGROUND/DISCUSSION

At its meeting on January 19, 2011, the Committee reviewed proposed amendments to the Municipal Planning Strategies for Bedford and for Beaver Bank, Hammonds Plains and Upper Sackville, as well as the Regional Subdivision By-law.

The report was in response to requested amendments to relocate the boundary lines between several Sub Areas (5, 9 and 10) of Bedford West, as well as a request to place a revised community concept within the Secondary Planning Strategy which identifies proposed land uses permitted in several of the Sub Areas (5 and 9).

The Committee is recommending that a public hearing be held and that the proposed amendments be approved by Council.
