## **SUBJECT:** Oval Naming Rights & Sponsorship: Next Steps

### **ORIGIN**

March 29, 2011 Regional Council motion, regarding the Long Term Arena Strategy moved by Councillor Rankin, seconded by Councillor Sloane.

### **RECOMMENDATION**

It is recommended that Regional Council direct staff to return to Council in the next fiscal year with a recommendation on an approach to a sponsorship policy in general.

#### BACKGROUND

On March 29, 2011 Halifax Regional Council approved a motion to:

- 1. Make the Canada Games Oval permanent on the Halifax North Common;
- 2. Direct staff to include the required capital and operating funds for the Canada Games Oval in the proposed 2011/12 Project and Operating Budget as outlined in the budget implications section of this report;
- 3. Direct staff to immediately engage consulting services as outlined in the discussion and budget implications sections of the March 25, 2011 staff report, funded from the advanced project account CBX01268 Consulting Buildings, until a full funding strategy is approved by Council as part of the 2011/12 budget;
- 4. Authorize staff to accept donations to put toward the capital costs of making the Canada Games Oval permanent; and
- 5. Provide direction to staff as to whether or not to entertain proposals for corporate naming rights and other commercial advertising at the Canada Games Oval.

#### DISCUSSION

The following is intended to provide an update on various ongoing activities related to the Oval.

#### Formal sponsorship policy for HRM

In September 2011, Council requested that a staff report outlining research potential naming rights and sponsorship policies be brought forward with various options for Council's consideration respecting public assets and events. This work is underway. However, based on the timing of the opening of the Oval and a desire to ensure appropriate recognition for potential naming sponsors staff are proceeding as directed at the August 2011 Council session with Oval naming sponsors in advance of the above mentioned report being presented to Council. That information is addressed in the confidential in camera report of 22 November 2011.

#### Programming sponsors

Staff is continuing to explore various operating program sponsors. Staff is currently confirming the oval program which will be very similar to last year's program offerings. In order to ensure that the maximum amount of public skates are available free of charge to all members of the HRM community, program sponsors will assist to offset budgetary costs.

#### Amenities at the Oval

The Oval project has been divided into two phases. Phase I is "Building the Essentials". This entails building the core infrastructure required for the Winter 2011/12 skating season. This phase includes site grading and drainage, structural concrete slab to contain refrigerant piping, refrigeration system (chillers, pumps, power) a gravel surround and temporary trailers, maintenance shed and washrooms similar to what was provided for the Canada Winter Games. As discussed by Council at the March 29, 2011 Regional Council session and at ensuing

Regional Council Capital Budget debates, Phase I of the Permanent Oval project budget for the oval was \$4,297,000 and the proposed funding was from Project Account #CPX01190 – Park Upgrades (10/11), \$247,000, Project Account #CPX01329 – Park Upgrades (11/12) \$300,000 and Capital Account CBX01344 – Skating Oval \$3,750,000.

Phase II, "Adding the Amenities" is set for development in 2012/13. It entails the design and construction of the permanent components required to replace the temporary support amenities. There was an allocation of \$1.4 m for Phase II in Year 2 of the Approved 2011/12 Capital Budget. Council also directed staff to consult with the public on what amenities and permanent facilities should be incorporated into Phase II. The consultation and design process for Phase II is underway.

The schedule for these phases can be found in Attachment 1. Staff are currently considering accelerating the time lines for Phase II and bringing it forward for Advanced Capital funding to ensure that the project can be completed in the summer of 2012, thereby ensuring delivery for the 2012/13 skating season and minimizing disruption on the Common. A conceptual site plan for both Phases I and II is found in Attachments 2 and 3 for reference in Council's discussions.

#### Recognition for Save the Oval group

The Save the Oval organization has continued to be a voice of public support for what Council is doing for the community in providing the Oval. They also continue to be a conduit through which potential sponsors have been approaching HRM. Save the Oval have had discussions with HRM staff as to how it could continue to best support the oval over the longer term. These could include fundraising, volunteer organization, event planning etc. During those discussions the concept of formalizing the relationship between the group and HRM has come up. The option of creating an agreement similar to the HRM/Public Gardens Foundation which raised money and helped facilitate the restoration of the Public Gardens has been mentioned. Further discussions with the group will be undertaken. As required, a further staff report would be brought to Council for direction with respect to this relationship.



- 6 Grass field inside the Oval


