SUBJECT: Street Closure – Portion of Wyse Road Right-of-Way, Dartmouth

ORIGIN

A request from Sobey Leased Properties Limited expressing an interest in acquiring a portion of Wyse Road, more particularly described as a portion of PID 41256777.

RECOMMENDATION

It is recommended that Regional Council:

- 1. Approve the closure of a portion of the Wyse Road right-of-way, as shown on Attachment "B", subject to the conclusion of the Public Hearing, to facilitate the market disposal of the property to Sobey Leased Properties Limited; and
- 2. Set a date for a Public Hearing for consideration of HRM Administrative Order No. SC-69 concerning the closure of a portion of the Wyse Road right-of-way, Dartmouth, (Attachment "A").

BACKGROUND

Wyse Road is a main thoroughfare for commercial development. The subject property is the site of a commercial strip mall located along Wyse Road. In 1962, the former City of Dartmouth leased the site to Foord Construction Limited. The site was leased for a 50 year term to allow for parking for their retail strip mall. In 1963, Foord Construction Limited sub-leased the land to Sobey Leased Properties Limited, who is still leasing the property. During their term, Sobey has utilized the site as access parking as well as constructing a Tim Hortons drive-thru on the site. The lease is still in effect and will be ending the 20th day of July, 2012.

In 1996, Sobey enquired about purchasing the site from the City of Dartmouth. At that time, the land was reviewed and retained by the Municipality.

With the lease nearing the expiration date, in 2010, Sobey once again approached HRM about purchasing the site. The site was reviewed and HRM deemed a portion of the site surplus. A portion of the subject property is to be retained for future road widening purposes.

DISCUSSION

Sobey is interested in purchasing a portion of the lands and leasing the remainder of the site, as per Attachment "B".

The portion of the property to be sold to Sobey Leased Properties Limited is outlined in red on attachment "B". The remainder of the site, outlined in blue on attachment "B", is to be retained for future street purposes. There is a Tim Hortons drive-thru encroaching on the portion of land HRM is to retain; therefore, Sobey has requested to lease the remainder of the property to allow for the encroachment and to have additional parking available to the site. Due to the property being a right-of-way, HRM will be granting an encroachment license for Sobey Lease Properties Limited. All the conditions of the encroachment license will be the subject of a future report.

The closure of the subject parcel will facilitate the sale of lands which was the subject of a previous approval report under the delegated approval authority of the CAO, as per the terms and conditions detailed within the private and confidential information report dated March 13, 2012.


