SUBJECT:	Write-off of Uncollectible Accounts

<u>ORIGIN</u>

A recommendation approved by the Audit and Finance Standing Committee at a meeting held on February 27, 2013.

LEGISLATIVE AUTHORITY

Section 42 of the Halifax Regional Municipality (HRM) Charter requires that:

The Treasurer shall promptly advise Council of

(a) all moneys due to the Municipality that the Treasurer considers cannot reasonably be collected after pursuing all reasonable avenues of collection; and

(b) the reasons for the belief that such moneys cannot be collected, and the Council may write off the amounts determined to be uncollectible.

RECOMMENDATION

The Audit and Finance Standing Committee recommends Halifax Regional Council approve:

- 1. The business occupancy tax accounts in the amount of \$86,408.37 comprised of \$60,494.95 principal and \$25,913.42 interest as detailed in Schedule 2 be formally written out of the books of account;
- 2. The general revenue accounts in the amount of \$209,080.76 comprised of \$201,727.73 principal and \$7,353.03 interest as detailed in Schedule 3 be formally written out of the books of account;

RECOMMENDATIONS CONTINUTED ON PAGE 2

3. The real property tax accounts in the amount of \$169,474.03 comprised of \$97,818.89 principal and \$71,655.14 interest as detailed in Schedule 4 be formally written out of the books of account.

SUBJECT:	Write-off of Uncollectible Accounts	

<u>ORIGIN</u>

Staff and HRM Charter requirement.

LEGISLATIVE AUTHORITY

Section 42 of the Halifax Regional Municipality (HRM) Charter requires that;

The Treasurer shall promptly advise Council of

(a) all moneys due to the Municipality that the Treasurer considers cannot reasonably be collected after pursuing all reasonable avenues of collection; and

(b) the reasons for the belief that such moneys cannot be collected, and the Council may write off the amounts determined to be uncollectible.

<u>RECOMMENDATION</u>

It is recommended that

1. The Audit and Finance Standing Committee forward this report to HRM Regional Council for approval;

- 2. The business occupancy tax accounts in the amount of \$86,408.37 comprised of \$60,494.95 principal and \$25,913.42 interest as detailed in Schedule 2 be formally written out of the books of account;
- 3. The general revenue accounts in the amount of \$209,080.76 comprised of \$201,727.73 principal and \$7,353.03 interest as detailed in Schedule 3 be formally written out of the books of account;
- 4. The real property tax accounts in the amount of \$169,474.03 comprised of \$97,818.89 principal and \$71,655.14 interest as detailed in Schedule 4 be formally written out of the books of account;

BACKGROUND

The HRM Charter requires that all accounts considered uncollectible and which are to be permanently removed from the accounts of the HRM be approved by Council. Administrative order 18, The Revenue and Collections Policy, section 5(g) requires staff to provide Council with a write-off report at least once per year.

The last write-off report to Council was on March 27, 2012.

DISCUSSION

Each year the provision for losses on accounts is budgeted in the operating fund as mandated by the HRM Charter. The HRM Charter section 93(1) - (2b) requires that:

93 (1) The Council shall make estimates of the sums that are required by the Municipality for the fiscal year.

(2) The estimates shall include the probable revenue from all sources other than taxes for the fiscal year and make due allowance for

(a) the abatement and losses that might occur in the collection of the taxes; and

(b) taxes for the current fiscal year that might not be collected.

This provision is accumulated each year in the valuation allowance account in order to offset on the balance sheet the value of the receivables recorded in the books of account. In this way, and in accordance with legislation and with generally accepted accounting practices, there is recognition that not all accounts billed will be collectible.

Business Occupancy Account Write-offs:

Fiscal 2012-13 was the last year for business occupancy tax billings. Our current recommended write-offs for business occupancy, (\$88,825.37), are for companies that are defunct and/or bankrupt. Since the phase-out of business occupancy tax in 2006, HRM has billed \$117.8M in revenues and has written-off \$2.3M, for an uncollectible rate of 1.95%. With only \$77,000 remaining in business occupancy receivables, Staff will continue collection efforts, as the companies that make up the remaining receivable balances are active companies.

General Revenue:

General Revenue charges being recommended for write-off, (\$189,213.72), are for miscellaneous and recreation charges related to bankruptcies, defunct companies or inaccessible entities/persons that have been deemed uncollectible.

Real Property:

The amount of real property charges, (\$169,474.03), being recommended for write-off is for amounts related to:

- Residential mobile home accounts
- Leased land accounts
- Accounts relating to dissolved companies that have been struck from the Registry of Joint Stocks, and
- Assessment accounts that have been struck from the 2013 assessment roll

Write-offs over \$25,000

Assessment account 04467965, Nova Scotia Department of Justice. This real property account was formerly in the name of Vac Daniels. This company went bankrupt and was subsequently struck from the Registry of Joint Stocks. HRM attempted to sell the property through tax sale, however due to environmental issues associated with the property, no buyers came forward. When the business was dissolved and struck from the Registry of Joint Stocks, the property was then transferred the Nova Scotia Department of Justice. Under section s.27 and 28 of the Corporations Miscellaneous Provisions Act:

27 (1) Where a corporation is dissolved, the lands, tenements and hereditaments situate in the Province of which the corporation was seized, or to which it was entitled at the time of its

dissolution, shall for all purposes be deemed to escheat to Her Majesty in right of the Province and the Attorney General shall cause possession thereof to be taken in the name of Her Majesty.

- 4 -

28 Where a corporation is dissolved, all personal property and rights whatsoever situate in the Province, vested in or held in trust for the corporation at the time of its dissolution shall be deemed to be *bona vacant* and shall accordingly belong to and vest in Her Majesty in right of the Province. R.S., c. 100, s. 28.

This account is currently on the Province of Nova Scotia PILT schedule. HRM Legal Services has been consulted on this account and they have advised that the arrears are not collectible, and should be forwarded for write-off.

- Nic Nax \$81,957.84. This receivable resulted from a consignment sales arrangement for the sale of Metro Transit bus tickets and passes. The balance represents consignment of pass and ticket inventory to 3 Nic Nax convenience store outlets for 2 months. Staff after ceasing any further consignment of transit tickets and pass inventory, were successful in working with the owner to get a payment arrangement in place and collecting some account arrears. Nic Nax had committed to provide a payment of \$12,500 to HRM by December 31, 2012, but closed and ceased operations in mid-December 2012. HRM Legal services were consulted on this matter and advised finance that there are no assets available for HRM to pursue for payment, and the account should be presented for write-off.
- Park West Playground \$32,482.11. This receivable resulted from the construction of the Park West playground. The project was to be cost shared by the province, HRM and the Park West Community Organization in equal installments. The project came in over budget in 2009 by \$32,482.11. In the absence of a formal funding arrangement HRM Legal Services has advised finance that there is no recourse for the recovery, and thus should be forwarded for write-off.

Schedules 5, 6 and 7 illustrate trends with respect to current and past write-off reports.

FINANCIAL IMPLICATIONS

Each year an allowance for bad debt, the valuation allowance, is calculated based on estimates of amounts outstanding that may be uncollectible in future years. Accounts proposed for write-off in this report have been 100% provided for in the annual valuation allowance expense.

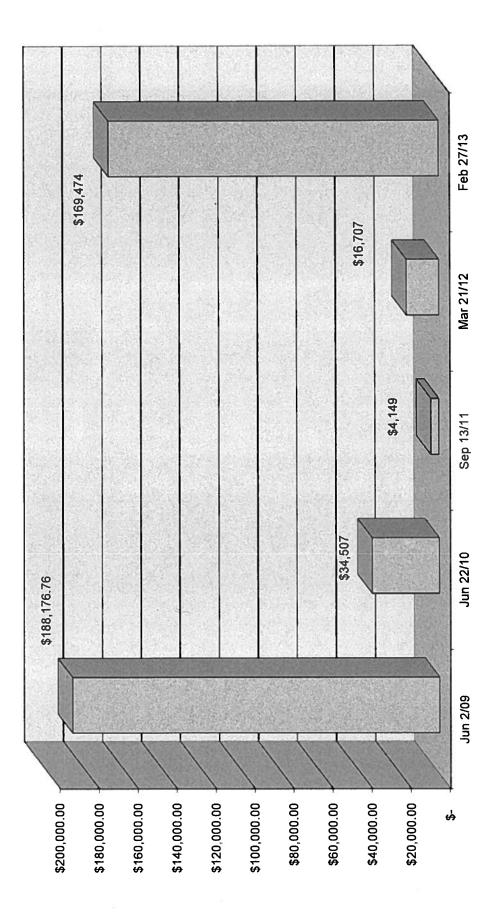

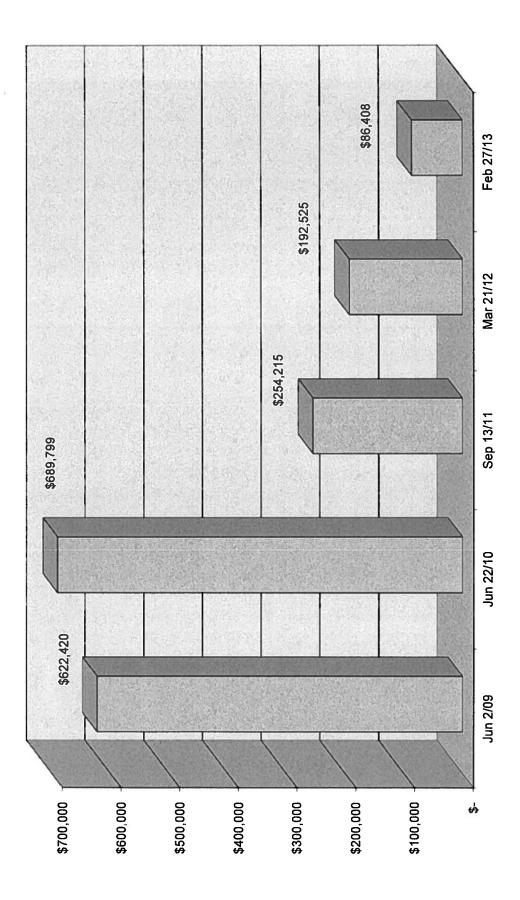

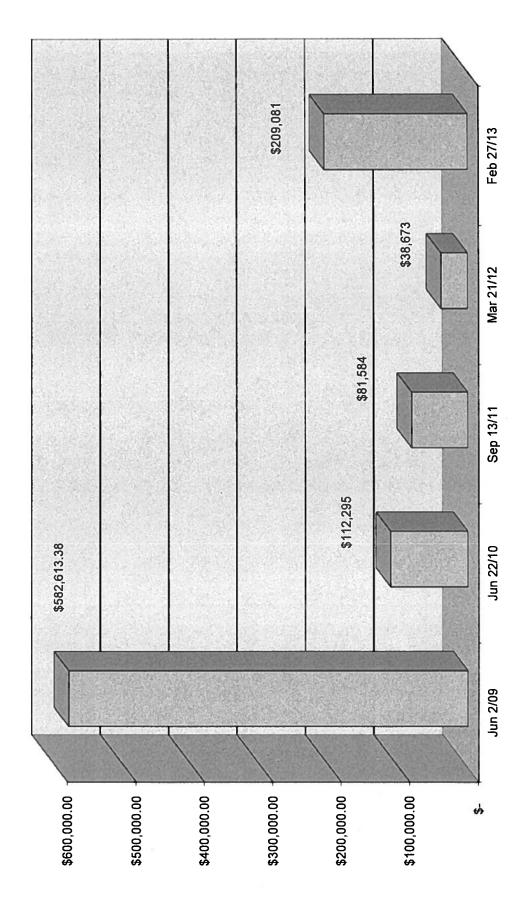
