# **RECOMMENDATION**

It is recommended that the Special Events Advisory Committee recommend that Halifax Regional Council:

1. Approve the 2014/15 Summer Festival grant awards of \$24,500 funded from the Regional Recreation and Culture (C760-6933) 2014/15 Operating Budget as identified below:

# **BACKGROUND**

This report is intended to assist the Special Events Advisory Committee (SEAC) in its discussions respecting the 2014/15 Summer Festival grant allocation in accordance with the Grant Application and Eligibility Process (Attachment 1).

The Summer Festival Grant Program funds community events located within the former Halifax County (see Attachment 2 for Summer Festival history). The total value of the grant program is \$25,000. Prior to 2012, eligible applications were reviewed by a sub-committee of three HRM Councillors who represented the former Halifax County. On March 7, 2012, the Special Events Advisory Committee motioned to discontinue the Summer Festival Sub-Committee and have the Summer Festival report brought directly to SEAC.

There were 7 applications received for 2014:

- 1) Canada Day in Beaver Bank
- 2) Cole Harbour Harvest Festival
- 3) Fall River Canal Days
- 4) Lake and Shore Days
- 5) North Preston Days
- 6) Sambro Sou'Wester Days
- 7) Seaside Festival

# DISCUSSION

Upon review of applications, it was determined that all events meet eligibility criteria. Staff reviewed each application based on the following grant criteria:

- Free/ low cost;
- Arts & culture included;
- Attendance size;
- Accessible to general public;
- Publicized regionally;
- Secured sponsorship;
- Community engagement; and
- Partnerships secured.

A summary of each application is outlined in Attachment 3. After reviewing the applications, it was determined that all events were similar in scale and merit. In 2012 and under similar circumstances, the Summer Festival grant was split equally between all seven applicants. In 2013 the Summer Festival grant was awarded using the same process; however two event's requests were less than the equal split of four applications. This resulted in 2 grants of \$5,000 and 2 grants of \$7,500 being awarded.

Using this existing decision process, the 2014 Summer Festivals grant awards would be divided equally among the applicants. Therefore, it is recommended that all applicants receive a \$3,500 grant award for 2014/15 (Table 1).

#### Attachment 1

## **Grant Application and Eligibility Process**

There are two intake processes for all HRM event grants. Applications for the Summer Festival program are received during the first intake. Each intake process requires several steps as outlined below:

#### **Step One: Eligibility Screening**

Applications are reviewed to determine eligibility and whether the proposal qualifies for a specific grant program.

#### Step Two: Staff Review

Staff team is struck to review all eligible applications and make recommendations to SEAC based on the following guidelines:

- Possibility of annual event status
- Local sport competitions do not qualify
- Fundraising dinners/functions of a similar nature are not eligible for funding
- Preference is not given to new events
- Community and corporate support for the event must be evident
- Events must be accessible to the general public
- Emphasis must be on low cost gate fees

#### **Step Three: Special Events Advisory Committee Deliberations**

Upon review of all applications, SEAC prepares and forwards its recommendations to Regional Council. A committee report is tabled for Council's consideration.

# **Step Four: Regional Council Decision**

Upon review of the recommendations provided by the SEAC, Regional Council makes a final decision on the proposed grants. Successful and unsuccessful grant applicants are officially notified by letter of the grant amount awarded.

# Attachment 3 Event Description and Information

The following is the description of the eligible events being recommended:

# 1) Canada Day in Beaver Bank

*Program Description:* A free 1-day celebration of Canada to be held on July 1, 2014, at the Beaver Bank Kinsac Community Centre. The celebration's purpose is to promote a sense of unity and involvement. Events include a pancake breakfast, flag raising ceremony, family fair, youth talent concert and a fireworks display. Estimated attendance for 2014 is 1,600 and the proposed budget is \$17,000.

#### 2) Cole Harbour Harvest Festival

*Program Description:* A free 1-day event to be held on September 6, 2014, at Cole Harbour Place (indoor & outdoor). The event includes a music concert featuring local bands, art and culture displays, youth sport events (skateboard competition), farmer's market, a free skate and inflatable games. The festival is held in conjunction with a Health Fair organized by Cole Harbour Place. Estimated attendance for 2014 is 5,000 and the proposed budget is \$18,600.

# 3) Fall River Canal Days

*Program Description:* A free 1-day community celebration of Canada Day to be held on July 1, 2014, at various locations in Fall River. The event starts with a community breakfast, parade of water crafts down the Shubenacadie Canal and then a flag raising ceremony at the Gordon R. Snow Community Centre. Also held at the community centre will be a fishing derby, pet show, and children's entertainment, live music by local groups, a pig roast and a fireworks display. Estimated attendance for 2014 is 3,300 and the proposed budget is \$28,000.

# 4) Lake and Shore Days

*Program Description:* A week long community celebration to be held on August 3-10, 2014, at various locations in Porters Lake. The majority of events are free however some events are gated with a ticket fee of \$5-\$15. Events include BBQs, breakfasts, a family movie, youth dance, teddy bear picnic, public yard sale, children's carnival, adult dance, parade, parade of lights on the lake and fireworks. Estimated attendance for 2014 is 2,500 and the proposed budget is \$27,000.

#### 5) North Preston Days

*Program Description:* A free 3-day community celebration to be held on August 1-4, 2014, at various locations in North Preston. Events include talent showcases (dance, singing, rap and poetry), sports tournaments (boxing, basketball and hockey), community celebrations (parade and live concerts) and food (BBQ cooking contest). Estimated attendance for 2014 is 1,400 and the proposed budget is \$13,000.

#### 6) Sambro Sou'Wester Days

*Program Description:* A free 3-day festival to be held on August 8-10, 2014, at various locations in Sambro. Events include historical water tours to Sambro Island, walking tours of the community, children's carnival, washer toss tournament, community parade,

and historic dory racing demonstrations, adult dance, adult comedy show, beer garden, local musical show and fireworks. Estimated attendance for 2014 is 2,000 and the proposed budget is \$28,000.

# 7) Seaside Harvest Festival

*Program Description:* A free 2-day community celebration to be held on October 3-4, 2014, at Fisherman's Cove, Eastern Passage. The event is focused on family, community and coastal heritage. Events include a farmer's market, pumpkin carving, scarecrow decorating, scavenger hunt, art exhibits, live music, storytelling and crafts that reflect the local culture and heritage. Estimated attendance for 2014 is 5,000 and the proposed budget is \$20,000.
