ORIGIN

May 1, 2014 – Environment & Sustainability Standing Committee June 23, 2014 – Executive Standing Committee

LEGISLATIVE AUTHORITY

Section 3.5.2 Terms of Reference of the Environment & Sustainability Standing Committee which directs the Committee to act as the nominating body to Regional Council one (1) member of the Standing Committee as one (1) of the Regional Council appointments to the Board of Halifax Water.

Section 3.2.1 Terms of Reference of the Executive Standing Committee which directs the Committee to act as the nominating body to Regional Council on Committees not otherwise delegated to other Standing Committees.

RECOMMENDATION

It is recommended that Halifax Regional Council appoint Councillor Barry Dalrymple (ESSC Representative), Councillor Walker and Councillor Hendsbee to the Board of Halifax Water for a term to March, 2016.

BACKGROUND

Based in the Terms of Reference of the Standing Committees, as approved by Regional Council, each Committee has the responsibility to be the nominating body to Regional Council for the members of Boards and Committees within their mandates.

DISCUSSION

As is practice, the Clerk's Office put forward an Expression of Interest on April 7, 2014 to all members of Regional Council in regard to serving on the Board of Halifax Water. Councillors Walker, Hendsbee and Johns put their names forward to serve on the Board of Halifax Water for the new term to March 2016.

At the Executive Standing Committee of June 23, 2014 Councillor Johns withdrew his expression of interest and the Committee duly nominated Councillors Walker and Hendsbee to serve on the Board of Halifax Water.

At the meeting of May 1, 2014 the Environment & Sustainability Standing Committee nominated Councillor Dalrymple as their nominee to the Board of Halifax Water.
