ORIGIN

Executive Standing Committee August 6, 2014 and September 22, 2014 meetings.

Motion of Regional Council June 24, 2013 that the Executive Standing Committee, supported by staff, is directed to undertake a review of Council's governance & committee structure and the TOR of Standing Committees to ensure the structure supports Council's priorities.

LEGISLATIVE AUTHORITY

Executive Standing Committee Terms of Reference, Section 3.6 General Council Governance; Section 3.6.1 – *The Committee shall act as a review committee for matters related to the general self-governance and administration of Council as directed by Regional Council.*

RECOMMENDATION

It is recommended that Halifax Regional Council:

- 1a. Make no changes to the process for appointments to the Halifax Water Commission board, the Police Commission, the Community Monitoring Committee or the FCM and UNSM boards at this time.
- 1b. Reduce the number of Councillors appointed to the Regional Library Board and the Halifax-Dartmouth Bridge Commission Board to two (2) Council members from four (4) and, with respect to the Regional Library, work with the Provincial Government to make appropriate changes to the relevant agreements.
2. May consider the appointment of Council members to external boards or committees, as set out by Administrative Order, which in the opinion of Council:
 - Are regional in scope;
 - Affect or may affect a municipal interest; or

- Is a community organization with a mandate to provide an alternate service delivery in respect of municipal property on behalf of HRM and to which the municipality is the primary funder.
- 3. That staff be directed to draft an Administrative Order to implement recommendation #2 as set out in Table 1 and Table 2 of the supplementary staff report dated September 19, 2014 with the addition of HRM Chain of Lakes Trail Association in Table 1 (Council appointments).
- 4. Advise all councillors who sit on boards or committees to which they have not been appointed by Regional Council to inform the Municipal Clerk of those positions, to annually review the list of those boards and committees and inform the Municipal Clerk of any errors or omissions and that, in accordance with the NS Municipal Conflict of Interest Act, the list be retained in the Office of the Municipal Clerk as a public record.

BACKGROUND

The Executive Standing Committee discussed the staff recommendations outlined in the July 29, 2014 report at their August 6, 2014 special meeting in regard to external boards and committees. The Committee deferred the matter back to staff to respond to the Committee's concerns and questions raised during the meeting; as outlined in the background section of the supplementary staff report dated September 19, 2014 provided to the Committee September 22, 2014 attached to this report.

DISCUSSION

The Executive Standing Committee discussed and approved the staff recommendations brought forward in the September 19, 2014 supplementary staff report, with an amendment to recommendation #3 to include the addition of HRM Chain of Lakes Trail Association in Table 1 (Council appointments).

SUPPLEMENTARY REPORT

ORIGIN

On June 24, 2013, Regional Council moved and passed the following motion:

That the Executive Committee, supported by staff, is directed to undertake a review of Council's governance & committee structure and the TOR of Standing Committees to ensure the structure supports Council's priorities.

On August 6, 2014, the Executive Standing Committee moved the following motion:

MOVED by Councillor Rankin, seconded by Councillor Whitman that the Executive Standing Committee recommends to Halifax Regional Council that:

- **Recommendation #1A:** Regional Council make no changes to the process for appointments to the Halifax Water Commission board, the Police Commission, the Community Monitoring Committee or the FCM and UNSM boards.
- **Recommendation #1B:** Regional Council reduce the number of Councillors appointed to the Regional Library Board and work with the Provincial Government to make appropriate changes to the relevant agreement.
- **Recommendation #2:** Regional Council, when dealing with appointments to other external boards and committees, consider first, competency based appointment of HRM residents, second, appointment of relevant HRM staff members, and third, appointment of elected officials only if suitable appointments cannot be made under the first two categories.
- **Recommendation #3:** Regional Council cease appointing councillors to the boards of Alderney Landing, Canada Games Centre, Neptune Theatre and the Business Improvement Districts, and to the boards of other organizations which might invite the appointment of councillors.

- **Recommendation #4:** Regional Council advise all councillors who sit on boards or committees to which they have not been appointed by Regional Council to inform the Municipal Clerk of those positions.

At the same meeting, the Executive Committee moved and passed the following motion

MOVED by Councillor Karsten, seconded by Councillor Whitman that the Executive Standing Committee refer the matter back to staff for supplementary report responding to the concerns and questions laid out in the discussion and that the supplementary report be considered at the next meeting of the Committee.

MOTION PUT AND PASSED

LEGISLATIVE AUTHORITY

Halifax Regional Municipality Charter, Chapter 39 of the Acts of 2008 as amended

- Subsection 11(1) - The powers of the Municipality are exercised by the Council.
- Clause 20(1)(c) - Council may make Administrative Orders providing for committees and conferring powers and duties upon them, except the power to expend funds.
- Subsection 20(2) - The Council may, by Administrative Order, require that where a Council member is nominated or appointed by the Council to a board, commission or other position or is otherwise appointed as a representative of the Municipality, any remuneration from that position, excluding reimbursement of expenses, to which that Council member is entitled shall be paid to the Municipality.

RECOMMENDATIONS

It is recommended that the Executive Standing Committee move the following highlighted amendments to the August 6, 2014 motion:

Recommendation #1A:

Regional Council make no changes to the process for appointments to the Halifax Water Commission board, the Police Commission, the Community Monitoring Committee or the FCM and UNSM boards at this time.

Recommendation # 1B:

BACKGROUND

On August 6, 2014, the members of the Executive Standing Committee discussed the staff recommendations found in the July 29, 2014 recommendation report in regard to external boards and committees. At the August 6, 2014 meeting, the members of the Executive Committee discussed:

- revising recommendations #2 and #3 of the July 29th 2014 staff report to provide more flexibility and options for Council to consider;
- clarifying on which external boards and committees Council members may serve on;
- adding wording respecting Council members and HRM Management in recommendation #4; and
- clarifying how the Office of the Clerk would implement and maintain the list of all the external boards or committees on which the Council members serve.

DISCUSSION

Based on the above discussions of the Executive Committee meeting, staff have revised recommendations 2, 3 and 4 for the Committee's consideration.

Recommendations #2 #3 - Revised

Recommendation #3 from the July 29, 2014 staff report has been consolidated with recommendation #2. The revised recommendation provides greater flexibility by removing the hierarchy of appointment of residents, staff and then Council members. The revised recommendation no longer requires the public to be considered first. Rather, the revised recommendation allows broader discretion by setting criteria for Council to consider when looking at appointments to boards or committees that:

- are regional in scope;
- affect or may affect municipal interest ; or
- is a community organization with a mandate to provide an alternate service delivery in respect of municipal property on behalf of HRM and to which the municipality is the primary funder.

The terms and conditions of the appointment to external boards and committees would be set out in a new Administrative Order. Accordingly, the revised recommendation #3 directs staff to draft the Administrative Order in accordance with Table 1 and Table 2 for Council's consideration.

If Council adopts the revised recommendation #2, the following will result:

The revised recommendation removes staff from general consideration for appointments to external boards and committees. The appointment of staff to external boards and committee may put the staff member in a conflict of interest on issues involving HRM and the Organization. Accordingly, staff appointments should be considered on a case by case basis.

Recommendation #4 - Revised

Recommendation #4 was advanced in regard to the recent case law outlined in the January 23, 2014 Private and Confidential staff report. In accordance with the definition of "member" within the *Municipal Conflict of Interest Act*, the Act applies to "a member, in whatever capacity, of a council or a local board." The intent of the Act is to assist those cited in the legislation in conducting themselves in accordance with the Act so as to protect both them and the public interest.

Recommendation #4 is put forward to provide full transparency in regard to subsection 7(3) of the Act which says:

Every municipality and local board shall keep a central record of disclosure, which shall be open to inspection by any elector without fee at all reasonable times.

The Office of the Municipal Clerk would maintain a list of all the external boards of committees on which Council members serve. Council members will be responsible to annually review the list and inform the Municipal Clerk of any errors or omissions changes. In accordance with the Act that list would be a public record kept in the Office of the Municipal Clerk.

If applicable, the CAO will direct the Directors to make a similar declaration respecting members of staff on external boards and committees.

Additional Amendment - Recommendation #1B

It was determined during the governance review that there is nothing within the *Halifax-Dartmouth Bridge Commission Act* that requires the four (4) municipal appointments by the municipality to be Council members. Accordingly, Council may consider reducing this number to two (2) Council members.

FINANCIAL IMPLICATIONS

There are no financial implications to this report beyond those in the staff report of July 29, 2014

COMMUNITY ENGAGEMENT

The request for a supplemental report did not seek additional input from the community.

BACKGROUND

INTRODUCTION

In this governance review, to date the Project Manager has

- interviewed councillors about HRM's governance: what works, what needs improvement and how external committee appointments might be managed better.
- researched governance practices in HRM and other comparable Canadian municipalities
- prepared reports and presentations for the Executive Standing Committee to
 - provide feedback on the interviews with councillors,

Regional Council has also received a number of briefings and advice on Conflicts of Interest.

This report focuses on the external committees to which Council makes appointments. It makes change recommendations for Executive Standing Committee to consider.

COMMITTEES

Regional Councillors sit on many boards and committees as appointees or representatives of Regional Council, or as volunteers. Some of the boards and committees are "Internal" and others are "External".

Internal committees, like Community Councils and Standing Committees and groups which report to them, are established by Regional Council itself. A previous report made recommendations covering internal committees. After discussion at Executive Standing Committee, the report was presented to Regional Council.

External boards or committees are generally established by other organizations. HRM is often asked to appoint members to those boards or committees.

EXTERNAL COMMITTEES

There are both "regional" and "local" external committees. The latter tend to have a specific geographic focus that centres on a single council electoral district.

Regional external committees fall into five broad categories for Councillor appointments;

- Mandated under provincial legislation
- Established to deal with intergovernmental issues
- Directed by motion of Regional Council or by agreement
- Appointed to provide financial oversight or liaison
- Invited under the bylaws of the external organization

DISCUSSION

Regional Council appoints councillors to external Boards/Committees for two main reasons:

- accountability - to know that the organization uses HRM funds/other resources effectively.
- communication - to know what the external body does or to tell it what HRM is doing.

In meetings with the Governance Project Manager, Regional Councillors raised many issues about appointing councillors to the boards or committees of external organizations.

The presence of regional councillors on external boards and committees raises some legal issues. The January 23, 2014 private and confidential report from Legal Services to Executive Standing Committee provides information on those questions. The legal issues require that Regional Council carefully consider its approach for some types of external boards and committees.

A summary of the appointments, by category, follows with recommendations for action. (Attachment A includes legislative and other information about external committees and Attachment B provides an overview of the appointment situation for external committees.)

Appointments mandated under provincial legislation or dealing with intergovernmental issues

Recommendation #1A: Regional Council make no changes to the process for appointments to the Halifax Water Commission board, the Police Commission, the Community Monitoring Committee or the FCM and UNSM boards.

Halifax Water, Halifax Library, the Police Commission, the Community Monitoring Committee, the Federation of Canadian Municipalities, the Union of Nova Scotia Municipalities and the Canadian Urban Transit Association are the organizations in these two categories.

For Halifax Water, the Halifax Library, and the Police Commission, appointing elected officials and residents by Council fulfills the requirements of the relevant legislation. (Attachment A).

For the Community Monitoring Committee, the agreement between Halifax and the community covers appointments. Any change requires the agreement of the community.

For intergovernmental organizations, like FCM and UNSM, appointing elected officials meets the requirements of the bylaws of those organizations. As long as Halifax is a member of those organizations, it must abide by their bylaws. For the Transit Committee of CUTA, appointing an elected official, if requested by the Transportation Standing Committee, is appropriate.

Recommendation #1B: Regional Council reduce the number of Councillors appointed to the Regional Library Board and work with the Provincial Government to make appropriate changes to the relevant agreement.

The Halifax Regional Library Board is reviewing its governing by-laws. It has discussed the Library Board's composition. Given that Regional Council's size has gone from 23 to 16 councillors, the Library Board suggests that the number of Councillors appointed to the Board be reduced from 4 to 3 and that the number of citizens appointed go from 4 to 5. The Governance Working Group suggests that the appointment of 2 councillors and 6 citizens also be considered.

Discussions with the Province of Nova Scotia suggest that making appropriate changes to the agreement covering the Halifax Regional Library should be straight forward.

Appointments directed by motion of Regional Council or by agreement

Recommendation #2: *Regional Council, when dealing with appointments to other external boards and committees, consider first, competency based appointment of HRM residents, second, appointment of relevant HRM staff members, and third, appointment of elected officials only if suitable appointments cannot be made under the first two categories*

Organizations in this category include: Halifax Bridge Commission, Shubenacadie Canal Commission, Destination Halifax, and the Greater Halifax Partnership.

The Working Group recommends that Council move to competency based resident appointments as the primary appointments to boards/committees in this category. Council could make HRM staff appointments as a secondary choice. Council should appoint an elected official only under special circumstances.

If adopted, these changes could be implemented in the next round of appointments to both the Halifax Bridge Commission and the Shubenacadie Canal Commission.

If adopted, the changes would require HRM to negotiate amendments to the current agreements with or bylaws of, Destination Halifax and the Greater Halifax Partnership.

The Project Working Group does not recommend changes to the HRM appointments to the Trade Centre Limited. The Trade Centre will soon be replaced by the Halifax Convention Centre and the TCL board wound down. The new legislation governing the appointment of the board of the Halifax Convention centre requires the appointment by Regional Council of four residents with the competencies and experience needed. The partners in the convention centre, Halifax and the province, are developing the competencies required on the new board.

The legislation for the Bridge Commission and the Canal Commission does not require the appointment of councillors to either body.

Given the importance of the harbour bridges to Halifax, it could be argued that it would be useful to have one or two councillors appointed to the Bridge Commission. A similar argument could be made for the Canal Commission. If Regional Council chooses to appoint councillors to either of both of these boards, Regional Council should note that it does not have to make such appointments.

Appointments made to provide financial oversight or liaison

Recommendation #3: *Regional Council cease appointing councillors to the boards of Alderney Landing, Canada Games Centre, Neptune Theatre and the Business Improvement Districts, and to the boards of other organizations which might invite the appointment of councillors.*

Organizations included in this category are: Alderney Landing, Canada Games Centre, Neptune Theatre, and the boards of the various organizations which manage the affairs of the Business Improvement Districts.

The Working Group strongly recommends that no appointments of elected officials be made in this category. Currently there is a lack of consistency about why elected officials serve on some boards and not others of a similar nature.

While oversight and liaison with community facility and arts organizations are important to HRM, especially when HRM makes significant financial contributions, the Working Group's position is that appropriate financial oversight and liaison can be achieved through more stringent service agreements and clearer, direct, regular reporting requirements. Such approaches minimize the potential for real or perceived conflict of interest.

The use of a staff Liaison Officer model, currently in place with Trade Centre Limited, is another robust method for understanding and overseeing the operations of external organizations.

To implement this approach, in several cases, changes to the bylaws of the relevant organizations will need to be negotiated.

Invited under the bylaws of the external organization

Recommendation #3 covers the situation of such organizations. The Working Group recommends that Regional Council not appoint elected officials to the boards and committees in this category, too. Good service agreements, where appropriate, and clearer reporting can meet financial oversight and liaison requirements. In several cases, changes to the bylaws of the organizations will need to be negotiated.

Local External Organizations

Recommendation #4: *Regional Council advise all councillors who sit on boards or committees to which they have not been appointed by Regional Council to inform the Municipal Clerk of those positions.*

Recent case law, as outlined in the January 23rd Private and Confidential Report, is provided under separate cover. If elected officials choose to serve on local boards or committees, they should take appropriate steps in accordance with the Municipal Conflict of Interest Act to identify and deal with Conflicts in accordance with the Act.

The Working Group recommends that Council require Elected Officials to advise the Office of the Municipal Clerk of any and all Boards & Committees on which they serve and to which Regional Council or Community Council has not appointed them. It is further recommended that a public list should be kept with the Office of the Municipal Clerk as part of the Conflict of Interest log required by the HRM Charter.

FINANCIAL IMPLICATIONS

Costs – Several External Boards pay stipends for attendance at Board meetings. To meet the requirements of the HRM Charter, Councillors appointed to those boards do not receive the stipends. They are paid as revenue to the operating budget of the Councillors' Support Office. The same would be the case for staff appointments. Should citizen appointments be made it would result in a reduction in the operating budget of the Councillor's Support Office - Cost Centre E200 estimated at about \$15,000 annually. This reduction should be adjusted for in future HRM operating budgets.

Savings – There would be indirect savings from not appointing councillors to Boards and Committees. The time the councillors spend at these board meetings would be available for other activities. For some boards this time saving could be significant. For example, Councillors who sit on the Bridge Commission also sit on subcommittees of that board, attend planning sessions and otherwise engage heavily with the work of the board. That time would be available for other duties.

COMMUNITY ENGAGEMENT

The Project Manager met with Councillors to develop this proposal but there has been no community engagement to date on the issues presented here. In moving to implement some of the suggestions made, it will be necessary to consult with many organizations to make changes in their bylaws.

ENVIRONMENTAL IMPLICATIONS

There are no significant environmental implications in changing the appointment of councillors to external boards and committees.

ALTERNATIVES

(1) Status Quo: The Executive Standing Committee could recommend that no changes be made to the current practise of appointments to External Boards and Committees

(2) Partial implementation of recommendations: The Executive Standing Committee could choose to implement some of the recommendations only.

Attachment A – Legislation Covering External Committees

Halifax Water Commission - The *Halifax Regional Water Commission Act* states that

4 (1) The Commission Board consists of

- (a) the Mayor of the Regional Municipality;
- (b) three members of the Council appointed by the Council;
- (c) three residents of the Regional Municipality, who are not members of the Council, appointed by the Council; and
- (d) one member of the Regional Municipality staff, appointed by the Chief Administrative Officer of the Regional Municipality, who shall be a non-voting member of the Commission Board.

Board of Police Commissioners - The *Police Act* states that

44(1) Every municipality that establishes a municipal police department pursuant to Section 36, 84 or 85 shall, by by-law, provide for a board of police commissioners.

- (4) A seven-member board appointed pursuant to subsection (1) consists of
 - (a) three members of council appointed by resolution of the council
 - (b) three members appointed by resolution who are neither members of council nor employees of the municipality
 - (c) one member appointed by the Minister

HRM Regional Library Board - The *Libraries Act* states

10 (1) Where an agreement for the establishment and support of a regional public library is entered into under this Act there shall be a regional library board for the management and operation of the library.

- (2) A regional library board shall consist of
 - (a) one member appointed by each city, town and municipality that is a party to the agreement
 - (b) two members appointed by the Governor in Council; and
 - (c) additional members appointed in such manner and number as the parties to the agreement agree.

In 1996, HRM and the Province signed an agreement that stated:

the regional library board shall be known as the Halifax Regional Library Board and shall consist of eleven members to be appointed in the following manner:

- (a) the Mayor of the Municipality, ex officio;
- (b) two members appointed by the Governor in Council pursuant to clause 10(2)(b) of the Libraries Act; and
- (c) eight persons appointed by the Council of the Municipality pursuant to clause 10(2)(c) of the Act as follows:
 - (i) four councillors of the Municipality, and

(ii) four citizens of the Municipality.

[In a June 5, 2014 letter to the Mayor, the Chair of the Halifax Regional Library Board suggested reducing the number of councillor appointments from four to three and increasing the number of citizen appointments from four to five.]

Bridge Commission - The *Halifax-Dartmouth Bridge Commission Act* states

3 The Halifax-Dartmouth Bridge Commission consists of

(a) five members appointed by the Governor in Council, one of whom is to be the Chair and one of whom is to be the Vice-chair; and

(b) four members appointed by the Municipality

Shubenacadie Canal Commission - An amendment to the *Shubenacadie Canal Commission* legislation states that membership will include:

(a) Four persons resident in HRM appointed by the Council of HRM for such terms of office as the Council may determine

Community Monitoring Committee - Section 7.01 of the Monitoring Agreement between HRM and the Halifax Waste/Resource Society defines the responsibilities of the Community Monitoring Committee. CMC has the responsibility to:

1. Monitor all operations at the Otter Lake landfill;
2. Report important information about the landfill operation to the local community;
3. Hear concerns from the local community and report those views to the Council of HRM;
4. Report its own views to Council on any other aspect of HRM's waste management facilities that could have an impact on the landfill facilities;
5. Report concerns to any other relevant body (ex. Nova Scotia Department of Environment) regarding any concerns it may have concerning issues inside of its mandate.

Under the agreement with HRM, the CMC comprises:

1. The Mayor;
2. 2 local Councillors;
3. 1 other Councillor appointed by Council;
4. 2 residents of HRM who do not live in the area, appointed by Council;
5. 9 residents of HRM who are elected, with 4 to 6 coming from the local community.

Destination Halifax - The By-Laws of Destination Halifax state

5.04 The following shall each be entitled to be represented on the Board of Directors as long as the organization they represent is providing money for the operation of the Society in an amount no less than that which existed at the time of the organization's incorporation. Any changes to the financial contributions, by way of reduced investment will call for review by a committee comprised of members of the Board, in the elected categories, and may result but not be limited to:

- a) no change to status
- b) modification to voting status
- c) reduction to number of allocated seats on the Board
- d) elimination of entitlement for representation on the Board
- (i) The Mayor of Halifax Regional Municipality or his or her designate;
- (ii) A member of Halifax Regional Municipal Council appointed (not elected) by Council;

- (iii) The Chief Administrative Officer of the Halifax Regional Municipality, or his or her designate;
- (iv) The President of the Hotel Association of Nova Scotia, or his or her designate;
- (v) The President of Trade Centre Limited or his or her designate;
- (vi) The Deputy Minister, of the Nova Scotia government, responsible for Tourism or his or her designate

5.05 Up to two (2) positions on the Board of Directors shall be elected from members who provide accommodation services with at least one facility that has between 20 and 99 rooms and which is located outside the current Districts 7 and 8 of the Halifax Regional Municipality.

5.06 Up to seven (7) positions on the Board of Directors shall be elected from members involved in the Tourism industry in HRM who do not qualify under Bylaw 5.05.

Greater Halifax Partnership - The By-laws of the Greater Halifax Partnership state

23 The composition of the Board of Directors shall be as follows:

- (a) Seven members representing the Investors;
- (b) Two members representing the Municipal Council of HRM; and
- (c) Six members representing the Community at Large.

24 The Board shall have five *ex officio* members. The *ex officio* members have the right to attend Board meetings and to speak at such meetings, but an *ex officio* member shall not have the right to vote at such meetings. The attendance of an *ex officio* member at a Board meeting shall not be included when determining whether a quorum is present. The *ex officio* members of the Board shall be as follows:

- a. The Mayor of the Halifax Regional Municipality, or designate;
- b. The Chief Administrative Officer of the Halifax Regional Municipality, or designate;
- c. The Provincial Minister responsible for Economic Development, or designate;
- d. The Federal Minister responsible for the Atlantic Canadian Opportunities Agency, or designate; and
- e. The Commander of Joint Task Force Atlantic, or designate.

Federation of Canadian Municipalities - The bylaws of FCM state:

4.05 Directors Representing Nova Scotia. There shall be four (4) Directors representing Nova Scotia, one (1) of whom shall be appointed by its Affiliate Member (Union of Nova Scotia Municipalities) being its president, one of whom shall be appointed by the Halifax Regional Municipality and each of the other two (2) Directors shall be elected by the Accredited Representatives of its Municipal Members.

Union of Nova Scotia Municipalities - The Bylaws of UNSM state:

4.1 At each Annual Conference delegates representing towns, rural municipalities and regional municipalities shall meet in their respective caucuses to elect three members to serve on the Board of Directors to replace the members elected by that particular caucus who are completing as of the Annual Conference the second year of their two-year term or were elected between Annual Conferences by that particular caucus to replace a member who was unable or unwilling to continue serving as a member of the Board of Directors. At the Annual Conference voting delegates from each caucus shall elect such members to serve on the Board of Directors as are necessary to ensure that each caucus has elected to service three (3) members on the Board of Directors. One (1) of the three (3) persons elected by each caucus to serve on the Board of Directors shall be elected as Caucus Chair.
