SUBJECT: Award Tender No. 14-092 – Janitorial Services – Halifax Central Library

#### **ORIGIN**

This report originates with the requirement for Janitorial Services for the new Halifax Central Library and Parkade area.

## **LEGISLATIVE AUTHORITY**

Under the HRM Charter, Section 79, Halifax Regional Council may expend money for municipal purposes. Administrative Order #35, the Procurement Policy, requires Council to approve the award of contracts for sole sources exceeding \$50,000 or \$500,000 for tenders and RFP's. See Charter Sections 79(1) and 322(3).

## **RECOMMENDATION**

It is recommended that Halifax Regional Council award Tender No.14-092, Janitorial Services for the Halifax Central Library, to the second lowest bidder meeting specifications, ZM Supreme Cleaning, for a total three year tender price of \$780,188.59 (net HST included), with the option to renew for two additional one year periods. Funding will come from Operating Account B034 - 6304 as outlined in the Financial Implications section of this report.

## **BACKGROUND**

Tender No. 14-092 – Janitorial Services for the Halifax Central Library and Parkade area is for a three year period with an option to renew for two (2) additional one (1) year terms.

Work includes the furnishing of all labour, material, tools, and equipment required for janitorial cleaning services as specified in the contract documents.

Note: Contract period is anticipated to start any time between November 15, 2014, and December 1, 2014.

#### DISCUSSION

Tenders were called and posted to the Province of Nova Scotia's Procurement website on August 25, 2014, with a mandatory site visit on August 28, 2014, with the tender closing on September 17, 2014. Bids were received as an annual lump sum as noted below.

D&J's Cleaning was the original low bid, but after meeting with Facility Management and Library staff to review the requirements and performance standards outlined in the Tender and doing an additional walk through of the building, D&J's Cleaning requested that HRM accept their bid withdrawal. They recognized that they could not meet the requirements and services standards outlined in Tender for the bid price submitted and staff have determined that it is in HRM's best interest to accommodate their request. As a result, HRM is recommending T14-092 be awarded to the second low bidder, ZM Supreme Cleaning. HRM has met with ZM Supreme to review the Tender documents and do an additional walk through of the facility and they are confident they can fulfill their contractual obligations at the price submitted.
