SUBJECT: Summer Festivals Grants Report 2015

#### <u>ORIGIN</u>

Civic Events Policy and Granting Framework approved by Regional Council on March 27, 2007.

#### **LEGISLATIVE AUTHORITY**

Halifax Regional Municipality Charter, Section 79, (1) (av)

## **RECOMMENDATION**

It is recommended that Halifax Regional Council Approve the 2015/16 Summer Festivals grant awards for a total of \$24,975 as identified in Table 1 to be funded from the approved 2015/16 Operating Budget Account No. C760, Culture & Events.

#### **BACKGROUND**

This report is intended to assist Regional Council in its deliberations respecting the Summer Festivals grants allocation for the 2015/16 budget in accordance with the Grant Application Eligibility and Evaluation Process (Attachment 1).

The Summer Festival Grant Program funds community events located within the former Halifax County (see Attachment 2 for Summer Festival history). The total value of the grant program is \$25,000. Prior to 2012, eligible applications were reviewed by a sub-committee of three (3) HRM Councillors who represented the former Halifax County. On March 7, 2012, the Special Events Advisory Committee (SEAC) motioned to discontinue the Summer Festival Sub-Committee and have the Summer Festival report brought directly to SEAC.

There were nine (9) applications received for 2015:

- 1. Canada Day in Beaver Bank
- 2. Cole Harbour Harvest Festival
- 3. Fall River Canal Days
- 4. Lake and Shore Days
- 5. North Preston Days
- 6. Peggy's Cove Area Festival of the Arts
- 7. Sambro Sou' Wester Days 2015
- 8. Seaside Harvest Festival
- 9. Tallahassee Days

On May 26, 2015, Regional Council approved a new Administrative Order (A0) which outlined a new process and categories for the provision of event grants. Since the event grant process was already underway for the 2015 season, applications were received under the existing process and the new AO and categories will take effect for the 2016/17 fiscal year. Pursuant to the existing process, this report was scheduled to go to SEAC on July 8, 2015, and subsequently onto Regional Council for consideration on July 21, 2015. As the many of community events are scheduled for July 1<sup>st</sup>, and therefore require funding confirmation as soon as possible, staff was requested to bring the report directly to Regional Council. This change has been supported by the Chair of SEAC.

#### **DISCUSSION**

Upon review of the applications, it was determined that all events meet eligibility criteria. Staff reviewed each application based on the following grant criteria:

- Free/ low cost;
- Arts & culture included;
- Attendance size:
- Accessible to general public;
- Publicized regionally;
- Secured sponsorship:
- · Community engagement; and
- Partnerships secured.

A summary of each application is outlined in Attachment 3. After reviewing the applications, it was determined that while there were two (2) new applicants to the program, all events were similar in scale and merit. From 2012 to 2014 and under similar circumstances, the Summer Festival grant budget has been split equally between all eligible applicants.

Using this existing decision process, the 2015 Summer Festivals grant awards would be divided equally among the applicants. Therefore, it is recommended that all applicants receive a \$2,775 grant award for 2015/16 (Table 1).

It should be noted that the reduction in each grant of \$725.00 from the 2014 amount of \$3,500.00 is in no way a reflection on the quality of the applicants, but rather that additional applicants to the program have impacted the total available funds.

# Attachment 1 Grant Application Eligibility and Evaluation Process

The application process requires several steps until a final decision is made by Regional Council, as outlined below:

#### Step One: Eligibility Screening

The approved Civic Events Granting Framework and Policy guides all decisions respecting event categories that may be considered for funding. Applications are reviewed to determine eligibility and whether the proposal qualifies for the Summer Festivals program.

#### Step Two: Staff Review

Staff reviews all eligible applications and makes recommendations to SEAC based on the following guidelines:

- Possibility of becoming an annual event
- Community and corporate support for the event must be evident
- Events must be accessible to the general public
- Emphasis on low cost gate fees must be evident
- · Local sport competitions do not qualify
- Fundraising dinners/functions of a similar nature are not eligible for funding

#### **Step Three: Special Events Advisory Committee Deliberations**

Upon review of all applications, SEAC prepares and forwards its recommendations to Regional Council. A committee report is tabled for Council's consideration.

#### **Step Four: Regional Council Decision**

Upon review of the recommendations provided by SEAC, Regional Council makes a final decision on the proposed grants. Successful grant applicants are officially notified by staff of the grant amount awarded.

The following is the descriptions of the eligible events being recommended:

#### 1. Canada Day in Beaver Bank

Organization: Beaver Bank Kinsac Community Centre

When: June 30 - July 1, 2015

Where: Beaver Bank Rd. Community Centre, school on Kinsac Rd, ball field in Beaver Bank Program Description: Free Canada Day Celebrations including beer tent, open mic, pancake

breakfast, flag raising, family fair, youth event and fireworks.

Attendance: 1,700 Budget: \$37,000 HRM Request: \$5,000

Proposed HRM Funding: \$2,775

#### 2. Cole Harbour Harvest Festival

Organization: Cole Harbour Harvest Festival Society

When: September 12, 2015

Where: In and around Cole Harbour Place

**Program Description:** A free event to celebrate the Cole Harbour community including a music concert with local bands, and children's entertainment that includes face painting, art, culture, healthy living and food displays. Sports events include a skateboard competition and a free skate, a Farmer's

Market, street parade and fireworks show.

**Attendance:** 5,000 **Budget:** \$28,250 **HRM Request:** \$22,000

**Proposed HRM Funding:** \$2,775

#### 3. Fall River Canal Days

Organization: Fall River Canal Days Society

When: July 1, 2015

Where: Gordon R. Snow Community Centre, Fall River

**Program Description**: A free event open to the public celebrating the community of Fall River on Canada Day including community breakfasts, road parade, a flag ceremony, children's activities and

fireworks.

**Attendance:** 3,137 **Budget:** \$28,000 **HRM Request:** \$5,000

Proposed HRM Funding: \$2,775

#### 4. Lake and Shore Days

Organization: Porter's Lake Community Services Association

When: August 3 - 9, 2015

Where: Porter's Lake Community Centre

Program Description: Events for all age groups that are a combination of free/low-cost including

youth and teen dances, special bingo, teddy bear picnic and children's fair and local adult

entertainment. There will also be a Grand street parade, parade of lights on Porter's Lake and grand

finale fireworks show. *Attendance:* 2,500 people

**Budget**: \$31,545 **HRM Request:** \$5,000

Proposed HRM Funding: \$2,775

#### 5. North Preston Day

Organization: Women with a Vision

When: August 7 - 9, 2015

Where: 44 Simmonds Road, North Preston

**Program Description:** Combination of both public access and community rental - summer carnival involving other community organizations, parade, BBQ, talent shows, marching bands, and

entertainment for youth, adults and seniors.

Attendance: 1,000 Budget: \$18,650 HRM Request: \$5,000

**Proposed HRM Funding:** \$2,775

#### 6. Peggy's Cove Area Festival of the Arts

Organization: Peggy's Cove Area Festival of the Arts

When: July 9 19, 2015

Where: HRM communities surrounding Peggy's Cove, from Prospect Road to East River

**Program Description:** Festival featuring live music, refreshments, a silent auction of art and craft works, demos by artists and artisans creating works in a variety of media and a 'Community Canvas' created by attendees. There is also *Paint Peggy's Cove & Beyond*, a four day painting event where 35 artists from across the Maritimes interact with visitors as they paint outdoors in Peggy's Cove and Hubbards. There's also an arts fair and the final event is a studio tour involving over 60 artists in their studios.

**Attendance:** 5,000 **Budget**: \$38,600 **HRM Request:** \$5,000

Proposed HRM Funding: \$2,775

#### 7. Sambro Sou' Wester Days 2015

Organization: Sambro & Area Community Association

When: August 7 - 9, 2015

Where: St. James Memorial Ball Field; parking lot off of the Harrietsfield-Sambro Fire Station, Crystal

Crescent beach, Sambro Island light house and community wharf

**Program Description:** This event has a range of activities that are both free and gated. Included in the gated events are a children's carnival, a washer toss tournament, and a community adult dance. The beer garden/tailgate party is free but alcohol must be purchased. There is a fee to join the ball team in tournament but no cost to watch the game. There are also free self-guided historical walking tours, the blessing of the fleet, a local talent/ceilidh, a community parade and the closing fireworks.

**Attendance:** 2,000 **Budget:** \$35,000 **HRM Request:** \$3,500

Proposed HRM Funding: \$2,775

#### 8. Seaside Harvest Festival

**Organization:** Seaside Harvest Festival **When:** September 25 & 26, 2015

Where: Tallahassee Community Recreation Centre

**Program Description:** This two (2) day festival is free and includes live music, children's

entertainment and crafts, and art expos. All of the activities are intended to bring people together to

celebrate the community while enjoying local culture.

Attendance: 5,000 Budget: \$12,000 HRM Request: \$10,000

Proposed HRM Funding: \$2,775

#### 9. Tallahassee Days

Organization: Fisherman's Cove Development Association

When: August 21 - 23, 2015

Where: Fisherman's Cove in Eastern Passage

Program Description: A program of free events include the Sea of Lights boat parade, live music,

treasure hunts, live mermaids, free food/drinks and marine ecology education sessions.

**Attendance:** 4,000 **Budget:** \$10,111

**HRM Request:** \$10,000

**Proposed HRM Funding**: \$2,775
