The Approved 2005/06 Capital Budget - Capital Account No. CB300551
The Approved Advanced 2006/07 Capital Budget - Capital Account No. CB300864

RECOMMENDATION

IT IS RECOMMENDED THAT COUNCIL award Tender No: 06-042 Spryfield Wave Pool Dehumidification to Western Plumbing and Heating for materials and services specified, for a total tender price of \$248,214 including net HST, with funding in the amount of \$195,424 from Capital Account No.CB300864 and \$52,790 from Capital Account No. CB300551, as per the Budget Implications section of this report.

BACKGROUND

The Captain William Spry Centre is a wave generating swimming pool. Swimming pools generate high humidity levels from the evaporation of pool water and a wave pool is a level of magnitude higher (in humidity generation) than a standard 25 metre pool.

The original dehumidification equipment was installed in 1985. The units failed two years ago and a replacement unit was required. These dehumidification units serve two main functions, client comfort and corrosion prevention. HRM engaged a consultant to determine the best approach to humidity control and a two year project was started in the 05/06 capital year. This consisted of mechanical work required in preparation of installing a dehumidification unit.

Dehumidification at the Spryfield Wave Pool will be performed using a dilution method, by installing an energy efficient heat recovery system with variable speed drives which will vary based on the Pool's relative humidity. Special construction products for this project were considered in order to ensure the product will withstand the harsh pool environment. A life cycle cost analysis was performed determining the most economical solution based on energy cost, life equipment cycle, and functionality.

DISCUSSION

Tenders were publicly advertised on March 18, 2006 and March 22, 2006 and closed on April 29, 2006. Bids were received from the following bidders:

BUDGET IMPLICATIONS

Based on the lowest tendered price of \$248,214, including net HST, funding is available from Capital Account No.CB300864 in the amount of \$195,424 and Capital Account No.CB300551 in the amount of \$52,790. The budget availability has been confirmed by Financial Services.
