### **ORIGIN**

The change in structure of the Taxi and Limousine Committee requires a minor change to the Appeals Committee By-Law.

## **RECOMMENDATION**

It is recommended that Halifax Regional Council approve in principle the amendments to By-Law A-100, the Appeals Committee By-Law attached as Appendix "A" to this report and direct staff to arrange for their formal adoption.

#### **BACKGROUND/DISCUSSION**

Section 3(2) of By-Law A-100, the Appeals Committee By-Law, provides:

3 (2) The Committee shall consist of five Councillors who shall be appointed by Council and shall include the two Councillors appointed from time to time by Council to the Taxi and Limousine Committee.

Since the new Taxi and Limousine Advisory Committee no longer has members of Council on the Committee, it is necessary to eliminate the reference in By-Law A-100 providing that "two Councillors appointed from time to time by Council to the Taxi and Limousine Committee". By-Law A-101 attached as Appendix "A" to this report, if adopted, would accomplish this change such that on a go forward basis the Appeals Committee would have five Councillor member at large.

# A By-Law To Amend The Appeals Committee By-Law

**BE IT ENACTED** by the Council of the Halifax Regional Municipality under the authority of the *Municipal Government Act* as follows:

1. Subsection (2) of Section 3 of By-Law A-100, the Appeals Committee By-Law is amended by deleting the words "and shall include the two Councillors appointed from time to time by Council to the Taxi and Limousine Committee".
