SUBJECT: Celebration of 10 Years of HRM Amalgamation

INFORMATION REPORT

ORIGIN

At the November 24, 2005 meeting of North West Community Council, during the Public Participation session a brief discussion was held regarding the 10th anniversary of HRM in April 2006. The Councillors questioned whether there were any official corporate celebrations planned for the event.

BACKGROUND

On April 1, 1996 the former City of Halifax, City of Dartmouth, Town of Bedford and County of Halifax joined to create the Halifax Regional Municipality. At that time, a small celebration was held to celebrate the creation of the new municipality, including a bus tour with newly elected Council members to various locations within the Halifax Regional Municipality. Ten years has passed since amalgamation and April 1, 2006 will represent a full decade since the union of the four municipal units.

DISCUSSION

In response to interest in developing a program to celebrate and recognize the 10th anniversary of HRM amalgamation, Recreation, Tourism and Culture staff have began discussions with the Halifax-Dartmouth Natal Day Steering Committee. The purpose of this dialogue is gauge the interest of the committee in delivering the anniversary celebration in conjunction with the 2006 Natal Day Festival.

The Halifax-Dartmouth Natal Day Steering Committee has and continues to organize and deliver the "Municipal Birthday Celebration" on the five days leading up to the first Monday in August within the Halifax Regional Municipality. Since 1997, the Natal Day Committee has been a combined group representing the communities of Halifax and Dartmouth, but has within its Terms of Reference the mandate to organize the event for the enjoyment of all the citizens within the Halifax Regional Municipality. The committee is currently composed of 21 HRM citizens representing an array of diverse individuals living in a variety of geographic regions throughout the municipality.

As well as celebrating significant historical Natal Day events such as the Natal Day Parade(s), Children's Day, BridgeWalk, and the Natal Day Road Race the Halifax-Dartmouth Natal Day Steering Committee has worked successfully with other event partners over the last two years, including Tall Ships 2004 and the 50th Anniversary of the Macdonald Bridge in 2005. This recent experience of combining other significant events with the Natal Day program has proven to be quite successful.

Staff will continue to explore the option of combining the anniversary celebration in conjunction with the Natal Day Festival and report back to Council with specific plans and budget figures when finalized. In addition, HRM will conduct a communications and marketing campaign in late March or early April 2006 to inform the public of the anniversary and plans for celebrating the occasion and achievements over the last ten years.

BUDGET IMPLICATIONS

There are no direct budget implications as a result of the material discussed herein. However, upon identification of the funding required to deliver the program, a request will be included in the Special Event Reserve budget for Council consideration during the budget deliberations for the 2006/07 fiscal year.
