INFORMATION REPORT

ORIGIN

Halifax Regional Council meeting of June 13, 2006, Item 8.2.

BACKGROUND

At the June 13, 2006 Halifax Regional Council meeting, Councillor Adams served a petition from residents requesting Duncans Cove Road be paved and that staff provide information from a previous request in 1991 to have Duncans Cove Road paved by the Province and the former County of Halifax.

DISCUSSION

Staff has completed a search regarding the paving petition submitted by MLA Robert Chisholm. This petition was tabled at the Legislative Assembly on November 2, 1993 (refer to attachment). At the Halifax County Council Session dated November 2, 1993, Councillor Ball moved that a letter be written to the Department of Transportation and Communication requesting the paving of Duncans Cove Road (refer to attachment). After extensive review staff was unable to locate or confirm that this letter was written. No additional documents regarding this issue were found.

The Nova Scotia Department of Transportation and Public Works (NST&PW) has classified Duncans Cove Road as an "H" Class road from Chebucto Head Road for a distance of 374 metres. The remaining portion of this road is privately owned. At this time, NST&PW do not include "H" class roads in the paving program. To date, streets eligible for paving under the current Aid to Municipalities cost sharing program must be classified as "J" class roads.

Prior to amalgamation, the paving of gravel subdivision roads was initiated under the Suburban Paving Program. This was a cost sharing program between Halifax County and Department of Transportation pursuant to the Municipality's Street Improvement By-Law. Halifax County would recover their portion through a local improvement charge to the property owners. County staff would petition the property owners and if successful would then notify the Province of the results. The petition was valid for two years from date of filing. The Department of Transportation would notify Halifax County as to which streets were approved for paving.

There are no budget implications at this time.


