Award of Unit Price Tender No. 05-214, New Sidewalk and

Resurfacing, Rocky Hill Road and Wren Street - West Region

ORIGIN

The Approved 2003/04 and 2005/06 Capital Budget.

RECOMMENDATIONS:

It is recommended that Council:

- 1. approve an increase in the Gross Budget for Capital Account No. CZU00719, Resurfacing by \$6,000 to reflect cost sharing of the water main related work on Wren Street with no change in the Net Budget.
- 2. approve the recovery of Local Improvement Charges for the new concrete sidewalk and new concrete curb and gutter on Rocky Hill Road and Wren Street, West Region, by an amount of \$59,834 to be applied to an area rate of a portion of District 16, as shown on the attached sketch.

3. award Tender No. 05-214, New Sidewalk and Resurfacing Rocky Hill Road and Wren Street - West Region to Ocean Contractors Limited for materials and services listed at the unit prices quoted for a Tender Price of \$336,220 plus net HST for a total cost of \$347,749 from Capital Accounts Numbers CJU00719, New Sidewalks, CZR00357 Resurfacing, CZU00717 Resurfacing and CUG00461, Sewer Laterals Replacement, with funding authorized as per the Budget Implications Section of this report.

BACKGROUND

The Approved 2003/04 and 2005/06 Capital Budgets included funds for the New Sidewalk and Resurfacing of Rocky Hill Road from Tremont Drive to Forest Hill Drive and Wren Street from Forest Hill Drive to Pioneer Avenue.

DISCUSSION

Tenders were called on May 28, 2005 and closed on June 10, 2005. The following bids, exclusive of taxes, were received:

The scope of work for this tender generally consists of new concrete sidewalk and new concrete curb and gutter, removal of the existing asphalt, installation of new asphalt, and associated reinstatement.

It is anticipated that work will commence within two weeks of the tender award.

This is a **UNIT PRICE** contract and the cost will be dependent upon the actual quantities measured and approved by the HRM Project Manager.

The installation of concrete curb and gutter and concrete sidewalk is subject to Local Improvement Charges (LIC's). As requested by Councillor Hum, the recovery of LIC's is to be by way of area rate for a portion of District 16, as shown on attached sketch. The total LIC for Rocky Hill Road is \$19,051.20 for concrete curb and gutter and \$14,307.30 for concrete sidewalk. The total LIC for Wren Street is \$15,120.00 for concrete curb and gutter and \$11,355.00 for concrete sidewalks.

BUDGET IMPLICATIONS

Based on the lowest tendered price of \$336,220, plus net HST for a total project cost of \$347,749, funding for this total tender cost is available in the Approved 2003/04 Capital Budget from Account No. CZR00357 and the Approved 2005/06 Capital Budget from Account Numbers CJU00719 New Sidewalk and CZR00717 Resurfacing. The availability has been confirmed by Financial Services.


