<u>ORIGIN</u>

The Approved 2005/06 Capital Budget.

RECOMMENDATION

It is recommended that Council award Tender No.05-268, Micro Paving - Local Streets, Halifax Regional Municipality to Industrial Cold Milling for materials and services listed at the unit prices quoted for a Tender Price of \$778,572 including net HST from Capital Account No. CZU00717, Resurfacing, with funding authorized as per the Budget Implications Section of this report.

BACKGROUND

The Approved 2005/2006 Capital Budget includes funds for a paving resurfacing program that will significantly improve the level of service to the public.

DISCUSSION

Tenders were called on May 18, 2005 and closed on May 25, 2005. The following bid, exclusive of taxes, was received:

Bid Price \$752,760.00

The scope of work for this tender includes Micro Paving on streets selected under the Capital Works Program.

All unit price extensions have been checked and found to be correct. Although this is a single tender submission, the following should be noted:

- 1. This was a publicly advertised tender, and tender documents were taken out by three companies.
- 2. Industrial Cold Milling is experienced in the micro paving process and has carried out surface sealing programs for HRM based on previous single-bid submissions.
- 3. The unit prices tendered for the work are considered reasonable and, in general, are only slightly higher than the previous unit price bid submission for this type of work in 2004.

It is anticipated that work will commence within three weeks of the tender award.

This is a **UNIT PRICE** contract and the cost will be dependent upon the actual quantities measured and approved by the HRM Project Manager.

There are no Local Improvement Charges associated with this work.

The list of streets to be micro paved is attached.

BUDGET IMPLICATIONS

Based on the lowest tendered price of \$752,760, plus net HST for a total project cost of \$778,572, funding is available in the Approved 2005/06 Capital Budget from Account No. CZU00717, Resurfacing. The budget availability has been confirmed by Financial Services.
