#### **ORIGIN**

The Approved 2005/06 Capital Budget.

### **RECOMMENDATION**

It is recommended that Council award Tender No. 05-291, Resurfacing, Atlantic Street - West Region to Ocean Contractors Limited for materials and services listed at the unit prices quoted for a Tender Price of \$199,887 including net HST from Capital Account No. CZU00717, Resurfacing, with funding authorized as per the Budget Implications Section of this report.

### **BACKGROUND**

The Approved 2005/06 Capital Budget included funds for the Resurfacing of Atlantic Street from South Bland Street to Young Avenue.

#### **DISCUSSION**

Tenders were called on September 3, 2005 and closed on September 14, 2005. The following bids, exclusive of taxes, were received:

1.	Ocean Contractors Limited	\$193,260.00
2.	Lafarge Canada Inc.	\$195,000.00
3.	Dexter Construction Company Limited	\$236,540.00
4.	Basin Contracting Limited	\$298,400.00

The scope of work for this tender generally consists of resurfacing, adjustment of manholes, catchbasins, water valves, some curb and gutter replacement as well as sidewalk renewals on the north side from Young Avenue to McLean Street and Brussels Street to South Bland Street.

It is anticipated that construction will commence within one week of the tender award and take four weeks to complete.

This is a **UNIT PRICE** contract and the cost will be dependent upon the actual quantities measured and approved by the HRM Project Manager.

There are no Local Improvement Charges associated with this work.

#### **BUDGET IMPLICATIONS**

Based on the lowest tendered price of \$193,260, plus net HST for a total project cost of \$199,887, funding is available in the Approved 2005/06 Capital Budget from Account No. CZU00717, Resurfacing. The budget availability has been confirmed by Financial Services.
