### **ORIGIN**

The Approved Advanced 2006/07 Capital Budget.

### **RECOMMENDATION**

It is recommended that Council award Tender No. 06-205, Traffic Signal Installation, Bayers Road at Oxford Street - West Region to Black & McDonald Limited for materials and services listed at the unit prices quoted for a Tender Price of \$145,788 including net HST from Capital Account No. CTU00561, Traffic Signal Installation, with funding authorized as per the Budget Implications section of this report.

# **BACKGROUND**

The Approved Advanced 2006/07 Capital Budget includes funds for the installation of new traffic signals within the municipality. The intersection of Bayers Road at Oxford Street meets or exceeds the warrants for signalization.

## **DISCUSSION**

Tenders for this project were called on December 10, 2005 and closed on January 18, 2006. The following bids, exclusive of taxes, were received:

1.	Black & McDonald Limited	\$140,954.00
2.	XL Electric Limited	\$172,167.56

The scope of work for this tender generally consists of the installation of poles, signals, wiring, detector loops, Opticom Detectors and all necessary appurtenances to complete the project. HRM is to supply and install the controller.

It is anticipated that work will commence when weather permits in the spring of 2006 and take 5 weeks to complete.

This is a **UNIT PRICE** contract and the cost will be dependent upon the actual quantities measured and approved by the HRM Project Manager.

There are no Local Improvement Charges associated with this work.

### **BUDGET IMPLICATIONS**

Based on the lowest tendered price of \$140,954.00, plus net HST, for a total project cost of \$145,788, funding is available in the Approved Advanced 2006/07 Capital Budget from Account No. CTU00561, Traffic Signal Installation. The budget availability has been approved by Financial Services.
