In response to Councillor Smith as to whether or not the motion was contrary to the public hearing, Ms. Mary Ellen Donovan, Municipal Solicitor, advised the essence of the motion was to essentially not to forward the proposals that are in the draft By-Law that was put forward to the community's consideration and that is certainly well within the purview of Council to decide in the process.

MOVED by Councillor Adams, seconded by Councillor Sloane, that the question now be put. MOTION DEFEATED (9 in favour, 11 against)

Those voting against were Councillors Snow, Hendsbee, McCluskey, Younger, Karsten, Smith, Wile, Fougere, Walker, Mosher and Johns.

Councillors Streatch, McInroy, Kent and Martin were absent.

In response to a point of clarification by Councillor Karsten and in response to Mayor Kelly, Councillor Sloane stated her motion was in reference to the proposed By-Law A-300.

At the request of Mayor Kelly, the Municipal Clerk restated the motion as put forward by Councillor Sloane.

In response to Councillor Murphy, staff advised the proposal did not include a spay and neuter program.

Council recessed at 7:25 p.m. Council reconvened at 7:40 p.m.
