INFORMATION REPORT

ORIGIN

At the Regional Council Meeting of July 17, 2001 (Item No. 9.1), Council approved the adoption of By-Law W-101 respecting the Discharge of Wastewater into Public Sewers. During the discussion of the by-law, Councillor Hetherington requested that quarterly reports be prepared for Council regarding the Pollution Prevention (P2) Program.

BACKGROUND

This report is the second quarterly report regarding the P2 Program.

DISCUSSION

Activities for this reporting period have focussed on the preparation of a tracking system to permit effective case management. Information such as business name, ownership, location, and details regarding correspondence, by-law notification, sampling, inspection and enforcement details are being compiled. Currently, 2511 of the estimated 5000 businesses in HRM have been recorded.

Also, educational and promotional information related to the P2 Program for Residential and Industrial-Commercial-Institutional (ICI) sectors has been provided through the following:

- 1. HRM's Naturally Green publication
- 2. Burnside Business News
- 3. Presentation to 40 representatives of the Canadian Petroleum Products Institute
- 4. Presentation to 60 representatives of the Nova Scotia Institute of Environmental Industries

Staff have additionally responded to numerous telephone inquiries regarding the P2 Program. Response by telephone has provided the owners, operators or managers of businesses in HRM with direct information regarding By-Law W-101. A record will be kept and reported of all future direct telephone contacts regarding the P2 Program.

As a result of the presentation to the Canadian Petroleum Products Institute, a cooperative approach to providing information regarding pollution prevention has been developed. The CPPI represents an estimated 350 retailers, distributers and manufacturers of petroleum related products within Halifax Regional Municipality. Cooperatively, best management plans are being developed to assist auto repair shops, undercoating businesses, gas stations and other related business activities with appropriate pollution prevention information to assist each location in complying with the provisions of By-Law W-101.
