SUBJECT:

Harbour Solutions Financing Act

ORIGIN:

On March 26, 2002, Halifax Regional Council approved a motion directing staff to arrange for the introduction of a Bill before the Nova Scotia Legislature in its Spring sitting to permit the Halifax Regional Municipality to finance the Harbour Solutions Project through sources other than the Municipal Finance Corporation.

RECOMMENDATION

It is recommended that Halifax Regional Council approve the form of the Bill attached as Appendix "A" to this report.

BACKGROUND/DISCUSSION

The draft bill approved by Council at the March 26, 2002 Council meeting was forwarded to the Legislature and the final form of the Bill was drafted. It is attached as Appendix "A" to this report. The Bill is now ready to be introduced into the Legislature. The procedure of the House of Assembly requires a formal resolution of Regional Council approving the form of the Bill.

BUDGET IMPLICATIONS

The Bill, if adopted by the Legislature will give the HRM greater flexibility to seeking financing options for the project.

An Act to Provide for the Financing of the Halifax Harbour Solutions Project by the Halifax Regional Municipality

Be it enacted by the Governor and Assembly as follows:

- 1 This Act may be cited as the Halifax Regional Municipality Harbour Solution Financing Act.
- 2 $\,$ In this Act, "municipality" has the same meaning as in the $\it Municipal$ $\it Finance Corporation Act.$
- 3 Notwithstanding subsection 91(2) of the *Municipal Government Act* and subsection 16(1) of the *Municipal Finance Corporation Act*, the Halifax Regional Municipality may, for the sole purpose of financing the Halifax Harbour Solutions Project, borrow money by the issue and sale of debentures to persons other than the Municipal Finance Corporation, the Government of Canada, the Province or another municipality, or any department, agency or fund thereof.
