## **RECOMMENDATION**

It is recommended that Council award Tender No. 02-201, RA-5 Overhead Crosswalk Lights - West Region to Black & McDonald Limited for materials and services listed at the unit prices quoted for a Tender Price of \$ 95,105., plus net HST from Capital Account CTR00420, RA-5 Replacement, with funding authorized as per the Budget Implications section of this report.

## **BACKGROUND**

The 2002/03 Approved Capital Budget includes the installation of RA-5 Overhead Crosswalk Lights at various busy crosswalk locations for pedestrian safety.

#### **DISCUSSION**

Tenders for this project were called on April 6, 2002 and closed on April 19, 2002. The following bids, exclusive of taxes, were received:

## **Bid Price**

1.	Black & McDonald Limited	\$ 95,105.00
2.	XL Electric Limited	\$124,410.25

The scope of work for this tender is the installation of RA-5 Crosswalk lights at the following locations:

- 1. Spring Garden Road at Grafton Street
- 2. Queen Street at Clyde Street
- 3. Coburg Road at Henry Street
- 4. Coburg Road at Seymour Street
- 5. Coburg Road at LeMarchant Street
- 6. Jubilee Road at Preston Street
- 7. Jubilee Road at Vernon Street
- 8. Watt Street at Vernon Street
- 9. Dutch Village Road at Craigmore Drive

This is a **UNIT PRICE** contract and the cost will be dependent upon the actual quantities measured and approved by the HRM Project Manager.

Since this project falls outside the Local Improvement Policy, charges do not apply.

## **BUDGET IMPLICATIONS**

Based on the lowest tendered price of \$ 95,105. plus net HST, for a total of \$101,220., funding is available in the 2002/03 Approved Capital Budget under Capital Account No. CTR00420, RA-5 Replacement . The budget availability has been approved by Financial Services.
