ORIGIN

Approved 2002/2003 Capital Budget.

RECOMMENDATION

It is recommended that Council award Tender No. 02-232, Resurfacing - Almon Street and Connaught Avenue - West Region to Dexter Construction Company Limited for materials and services listed at the unit prices quoted for a Tender Price of \$391,200., plus net HST from Capital Account CZR00357, Resurfacing, with funding authorized as outlined in the Budget Implications section of this report.

BID PRICE

BACKGROUND

The 2002/2003 Approved Capital Budget includes funds for a paving resurfacing program that will significantly improve the level of service to the public.

DISCUSSION

Tenders were called on March 27, 2002 and closed on April 12, 2002. The following bids, exclusive of taxes, were received:

1.	Dexter Construction Company Limited	\$ 391,200.00
2.	Lafarge Canada Inc.	\$ 448,968.25
3.	Ocean Contractors Limited	\$ 457,590.00
4.	Basin Contracting Limited	\$ 623,621.00

The scope of work for this tender includes milling and resurfacing of the existing asphalt pavement, some concrete curb and gutter and concrete sidewalk works on Almon Street from Oxford Street to Dublin Street, and on Connaught Avenue (East side of blvd.) from Roslyn Road to Regent Road. This tender also includes two (2) spot repairs to the combined sewer on Almon Street.

This is a unit price contract and the cost will be dependent upon the actual quantities measured and approved by the HRM Project Manager.

Since this project falls outside the Local Improvement Policy, charges do not apply.

BUDGET IMPLICATIONS

Based on the lowest tendered price of \$391,200. plus net HST for a total of \$416,351. funding for this tender is available in the 2002/2003 Approved Capital Budget under Capital Account Number CZR00357 - Resurfacing. The budget availability has been approved by Financial Services.
