ORIGIN

Approved 2002/03 Capital Budget.

RECOMMENDATION

It is recommended that Council award Tender No. 02-229, Paving Renewal and Resurfacing - West Region to Ocean Contractors Limited for materials and services listed at the unit prices quoted for a Tender Price of \$429,050., plus net HST for a total of \$456,634. with funding from Capital Account Nos. CYR00991, Paving Renewal Program and CZR00357, Resurfacing with funding authorized as per the Budget Implications section of this report.

BACKGROUND

The 2001/2002 Approved Capital Budget includes funds for the renewal of streets and resurfacing of streets within Halifax Regional Municipality for the purpose of extending the life of the road structure and to reduce maintenance costs and significantly improve the level of service to the public.

DISCUSSION

Tenders for this project were called on April 13, 2002 and closed on April 30, 2002. The following bids, exclusive of taxes, were received:

The scope of work for this project includes street reconstruction including some curb & gutter replacement on both sides of Hazelholme Drive in Halifax from Clayton Park Drive West to Northcliffe Lane. This project also includes the resurfacing of the Armdale Rotary, Barrington Street from South Street to Green Street and Cornwallis Street from Gottingen Street to Maitland Street.

It is anticipated that construction will commence within four weeks after the award of tender.

This is a **UNIT PRICE** contract and the cost will be dependent upon the actual quantities measured and approved by the HRM Project Manager.

There are no Local Improvement Charges associated with this work.

BUDGET IMPLICATIONS

Based on the lowest tendered price of \$429,050. from Ocean Contractors Limited, plus net HST for a total of \$456,634., funding is available in the 2001/02 Approved Capital Budget under Capital Account Nos. CYR00991, Paving Renewal Program and CZR00357, Resurfacing. The budget availability has been approved by Financial Services.
