ORIGIN

Approved 2002/03 Capital Budget.

RECOMMENDATION

It is recommended that Council award Tender No. 02-240, Sidewalk Renewals - West Region to Ocean Contractors Limited for materials and services listed at the unit prices quoted for a Tender price of \$120,860.00 plus net HST for a total of \$128,631. from Capital Account CKU00141, Sidewalk Renewals, with finding authorized as per the Budget Implications section of this report.

BACKGROUND

The 2002/03 Approved Capital Budget includes the replacement of concrete sidewalks because of their overall poor condition.

DISCUSSION

Tenders for this project were called on April 27, 2002 and closed on May 9, 2002. The following bids, exclusive of taxes, were received:

The scope of work for this tender includes the renewal of concrete sidewalk, concrete curb and gutter and sodding at the locations listed below:

- Isleville Street (E) Stairs Street to Stanley Street
- May street (N) Fern Street to Robie Street
- Drummond Court (N) Leaman Street to Leaman Street
- Bloomfield Street (N) Gottingen Street to Isleville Street
- Young Street (S) Albert Street to Devonshire Avenue

It is anticipated that work will commence within two weeks after award of tender.

This is a **UNIT PRICE** contract and the cost will be dependent upon the actual quantities measured and approved by the HRM Project Manager.

There are no Local Improvement Charges associated with this work.

BUDGET IMPLICATIONS

Based on the lowest tendered price of \$120,860.00 plus net HST for a total of \$128,631., funding is available in the 2002/03 Approved Capital Budget under Capital Account No. CKU00141 - Sidewalk Renewals. The budget availability has been approved by Financial Services.

The remaining funds from this account are required to implement the remaining 2002/03 sidewalk renewal locations approved by Council.
