### **ORIGIN**

Approved 2002/03 Roads and Streets Capital Budget.

## RECOMMENDATIONS

It is recommended that Halifax Regional Council:

- 1. approve the recovery of Local Improvement Charges for the replacement of asphalt curb with concrete curb and gutter on Dickey Drive in the amount of \$18,330. to be applied to the general area rate of District 20.
- award Tender No. 02-244, Dickey Drive (Magee Drive Zinck Avenue), Paving Resurfacing - Central Region to Basin Contracting Limited for materials and services listed at the unit prices quoted for a Tender Price of \$443,300., plus net HST for a total of \$471,799.75 from Capital Account No. CZR00357, Resurfacing, with funding authorized as per the Budget Implications section of this report.

#### BACKGROUND

The 2002/03 Approved Capital Budget includes funds for a paving resurfacing program that will significantly improve the level of service to the public.

#### **DISCUSSION**

Tenders were called on April 17, 2002 and closed on May 2, 2002. The following bids, exclusive of taxes, were received:

The scope of work for this tender includes milling and resurfacing of the existing asphalt pavement and replacement of asphalt curb with concrete curb and gutter on Dickey Drive between Magee Drive and Zinck Avenue.

It is anticipated that work will commence within four weeks of the tender award.

This is the **UNIT PRICE** contract and the cost will be dependent upon the actual quantities measured and approved by the HRM Project Manager.

The replacement of asphalt curb with concrete curb and gutter is subject to Local Improvement Charges. As requested by Councillor Bob Harvey, Local Improvement Charges of \$18,330., based on the 2002/03 rate of \$12.22 per foot of frontage, will be recovered by a general area rate of District 20.
