SUBJECT: Award of Unit Price Tender No. 02-289, Park and Ride Lot -

Cobequid Road - Central Region

ORIGIN

Approved 2001/02 Capital Budget.

RECOMMENDATION

It is recommended that Council award Tender No. 02-289, Park and Ride Lot - Cobequid Road - Central Region to Sackville Trenching for materials and services listed at the unit prices quoted for a Tender Price of \$54,720, plus net HST for a total of \$58,238 from Account No. CBQ00002, Park and Ride Lots, with funding authorized as per the Budget Implications section of this report.

BACKGROUND

The 2001/02 Approved Capital Budget includes funds for the paving of gravel park and ride lots within the Municipality to reduce maintenance and increase parking capacity.

DISCUSSION

Tenders were called on August 10, 2002 and closed on August 23, 2002. The following bids, exclusive of taxes, were received:

The scope of work for this tender includes paving of the Metro Transit Cobequid Park and Ride Lot used by Metro Transit patrons. The work generally consists of the placement of gravels, grading, placement of asphalt pavement and painting of parking stalls.

It is anticipated that work will commence within three weeks of the tender award.

This is a **UNIT PRICE** contract and the cost will be dependent upon the actual quantities measured and approved by the HRM Project Manager.

There are no Local Improvement Charges associated with this work.

BUDGET IMPLICATIONS

Based on the lowest tendered price of \$54,720, plus net HST for a total of \$58,238, funding is available in the 2001/02 Approved Capital Budget under Account No. CBQ00002, Park and Ride Lots. The budget availability has been approved by Financial Services.
