A tender for this project was advertised and closed on Thursday July 25, 2002. Two bids were received.

Parks & Recreation Services, Park Planning and Development recommend that the tender be awarded to Turf Masters Landscaping Ltd., the lowest bidder, for the tender price of \$55,947.34, plus net HST taxes, for a total project cost of \$59,544.19.
