### **ORIGIN**

Halifax Regional Council, May 21, 2002, item 9.2.5.

### **BACKGROUND**

Councillor Hines served a petition from residents of Richard and Hescott Streets in Elmsdale demanding the following: proper maintenance and upgrading of both streets, posted speed limit signs, posted "caution children playing" signs and paving of both roads.

### **DISCUSSION**

Staff response to the issues raised are as follows:

### Maintenance and paving

The sections of both Hescott Street and Richards Street between Old Post Road and Nathan Street, and Nathan Street are owned by the Province and maintained by the Nova Scotia Department of Transportation and Public Works (NSTPW). The remaining sections of Hescott Street and Richards Street are owned and maintained by HRM.

All streets in this subdivision are gravel roads which require grading on a regular basis. Staff of HRM Streets and Roads has inspected the sections of streets that HRM is responsible for and has indicated that they are in reasonably good condition at this time. Staff has contacted the Province to make them aware of the concerns of residents regarding street maintenance and dust control (see attached).

In 1999 the streets owned by the Province were petitioned for paving under the Municipal Aid Program at a cost to homeowners of \$17.00 per foot. This petition failed, and the streets have not been repetitioned since. The street sections owned and maintained by HRM are the newest streets in the subdivision and have not been petitioned for paving.

## **Posted Speed Limit Signs**

NSTPW has been contacted and provided a response regarding the approval of speed limit signs (see attached).

# **Children Playing Signs**

Children Playing Signs are not used in HRM. Children live on nearly every residential street and this should be an expectation of all drivers. Experience has shown that attempts to warn motorists of obvious conditions have little benefit. Warning signs are most effective when used sparingly to advise motorists of unusual or unexpected conditions ahead. National standards do not support the use of these signs because they suggest it's okay for children to play on or near the street. This is not something Traffic Services wants to encourage parents and children to believe in.
