

SUBJECT: Schedule of Meetings: Tax Structure and C&D Public Hearings

ORIGIN

The issue was raised of conflicting dates for public sessions regarding Tax Structure and the C&D Public hearings. Councillor Walker asked staff to prepare a report clarifying all the proposed meetings date for the August 27th meeting.

RECOMMENDATION

It is recommended that Council approve the schedule of meetings provided in Attachment A.

DISCUSSION

The Clerk's office, the Councillors' office, Planning and Development and Finance met with the Chair of the Tax Structure Committee to review meeting requirements and possible dates. Community Council meetings and Committee meetings were identified and possible conflicts examined. Attachment A represents the best dates available to accommodate the requirements of Tax Structure and C&D public hearings. In some instances there are committee meetings scheduled at the same time as some of the Tax Structure meetings, but care was taken to ensure the Councillors of interest in the particular Tax Structure meeting would not be required at the committee meeting.

BUDGET IMPLICATIONS

There are financial implications in terms of advertising costs in changing dates. These will be absorbed in existing budgets.
