Rewards for Major Unsolved Crimes

INFORMATION REPORT

<u>ORIGIN</u>

At the In-Camera Session of Council on June 18, 2002, during discussion of the Police Study, Councillor Warshick requested staff look at the issue of rewards for major unsolved crimes again as he noted that Ontario has just recently posted a reward in an unsolved murder case.

BACKGROUND/DISCUSSION

At the April 8, 2002 meeting of the Halifax Regional Board of Police Commissioners, an Information Report was submitted which outlined the procedures followed by a number of Canadian police agencies with regard to the offering of rewards for major unsolved crimes.

Staff has determined that the Ontario Provincial Police has not changed its reward system as indicated in Appendix B which was attached to the original Information Report. However, in the particular case mentioned by the Councillor, the crime involved a vicious rape and murder and the OPP was concerned about the offender striking. In addition, the City of Quinte-West has contributed to the reward, thereby, facilitating the reward increase from \$25,000 to \$50,000.
