#### **ORIGIN**

Approved 2002/03 Capital Budget.

### RECOMMENDATIONS

It is recommended that Council:

- 1. approve an increase in the budget of Account No. CRU00231 Other Road Related Works by \$24,605 to cover cost sharing. These funds are to be recovered from the Nova Scotia Department of Transportation and Public Works and the Halifax-Dartmouth Bridge Commission as cost sharing (see attachments).
- 2. award Quotation No. 2002D567, Overhead Sign Structure Replacement, A. Murray MacKay Bridge ramp West Region be awarded to Black & McDonald Limited for materials and services listed at the unit prices quoted for a Quotation Price of \$35,821, plus taxes for a total of \$39,613 from Account No. CRU00231, Other Road Related Works Overhead Sign Structure Repairs, with funding authorized as per the Budget Implications section of this report.

#### BACKGROUND

The 2002/03 Approved Capital Budget includes funds for other related road works. Included in this account are funds for the repair or replacement of overhead sign structures. These structures, over time, require upgrading, repairs etc., because of age related problems or as in this case, accidental vehicular related damage.

### **DISCUSSION**

Quotations were called on December 6, 2002 and closed on December 11, 2002. The following bids, exclusive of taxes, were received:

The scope of work for this tender includes the supply, fabrication, delivery and installation of a monotube overhead sign structure (which was damaged after a vehicle collided with it in September 2002) on existing bases. The age of the structure (approximately 30 years) confirmed that full replacement was the only alternative to be considered.

It is anticipated that work will commence twelve weeks after the tender award due to the delays anticipated in acquiring the necessary equipment from the suppliers.

This is a **UNIT PRICE** contract and the cost will be dependant upon the actual quantities measured and approved by the HRM Project Manager.

There are no Local Improvement Charges associated with this work.

## **BUDGET IMPLICATIONS**

This project is cost shared between HRM, the Nova Scotia Department of Transportation and Public Works and the Halifax-Dartmouth Bridge Commission (see attachments).

Based on the lowest tendered price of \$35,82, plus taxes for a total of \$39,613, funding is available in the 2002/03 Approved Capital Budget under Account No. CRU00231, Other Related Road Works. The budget availability has been approved by Financial Services.

Funding for HRM's share of this project in the amount of \$15,008, is available in the 2002/03 Approved Capital Budget under Account No. CRU00231, Other Road Related Works - Overhead Sign Structure Repairs. This has been confirmed by staff of Finance. The remaining \$24,605 will be funded by the Nova Scotia Department of Transportation and Public Works and the Halifax-Dartmouth Bridge Commission. It is also the intent of HRM to recoup any funds resulting from claims against the insurers of the vehicle involved in this accident causing the replacement of the sign structure, which will then be deposited into Capital Account No.CRU00231, Other Related Road Works.

The remaining funds in this account are required to implement the remaining 2002/03 projects approved by Council.





Please be advised that the Halifax-Dartmouth Bridge Commission is prepared to commit up to \$10,000.00 (or 1/3 of the total cost whichever is less) for the replacement of the sign in Halifax directing motorists on Robie/Windsor Streets to Dartmouth via the MacKay Bridge.

It is understood that HRM will administer the tendering, purchase and reinstallment of the signs and support structure.

We wish to actively seek reimbursement from the owner of the motor vehicle that caused the damage, and would appreciate any assistance you can provide in this regard.

As previously noted the "Dartmouth" sign had symboled "no walking" and "no biking" signs over-layed in the lower corners and we wish to have these restrictive signs included on the new unit.
