### **ORIGIN**

2003/04 Approved Operating Budget.

#### RECOMMENDATIONS

It is recommended that Halifax Regional Council:

- 1. award Tender No. 03-052, Asphalt Patching, West Region, to Basin Contracting Ltd. for materials and services listed at the unit prices quoted for a Tender Price of \$245,500, plus net HST for a total of \$261,283 from Operating Account R731-6399, Patching, Contract Services, with funding authorized as per the Budget Implications section of this report.
- 2. award Tender No. 03-051, Asphalt Patching, East Region, to Ocean Contractors Ltd. for materials and services listed at the unit prices quoted for a Tender Price of \$169,500 plus net HST for a total of \$180,397 from Operating Account R731-6399, Patching, Contract Services with funding authorized as per the Budget Implications section of this report.
- award Tender No. 03-053, Asphalt Patching, Central Region, to Dexter Construction Ltd. for materials and services listed at the unit prices quoted for a Tender Price of \$208,900 plus net HST for a total of \$222,330 from Operating Account R731-6399, Patching, Contract Services with funding authorized as per the Budget Implications section of this report.

## **BACKGROUND**

The approved 2003/04 Operating Budget includes funds for patching of HRM streets within the Urban Core Boundary of the Halifax Regional Municipality.

## **DISCUSSION**

Tenders were called on May 3, 2003, and closed on May 22, 2003. The following bids, exclusive of taxes, were received:

These tenders include the asphalt patching by hand, by spreader and by cut and patch, of existing HRM streets and roadways within the Urban Core Boundary. The patching work is demand in nature and the overall amount of work exceeds with in-house resources. The tenders used estimated quantities to establish **UNIT PRICES** and will enable staff to maximize the units completed within the approved budget allotment.

It is anticipated that work will commence within three weeks of the tender award and continue for a period of approximately eight weeks.

This is a **UNIT PRICE** contract and the cost will be dependent upon the actual quantities measured and approved by the HRM Project Manager.

There are no Local Improvement Charges associated with this work.

## **BUDGET IMPLICATIONS**

Based on the lowest tendered prices totalling \$623,900, plus net HST for a total of \$664,010, funding is available in the 2003/04 Approved Operating Budget under Operating Account No. R731-6399 Patching - Contract Services. The budget availability has been approved by Financial Services.
