ORIGIN

Approved 2003/04 Capital Budgets

RECOMMENDATIONS:

It is recommended that Regional Council:

- 1. approve the recovery of Local Improvement Charges to be applied to the general area rate of District 21 for the installation of new concrete sidewalk on Rutledge Street by a rate to be established in By-Law S-412 which was presented to Council on June 10, 2003.
- 2. award Tender No. 03-251, Paving and New Sidewalk Rutledge Street to Basin Contracting Limited for materials and services listed at the unit prices quoted for a Tender Price of \$319,720, plus net HST for a total of \$340,275, from Account No. CJR00956, New Sidewalk and Account No. CZR00357, Resurfacing, with funding authorized as per the Budget Implications section of this report

BACKGROUND

The 2003/04 Approved Capital Budget includes funds for the construction of a concrete sidewalk to provide for pedestrian safety and includes funds for the resurfacing of the street and the upgrading of asphalt curb to concrete curb and gutter.

DISCUSSION

Tenders for this project were called on June 7, 2003 and closed on June 18, 2003. The following bids, exclusive of taxes, were received:

1.	Basin Contracting Limited	\$ 319.720.00
2.	Lafarge Canada Inc.	\$ 379,859.00
3.	Dexter Construction Company Limited	\$ 380,220.00
4.	Ocean Contractors Limited	\$ 385,665.00

The scope of work for this tender includes the replacement of the asphalt curb with new concrete curb and gutter, the resurfacing of the street, and the installation of a concrete sidewalk on the west side of Rutledge Street from end (Shoreview Drive) to Frederick Street.

This is a **UNIT PRICE** contract and the cost will be dependent upon the actual quantities measured and approved by the HRM Project Manager.

The installation of new concrete sidewalk is subject to Local Improvement Charges. The proposed By-Law S-412, Respecting Charges for Street Improvements was presented to Council on June 10, 2003, but will not likely be approved until the formal adoption process is finalized in July. Staff is therefore recommending that Council approve this tender with the understanding that the LIC rates that are applied, will be those approved by Council in By-Law S-412. This will allow construction to begin at an earlier date rather than waiting until the By-Law is approved. In the event that By-Law S-412 is not adopted, 2002 rates will apply.

BUDGET IMPLICATIONS

Based on the lowest tendered price of \$319,720 plus net HST, the total cost for this project is \$340,275. Funding is available in Account No. CJR00956, New Sidewalk, and Account No. CZR00357 Resurfacing - Rutledge Street - Paving and New Sidewalk. The budget availability has been approved by Financial Services.
