SUBJECT: Preliminary Financial Impact - Hurricane Juan

INFORMATION REPORT

ORIGIN

Financial Services has committed to provide a report on ongoing basis to keep council informed of the financial impact on HRM as a result of Hurricane Juan as further information becomes available.

BACKGROUND

On September 28, 2003, Hurricane Juan struck HRM causing severe damage to the municipality's infrastructure. In addition to the infrastructure damage the city was faced with significant clean-up in order to re-establish public safety. With over one thousand sites to be assessed, there is still a great deal of work that has not begun, and it is anticipated the work caused by Hurricane Juan will continue for the next 18 months.

To date, a substantial part of the clean-up has been completed, and the infrastructure repairs have begun. In addition, the Disaster Financial Assistance Claim Team (D-FACT) has been created in order to process all financial assistance claims. D-FACT has completed the majority of planning necessary for the project and anticipates the first financial claims to be submitted within the next couple of weeks.

Cost incurred as a result of disaster of this magnitude are quite significant. Funding for the costs associated with Hurricane Juan will come from one of four sources: insurance claims, the federal Disaster Financial Assistance (DFA) program, public donations, and the HRM budget.

DISCUSSION

To date approximately \$5.4 million has been spent as a result of Hurricane Juan, with anticipated future costs of \$19 million, for a total cost of \$24.4 million of incremental costs to HRM.

Not included in the above figure are regular time wages of HRM staff who have worked exclusively on the Hurricane Juan recovery. These cost exceed \$1 million and, while they do not represent incremental costs to HRM they do represent an opportunity cost. Further details of this figure will be included in a future report.

It is anticipated that \$1.8 million of the above costs will be recovered through insurance, leaving a figure of \$22.6 million. D-FACT is fairly confident in its interpretation of the DFA program and believe a substantial portion of these costs will be funded through DFA. Final rulings by provincial and federal officials will not be made until HRM's claims are audited well into 2004.

Money raised through donations and the Infrastructure Renewal Committee has not been included in the attachments to this report, neither has the capacity the Business Units are working to create. To date approximately \$1 million has been raised through public donations.

It should also be noted that, as of this date, approximately 800 of a total 1200 HRM properties have been assessed and, therefore, these preliminary estimates are subject to change.

BUDGET IMPLICATIONS

Any cost not recovered through insurance claims, FA claims, or Public donations will impact the HRM budget.

FINANCIAL MANAGEMENT POLICIES / BUSINESS PLAN

This report complies with the Municipality's Multi-Year Financial Strategy, the approved Operating, Capital and Reserve Budgets, policies and procedures regarding withdrawals from the utilization of Capital and Operating reserves as well as any relevant legislation.
