11.3 Property Matter - Spryfield Lions Arena

 This item was addressed at an earlier In Camera meeting held prior to the regular session and was now before Council for ratification.

MOVED by Councillor Adams, seconded by Councillor Streatch, that Regional Council:

- 1. Direct staff to provide an additional \$71,500 in transition funding to the Spryfield Lions Club as part of the 2006/07 Proposed Operating Budget as per the Budget Implications section of the February 16, 2006 Private and Confidential staff report.
- 2. Not release the February 16, 2006 Private and Confidential staff report.

MOTION PUT AND PASSED UNANIMOUSLY.

8.3.1 Halifax 2014 Commonwealth Games Bid

Mr. Scott Logan, CEO, made a presentation to Council advising:

- The Games can be a catalyst for a better Nova Scotia,
- The Games could be a way to enhance marketing objectives,
- Any legacy as a result of the Games has to be maintainable and sustainable,
- There is a need to ensure public support for the initiative,
- A unified front is very important,
- The bid will require a strong technical element and ability to provide athletes with qualitative experience here in Nova Scotia,
- Designs will take into consideration long term sustainability.

Ms. Dale MacLennan, HRM Director of Finance addressed the budget portion of the bid noting:

- Any proposal has to ensure the games reflect what the community needs and can
 use after the games are over,
- There has to be accountability,
- There must be a reporting process through the municipality and cabinet to the public,
- There is a need to protect the net benefit to the community,
- Risk management must be built into the games structure,
- Sponsorship funds can go one hundred percent to the bid,

Inflation will be addressed in the budget.

In response to the Mayor, Mr. Logan advised that as the detail is developed in terms of the plan, budget etc. HRM will enter into negotiations with the federal government which will determine cost sharing while demonstrating that the business plan is sound. When that has been completed, HRM will have the final contract agreement to go forward with in terms of funding and other supports.

In response to questions from Council, Mr. Logan advised:

- No ceiling had been reached on funding at this time,
- They will be coming back to Council with a final budget at a future date,
- Corporate sponsors have been identified,
- The budget includes long term sustainability for facilities,
- Inflation costs are covered in the contract,
- Existing facilities will be enhanced for the games,
- Potential for outside the core venues exists,
- There will be a volunteer database.

Mayor Kelly thanked Mr. Logan and Ms. MacLennan for their presentation.

11.4 Contractual Matter - 2014 Commonwealth Games - Letter of Intent

- 1. Authorize the Mayor to sign the "Candidate Procedure of Acceptance" indicating Halifax Regional Municipality's intent to file an International Bid to Host the 2014 Commonwealth Games.
- 2. Authorize immediate release of this report subject to the approval of the Commonwealth Games Canada.

MOVED by Councillor McCluskey, seconded by Councillor Younger, that Council award Tender No. 06-213, Traffic Signal Installation, Wright Avenue at Joseph Zatzman Drive & Raddall Avenue - East Region to Black & McDonald Limited for materials and services listed at the unit prices quoted for a Tender Price of \$154,771 including net HST from the 2005/06 Capital Budget and the Approved Advanced 2006/07 Capital Budget from Account No. CTU00561, Traffic Signal Installation, with funding authorized as per the Budget Implications section of the February 10, 2006 report. MOTION PUT AND PASSED UNANIMOUSLY.

9.1.3 Request for Quotation Q05C423 - Cleaning Contract, Acadia School Municipal Building

MOVED by Councillor Harvey, seconded by Councillor Johns, that HRM award Quotation Number Q05C423 for cleaning contract services at Acadia School Municipal Building for a three (3) year period for \$173,395.20 (including net HST) commencing March 1, 2006 to D & J's Cleaning as outlined in the Budget Implication section of the February 8, 2006 report. Further funding is available from operating budget Account Number W130. MOTION PUT AND PASSED UNANIMOUSLY.

9.1.4 <u>Request for Proposal 05-157 - Architectural Services, District 2</u> Recreation Centre and Zone 4 Fire Station, Fall River

Further, funding is available from Capital Account No. CB200454, District 2 Recreation Centre, as outlined in the Budget Implications section of the February 7, 2006 report. - 1. HRM enter into an agreement with a community based fund raising group, for the purpose of leading fund raising efforts for the new Mainland Common Recreation Centre (MCRC) that demonstrates commitment and broad based support to the selected option and to fund raising; and
- 2. Based on demonstrated broad-based community support and commitment to community fund raising, HRM work with the community group to identify additional Provincial and Federal funding opportunities as outlined in the February 13, 2006 report.

9.1.7 <u>Administrative Order SC-41, Respecting Closure of Surplus Right of Way - Cole Harbour Road, Cole Harbour</u>

11.1 Sidewalk Snow Plowing

MOVED by Councillor McCluskey, seconded by Councillor Wile, that the sidewalk snow removal program for Halifax Regional Municipality include all present elements and the following components:

- 1. All arterials and transit routes within the Municipality funded through the Urban General Tax rate;
- 2. An enhanced Seniors and Disabled individuals' sidewalk snow removal program funded through the Urban General rate;
- 3. Continue the service in the areas which receive residential sidewalk snow removal and fund through a single area rate; and
- 4. That the sidewalk snow removal program be set for a period of not less than five years so staff can make the necessary operational and service level improvements to ensure program effectiveness.

This recommendation will replace the motion set out in the August 9, 2005 meeting of Committee of the Whole.

MOTION PUT AND PASSED. (12 in favour, 7 against)
