Ms. Jillian MacLellan, Planner, responded to questions of clarification from Members of the Community Council.

Councillor Rankin clarified that the realignment of the streets was to accommodate wetlands and resulted in a more efficient layout.

Ms. MacLellan clarified that in regard to the parkland:

• the percentage is consistent with HRM policy

• the private community association parklands are available to the public who live in the area and are not for the exclusive use of any one party.

Mr. Nick Pryce, Genivar, clarified that the private parkland will be maintained by the community association.
