THE COUNTY OF HALIFAX.

FIRST DAY.

HALIFAX, FRIDAY, January 7th, 1881.

Pursuant to notice from the Warden, the County Council met at the Court House, in the West Court Room, at 10.30 o'clock.

On motion of Councillor Jas. E. Shatford, seconded by Councillor Tupper, Councillor Donald Arichibald was appointed Chairman.

At the suggestion of Councillor Jno. E. Shatford, the Clerk read the notice of the Warden, calling this meeting of Council.

The Clerk called the Roll. Present—Councillors Monk, O'Leary, Jas. E. Shatford, A. Hubley, Burgess, Hamilton, Tupper, Dean, Ryan, Belfontaine, Crooks, Griffin, Donovan, Jno. E. Shatford, Himelman, Donald Archibald, Jno. Smith, and subsequently, Councillors Henneberry, Umlah and Dillman—20 in all.

Read notes from Councillors W. Guild and A. W. Smith, stating their inability to be present. Also a letter from the Warden, mentioning his being unexpectedly obliged to proceed to England, and regretting his enforced absence.

Councillor Jno. E. Shatford referred to the present meeting as being chiefly for the purpose of obtaining reports of the several Committees and receiving the Treasurer's accounts, so as to know in what position the Municipality stood. Also referred to the resolutions of May meeting not being acted upon in regard to Mr. Gietz, Collector District 33, and his bondsman, and wished an explanation.

Conversation followed on various matters. by Messrs. Ryan, J. E.

Shatford, Tupper, Himelman and others. Dissatisfaction was expressed at the accounts not being ready. The indebtedness of the City and Dartmouth was also discussed.

The Clerk stated that Mr. Gaetz and his bondsman, J. H. Anderson, J. P., had been written to and the amount due demanded. That Mr. Anderson had replied, asking reconsideration, but had not paid anything yet. That he had not been authorized to take legal steps and employ an attorney. In reference to the Treasurer's accounts, the Incorporation Act had changed the closing of all accounts to December 31st, a month later than the Sessions, and the Auditors' had not attanded in consequence but a few times, as the claims splinst the County were not received.

Moved by Councillor Donovan, seconded by Councillor Hamilton, and passed :

"That each Committee prepared present their report."

The Chairman enquired if any Committee was ready-

There being no response, it was moved by Councillor Griffin, seconded by Councillor Bargess :

"That the Court adjourn until II o'clock to-morrow to enable the Committees to prepare their reports."

Passed.

The Council then adjourned.

SECOND DAY.

HALIFAN, SATURDAN, JANUARY S, 1331.

The Council met in the West Court Room at II o'clock-

The Roll was called. Present—Conneillors Burgess, Hanneberry, Jas-E. Shatford, Hubley, Umlah, Dillman, Tupper, Dean, Ryan, Belfontain, Griffin, Donovan, Jao E. Shatford, Himelman, O'Leary, Donald Archibald, Smith and Monk—17.

Minutes of previous day read, amended and confirmed.

While waiting for a querum the Clerk stated that circulars had been sent to all parties known to have accounts, and letters to the Prothonotary for return of jury fees, and Sheriff for jury fines. The Prothonotary had furnished a brief report, with a suggestion that all jury fees should be paid by litigants to County Treasurer. He had also paid over to Treasurer balance in his hands. The Sheriff had received no finessince last returns paid to the Treasurer in May.

The Chairman stated that the business was principally the Reports of Committees. The Report of Committee on Jury Fines Fees, and Attorney General's complaint, prepared by the Warden, was submitted and read.

Report of Committee on Jury Fees and Fines, and Attorney General's Complaint against the Treasurer.

To the Warden and Council, County of Halifax:

Your Committee have examined into the whole question of Jury Fees received by the Prothonotary and paid over to the County Treasurer, and find that no satisfactory record of the amounts received or paid has been furnished. The work has been loosely and therefore unsatisfactorily done.

As far as can be ascertained, in 1877 amount paid to Jurors, \$1564.25; amount received from Prothonotary, 510.50; balance met by County, 1053.75. In 1878 the amount paid to Jurors, 1199.90; amount received per Prothonotary 518.09; balance met by County, 681.81. In 1879, amount paid to Jurors, 1329 60; amount received, 331.00; balance met by County, 998.60; less received to 30th January, 1880, 176.75 = 821.85.

The Amendment to the County Incorporation Act, if carried out in its true spirit, will, it is hoped, obviate these difficulties.

Your Committee interpreted the amended clause to mean that a detailed account of all Jury Fees collected, stating the case for which that amount was paid, shall be furnished it the end of each quarter, so that the accounts may then be verified; and with this arrangement carried into effect, your Committee apprehend that there need be no trouble in future; but they would recommend that a notification that this return will be required be forthwith sent by the Warden to the Prothonotary.

In regard to Jurors' Fees, your Committee notice that the total amount of fines received (less 5 per cent retained as commission) is \$248.30, which seems an absurdly small sum to have collected in three years-1876, 1877, 1878; also that the Sheriff holds \$42.75, being total of fees for 1879, which he has retained on account of a debt stated to be due to him by the County ; this is clearly wrong, all sums received to credit of County should be at once paid over, and all accounts against the County sent in for settlement. Sec. 44, Chap. 92 Revised Statutes provide for the levying of a fine of \$2.00 on all absent jurors, and Sec. 45 of same Chap. for the collection of same, and enacts that a statement of all fines imposed, whether collected or not, shall be returned by the Sheriff to the Prothonotary to be laid before the Court. Your Committee consider that this statement (after being approved by the Court), which is of importance to the County as verifying the accounts and shewing one source of revenue of the County, should be forwarded to the County Clerk for the information of the Finance Committee and Council.

In reference to the subject of fees to Crown Witnesses, your Committee feel that this important subject demands serious consideration. The County Treasurer, it now appears, is required to pay these fees on the Prothonotary's certificate; and whilst the County is protected by the requirements of Sec. 63, Appendix B, it does not always appear that these requirements have been fulfilled previous to the issue of the Prothonotary's certificate. It is, therefore, recommended that a form of certificate as appended be established, and that the Treasurer be directed to make payments on this form only.

Considerable expense is saddled on the County by the postponement of the trials of cases, and your Committee feel that it is extremely unfair that this burden should be borne by the ratepayers. If the County provides means for the administration of justice, and the parties are not ready for trial at the time named, it seems but reasonable that the party at whose / instance the case is postponed should bear all expenses caused by the postponement, and your Committee would urge that an application be made that the law be amended to carry out the above suggestions.

Your Committee have had a later letter from the Hon. Attorney-General submitted to them, and regret that they are unable to obtain particulars of the cases alluded to by the Hon. Attorney-General in his first letter containing the complaints. The County Treasurer has satisfied the Committee that, in many cases, the requirements of the law were not carried out, and that charges were made which were in excess of what is generally understood as admissible. If the County Treasurer exceeded his duty, he erred with a desire to save the County extra expenditure. Your Committee feel that the Council will unite with them in regretting that any discourtesy should be experienced by any gentlemen having dealings with the County officials, but feel assured that all has arisen from a misunder-Your Committee trust that the suggestions they have made in standing. reference to the new form of certificate to be sent in by the Prothonotary to the Treasurer will obviate any possibility of a recurrence of such unpleasantness.

All of which is submitted for the consideration of the Council.

Councillor Jno. E. Shatford made some explanations in reference to the efforts of the Sessions to get the fines and fees rectified and paid over by the Prothonotary, without success. After remarks by Councillors Tupper and Himelman.

Moved by Councillor Jno. E. Shatford, seconded by Councillor Griffin:

"That the Report of the Committee be adopted and referred to the new Council to deal with."

Passed.

Read a series of Resolutions from the proceedings of the Annual and Semi-Annual Meetings 1880, having the nature and force of Bye-Laws, compiled by the Clerk and approved by the Warden for the action of the Council, with the view of inserting them with the other Bye-Laws for publication.

After discussion and suggestions, moved by Councillor Himelman, seconded by Councillor Dean :

"That the suggestions be referred to Bye-Law Committee."

Councillor Griffin, Chairman, presented Report of Committee on Public Property, which was read, together with letter from Sheriff Bell, and Report of Dr. Woodill, Surgeon.

Report of the Committee on Tenders and Public Property.

To the Worshipful the Warden and Councillors of the County of Halifax:

GENTLEMEN, — Your Committee visited the jail regularly, weekly and monthly in turn, and found the prisoners carefully dealt with, the premises clean and orderly, and the jailor ever attentive.

Your Committee, in accordance with the desire of his Lordship Bishop Binney, has instructed the jailor to divide the rations for the prisoners, so as they may have three meals each day.

Your Committee has from time to time given instructions, when necessary, for the repairs of the jail building and fence, as brought to their notice, and now find, from the Report of the jailor, that the roof of the jail building is in a bad state, leaking, and probably would require a new roof of slating.

Your Committee recommend a light to be placed in the corridors of the jail building, for the accommodation of the prisoners therein, during four months of the winter season—from the first of November till the first day of March, in the evenings until nine o'clock, at which time said light is to be removed and taken away by the jailor.

Your Committee recommend that the Surgeon who attends the jail should once a week visit the jail, in addition to the times he may be sen for; and that, whenever attending, he should register his name in the book and mention anything necessary with regard to the health or condition of the inmates of the jail; also, make a written Report to the Committee half yearly.

Your Committee, in compliance with the requirements of the jail in forwarding prisoners to the Penitentiary at Dorchester, on the application of Sheriff Bell, and on his suggestion, do recommend that four pairs each of patent adjustible handcuffs and leg irons be immediately provided for such use as the Sheriff may require, and that Sheriff Bell be instructed to obtain the same. All of which your Committee respectfully submit.

JAMES L. GRIFFIN, Chairman, JOSEPH HIMELMAN, EDMUND RYAN, DANIEL DONOVAN.

In reply to Councillor Shatford, Councillor Griffin mentioned that the changes made were in compliance with request of the Bishop. They did not involve increased expense as to meals, nor danger or vitiation of insurance in respect to lights. Before further action Councillor Himelman asked to have existing Jail regulations examined and read.

The Chairman stated, on behalf of the Committee on Roads and Bridges, that he had a partial report prepared, but a number of the Schedules asked for by the Provincial Secretary were still wanting.

The Clerk said, on receiving notice from the Government, that the Schedules must be returned without delay, he had sent a circular to that effect to all Councillors, with fresh blanks, but there were quite a number of these yet unfilled.

Councillor Ryan, Chairman, presented Report of Committee on Insane Patients, which was read.

Report of Committee on Hospital for Insane.

Your Committee find that they have since February last committed twenty-three patients to the Hospital—ten from the City of Halifax, six from Dartmouth, and seven from the Municipality. Two of those from the City are chargeable to Government, two are paying, and two others are paying part maintenance, and one from the Municipality paying part maintenance, leaving sixteen chargeable to the County.

Your Committee have removed to the Poors' Asylum in the City, nine patients from the Hospital for Insane, and are now chargeable as poor paupers to the City of Halifax, thus relieving the County of a very heavy charge.

Your Committee have secured the services of William Taylor, Esq., J. P, to make an investigation of the charges of the Hospital against this Municipality.

Your Committee are of opinion that the charge of ten dollars to the two doctors (five dollars each) for examining a patient seeking admission to the Hospital for Insane exorbitant, and trust that the Council will take such steps as will be necessary to obtain legislation to have the fers reduced.

All of which is respectfully submitted.

Edmund Ryan, James L. Griffin. He explained some matters in connection with it, and referred to the large expenses connected with this Service. The subject of admission fees was discussed. The general opinion of the Council was that they were too high, being \$10 for medical certificates.

On motion of Councillor Dean, seconded by Councillor Himelman, the Report was received.

Councillor Himelman here read that portion of the established Jail Regulations concerning lights, which, by inference, warranted the action of the Committee on Public Property in that particular.

Moved by Councillor Jas. E. Shatford, seconded by Councillor Tupper:

"That the Report of the Committee be adopted."

Passed.

Councillor Jas. E. Shatford, Chairman Committee on Public Accounts, reported verbally that he had expected to submit the Financial Statements, and had endeavored to fulfil that duty by urging the Treasurer, by letter, some weeks ago, to have the accounts audited and prepared. There was no use to summon his Committee unless there was business for them to do. The Treasurer was not yet ready, but he and the Auditors were now engy ged at the Accounts.

The Report of the Committee on Roads and Bridges was read, and led to a general and lengthy discussion on the subject of the reserved balance. Messrs. Jno. E. Skatford, Ryan, Dean, Himelman, Dillman, Hubley, Donovan explained the necessity for extra allowances in their districts, and other points, On motion, the Report was amended by the insertion of the amounts named for District 32, \$17.00; 31, \$2.10; 20, \$4.56; 22, \$2.68.

Report of Committee on Roads and Bridges.

To the Worshipful Warden and Council:

Your Committee has carefully gone over the summary of Roads and Bridge commissions for 1880, and find the accounts very satisfactory. Only in one instance has the amount been overdrawn, namely, in District 22, to the amount of \$2.68, while three or four Districts have not yet fully drawn the amount allotted them. In the distribution of the road allowance, a balance of one hundred dollars was reserved for emergencies. There are two applications, one from District 22 for \$20 to repair a bridge, on which already there has been two accidents, and one from District 32, where a bank had fallen down and stopped the travelling on the mail road, involving an expense of \$17 00. Also \$4.36 to District No. 20, and \$2.10 for District 31. Your Committee recommend that these four amounts be allowed,

Your Committee regret to find that a great number of the overseers of Statute Labor have neglected to send in their returns, and would recommend that the Councillors for each District notify the overseers that the returns must be sent in without delay.

DONALD ARCHIBALD, Chairman. R. E. MONK, John E. Shatford.

Moved by Councillor Jno. E. Shatford, seconded by Councillor Dean :

"That the Report as thus amended be adopted."

Passed.

Moved by Councillor E. Ryan, seconded by Councillor Jas. E. Shatford :

"Resolved, That all Councillors drawing money from the reserved fund, the same shall be considered as advances from next year's grant, and be charged against them as such."

Passed (two Councillors dissenting.)

On motion of Councillor Griffin, seconded by Councillor Tupper:

"Resolved, That the Reports on the Schedules be handed to the Committee on Roads and Bridges to make up."

Passed.

Councillor Ryan addressed the Council on the subject of the indebtedness of Dartsmouth, which was still unsettled and increasing, also the nonpayment of assessment of 1880, and previous balances by the City of Halifax. He submitted a memo. of the Dartsmouth debt, as follows:---

Steps should be taken to have this matter settled immediately. He thought that this could be done, and that the City, also, could be compelled to pay up at once.

Councillor Jno. E. Shatford and others took part in the discussion, in which it was shown that the City Council had caused the County tax for 1880 to be levied and collected from the citizens, but that they withheld the same, in contravention of the Statute and precedent.

The following resolution by Councillor Ryan, seconded by Councillor Jas. E. Shatford, was moved, and passed unanimously:

"Resolved, That Councillor Donald Archibald and Councillor Jno. E. Shatford be appointed a Committee, with power to employ an attorney, to prepare a Bill to present to the Government, asking for legislation to compel the Town of Dartmouth to pay all moneys due by said town to this Municipality."

On motion, the Council adjourned, to meet Monday at 11 o'clock.

THIRD DAY.

MONDAY MORNING, January 10th, 1881.

The Council met in the County Court Room at 11.30, Councillor Donald Archibald in the Chair.

The Roll was called. Present—Councillors Hubley, Monk, Umlah, Griffin, Burgess, Dillman, Tupper, Dean, Ryan, Guild, Belfontaine, Donovan, Himelman, O'Leary, John Smith, Jno. E. Shatford, Jas. E. Shatford—19.

Read a letter received from Dr. Ternan, complaining of the interference of the Councillor for District (No. 17) with him in the discharge of his duty as Overseer of Highways to which he had been appointed, and asking action of the Council thereon.

On motion of Councillor Himelman, seconded by Councillor Ryan :

"Resolved, That the letter of Dr. Ternan, as submitted, be referred to the Committee on Roads and Bridges."

Passed.

Councillor Griffin presented the Report of Committee on Bye-Laws which was read, and in connection therewith, the resolutions recommended to be added to the existing Bye-Laws as marked on the Clork's copy. The resolutions net considered advisable to add, were also read on request. The whole were separately considered, and on the clause relating to the Poor considerable discussion took place. The dropped clauses were passed over, and the report on motion was received and passed as a whole.

Bye-Laws Relating to County Clerk.

x "That the Clerk perform the duties heretofore performed by the Clerk of the Peace, also all duties required of him by the Council, and those laid down in section 35 and 36 of the Incorporation Act and other Statutes."

The amount of Bond to be given by the Clerk be for One Thousand Dollars. *Treasurer*.

x "Resolved, That the Treasurer do all the duties contained in section 37 of the Act, and all other duties in connection therewith, as required by the Council."

x "That the Bonds of the County Treasurer be the same as formerly, Eight Thousand Dollars, currency," Passed. x "Resolved, That the Treasurer present a statement of the Finances of the County

in January of each year, for circulation among the Councillors, showing assets and disbursements of the fiscal year ; and that a copy thereof be furnished to each Councillor."

x "Resolved, That the Treasurer place in a Bank to be named by the Council, all moneys that pass through his hands belonging to this Corporation, in the name of said Corporation." Passed.

x "That the funds of this Municipality be deposited by the Treasurer with the Halifax Banking Company, to be drawn as required." Passed.

County Officers.

x "Resolved, That the Warden be instructed to take charge of the bonds of the

Clerk and Treasurer, and that the same be handed down to the keeping of every succeeding Warden of the Municipality." Passed.

× "Resolved, That the Warden have power to call upon a committee of Councillors, to be nominated by him, at any time to meet, to whom can be referred any matters of emergency."

That the Warden be considered a member of all Committees ex officio.

District Officers.

 \times "Resolved, That all presiding officers for holding municipal elections be appointed not later than the semi-annual meeting in May. In case of a vacancy occurring among such officers before such election takes place, the Warden shall have power to fill such vacancies." Passed.

Bye-Laws Relating to Roads and Bridges.

x "Resolved, That the Clerk of the Council forward to the various Councillors a sufficient number of blank Returns for the expenditure of the Government money; and each Councillor appoint Commissioners and fill up such blanks; and that the Clerk shall also notify each Councillor the amount of money to the credit of their respective districts." Passed.

"Resolved, That the section of the road known as Kearney Road, about five miles in length, leading from Bedford Basin to Hammond's Plains, be included in Municipal District No. 16." Passed.

"Resolved, That all applications for Road Expenditure, Committees for appraising damages, or laying out new roads, or regulating Statute labor, be referred to the Committee on Roads and Bridges."

"Resolved, That the Pittsburgh and N. S. Mining Company, doing business at Tangier, have permission to build a race or flume across the main road at Tangier, for the purpose of conveying water to the crusher, the bottom of said race or flume to be at least twelve feet above the road."

 \times "Resolved, That the license fees and fines, when expended, be drawn from the Treasurer by the sworn account of the party expending the same, who shall be appointed by the District Councillor, and the account shall be accompanied by a certificate from such Councillor that the amount has been satisfactorily expended for the benefit of Roads and Bridges."

See also Clauses 3, 4 and 6 of the January Report of Committee on Roads and Bridges.

Licenses.

"That licenses for the sale of intoxicating liquors be granted by the Council, on the recommendation of the License Committee, to such persons as request them."

"That the license fee for the sale of intoxicating liquors be fixed at \$40."

"That any Acts of the late Court of Quarter Sessions conflicting with the Bye-Laws of this Council are hereby declared null and void."

Assessments.

x "That as soon as the Assessment Roll is handed to the Councillors for the different districts, they be at once handed over to the Collectors for immediate collection."

"Resolved, That any Councillor who requires three Assessors in his district shall have power to appoint them." Passed.

The Poor.

 \times "Resolved, That in all cases when Poor Rates are collected, the Treasurer of the Overseers of the Poor for the Section be required to give bonds for double the amount of such sum as may be held by him, the said bonds to be filed with the Clerk of the County; and the Overseers of every District shall be required to report to the Council, at the January meeting, a full account of the year's proceedings. The Bond to be approved by the Councillor of District."

Councillor Griffin begged to enquire of the Councillor for District 36 whether he had obtained a special allowance of \$50 for roads in his District by or through one of the County members. The enquiry elicited a lengthy debate, in which such a course was strongly reprobated as infringing the prerogatives of the Municipal Councils, leading to confusion and tending to a reduction of the fund for Roads and Bridges the succeeding year.

Councillor Smith replied that he could not state where the money came from. He had applied to the Warden and Clerk for \$50 extra for a bad road, and it was refused. He then went to Mr Harrington, and the money was obtained. He did not think it would be taken out of next Grant.

Councillor Himelman referred to the subject of extra allowance to Assessors in certain cases, and handed in a claim from Assessors of District 33 for 5 days' extra duty.

A discussion followed, in which the whole subject of the duties and pay of Assessors was considered, also the number of them for each District. The Chairman read the Sections from the Local Act (1862), and the Clerk pointed out the clauses in Chap. 21, Rev. Stat. (of County Assessments) bearing on points not provided for in the Local Act referring to duties neglected by most Assessors. From the printed proceedings, the course pursued last year was quoted and Messrs. Jno. Shatford and Ryan cited the County Incorporation Act and Amendment thereto.

Councillor Griffin, seconded by Councillor Burgess, moved the following resolution :

"Resolved, That the remuneration for the services of Assessors having been arranged at a former meeting of this Council, no extra allowances be granted."

Passed.

On motion, the Council adjourned to 4.30 p.m.

MONDAY AFTERNOON, January 10th, 1881.

The Council met in the County Court Room at 4.30. Present, the Chairman and 14 Councillors.

The Minutes were read and passed. The Chairman of Finance Committee reported progress. The accounts would not be ready until Tuesday merning.

The Report of Committee of Public Preperty on the County Jail was submitted by the Chairman. Councillor Griffin, including that of Mr. Chambers, the Jailor, for the term from May to December 31st. During that time the persons incarcerated were 162 criminals, 165 debtors. Total, 327. At present there were in the Jail 11 criminals, 5 debtors=16. Of the criminals, 24 were sentenced for larceny, 32 for assaults, 38 for drunkenness, and the remainder for petty crimes and misdemeanors. The committals were from the following Courts for the year 1880 :--

From City Courts, 200; Supreme and County Courts, 105; Dartmouth, 2

32; County Magistrates, 78; Coroner, 1. Total, 476. During the year the fees received for board of military prisoners and room rent was \$78.34.

Report of Committee on Public Property, Enclosing Jailor's Report.

To the Municipal Council, County of Halifax:

GENTLEMEN,—The Committee on Public Property having examined carefully the Report of the Jailor for year ending December 31st, and finding it correct, report favorably on the same.

After some conversation respecting the large number of committals from the City, some of which should have been made to the City Prison, it was moved by Councillor Himelman, seconded by Councillor Monk,

"That the Jailor's Report be received and handed to the Committee to annex to their General Report."

Moved by Councillor Jas. E. Shatford, seconded by Counciller Ryan:

"Resolved, That all accounts against the County be made up to and rendered not later than 31st December, instead of 30th November, as hitherto, in each year, and payable thereafter."

Passed.

On motion, the Council adjourned to meet to-morrow morning at 10 o'clock.

FOURTH DAY.

TUESDAY MORNING, January 11th, 1881.

The Council met at 10 o'clock. Present, the Chairman and 22 Councillors. Reading of Minutes deferred.

The Chairman called for the Report of Finance Committee, which was submitted by the Chairman, Councillor Jas. E. Shatford, who, with Councillor Hubley, spoke favorably of the assistance of the Clerk and the satisfactory manner in which the business of the County entrusted to him was carried out and presented to the Council.

Report of the Committee on Public Accounts and Finance, December 31st, 1880.

To the Worshipful the Warden and Councillors of the County Council:

GENTLEMEN,—We beg leave to report that we have examined the accounts of the ('ounty Treasurer, from 30th November, 1879, to 31st December, 188), and have found them to be correct. In order to comply with the requirements of the Act of Incorporation, the ('ommittee have had to bring all expenditures down to the latter date, making the actual term 13 months, as the accounts made up under the Sessions by the Grand Jury of 1879 were only to the close of November of that year.

We have made up a statement of Assets and Liabilities of the County, of which the following is a succinct account :--

Your Committee strongly recommend that some prompt action be taken in regard to the collection of the amount due by the City of Halifax. They feel that they will be unable to pay anything on account of amount due the Lunatic Asylum, until they receive the amount due from the City, as the greater portion of that account is due on behalf of Lunatic Paupers from the City and Dartmouth.

Your Committee are of opinion also, that in the accounts rendered by the Board of Public Charities, there are a number of Patients charged to this County who have no settlement therein, and the charges for these should be deducted.

In order to ascertain this definitely, Wm. Taylor, Esq., has been employed to investigate the claims of said Patients upon the County, and report to the Council at their May Session.

It will be seen by the above statement of Liabilities and Assets that thebalance, though large, is not at present available. That part of it, which appears as cash, will be required to meet the current exigencies of the Municipality before the yearly assessments can be again collected from the several Districts.

With reference to the legacy left to us by our predecessors in the form of the debt due by Dartmouth, it must be specially noted that there is being added to it a large sum yearly, and in order to adjust the same your Committee, while relying fully upon the promise of the Government to the Committee appointed to confer with it last May to provide legislation to enable the County Council to collect the amount due, yet feel that before calling for such legislation it would be desirable to ask the Town Council of Dartmouth to appoint a Committee to confer with a Committee of this Council with a view to an amicable settlement of the whole matter.

It is hoped that the suggestions made by the Committee on Jury fines and fees in their report may be carried into effect so that the large outlay for Jurors and Witnesses fees hitherto, may be obviated, and the amount yearly saved the County.

All of which is respectfully submitted.

Councillor Himelman submitted the Juilor's Report for 1880, a synopsis of which was read Monday afternoon. Being too lengthy, the reading was deferred.

Councillor Ryan, in reply to a question, explained as to the right of

the City to the use of the County Jail, and Messrs. Hubley, Jno. E Shatford, Himelman, Jas. E. Shatford and N. Hayes, Jr., discussed the subject.

The Report was then adopted.

Councillor Griffin (Chairman) submitted Report of Committee on Assessments, which was read.

Report of the Committee on Assessments for 1880.

To the Worshipful the Warden and Councillors of the County Council:

GENTLEMEN, - Your Committee cannot recommend any reduction in the taxes of Benjamin t'olp, in District No. 32. on the ground that his property has been valued by three sworn Assessors, and which, in our opinien, is entitled to credit in preference to the appellant; therefore, do sustain the assessment of District No. 32.

Your Committee also beg to state that we cannot recommend any reduction in the assessed value of Henry Wisdem's taxes, as he is not present, neither is his petition accompanied by affiliavit; therefore, do sustain the assessment of District No. 30.

Your Committee on receiving a communication from W. D. Sutherland, Esq., in reference to his assessment on gold streas, cannot recommend any reduction in his taxes for reasons as above, he (the appellant) not being present to state grievances on oath ; therefore, do sustain the assessment of District No. 31.

By resolution of the May Session, the following action was taken with respect to District No. 11 in reference to a correspondence with the Assessors of said District, respecting sending back the assessment roll for revision. We find that they responded to the request of your worshipful Council, by adding to the assessment roll the sum of \$16,000, thereby rectifying their previous return and establishing the decision of the Council that there existed a necessity for the revision.—

A lengthy correspondence took place between the County and City authorities on the subject of the valuation return which, by law, the Mayor should make annually to the Clerk, in order to make up the assessment for the whole County. The correspondence can be at any time examined. It is at present only necessary to say that, under the advice of the Attorney-General, the valuation last obtained from the city was taken, and the assessment based accordingly. On the amount of assessments being furnished to the City Council, that body notified the clerk of their refusal to accept it. It is, however, a curious commentary on their own conclusion respecting it, that the city proceeded to assess the citizens at the rate named by the County, and have collected a large portion of the amount, but instead of paying over the sum, as the Statute requires, to the County Treasurer, they have retained and devoted it to city purposes, and the County so far has not received one dollar of it.

All of which your Committee respectfully submit.

The memorials of W. Sutherland, H. Wisdom and B. Colp were enclosed; also letter of Assessors of District 11.

The Clerk mentioned that a large number of appeals against over valuation had been received, and either allowed or rejected on consulting with Assessors and the Warden; also explained the late issue of the Assessment Rolls was in consequence of the City refusing to give or accept the valuation required by law. A large amount of correspondence was submitted relating thereto.

After some discussion, it was moved by Councillor Himelman, seconded by Councillor Jas. E. Shatford,

"That the Report, with the Petitions enclosed therein, be all referred to the new Council."

Passed.

The Clerk, as acting Sheriff, appointed 2 o'clock instead of 12 for the meeting of the new Council.

Councillor Monk, on retiring, expressed his thanks for the pleasant and satisfactory, intercourse he had experienced with all members of Council and wished them success.

SECOND DAY.

WEDNESDAY, January 12th.

The Council met in the West Court Room at 10 o'clock.

Roll was called ; Warden and 28 members present.

The Minutes of last meeting were read.

In reply to Councillor Dean, the Clerk reiterated the vote respecting salary of Treasurer-19 to 3.

The Minutes were confirmed.

The Clerk and Treasurer were sworn into office by Councillor Ryan.

Councillor Jno. E. Shatford enquired whether the report was correct in the newspapers that the Assessment Committee had rejected all the petitions of parties who appealed against their valuations ?

The Warden, referring to their Report, read the Resolution transmitting it to Committee of new Council.

Councillor Shatford also enquired whether the Bye-Laws had been sanctioned by the Government, and if so, considered that they should be acted upon. He complained of interruption by a Councillor whilst addressing the Chair.

The Clerk replied that the Bye-Laws, as last amended in May, had been so approved, and were now in force.

The Treasurer, in reference to the appointment of P A. Frederickson as a County Constable, begged to remark that such officers should be appointed as would do the work of the County when required. Moved by Councillor Himelman, seconded by Councillor Burgess :

"That Councillors Chipman, Leslie, Dean, Jas. E. Shatford, and D. W. Archibald be a Committee on Bye-Laws."

Passed.

Moved by Councillor Himelman, seconded by Councillor Dean :

"Resolved, That the Clerk and Treasurer's Bonds be same as last year, viz. : Clerk, \$1000; Treasurer, \$8000."

Passed.

Moved by Coucillor Himelman, seconded by Councillor Rowlings :

"*Resolved*, That the Committee on Bye-Laws be empowered to define the duties of the Committee on Poor."

Passed.

The Clerk submitted a letter received from Col. Laurie, referring to business of the past year, and offering some practical suggestions for the consideration of the present Council.

The letter was read, and on motion of Councillor Jno. E. Shatford, seconded by Jas. E. Shatford :

"That the recommendations contained in the letter from the late Warden be received and published with the proceedings of this meeting of Council."

Passed.

Letter from Col. Laurie.

London, December 29th, 1880.

Gentlemen of the Municipal Council:

In closing the first year of our existence as a Municipality and in vacating the office of Warden, I feel that I may offer you my hearty congratulations on the manner in which the work of the Council has been carried on. Whilst assembled with an earnest desire to discharge our work to the best of our ability, thorough harmony has characterized our proceedings, and I cannot recall a single harsh word or unpleasant incident at any of our meetings. Party differences in Provincial or Dominion matters have been entirely put aside in dealing with County affairs, and each and all I much regret that a severe attack of illness has incapacitated meduring a large part of the year from taking such an active part as I could have wished in the work of the Municipality; hence I have little especially to report to you but I feel it my duty to submit various matters for your consideration and possibly, if so deemed advisable, for your action.

In my enforced absence I have placed the Bonds of the County Clerk and Treasurer in the hands of the President of the Halifax Banking Company for safe keeping, and to be delivered by him to the incoming Warden.

In carrying out the provisions of the Municipal Act, you will have found out any weak point or deficiencies and it will be well that any proposed amendments should be well considered at the present meeting and a strong Committee named who would press the alterations you would suggest on the Provincial Legislature at the ensuing session.

Much of the real work of the County is done by the several Committees during the year; their reports will be laid before you and will, I believe, shew that they have faithfully discharged their responsible tasks.

In accordance with your instructions. I addressed the Government, requesting the appointment of Commissioners in whom the title to the Court Horse should vest, but, beyond correspondence which will be laid before you, no action has been taken. In view of the financial position of the County, to be considered later, no action has been taken in relation to alteration of the room selected as a County Council Chamber.

As the ('ity of Halifax has taken no decided step toward the settlement of the outstanding account. nearly \$28,000, for ('ounty Taxes, actually collected or in process of collection by it being now due to the Municipality, and as the County is thereby incapacitated from discharging its liabilities, I by your authority placed the matter in the hands of the Honorable the Attorney General, as our legal adviser, for collection; a comparatively small sum has been paid over on account and the public services have been so far maintained without incurring the authorised loan, for which, however, I obtained the sanction of the Lieutenant Govern r in Council and made arrangements with the Halifax Banking Company to furnish the funds as required.

No p ogress has been made in the Dartmouth matter, which remains as reported to you last year. Our financial position demands your most serious consideration. Some steps must be taken, first to enforce the law as it at present stands, and then so to re-organize that this, or similar trouble, shall not arise in future.

I see no better plan than that suggested by me last Session, that the City of Halifax and Town of Dartmouth shall be set apart as separate Municipalities for all purposes, and that the rural portions of the County shall be divided into an Eastern and Western District.

The most important part of our duty is to provide the ways and means for the ordinary services of the County, of which the most pressing is the maintenance of the means of communication, and as the Provincial Road Grant diminishes, greater care must be exercised that the amount allowed to us is economically and judiciously expended, and that the burden of providing the remainder is equitably distributed.

First, therefore, it is important that property shall be fairly and equally appraised; you will recollect that in this the present system has not been found to work satisfactorily.

Secondly, that the taxes actually assessed on property should be collected; at present our Collectors are bound in penalties to pay over whatever they actually collect, but no obligation is imposed on them to press the collection of the taxes, consequently considerable amounts annually remain uncollected; to remedy this, the Collectors' duties might be more strictly defined.

Councillor D. W. Archibald's resolution of last year. providing for the proparation of the electoral lists from the assessment of the same year, and solely on the valuation made and taxes paid, would at least secure that those who exercised the franchise contributed in due proportion to the County funds.

By carrying out the instructions as prescribed at page 46 of the printed proceedings of May last, and posting up the Assessors' lists of valuation of property, their work will be subjected to the criticism of the community, and a fairer and more equitable appraisement be made.

The County funds also suffer serious loss from the difficulty of co'lecting the taxes from non resident land owners, and some readier means than those at present provided under statute are required to facilitate the collection.

The system of furnishing a varying number of days' labour for maintenance of roads is also extremely unsatisfactory. In this case the statutory provision is that eight hours work shall be counted a day's labour, or a commutation of 50 cents be paid in lieu of each such day's work. Reference to the returns of Overseers of Statute Labour will shew that, in more than one case, the parties paid in the commutation fee of 50 cents, and were then employed a day of ten hours for \$1 25. Further, so many exemptions from this service are allowed, that, in some districts hardly any road work is performed. All exemptions should be abolished, as recommended by this to ouncil last year, and I believe it is fully time that the road tax should be collected in cash, on all property, and expended under the orders of the Council, and that it should be so expended in the District in which the property is situate.

Section 6 of Chap. 21 would imply that the *property* should pay the Statute Labour, &c., but the law is generally interpreted according to Sec. 3 of same Chap., that it is only a *male* possessing the property who can be called on to furnish the labour, or pay the commutation fee, and then only in the District in which he *resides*. (See Sec. 20).

Under the present general interpretation of the law, all the Statute Labour due from non-resident property is therefore virtually lost. We are thus brought back to the subject of non-resident property holders; their properties lie generally unimproved and unproductive; they contribute very little, if anything, to the County Funds and Poor Rates; nothing whatever as a general thing to School Rates or Road work; held in this way, they are obstacles to the development of the County; the bona fide settlen are forced to take up land far from roads, and almost inaccessible to market; the public funds are frittered away in opening up new roads to their clearings; whilst miles of road are maintained through wilderness land thus held. In some of the Western States of the American Union. wilderness lands thus held are saddled with double taxation for all municipal purposes; whilst in Ont-rio the owners are afforded reasonable oppertunties of paying the taxes assessed on them, but if they fail or neglect to do so for three years, the property is put up to auction, and can thus at once be bought and brought into cultivation; a very decided improvement on the method prescribed in our law, of first stripping the land of its timoer and peles, thus rendering it valueless to the back-woods pioneer, and then selling it in portions.

When these tracts of land were originally granted, the grants were probably accompanied by some conditions implied or expressed as to improvement and settlement; and as no steps have been taken to this end, the lands should surely revert to the Province and be open for regranting and settlement.

If the Crown Lands of each County were transferred to the Municipality, with all the records and maps I believe that active Committees from the Councils would take up this whole subject, and would thus op in up vast tracts of lands for settlement, thus increasing the population without seriously increasing the expenditure, and a revenue would thus undoubtedly accrue from the sale of these lands.

I am aware that in making this proposition I am reverting to an idea formerly expressed by me, that the County Councils might very economically discharge much of the work now allotted to the Provincial Government. Equally I can see no reason why, if it was possible to assimilate the Criminal law of the Dominion and take its administration into the hands of the General Parliament, the civil law could not equally be consolidated and administered under the same authority, our Magistrates would then obtain all their authority from the one source and be responsible to the one head.

The withdrawal of these duties from our Provincial Legislature would leave it so short of work that it would soon be recognized that but little reason remained for its continued existence, and the present Dominion subsidy could be paid over directly to the several Counties, which, thus receiving from \$20.000 to \$25,000 yearly, could readily assume their share of what all now know as Provincial charges—Education, Hospital for Insane and Poors' Asylum.

All this must come before you for thought now, and for action in the not distant future. I there fore offer you these ideas now that we may be the better prepared to deal with this subject when it ripens so as to be dealt with.

As Town meetings for the Poor are abolished, it is desirable that a Standing Committee should be appointed to receive the reports and examine the accounts of the Overseers of the Poor; these reports and accounts should be published for the information of the rate-payers; and it would be well if the Committee would fully consider the working, and suggest any improvements they deem desirable in the method of dealing with the poor. Books have been supplied to the Overseers and a regular system can now be established and followed up.

It will be found that in some cases considerable sums remain in the hands of the Overseers, and a more preferable plan would certainly be that the amounts assessed on and collected in Districts, should be paid over by the Collector to the County Treasurer with the County Rates, and be placed by him to the credit of the particular District, and such sums as are from time to time actually required could be drawn by orders from the Overseers.

Resolutions, establishing Standing Regulations, are, from time to time, passed at our meetings; these are virtually Bye Laws, and as such should be submitted for approval and embodied in our Bye Laws.

In regard to the Jail, the regulations now in force might well be re-A fixed hour for admission might well be established, considered. especially for prisoners from other lock-ups; and as a new medical officer is now to be appointed, it seems very desirable that his duties might be It seems but right, and following the practice pursued everymore defined. where else that all prisoners on admission should be subjected to a medical examination, as it is manifestly improper that, by the compulsory association incident to imprisonment, contagious diseases should be imparted. The regulations, when so considered. must be submitted for the approval of the Judges of the Supreme Court. Dr. Woodill having resigned the Jail Surgeony, on removal from the Province, it will be necessary to appoint a new medical officer and I hand in an application from Dr. Trenaman, the only one I have received.

It would be well that the contracts for Jail Supplies should terminate with the calendar quarter, so that the accounts could be closed at the end of the year

As the Jailor and Turnkey are paid by the County, and are under the supervision of a Committee of Council, it seems fitting that they should be appointed by the Council and not by the Sheriff as at present. I believe the present Jailor attends to his duties with satisfaction to the Jail Committee. but occasion might arise when, in the interests of the rate-payers, the authority of the Council night require to be asserted, and it would be better that the alteration should be made now when all was smooth.

Regulations defining the duties of the Jailor and any other officials paid by the County and employed in the County buildings, should also be framed and enforced under the supervision of the appropriate Committee.

Again expressing regret at my unavoidable absence from your deliberations, and feeling assured that the interests of the District I represent, as well as of the whole County, will receive your fullest attention,

The following Resolution was moved by Councillor D. W. Archiheld seconded by Councillor Guild:

"Resolved, That in consideration of the excessive amount of labor imposed upon the Clerk, that he be authorized to employ assistance during each Session of the Council, such assistance to be paid out of County funds."

In the conversation which followed the Clerk said that at certain times it was impossible for him, though working 12 to 14 hours per day to over take the work of the three positions held by him, and the salary of \$1000 did not admit of his employing an assistant. His predecessor, holding but one office, was paid \$1,400 and extras, and had to have a clerk constantly. The Government had added new functions to the office of County Clerk, but did not provide any pay.

Moved in amondment by Councillor Chipman, seconded by Councillor N. Hayes, Jr.:

"That the Clerk have power to employ an assistant during the Sessions, or if required, at a salary of not more than fifty dollars per annum."

The amendment passed.

Moved by Councillor O'Leary, seconded by Councillor Fancy :

"Resolved, That any sums the County Clerk had to pay out of his salary during the past year for an Assistant, shall be made good to him out of County funds." Passed.

The Warden submitted a letter and Memorial received from the Warden of Antigonish County, relative to a reduction of the representation and expenses of the House of Assembly, and the abolition of the Legislative Council, and recommending united action of all the Municipalities thereoo.

After brief discussion, a motion to take action in the matter was superseded by an amendment moved by Councillor Jas. E. Shatford, seconded by Councillor Ryan :

"Resolved, That the documents just read be referred to the Committee on Law Amendments to report upon."

Amendment passed-16 to 11.

Read a letter from J. A. Mann, Esq., Hon. Secretary Halifax Cotton and Woollen Mills Company, enclosing their Prospectus, and asking exemption from all County Taxes for thirty years.

On motion of Councillor Ryan, seconded by Councillor Griffin, the let ter was referred to the Finance Committee to report upon to the Council.

Read a letter from the Chief Justice, referring to the necessity of increased court room accommodation, and being reply to one from the County Clerk prior to the meeting of Council, asking that the West Court Room be granted for that purpose, as formerly to the Quarter Sessions, the County Incorporation Act requiring the Council to meet in the Court House in January and May. The Clerk detailed a conversation on the same subject with his Lordship and the County Court Judge, but nothing definite resulted. F nding the room unoccupied for the present, he had named it as the place of meeting, but could not say when they might be called upon to vacate it, to make room for the Equity or some other Court

Moved by 'ouncillor Himelman, seconded by Councillor Hubley':

"That the letter lie on the table."

Passed.

Councillor Tupper presented a petition from P. R. Clarke, collector of taxes for District 21, asking that. having collected all the amounts in full for the past year, he be paid the extra $2\frac{1}{2}$ per cent. under such circumstances allowable by law. A discussion arose on the possibility of, by so granting the addition, establishing a dangerous precedent, inasmuch as collectors would be tempted in many instances to pay small accounts outstanding themselves in order to gain the additional $2\frac{1}{2}$ per cent. They might as well offer a premium for all public officers for faithfully performing their duty. It was stated in favor of the petition that such additional grant was perfectly allowable by law, had always been paid, was a fair and proper incentive to faithful and complete work, and thereby largely beneficial to the County.

The Warden read the section from Revised Statutes, 4th Series, Chap. 21.

Moved by Councillor Joseph Himelman, seconded by Councillor John D. Tupper:

"That $2\frac{1}{2}$ per cent, be allowed to all collectors who have collected the whole amount of assessment in their several districts for the past year, 1880."

Moved in amendment by Councillor Jas. E. Shatford, seconded by Councillor Jas L. Griffin:

"That this Council give no extra allowance to collectors in the future."

Amendment carried, 14 to 10.

On motion, resolved :

"That the applications for position of County Constables not passed upon yesterday be referred to Committee on Public Property."

The Council adjourned till 2.30 p. m.

WEDNESDAY AFTERNOON, January 12, 1881.

The Council met at 2.20.

Present-the Warden and 28 Councillors.

The Minutes of last meeting were confirmed.

The Warden submitted and the Clerk read a correspondence in May last between the Hon. Provincial Secretary, the Warden, County Clerk, and Hon. Attorney-General, on the subject of legislation promised by the Government in the Dartmouth case. The Provincial Secretary declines to proceed in the matter on the ground that the Court had not definitely decided the points brought up and that judgment had not been entered up as he had understood from the conference with the Special Committee of the Council.

After some explanations by the Clerk, the correspondence was ordered to lie on the table for further consideration.

Councillor John E. Shatford, seconded by Councillor Dean, submitted the following resolution, which was read :

"Whereas, This Council has, on various occasions, felt the necessity of having a legal adviser, as is usual with all such bodies;

"And Whereas, The unsettled state of affairs now existing between this Council and the Municipalities of the City of Halifax and Town of Dartmouth will accessitate the services of a legal gentleman in order to carry out the resolutions of this Council;

"Therefore Resolved, That this Council engage a legal adviser for one year, with the same duties to perform and under the same regulations as the Recorder of the City of Halifax, and that this Council regulate the salary to be paid him."

The mover made some remarks in connection, and read from the City Laws and Ordinances the functions and services of the Recorder, who acts in the capacity referred to above.

The discussion was continued by Councillors Griffin, Hubley, John E. Shatford, Ryar, Chipman, Himelman and others.

'A resolution to defer the matter to May was moved by Councilor Ryan, seconded by Councillor Griffia, and by consent of the seconder afterwards withdrawn.

It was then moved by Councillor Chipman, seconded by Councillor Leslie:

"That Councillor Shatford's Resolution remain over until to-morrow, and that the Clerk meantime ascertain from the several attorneys during the past year the amount of their claims against the Corporation."

Passed.

Read a letter from P. A. Fredericson, being a reply to the statement of the County Treasurer that he had refused to perform his duty as County Constable, and asking that the charges be investigated, his appointment rescinded.

Moved by Councillor Leslie, seconded by Councillor Himelman :

"That Councillors Jno. E. Shatford, Griffin and Ryan be appointed a Committee to investigate the charges brought against Mr. Frederickson by Justice Evans."

Passed.

Read a draft of an Act recommended by the Committee on Education, to be submitted to the next session of the Provincial Legislature, relating to the education of children at the Halifax Blind Asylum, and the defraying of expenses of poor blind children while at the institution by the Destrict or County to which they belonged.

On motion of Counciller Ilimelman, seconded by ('ouncillor Dean, it was referred to the Committee on Laws and Amendments.

The Warden requested the Clerk to submit and read the correspondence between the late Warden. County (lerk, Hon. Prov. Secretary and Hon. Attorney General on the title to the (ourt House, and vesting it and the Jail in Commissioners as required by Law.

From this correspondence, it appears that the public property of the County has not been vested as required by the Act of 1864 in any persons, but simply supervised and managed by a Committee of the Sessions and Council. No Commissioners were nominated by the Governor in Council mor appointed since the decease of the members of the first Board. The Hon Attorney-General opines that the investment cannot be made in the Warden, the Chairman of Public Property and the Chairman of Finance Committees, by official designation as requested, and on the names of certain Councillors being given, raises the objection that changes in the Council would probably result in the Councillors being removed, &c. The Act thus expounded is inoperative and the appointments cannot be nade.

On motion, the correspondence was ordered to lie on the table.

Councillor Chipmon, seconded by Councillor Hamilton, moved :

"That the Legislature be asked to change the time of the semi-annual meeting of this Council to the third Tuesday in April instead of in the month of May, as heretofore."

The motion was received and referred to the Committee on Law Amendments.

Ŋ

The Council adjourned till 10 a. m. to-morrow.

THIRD DAY.

THURSDAY MORNING, January 13, 1881.

The Council met at 10 o'clock.

The Roll was called, -the Warden and 28 Councillors present.

The Minutes were read. Considerable time was spent discussing the number of votes on the Treasurer's salary, Councillor Dean claiming there were 6 instead of 3 voting against the higher salary. The majority decided that the Minutes were passed yesterday and should stund confirmed.

Councillor John E. Shatford, Chairman, presented Report of Committee appointed to investigate the complaint of P. A. Fredericson on the statement made against him by the County Treasurer, as follows:

Report of Committee on Complaint of Mr. P. A. Fredericson.

Your Committee after a careful consideration of the charge, consider the office held by Mr. Fredericson as Deputy Sheriff is quite sufficient, and as his time is wholly occupied as such, he cannot conveniently attend to the duties of County Constable.

Moved by Councillor Jas. E. Shatford, seconded by Councillor Hubley

"Resolved, That the Report be adopted."

Councillor John E. Shatford presented the Report of the Committee on Roads and Bridges, which was read and discussed.

Report of Committee on Roads and Bridges.

Your Committee beg to report that they have gone carefully over the Road and Bridge appropriations, and find that there should be to the credit of this Municipality in the Provincial Treasury the sum of \$179 59, of which sum \$55.84 remains to the credit of some of the Districts, long undrawn by the Councillors of said districts to which it was appropriated. The balance is the amount reserved last May for cases of emergency, none of which was drawn. Your Committee have also gone carefully over the schedules of the various Districts. They furnish a statement of the number of bridges 20 feet span and upwards, with the aggregate length in feet. Also the number of miles of post roads and second class roads, as contained in the Schedules, which can be sent to the Government for any further information they need in reference thereto.

Your Committee had also laid before them a bill of \$5.50 from District No 26, for repairs to roads and bridges. Also one from No. 21 for \$-4 for the same service. Also one from No. 25 of \$7.50 for the same service. All of which they recommend to be paid out of the funds and forfeitures to the credit of their respective Districts at once.

The Warden submitted, and the Clerk read, the lengthy correspondence between the County and City officials in April, May and June last on the several points in the Local Act and the action of the Vity in refusing to give the valuation or make the Assessment for County Rates for 1880. The substance of this correspondence, in brief, is that the County Clerk made the regular legal requisition to the Mayor, as the Local Act provides, for the City valuation, so as to make up the whole County assessment, includ-ing the City and Dartmouth, as hitherto. The City valuation for the previous year was then taken as the law directs, and subsequently as advised by the Attorney General the valuation of the year, unofficially returned by the Mayor. The Assessment was thus delayed two months, and on the rate and amount being notified to the City, the Council refused to accept it on the plea that they had not received an answer to their enquiry as to what the details of their proportion of the Assessment were. The Estimate published by the County Council was furnished to the Mayor and the City Clerk and they were further informed that the services to be paid for were the same as in previous years.

On motion, the correspondence was ordered to lie on the table.

The Council then adjourned, to meet at 10 a. m. next day.

FOURTH DAY.

FRIDAY, January 14th, 1881.

The Council met in the Warden's Room (the Court Room being occupied), at 10 o'clock.

Present-the Warden and 27 Councillors.

Councillor Lapierre asked permission to set off two new Statute Labor Sections in District 28—viz, John Murphy's to Porter's Lake Road, and John Niforth's to main road. Also to correct the mileage of roads in his District, which was more than that calculated last year, being 30 instead of 21½ miles.

Moved by Councillor Griffin, seconded by Councillor Rowlings :

"That the applications be granted for changes in District 28."

Passed.

Moved by Councillor Fancy, seconded by Councillor Guild :

"Resolved, That the Council grant leave to extend District No. 24 up Moser's River, so as to include the new settlers in said District."

Passed.

The Lists of District Officers for the County, except these for Districts 17 and 18 (the Councillors for these being absent), were submitted, and handed by the Warden to the Clerk to be filed, and a certified copy forwarded with Assessment Roll.

The Clerk presented List of Officers for 1880 in District 18, with a note from Col. Laurie, Councillor, recommending their re-appointment.

The List was approved and filed.

Moved by Councillor D. W. Archibald, seconded by Councillor Jno. E. Shatford, and—

"Resolved, That the lists of District Officers for 1381, as prepared and submitted by the respective Councillors, be approved by this Council."

Passed.

The Revisors of Electoral Lists for the Revisal Sections in the County were then nominated and appointed for the year. The Clerk referred to the necessity of re-appointing some of the former Revisors, as the duty was an important one. Also mention that some difficulty occurred last Municipal Election in making up the voters list in District 31, which includes the residents of the Town who have no vote in such elections. The (lerk was empowered to arrange for details and copy of D. rtmouth Municipality valuations.

Moved by Councillor Jno. E Shatford, seconded by Councillor Burgess :

"That the Revisors be paid for their services the same remuneration as heretofore --six dollars each."

Passed.

Moved by Councillor Griffin, seconded by Councillor Shatford .

"That John Glendinning, the Revisor for Dartmouth last year, be re-appointed this year."

Passed.

Councillor Hublev presented a petition from the rate pavers in part of District No. 12. asking that an additional road section be established, viz. : from Wm Hubley's road to Benjamin Boutilier's. The petition was read and Councillor Shatford, seconded by Councillor Himelman, moved :

"That the prayer of the petition respecting change of road Section 12 be granted."

Passed.

Submitted, a petition from J. Lingley, Esq., J. P., for leave to erect a bay scale at Waverly, District 18.

Moved by Councillor Dillman, seconded by Councillor W. Guild: "That permission be granted."

Moved in amendment by Councillor Juo. E. Shatford, seconded by Councillor Burgess :

"Resolved. That Mr. Lingley's request respecting a hay scale be deferred by this Council until a petition of the inhabitants of the locality be received by this Council."

The Amendment passed.

Read, a petition from John Cox, District 35, asking that his name be removed from Assessment Roll of District 20 to that of District 35, he not being resident in the former as entered in error last year by the Assessors.

It was ordered that Councillor Dillman request the Assessors of District No. 20 to make the alteration and enter the petitioner as a non-resident of District 20.

Read, a letter from Judge Johnstone, dated 13th January, stating the inconveniences and want of accommodition for purposes of the County Court in the present Court Room, and asking for a conference with a Committee of the Council and Hon. Attorney General on the subject.

Moved by Councillor John E. Shatford, seconded by Councillor Burgess :

"Resolved, That the Committee on Public Property, with the Warden, meet with Judge Johnston and hold a conference, as per request in his letter."

Passed.

Messrs. Pugh and Harrington, M. P. P.'s, were present at the Council, and requested that the Road and Bridge returns be made as soon as possible, as it was important to have them in hand so that in the apportionment of

the Government road grant Halifax might be fairly represented. They also promised to assist in the legislation required when the subject should be under consideration in the House.

The Clerk enquired what the fee for Ferry Licenses should be for the year 1881.

Moved by Councillor John E. Shatford, seconded by Councillor Burgess:

"Resolved, That Ferrymen in this Municipality be allowed their Licenses free."

Passed.

Councillor D. W. Archibald, Chairman, reported verbally from the Committee on A. Drillio's matter, that the subject not being within their jurisdiction would have to be left to the Government to deal with.

Meved by Councillor Guild, seconded by Councillor Rowlings:

"Resolved, That the Report of Committee respecting A. Drillio, J. P., be received and adopted."

Passed.

Councillor Dillman presented a petition from District 20, Meagher's Grant, asking that a bounty be offered for the distruction of wild cate and bears in that district, which was read.

Moved by Councillor Himelman, seconded by Councillor Burgess, and

"Resolved, That the petition from Councillor Dillman's District respective bounties for bears and wild cats be referred to Committee on Bye-Laws."

Passed.

The boundary between Districts 13 and 23 being indefinite, Councillors Umlah and Ryan differing in opinion respecting the Road and Bridge outlay therein it was moved by Councillor John E. Shatford, seconded by Councillor Burgess:

"Resolved, That Councillors Christian, John Hays and Fitzgerald be a Committee to settle the disputed boundary between said Districts and report thereon."

Passed.

The Report of Committee on Law Amendments was submitted by the Chairman, Councillor James E Shatford, and read by the Clerk.

Report of Committee on Law Amendments.

To the Worshipful the Warden and Council of the Municipality of the County of Halifuz:

GENTLEMEN,-Your Committee beg leave to recommend-

That a respectful Memorial be prepared by our Warden on behalf 1st. of this Municipal Council, and presented to the Provincial Legislature at its next sittings, and also addressed to the Dominion Parliement asking that such changes be made in the Constitution of this Province as shall provide that each County shall be allowed to send but one Representative to the Provincial Legislature.

2nd. That a respectful Memorial be prepared by our Warden on behalf of this 'ouncil and presented to the Provincial Legislature at its next sitting, and also addressed to the Dominion Parliament, asking that such changes he made in the constitution of the Province as shall provide for the early abolishment of the Legislative (ouncil of this Province.

That Sec. 41 to 42 of the County Incorporation Act be amended 3rd. by modifying the Auditors' duties to simply auditing the yearly accounts.

That non-residents be liable for their proportion of Statute Labor, 4th. mailed notice to be considered sufficient.

That the Jury Fees be paid to the County Treasurer direct, who 5th. will certify the same for the information of the Prothonotary, who is desirous that the same should be done. By a reference to the Report of the Committee on Jury Fines and Fees, we find that the amounts paid to the County Treasurer for fines and fees to be so very small, when compared with the amounts paid out by him to Juries that some improvements in the law should be made respecting Juries, to compel litigants to pay their own Jury Fees in future, and further that the postponement of cases from day to day, after the Jurors have been sworn is entailing unnecessary expense upon the tounty, which in the future we are unwilling to bear.

That the appointment of the Jailor and Turnkey should be vested 6th. in the Council, as they are County Officers.

That in view of the large amount of work to be performed by 7th. Councillors, for which there is no remuneration, they be exempted from Statute Labor.

8th. That the Government allowance for Road and Bridge service be each year hunded over to the County Treasurer in order to avoid expense and inconvenience attending the present system.

Your Committee would further recommend that the day for the Semi-Annual meeting be fixed for the third Tuesday of April, instead of the day the law now provides.

All of which is respectfully submitted.

The Warden having to attend a conference with the Hon. Attorney General, on motion, Councillor James E. Shatford took the Chair.

Report of Committee on Disputed Boundary between Districts 13 and 23.

Your Committee recommend that the river and bridge in dispute between Councillors Umlah and Ryan be taken into Councillor Ryan's District, (23).

In examining the petitions of the several appellants, we find that only one has been made according to law. We therefore recommend that the Assessments of Districts No. 30 and 31 be sustained.

After careful consideration of Benjamin Colp's petition, which has been made according to law, we recommend that the Assessors and the appellant be notified to appear before your ('ommittee at the next semi-annual meeting of this Council, that your Committee may be able to hear and determine the case.

Your Committee beg leave to recommend that some mode be adopted by this Council whereby disputes arising on Assessments may be more easily and readily settled than the present way.

It was moved in amendment by Councillor Leslie, seconded by Councillor Tupper:

"Resolved, That the resolution passed by this Council on the 7th May, 1880, with respect to County moneys colletced by Samuel Gaetz, in East Chezzetcook, be enforced."

The amendment was put and carried by a large majority.

The Warden resumed the Chair.

The Report of the (ommittee on Public Property was submitted by the Chairman, Councillor Griffin, and read, as follows:

Report of Committee on Public Property.

To the Warden and Councillors of the Connty of Halifax:

GENTLEMEN, — Your Committee beg leave to report that they visited the County Jail and found everything in a satisfactory condition, and on inspection of the stock on hand, found them complete, as per inventory of Mr Chambers, Jailor.

Your Committee, from certificate of William H. Wiswell, County Clerk, find that the County Court House is insured in the Halifax Fire Insurance Office for the sum of \$10,000, and in the Lancashire Fire Insurance \$10,000, and the county Juil in the Royal Insurance Office in the sum of \$8,000.

Your Committee on considering the applications of Thomas A. James and John Sullivan for the office of County Constables, which have been submitted to them to report upon, beg leave to recommend that the said Thomas A. James and John Sullivan be appointed to the office of County Constable for the ensuing year.

All of which your Committee respectfully submit.

JAMES L. GRIFFIN, Chairman, B. W. CHIPMAN, EDMUND RYAN, NORMAN HAY3.

The subject of Assessments for the Poor in the various Districts was brought up. The Councillors handed in written requisitions, and the following appropriations were made by separate votes: District 7, \$60; 10, \$50; 11, \$100; 12, \$85; 18, \$250, 19, \$75; 21, \$110; 22, \$50, 23, \$15; 24, \$130; 25, \$150; 26, \$150; 27, \$30; 28, \$100; 29, \$61; 30, \$40; 21, \$100; 32, \$65; 33, \$110; 36, \$60. The Districts not named do not require any poor appropriation.

On motion of Councillor Jas. E. Shatford, seconded by Councillor D. W. Archibald :

"Resolved, That the Report on Public Property be adopted."

Passed.

The Warden made a verbal report of an interview with Judge Johnston and the Attorney General, who desired improved accommodation for the County Court, and promised to use their influence with the Government to have the Government pay half the expenses of the required improvements.

The whole subject was discussed by Councillors Jno E. Shatford, N. Hayes, Jr., Ryan Himelman, Jas. E Shatford, and others.

Moved by Councillor Jas E. Shatford, seconded by Councillor Burgess,

"Resolved, That the Committee on Public Property be authorized to have an estimate and plans prepared for the required improvements and building, the same to be presented at the May meeting of the Council."

On the vote being taken, it stood 11 to 11. The Warden gave the casting vote in favour of the Resolution.

Passed.

Moved by Councillor D. W. Archibald, seconded by Councillor Burgess :

"Resolved, That when the Government of the City and Dartmouth are prepared to bear their proportion of the cost of the additional accommodation required at the County Court House, the County Council will be ready and willing to co-operate."

Passed.

The County Clerk enquired whether Councillor Hamilton was present, and if so, to mention amount required for Poor Assessment for District 17.

Councillor Hubley mentioned that no motion had been made with reference to pay of Warden and Councillors for the present and special session. Action thereon was deferred till to-morrow.

The Council then adjourned till 11 o'clock a. m. Saturday.

FIFTH DAY.

SATURDAY MORNING, January 15th, 1881.

The Council met in West Court Room at 11 a.m.

Roll called, Warden and 27 present.

The Minutes were approved. In connection therewith, the Clerk stated that J N. Ritchie, Esq., had that morning moved in Supreme Court for final proceedings in the Dartm uth case, with the view of judgment being entered up. The Bench would consider the application and give decision shortly. Also stated that Dartmouth Town Council had not yet appointed a committee on conference, asked for on 12th inst.

Read letter signed Jno. C. Ross, containing objections, as agent of W. C. Henley, against the election of G. A. Leslie for District 26, on the ground that the piper used for ballots was not according to Statute.

- Moved by Councillor Ryan, seconded by Councillor Shatford :

"Resolved, That the letter from J. C. Ross, referring to the return of Councillor Leslie as Councillor, lie on the table."

Passed.

The Committee on Licenses reported through Councillor Burgess, the Chairman, recommending that Licenses be Thirty Dollars each for the current year.

Moved by Councillor D. W. Archibald, seconded by Councillor John Tough:

"That the License Fee remain at Forty Dollars."

The vote being a tie, (11 to 11,) the Warden gave the casting vote in favor of Forty Dollars.

Passed.

By leave of the Chair, Councillor Himelman moved in amendment the following resolution, seconded by Councillor Dillman :

"Resolved, That no Licenses for the sale of Intoxicating Liquors be granted by the Council for the present year."

Lost by vote of 15 to 7.

Councillor Shatford, Chairman, presented Report of Committee on Public Accounts and Finance.

Report of Committee on Public Accounts and Finance.

1. Your Committee beg to report as follows: They have carefully gone into the estimates for the year 1851 (our Financial position having already been laid before this Council, your Committee decided it unnec ssary to go over it again, and we have submitted for the approval of the Council the estimates for the various services of the County, a schedule of which is annexed hereto.

2. Your Committee regret to inform the Council that the various services and liabilities of the County cannot be paid by the Treasurer until he receives the money due by the City of Halifax and town of Dartmouth, as the amount due the Asylum is very large and as that service is largely, if not nearly altogether, owing for patien's from the city of Halifax and town of Dartmouth, they therefore recommend that, pending a settlement with the City and Dartmouth, no money be paid on account of the Insane Hospital.

3. Your Committee do not feel warranted in recommending or placing in the estimates any sum to increase the accommodation in the Court House until a fair and satisfactory arrangement be arrived at, with respect to the financial position of the (ity and County; but they do recommend that as soon as a fair understanding is arrived at with the Government, City, and Dartmouth that a sum sufficient to meet the requirements for the Court House be put in the estimates.

4. Your Committee have had laid before them an application from the Secretary of the Cotton and Woollen Mills Company, asking to be exempted from taxation should they erect their mills in the County, outside the limits of the city. Your Committee beg to recommend that, in the event of their erecting mills within the limits of this County, they be exempt from taxation for a period of twenty years.

Your Committee have had laid before them a Bill in form of a warrant from a Mr. Torrance, J P. for Tangier, for Ten Dollars and Fifty Cents (\$10.50, which we beg to recommend be not paid until the matter be fully investigated. The Committee feel that if they begin to pay such claims they will be establishing a dangerous precedent.

Your Committee also have had laid before them a Grand Jury list, in which they find many irregularities ;—one is that the Jury, by giving leave of absence to two of their number, failed to form a quorum, thereby not being able to go on with their work, through their own act, and then charging the County for their services. The Committee therefore recommend that the bill be not paid and they hope in future that no bill be paid unless the law in all cases be complied with. Your Committee recommend that stringent measures be adopted to collect all County funds due and outstanding. It will be seen by the annexed schelule of the estimates that the sum of \$20,693.00 is required to be assessed on the County for the present year, to which must be added \$8,214.00 for Schools, making in all \$28,907.00, being \$1,093.00 less than list year.

All of which is respectfully submitted.

We also recommend that the Auditors' pay be \$2.00 each, per day, while actually engaged auditing accounts.

TUESDAY MORNING, May 3, 1881.

As required by law and pursuant to notice, the County Council met at the Court House, in the County Court Room, at 10 o'clock, a. m.

The Roll was called. Present, The Warden, Councillors John Hays, Fitzgerald, Christian, James E. Shatford, Hubley, Chirman, Burgess, N. Hays, Hamilton, Madill, Tupper, Dean, Ryan, Fancy, Leslie, Lapierre, Urook, Griffin, Bissett, John E. Shatford, Himelman and Rowlings.-23.

The Warden took the Chair, and the Clerk read the Minutes of last meeting.

The Warden then addressed the meeting as follows :-

Gentlemen of the Municipal Council of the County of Halifax:

In calling you together to attend to your duties on this second meeting of the second Council of this County. I have thought proper to prepare a list of some of the most important matters to which your attention will be directed.

In accordance with a resolution passed at the last meeting of Council, I directed a memorial to be addressed to both branches of the Legislature asking for the abolition of the Upper Branch, and that the Lower Branch of the Legislature be reduced to one representative for each County. excepting Halifax and Picton, which Counties were still to have two representatives each These memorials were presented, and in both instances were ordered to lie on the table.

The report of Committee on Bye-Laws, which was unanimously passed at our last meeting, has been forwarded to the Attorney-General for his concurrence, and he has consented to their approval, with one or two trifling exceptions

The recommendations submitted by the Law Amendment Committee and approved by the touncil, were presented to the Legislature, but I am sorry to say that in only one instance was any notice taken of them, and that recommendation was accepted by a change made in the Incorporation Act.

In accordance with the resolution passed last meeting a Committee was appointed to meet with a 'ommittee that might be appointed by the Town Council of Dartmouth to try and arrange amicably the dispute b tween the two Municipalities. I directed a communication to be forwarded to the Warden of Dartmouth, but owing to a misunderstanding, that body refused to appoint such 'ommittee until quite recently; and had it not been for the e ection of Councillors and Warden for that Municipality to-day, such conference would have been held yesterday; But I can inform you that the present to uncil are anxious that such conference shall take place before the close of our present meeting. In the meantime our Attorney in the Dartmouth case has succeeded in getting judgment filed against that Municipality in the sum of upwards of \$15,000.

According to a resolution passed at the last meeting of the old Council, for the appointment of some person or persons to investigate claims for inmates of the Insane Asylum, chargeable to this tounty, I can say that I procured the services of William Taylor. Esq., for that purpose, and while he has been unable to fully investigate the whole number chargeable to the County, yet by his partial report, which will be submitted to you, it will be seen that, in his opinion, we are paying for quite a number that have no legal claim upon the tounty.

You will be called upon to carry out the provisions of an Act pased by the Legislature at its last sitting to amend the Incorporation Act of 1879. with respect to the appropriation of public money on Roads and Bridges.

Your attention will also be directed to a Permissive Bill which passed the Legislature respecting increased Court Room accommodation.

Upon application to the financial officer of the Government we have been informed that the amount to the credit of Halifax County for Roads and Bridges is \$6,587 for the present year. Since we last met the small-pox broke out in District No. 31, which was promptly attended to by Councillor Bissett for that District, and as the statute provides that any expense in connection with an epidemic of that kind shall become a County charge, a bill of costs will be presented to you for approval; and I think that the thanks of this Council are due to (ouncillor Bissett for his promptness in attending to it on its first appearance, and in his endeavors to make the expense as small as possible.

I am sorry to inform you that our financial condition has not improved since our last meeting. We have been endeavoring to meet the current expenses of Court House and Jail, but have been unable to pay anything whatever to the Board of Commissioners of Public Charities on account of our insane paupers. The amount due by the City remains unpaid, and there appears to be no immediate prospect of the City authorities being in a position to liquidate our claim upon them. It was expected that a Bill would have been presented to the Legislature at its last session empowering the City authorities to borrow money to fund their debt, and in this way our claim wou d have been paid, but these expectations have been thwarted, and it now remains for us to decide what steps shall be taken to relieve us from our embarrassing condition.

Your attention will also be directed to many other matters of minor importance.

The Clerk stated that the Attorney-General had caused that portion of the amendment to the County Incorporation Act relating to Roads and Bridges to be published in the *Royal Gazette*, copies of which were distributed among the Councillors.

Some emergencies arising from the recent storm had also been provided for in Districts 29, 11, and others.

Councillor James E. Shatford announced that in his district (No. 11) three bridges had been blown down in the storm of 15th April, and that under instruction from the Government be had taken tenders for the erection of the structures, and awarded the contract to the lowest tender, and that the work was now under way.

Councillor Crook presented an account of expenses of repairs of bridge in District 29 damaged by the same storm. The leader makes if said

All the road and bridge moneys granted by the Legislature from time to time for the road and bridge service shall be expended by tender and contract, or after competition by public auction, after reasonable notice, and by contract entered into thereafter, and in accordance with such contract. by the provisions of Chapter 45 of the Revised Statutes, Of Expenditure of Moneys on Poads," relating to contracts, shall apply to contracts to be entered into under the provisions of this Act, and the conditions and forms of agreement specified in said Chapter may be used for contracts to be let under this Act, but the provisions of said Chapter, relative to dispensing with tender and contract, shall not apply.

5. Sectious 9 and 45 of Chapter 1 of the Acts of 1880. entitled. An Act to amend the County Incorporation Act of 1879," are hereby repealed. Harrington, Stairs and Pugh, in which they state that their attention was called by the published reports of the Council, which stated that they had been appointed Supervisors of Highways in this 'ounty, and they continue as follows: 111 1,121,121,12, 4, 4112, 40, 50, 1113 "I "You are more fully aware than we can tell you of the evils which, for many years previous to our present Parliamentary term, were inflicted on our road and bridge service by the expenditure of such moneys being considered a part of the patronage falling to the lot of members of the Legislature." It is a matter of Provincial history that under that system the most extravagant expenditure was found to be necessary to keep up the efficiency of the service; and that the members were. in many cases, not free from the suspicion that political advantage guided them in the exercise of that patronage rather than a strict regard to economy. The County Incorporation Act, by removing the road and bridge funds from the control of the members and calling into existence the Municipal & Suncils of the Prevince; accomplished what we believe the whole country new recognizes as a most salutary and necessary reform. When the Councils had become established;

however, it was found that in some parts of the Province the evils which had been supposed to be eradicated were being repeated in an aggravated form : that, while the members of the House of Assembly no longer controlled the road and bridge grant and made them subservient to political ends, the Municipal Councils were charged with the same offence; that commissions were often promised to secure votes for Councillors, and at other times are given to reward the services of friends. It was also found that most of the councils had adopted the practice of dividing the grant among the polling sections of the ounties oftentimes giving the lion's share to the most populous and most thickly settled polling districts, which had the least need for a liberal allowance, because they had the statute labor to depend on, and leaving comparatively unprovided for the roads in large and thinly settled districts, as well as bridges on the dividing lines between sections. It was also found, that in spite of the experience of the past the wasteful system of expending the moneys by commissioners for small amounts was being continued. To remiedy these great evils the amendments of last Session were adopted. First, placing the expenditure of road and bridge moneys under the inspection of Supervisors, not more than four of whom shall be appointed in each (ounty, while the distribution of the funds were still to be controlled to a large extent by the Councils Second, requiring all works to be done under tender and contract. as is done in the other Provinces and in all well managed communities

We have to express thanks to the 'ouncil for our almost unanimous election as such Supervisors. We feel that it is a gratitying expression of confidence and an assurance that we, at least, are entirely free from the suspicion that in our hands the road and bridge grants would be likely to be distributed as some previous members of the Legislature are charged with having distributed them, with a view to securing political power.

We accept it likewise, as an assurance that our administration of the road and bridge grant, while it was in our hands in 1479 (and to a limited extent under the special grant of 1×80) wis acceptable to our constituents. While we would be g'ad to be of service to the County in any position, we feel " however, that there are strong reasons, why we should not accept the honor which you have conferred on us. In the first place the appointment of the members for a County to any office by virtue of which they would necessarily have control of the road and bridge grants, would be a departure from the policy which brought about the County Incorporation Act of 1>79, and should only be sanctioned in cases of urgent necessity., In the next place such an appointment might be a precedent dangerous to be followed if the representation of the County should fall into the hands of persons whom the ouncil would not be willing to appoint so cheerfully, and by so large a vote as that by which we learn we are elected; In the third place we feel that, as we are all residents of the incorporated City of Halifax and Town of Dartmouth. the outlying and thinly settled sections of the County might fear the want of attention and due consideration which they experienced, it is said, under the system by which the largest and most influential polling sections obtained the larger proportion of the grants. For these reasons we beg to call your attention to section 17 of chap. 1 of the Acts of 1879 which provides that members of the Legislature shall be exempt from serving in any municipal office unless with their own consent, and to decline with thanks the honor which the Council has proposed to confer upon us."

Your Jom nittee have visited the Jail regularly, weekly and monthly, in turn, have found the prisoners carefully taken care of, and the premises clean, and the Jailor attentive.

Your Connittee, in examining the Doctor's Report, would recommend that some measure may be arrived at, whereby persons sent to the Jail in a state of intoxication may be compelled to pay for such medicine as they may require while there, if in a position to do so.

Your Committee have examined the failor's Reports, and find them cerrect, which shows a large proportion of Prisoners committed are from the City of Halifax and Town of Dartmouth, as follows, viz., City Court, 65; Dartmouth, 10; County Magistrate's Court, 25; Supreme and County Courts, 33; and of these numbers, there were 59 Criminals and 74 Debtors.

The Jailor's detailed statement and the Surgeon's Report were enclosed.

The Surgeon states the ventilation and sanitary condition of the Jail and surroundings and the health of the prisoners to be generally good. Only a few surgical cases required attention. With reference to committals for prolonged drunkenness and delirium tremens, he says : "Many are able to pay, but all expect free board. medical attendance and medicines. These are a class of cases which cause a great deal of trouble, and are attended with no little responsibility. They are usually committed as a matter of safety, as well as convenience to their friends, and I would recommend to your Council that some measure be devised by which a suitable charge shall be made for maintenance, and that they be expected to pay for medical treatment and such medicines as they may need." On motion, the Report, including the Jailor's and Surgeon's Returns, was adopted.

The Chairman of Road and Bridge Committee submitted the amended Road Scale, by which District 31 receives \$62 more than first allotted, that amount being deducted from various districts. Memonial to the Legislature,

Referred to in Report of Law Amendment Committee, January, 1881.

To the Honorable the Legislative Council of the Prevince of Nova Scotia in Annual Session now convened,

The respectful Memorial of the Municipal Council of the County of Halifax, HUMBLY SHEWETH:

That the changes which have resulted since the Union of the Provinces, and subsequent measures relating to Dominion and Provincial affairs have so greatly reduced the labor and responsibilities of Members of both Branches of our Legislature as to render a diminution of the number and pay of Members of the House of Assembly, and the cessation of the functions and constitution of the Legislative Council under existing financial conditions both desirable and necessary.

Your Memorialists respectfully present that the continuation of the Upper House as a separate body is not now requisite, not merely on financial considerations, although these are now of paramount importance, but they also submit that less complex and extensive machinery of Government would be sufficient for the present and future requirements of the Public Service.

The Province of Ontario has progressed successfully with but one Chamber; that of Prince Edward Island and the adjoining Province of New Brunswick have initiated similar measures as Governmental principles essential to the interests and general welfare of their people, and as retrenchment and other essential conditions demand such change in this Province, Your Memorialists respectfully ask Your Honorable House to adopt such early and effective proceedings as will be requisite in order to limit or reduce the Legislature, so that there shall be the House of Assembly alone, composed of Twenty Members,

To the Honorable the Members of the House of Assembly of Nova Sectia in Provincial Parliament now convened,

The respectful Memorial of the Municipal Council of Halifax County, HUMBLY SHEWETH:

That in the past few years important changes have been made in the Constitution of this Province by which as well as by the direct Legislative action of your own body much of the responsibility hitherto attaching to the Provincial Legislature has been relegated to other bodies, and especially as the Road and Bridge Service of the Province is now attended to by the several County Councils, Your Memorialists present that it is no longer necessary that the several Counties should have so large a representation in Your Honorable Body nor that the services required of that body require so large an expenditure of public funds for its maintenance.

Your Memorialists therefore humbly pray that such changes may be at an early day effected as shall provide that each County shall have but one representative, with the exception of the Counties of Halifax and Pictou, which shall have each two members to represent them in Your Honorable Body, and that the pay of each representative shall not exceed Five Dollars per day, and not more than Two Hundred Dollars per Annual Session, in addition to Travelling Expenses, going to or returning from each Session of the Legislature.
