### ANNUAL MEETING.

### January, 1902.

The January Session of the Halifax County Council was opened on Tuesday, Jan. 14th. All the Councillors, thirty-two in number, were present and were sworn in. The business was commenced at noon. The first business proceeded with was the election of a Warden. B. C. Wilson, of Waverley, and G. H. Madill, of Gay's River, were nominated. When the ballots were counted it was found that Mr. Madill had been elected, he having received eighteen votes and Mr. Wilson iourteen votes.

The new Warden thanked the Councillors for the honor done him, and he hoped that they would co-operate with him in carrying out the business as satisfactorily and as speedily as possible during the session. The Council then adjourned for lunch.

When the session was resumed in the afternoon, Chas. E. Smith, of Sambro, was elected Deputy Warden.

Norman H. Oakes' application was leferred to the committee on licenses, 28 his paper did not bear the required aumber of names. The application of Thomas Hamm for a hotel license at Upper Prospect was also referred to the license committee.

The License Inspector's report showed that the total receipts were \$1,625, and the expenses \$776.67, leaving a balance in favor of the municipality of \$848.33.

During Mr. Sedgewick's term of office fifty-five cases were prosecuted, which there were thirty-five convictions and eighteen dismissals. Twenty-nine of those convicted paid their fines. Mr. Sedgewick was re-appointed License Inspector.

The Council adjourned at 4.30 to meet on Wednesday morning at 10.30.

#### WEDNESDAY MORNING.

The Halifax County Council resumed business Wednesday morning at 10.30 o:clock, with the Warden, Geo. H. Madill, in the chair. The first business taken up was the report of the committee appointed to nominate standing committees.

#### Coroner's Constable Report.

. Chief County Constable Burbridge applied for reappointment.

Coroner's Constable Spencer reported eighty-five deaths during the year attended to by the different parties on the certificate of the Medical Examiner.

Joseph Spencer and W. H. Snow applied for appointment as Coroner's Constable. Mr. Spencer was re-appointed.

#### Jail Keeper's Report.

The report of W. L. Malcolm, keeper of the County jail, was real as follows:

During the year ending December 31st last 266 criminals and 47 debtors were committed to the jail, 38 of the criminals being females. The total was five above that of the previous year. The largest number of prisoners in the iail at any one time during the year was 35. Oakum picking was the only available employment for the prisoners and that had to be stopped for a time during the year until the surplus stock could be disposed of. Of the 313 prisoners committed 209 were from the City Court, 34 from the Supreme and County Courts and 15 from Dartmouth.

The money received from the sales of oakum, room rent, boarding deserters, etc., was \$141.50. There had been one death during the year. The conduct of the prisoners generally was good.

#### Peddler Inspector's Report.

Peddler Inspector Harry Wright reported that during 1901 39 peddler's licenses were taken out as against four in 1900, and the receipts amounted to \$346, as against \$39 in 1900.

Councillor Caufield raised the question as to what constituted a peddler. thought the by-law was faulty. The matter was referred to the committee on law amendments.

Clerk of License Parker Archibald recommended the appointment of assistant clerks in different parts of the County to issue licenses when required and expedite the enforcement of the peddling license by-law. He agreed with the Inspector that those who have taken out licenses are of a more respectable and responsible class that some of the peddlers who formerly travelled through the

### WEDNESDAY AFTERNOON.

The session was resumed at 2.30. A letter was read from C. E. Puttner, of the Victoria General Hospital, offering to supply pure vaccine at a moderate cost to any district in the County where it might be required. On motion of Councillors Flemming and Morien, the letter was placed on file.

Under the Stipendiary Magistrate's Act now in force the jurisdiction of the Magistrate extends over the Municipality, Hallifax and Dartmouth, and is not confined to the Municipality as heretofore. On account of possessing greater jurisdiction he was called upon to deal with cases which did not arise within the Municipality. In four of these cases the County received a substantial amount in fines. There were quite a number cases arising in the city and Dartmouth, however, which brought in no financial returns and yet the Magistrate was required to deal with them by virtue of his office.

During the year a large number of complaints were settled to the satisfaction of the parties concerned without the issue of papers. The Municipality was thus saved considerable sums which otherwise would have been expended in constables and witness fees.

The Magistrate has sought to assist Supervisors of Roads and Collectors of School Rates by the issue of warrants and otherwise to collect rates and taxes and gave special attention to the enforcement of the by-law relating to peddlers.

On account of the offences having been committed in the more distant parts of the County, and the local magistrates through other duties being unable to try the offenders, at their request and under instructions from His Honor the Warden, the Magistrate made four trips along the eastern shore, and determined the cases. The punishment of the offenders taught them and others to have a wholesome respect for law. The testimony of the leading men of the districts is that the regular visits of the Magistrates have caused a decrease in crime.

The Magistrate in closing his report desires to state that he is at all times ready to advise with members of the Council and county and district officers in regard to all matters relating to the welfare of the Municipality and to assist them in the solution of any difficulties that may arise in the performance of their duties.

#### County Jail Physician's Report.

The report of Dr. Trenaman, physician to the County Jail, was read as follows:

His Honor the Warden and the Councillors of the Municipality of Halifax County:

Gentlemen,—I herewith submit my report, as physician to the Halifax County Jail, for the year ending Dec. 31st, 1901:

There have been more than the usual number of cases under treatment during the year, most of them of a light character and due to conditions existing previous to their entering jail—such as chronic ulcer, rheumatic pains, heavy colds, etc.

One death occurred among the prisoners. On May 27th, James Lacy, aged years, while talking pleasantly with his companions, suddenly fell to the floor dead. The Medical Examiner investigated the case, and the post mortem revealed a rupture of the heart.

Several severe cases of delirium tremens gave much anxiety and necessitated careful watching.

Three insane persons were committed, all of whom were sent to Mount Hope Hospital.

Certificates of good health were prepared for and sent with all prisoners under sentence to Dorchester Penitensiary, as follows:

The jail building and fixtures are now in good condition, and the plumbing, sewerage and sanitary requirements generally, are satisfactory. The building has been kept clean, and the cells and corridors well lime washed. The food supplied has been of good quality and well cooked. The jailer, matron and turnkey have been thoughtful of the needs of those sick and attentive to their wants.

#### Canadian Forestry.

The following letter to the Warden of the County of Halifax was read and placed on file:

#### Halifax, 2nd Dec., 1901.

Dear Sir,—As the Nova Scotian repretative of the Canadian Forestry Association, I am asked to obtain for our annual meeting an estimate of the injury to the forests of this Province during the past year.

1. I will therefore be much obliged to you if you send me at your earliest convenience (a) the location of all forests fires you know to have occurred during the year, (b) an estimate of the average of square miles of forest injured, and (c) any information about the origin of the fires and the character of the destruction.

2. We are endeavoring to learn how our forests may be most economically stimulated for the production of the most useful woods, for the utilization of what would otherwise be barren lands, and for the improvement of climatic and general conditions with respect to (a) Government lands, (b) extensive private forests, and (c) forests or woodbelts on farm lands.

I shall be glad to know if you will be willing to make suggestions and to consider schemes which may be proposed for

such purposes. An early answer will oblige.

#### THURSDAY MORNING.

The Municipal Council resumed its session Thursday morning at 10.30. The Minutes of Wednesday afternoon's session were read and approved.

The report of the Revisors was referred to the committee on assessment.

This being the last day for presenting petitions the Clerk notified the Council to that effect.

#### Letter from Mayor Johnston, of Dartmouth.

The following letter was read by the Clerk:

Dartmouth, N. S., Jan. 13th, 1902. His Honor the Warden and Councillors of the Municipality of Halifax:

Gentlemen,—At the present time this town, as far as I am aware, is totally free from the sale of intoxicating liquor, due to the vigilance of our License Inspector, who is very prompt in having any violation of the License Law promptly punished.

It has not been without a great deal of trouble that this most desirable state of affairs has been reached, which while primarily in the interests of the Town, is also a benefit to the county at large.

Allow me to call your attention to the fact that the efforts made by the Town in this regard are to a certain extent nullified, owing to places existing outside the town and under your jurisdiction where, I helieve, liquor is freely and openly sold, contrary to law.

May I, as one of your own ratepayers, as well as Mayor of this Town, say that I feel sure that when this matter is publicly brought to your notice you will take such steps, at your present session, as may seem most advisable to close up the places complained of, and thus remove from your midst a great danger to the morals of the men, not only of this municipality, but of your own as well.

In reference to this letter the Warden said that he had heard a great deal of complaint about this matter and thought that perhaps a detective might he appointed to look into it.

Councillor Negus said that the whole thing was very hard to get at as the people in the district will give not information concerning it. Further he thought that there was much more drunkenness in the neighborhood of Fort Clarence.

Inspector Sedgewick said that the day after he took office he received a letter

search with Constable Burcomplete bidge and found nothing. He was again later on, but nothing dewritten to finite was in the information. At exhibition time he was again informed that if he went quietly without any chance of the parties in question getting wind of it, he would find liquor. He did so and found nothing.

On the first search there was a slight smell of ale, but afterwards not even a smell. He felt satisfied that nothing of an intoxicating character had been there.

#### Little River Petition.

The following petition was then read:

To the Warden and Councillors of the Municipality of Halifax County:

The petition of the undersigned ratepayers of Little River and Chaswood, in the County of Halifax, humbly showeth:

That the road leading from Chaswood to Little River is in a very unsatisfactory and dangerous condition; that it is the most direct route from Little River to Stewiacke Station; that the present road is a very heavy and continuous grade, making it extremely hard to haul loads up and dangerous to come down; that your petitioners believe that an easier grade and safer road is available without much expense by taking the line of the old Ervin Road so called, to the old line of main road, thence, westerly hy said old road to the mouth of the Meadow road so called, thence by said Meadow road to the junction of the present road, a distance of about one half mile. Your petitioners humbly ask that a precept be granted to Hervie Grant and Geo. H. Taylor, farmers, both of Chaswood, in District No. 21, for laying out such change of road, it heing understood that the cost of such laying out shall be a District charge.

#### the Nova Scotia Memorial of Eastern Railway Co.

The Clerk read the following letter:

Whereas, a charter has been granted by the Legislature of Nova Scotia to the Musquodoboit Railway Company, Limited, which, with amendments thereto authorizes the said Company to build and equip a line of railway heginning at some point on the Intercolonial Railway near Windsor Junction; thence easterly the eastern sections of the through County of Halifax, by way of the Musquodoboit Valley to the County line of Guysboro County, and thence to a point in the St. Mary's Valley, where a railway to be constructed from a point in the County of Pictou will intersect the railway first hercin described;

And whereas, a charter was also granted by the said Legislature to the Nova Scotia Eastern Railway Company, Limited, to huild and equip a railway from a point on the Intercolonial at or near New Glasgow, in the County of Pictou, to the said point of junction in the Valley of the St. Mary's, and thence hy way of Country Harbor, in Guysbord County, to the Strait of Canso;

And whereas. the said Nova Scotia Eastern Railway Company, Limited, and the said The Musquodoboit Railway Com-Limited, have been amalgamated pany, and united under the name of the Nova Scotia Eastern Railway Company, Limited, which united Company has undertaken to construct both lines of railway hereinbefore described;

And whereas, the charter incorporating We the undersigned, hereby give notice the said Nova Scotia Eastern Railway Company, Limited, provides that it shall he lawful for the Company to receive from any Municipality through which the said road shall pass, any real or perAnd whereas, the Municipality of the County of Halifax is desirous of assisting the construction of the said railway by paying the necessary damages for the right of way thereof;

Therefore resolved, that the lands to be taken or acquired in the said Municipality of the County of Halifax for tracks or station purposes and for terminal facilities for the line of railway and branches to be built by the said Company, as so amalgamated, that is to say, by the said Nova Scotia Eastern Railway Company, Limited, beginning at some point on the Intercolonial Railway near Windsor Junction, and thence easterly through the eastern districts of the County of Halifax by way of the Musquodoboit Valley to the County line of the County of Guyshoro, be and become a charge upon the Municipality of the County of Halifax, and the acquisition of such lands is hereby authorized.

Re the electric tramway on Bediord road, some discussion was caused over the fact that the proposed road might be a nuisance to passing teams. Several of the Councillors desired more information on the scope of the Act in question, and Councillor Canfield offered to bring his solicitor before the Council in the afternoon to explain the situation.

#### Dr. Sinclair's Report.

A report from Dr. Sinclair was in reference to the inspection of public, humane and penal institutions and also copy of the Act under which he proceeds were read.

The letter was as follows:

#### Halifax, Nov. 12th, 1901.

W. H. Wiswell, Esq., County Clerk, Halifax, N. S.:

Sir,—I enclose you a copy of the Act referring to the Inspector of Humane and Penal Institutions and in accordance with the duties therein mentioned ask that you will bring to the attention of the Council at its next meeting the following matters:

1st. The rules at present in force at the County Jail are not in my opinion sufficient or satisfactory. I have to request that others more modern and in keeping with the prevailing present day ideas be compiled. I would suggest that those which have been drawn up by the County Stipendiary as far as they go will meet with my approval.

2nd. I must ask that the system at present practised of having the turnkey visit the corridor occupied by female prisoners, be discontinued and that for the future the matron have the supervision and control of female inmates and that except in her company, no male cffcer of the jail be allowed to visit the part of the house occupied by female prisoners.

3rd. I consider it essential that bath tubs with hot and cold water and proper fittings should be installed at once in jail and that all prisoners be regularly bathed, at least once a week.

4th. I think that sheets should be provided for all the beds and changed at least once a week. The sanitary needs of the prison require this.

There should be provided a hook in which the Physician should record the date and hour of his visits, a brief account of the nature of the disease of every prisoner requiring treatment, and his instructions respecting diet, medicine, etc. This to be signed by the Physician. At intervals he should also inspect the sanitary state of the whole building and enter in his journal his opinion, with any suggestions he may have to make regarding changes and also as to the quality of the food, the suffciency of the prisoners clothing, bedding or other matters.

6th. There should be a diet scale arranged for the different classes of inmates, viz.: Adults, male prisoners awaiting trial, adult prisoners sentenced to hard labor and for women and juveniles under fourteen years of age.

7th. If they do not already exist there should be rules for the prisoners getting exercise in the open air every fine day unless the sentence forbids this.

Councillor Wilson said that vested rights had already been encroached upon. The road in some places was now very narrow, particularly about the hotel at Rookingham.

At the request of the Council Mr. Mc-Neil read from the Revised Statutes the provisions contained in the Charter which had heen granted to the Company.

Councillor C. E. Smith said that it would he well not to pass any resolution hastily. He thought it advlsable to first ascertain what liability the County would incur and to what extent the County would share in the profits, if any. The removal of snow was also an important matter, which should be earefully looked into.

Councillor S. Lydiard asked if the Municipality would be liable for damages in event of any accidents along the narrow road.

Mr. McNeil said that the road would be wide enough to prevent any accidents on the Company's part.

Councillor C. E. Smith said that the valuation of lands that might be appropriated by the Municipality should be obtained.

Councillor Wilson said that if it was the intention of the Company to place its track in the centre of the road, then it was time for the Council to stand out and not grant the request. He was not opposed to the Tramway taking one side of the road.

Councillor McMullen suggested that the Company take one side of the road, and leave at least 21 feet for public traffic.

Councillor Taylor said he thought that there might be a conflict of authority between the Company and the road overseer over the keeping up of the road.

On motion of Councillors C. E. Smith and McMullin the whole matter was deferred until next Tuesday at 11 o'ciock, so as to allow the Council to get further information.

Councillors John S. Flemming and S. W. Lydiard were appointed a committee to revise the Minutes of the Council.

If action was taken a road master living on the road would be enabled to more carefully oversee the road and make necessary repairs from time to time.

> When the road was laid out as a public road the understanding was that the land owners were to have the pripilege to keep gates on said road such has been the case and your petitioners still desire the same privilege.

> The distance of the road that your petitioners ask for a separate road section is one and a half miles in length.

> Your petitioners would therefore pray that your Honorable Council will grant their request and cause such road to be made into a separate road section.

#### Petition for a Precept.

The following petition was read:

Windsor Junction, Jan. 6th, 1902.

To the Warden and Members of the Halifax County Council:

Gentlemen,-We, the undersigned ratepayers of Windsor Junction and Fall River, in District 17, petition your Council to have a precept granted to lay out and survey a new piece of road from Windsor Junction to Grove siding, a distance of two miles. The petition was signed by 39 property owners of the district.

On motion of Councillor J. II. Taylor, seconded by Councillor Stewart, the following resolution was passed:

That the bridge at Murcheyville, in District 21, be placed under the Bridge Act of 1883, and amendments thereto. The old bridge being very rotten and not fit to stand repairs and the re-building of the said bridge will require a larger expenditure than can be afforded from the ordinary allotment of the public property.

On motion of Councillor Wilson, seconded by Councillor Croucher, the following was passed:

That the resolution granting Janitor Smith \$50 per year for services in cleaning the offices in the Court House he retrospective hack to 1st January, 1901.

#### Petition from District 15.

The following petition from Thos. Mitchell, Geo. VanBuskirk, Jos. Archibald and others of District 15, was read:

To His Honor the Warden and Members of the Council of the Municipality of

Halifax County, in Council convened: The Petition of the undersigned catepayers of District 15 respectfully sheweth:

1. By a resolution passed by this Council on or about the 3rd day of April, 1900, and by a subsequent resolution passed on or about the 3rd day of April, 1901, the read from Tannery Bridge to the Sackville River and all the side streets of Bedford Village were placed under a Commission of three persons, under the provisions of Chapter 23 of the Acts of Nova Scotia, 1900.

2. Your Petitioners, after careful consideration of the matters herein stated, are firmly of opinion that the operation of said Act, in District 15, has been a failure and that its provisions have been insufficient and inadequate for the improvement and better maintenance of our roads, and that it is in the interests of District 15 that said resolutions should be reconsidered and rescinded and that

the Commissioners so appointed shall he deposed from their position.

3. Your Petitioners believe that sail Act has been a failure for the following reasons:

(a) The result of two years' operation under the Commission has proved unarisfactory to the public generally. The roads have not been maintained and ken in as good repair as they would have been if provided for under the Road Act as formerly.

(b) The provisions of the Act are to general, and operations under it us conducted in a very loose manner. The duties of the different Commissionen, where there are more than one, are not defined, and in consequence the greated confusion has arisen in this District. Persons have not been served with notic for labor on the highways and generally the matter of the maintenance of the roads has been grossly neglected. Indeed, the Act is practically unworkable and the roads of District 15 are suffering in consequence.

(c) No oath of office is required of the Commissioners, as it is of Supervisor and Road Masters and other officials.

(d) Too much power is given the Commissioners by the Act. For example, your Petitioners do not think that the Commissioners should be empowered thereas money.

4. Your Petitioners further believe the the said resolutions should be reconsiered and the Commissioners appoint thereunder be deposed from their position for the reasons:

(a) The Commissioners are not precal road builders and have not had a experience as such heretofore. They men whose duties require them to their offices in the City of Halifax and as a consequence they are seldon be found in the District during the The result is that the roads receive of their attention.

(b) The Commissioners have tractine duties of their office with internet. They have been inactive and gent and have failed to perform duties required of them. In many stances persons have never been moned for lahor on the roads and other instances where persons have summoned the Commissioners failed

attend on the highway in order to oversee the work; and again, little or no effort has been made by them to collect commutation. Thus has much money and labor been lost to the roads of this District.

(c) The roads have not improved under the Commissioners and in many places they are exceedingly rough and uncared for. Many instances might be cited where the Commissioners have neglected to repair the roads and small bridges. For example, there has been a large hole in the bridge opposite the premises of J. E. DeWolfe, Bedford, for the past five months and the attention of the Commissioners has been called to this matter time and time again, but they have refused or neglected to have the same repaired. The bridge is still unrepaired and in a dangerous condition, and more than one accident has occurred there. This incident is characteristic of the manner in which the Commissioners have been fulfilling the duties of their office.

(d) Work has been done on the roads in October and late in the fall, when it could have been done better and more economically earlier in the year.

(e) Soil abd road materials are suffered to be carted from the roads to the premises of one of the Commissioners and it has frequently been necessary to cart like road materials from distant parts back to the roads from which materials and soil had been previously carted by the Commissioner as above stated.

(f) Material from the stone crusher has been used to build a walk over the private property of one of the Commissioners when needed on the roads.

(g) The work done  $b_{\nabla}$  the Commissioners could have been done better and more economically.

(h) No report of the operations of the Commissioners for the year 1900 has been presented to this Council, as required by Section 7 of this Act.

(i) The Commissioners have been negligent and remiss in their duties, and for further evidence of this your Petitioners would respectfully refer you to the letter of Lewis L. Dixon and others and the report of your road and bridge committee thereon, to be found in the Minutes, and report of this Council at pages 49 and 51 respectively, as published for the year 1901.

Wherefore your Petitioners humbly pray that this Council will see fit to reconsider and rescind the resolutions and appointments hereinbefore referred to and your Petitioners, as in duty bound, will ever pray.

#### Henry Heather's Protest.

The following letter from M. H. Guild, assessor of Middle Musquodoboit, together with a statement from Henry Heather, were read.

#### To Halifax County Council:

Sirs,-Having been informed that Henry Heather has protested against his personal assessment, I would say that the property we found to assess was turee steers, 4 years old, which we assessed \$20.00 each, they pastured on the place all summer; and also a brow of logs in his pasture, about 150,000 feet, which we assessed \$150.00, and over 300,000 of deals which we assessed \$320.00. We thought we were justified in assessing the logs and deals.

I, Henry Hcather, hereby declare that I believe myself unjustly assessed in that I am rated for personal property in District 21, in the municipality of Ilalifax County. That the personal property thus rated was at the time the assessment was made in District No. 15, in the County of Cumberland, and was then appraised. I, therefore, feel that I have no just right to be assessed or the same goods and chattels in two places in the same year, and humbly ask that such wrong may be righted by cancelling the charge against me for personal property in District 21, aforesaid.

And I make the foregoing statement, believing the same to be true.

That the road in Section No. 2, in District No. 32, leading from the main post road to Wm. Kennedy's on Boutilier's Point, a distance of 63 chains, also including the branch of said road leading to Abel Boutilier's, he made a separate road section and to be known as Section  $2\frac{1}{2}$ . The motion passed.

The following resolution: moved by Councillor Milne and seconded by Councilor Taylor, was passed:

Whereas, by the vote of this Council the Revisal Districts has been changed by adding District 35 to District 13 and 20, and under the old arrangement two revisors were appointed from District 20, and now there being two Revisors appointed from this District;

Therefore resolved, that J. D. Bayers' name be dropped from the list of Revisors for the present year, and that he be notified of such a change.

#### Petition from Clam Harbor.

The following petition was read and on moticn of Councillors Lydiard and A. F. Smith, it was referred to the Road and Bridge Committee. The petition was signed by seventy-eight residents of that vicinity.

To the Municipal Council of the Municipality of Halifax County:

This petition of the inhabitants of Clam Harbor and vieinity humbly sheweth:

That there is a great need of a road on the east side of Clam Harbor aforesaid extending along the shore from the present end of the road at Stephen Drake's on to David Ricbardson's, and that such road would be not only a great convenience to the settlers along this shore, but an absolute necessity.

Now the prayer of your Petitioners is that your Council would he pleased to make a grant sufficient to make a road in this hitherto much neglected part of the country and your humble Petitioners will, as in duty hound, ever pray.

#### Bridges in District 18.

Councillors Wilson and Croucher moved the following resolution. That the following bridges in District 18 be placed under the Small Bridge Act of 1900, viz.:

1. The hridge on the Guysboro road, near Robert Lang's, which is about 35 feet span and 20 feet high.

2. The bridge on the Truro road, socalled, between Enfield bridge and Elmsdale bridge, known as the Black Brook bridge, of 30 feet span.

The clerk read the following letter:

#### Petition From A. J. Reid.

To His Honor the Warden and Members of the Municipal Council, Halifax:

Gentlemen,-

In looking over the assessment roll for District 21 I find that the injustice of two years ago has been repeated. In that year I was assessed for income, the larger portion of which I neither earned nor received, having left the road early in the year, and I am again assessed this year for an income that is purely speculative, as my contract which I encose herewith will show. And further, I gave my house notice some three months ago of my intention to leave the road at the end of March. However, this is uncertain. I would not object to being heavily assessed if others were similarly treated, but it is a well known fact that both in District 21 and other Districts in the Municipality other men whose incomes are known to he larger than mine is supposed to be escape the income tax altogether. To show more clearly the injustice done me a reference to old assessment rolls will show that, five or six years ago I was aswhile sessed some \$900.00 or \$1,000.00 investments of income (in many cases before earned) have brought my assessment this year up to \$3,200.00, inclusive of interest in husiness of Arch & Reid. \$450.00 this amount is for property lately purchased in North School Section, which property is represented in this year's income, and you will see at a glance that the practical result of this is that I am assessed twice for the same dollar and I am every year carning money to pay for property on which I am already paying taxes, having continually invested my income in advance of its being earned again.

My neighbor and I own adjoining farms; he works his farm himself, while I go away and earn the money to pay two men to work mine and hy so doing develop it in such a way that I must pay taxes on the improvements and also for the money which paid for the improvements. In other words, I am doubly assessed while many others escape altogether.

If it was a case of over valuation I would have appealed to the Revising Board of Assessors, hut being such a manifest injustice, I felt that I should not be put to the trouble and expense of making and looking after such appeal.

Trusting that your honorable body will see that justice (which is all I ask) is granted me in this matter, I am

On motion of Councillors A. J. Reid, seconded by A. F. Smith, the petition was referred to the assessment committee.

#### Petition.

The following petition was read by the clerk:

To the Municipal Council of the County of Halifax:

The petition of the undersigned residents of Colchester and Halifax Counties, showeth,

That, David Moore, of Coldstream, in the County of Colchester, is the owner of certain marsh or intervale situate in the County of Halifax, for which he is assessed and is compelled to do road work in the County of Halifax, and at a place where the said road work is of no benefit. to him in hauling his hay off the marsh. Said David Moore wishes that he be allowed to perform the statute labor from the canal to the Colchester County line. This would be performing the said labor within the municipality, and at the same time in such place as would assist the said David Moore in hauling hay from his marsh and would also benefit others who have hay to haul.

And your petitioners as in duty bound will ever pray.

On motion of Warden Madill, seconded by Councillor McMillan, the request asked for was granted.

#### New District.

County Clerk Wiswell said that he had a matter to bring before the Council that he wanted some information upon. The Legislature had ereated a new district, which was known as 21 A., which made it necessary to re-arrange the revisal sections 22 and 23, as the law provides, and that 35, 19 and 20 be coupled together. The suggestion met with the general approval of the council. Councillor McMillin suggested that Distriet 21 A. be made district 37.

On motion of Councillors Wilson and Croucher, the following resolution was read and passed:

Whereas, by the admission of the new Municipal District 21 A, to form part of this municipality as contained in chapter 64, acts of Nova Scotia, it becomes necessary to re-arrange certain revisal sections.

Therefore resolved, That the said District 21 A, shall be and form part of Revisal Section, No. 13, together with Districts Nos. 21 and 22, and that District No. 35, now forming part of Revisal Section No. 13, be joined to Revisal Section No. 12, and together with Districts No. 19, 20, form Revisal Section No. 12.

Also resolved, that the revisors appointed for Districts No. 21 A and No. 35 be notified to act in accordance with the foregoing changes.

On motion of Councillors Taylor and Stewart the following resolution was passed.

That the Legislature be asked to change the number of the District known as No. 21 A to No. 37.

#### Miscellaneous.

Moved by Councillor Flemming, seconded by Councillor Lydiard, that James Adams Archihald Rafter and John Lindssay be authorized by this Council to lay out and survey the proposed new road from Windsor Junction to Grove Siding. The motion was passed.

Councillor Milne, seconded by Councillor Johnston, moved that section 12, in district 20, be divided into two road sections, the west line to be called a road section, and from Wyse's west line to section line be called a road section. The motion passed.

Councillor Wilson asked how many bridges had been built under the small bridge act.

Councillor Flemming said that one had been built in his district, and Councillor Lydiard said he had got one in his district.

Warden Madill stated that he applied for one but he was too late.

The Clerk said that in looking over the Assessment Act he found that no provision had been made to pay the expenses of the Board of Appeal, which was summoned to meet on Jan. 28. All the parties had been notified to attend. The law provides for witness fees only.

Councillor C. E. Smith said that the parties appealing were required to pay their own expenses.

#### Petition from Dover.

The Clerk read the following petition:

To the Honorable William Mulock, Postmaster-General, Dominion of Canada:

The petition of the undersigned residents and ratepgyers of Dover and other districts in the County of Halifax humbly showeth:

That at the present time there is a daily mail from Halifax to Peggy's Cove, in the County of Halifax.

That Peggy's Cove is situate a distance of two miles from West Dover, 2<sup>1</sup>/<sub>2</sub> miles from East Dover and 4 miles from McGrath's Cove.

That there are two mails per week from Peggy's Cove to East Dover.

That there are a large number of persons residing in the settlements of East Dover, West Dover and McGrath's Cove, and the population of these places is increasing. By the extension of the present coach route to West Dover, and the appointment of a mail courier for the carriage of mails daily from West Dover to East Dover and McGrath's Cove the needs of a large number of people for a daily mail would be met at a very small expense.

Your petitioners would also urge upon your favorable consideration the estab-

road lishment of a post office at McGrath's a Cove

Your petitionars would humbly urge that you may be pleased to grant their request to extend the route of the present mail coach to West Dover, appoint a mail courier to convey the mail daily from West Dover to East Dover and Mc-Grath's Cove and establish a post office at said McGrath's Cove.

And as in duty bound your petitioners will ever pray.

Councillor Ryan said that it was not a matter for the Council to deal with, and he did not think the Council should sanction it. Councillor Wilson said it was important that the Council should sanction it as it would assist the people in the district.

Councillor Connors, who presented the petition, said the people of the district were strong in favor of it and he only wished the Council to sanction it, and the Councillors to sign their names to it, so as to strengthen the petition.

The following resolution was moved by Councillors Connors and Wilson:

Whereas, the inhabitants of East and West Dover have a mail only twice a week, and further whereas, the village of Peggy's Cove, which is only two miles distance has a daily mail,

Therefore resolved, that in the opinion of this Council it is important that the daily mail from Peggy's Cove should be extended to Dover by coach.

The motion passed.

The Council adjourned at 4.45 to meet on Friday morning at 10.30.

#### FRIDAY MORNING.

The Council resumed its session Friday morning. The Minutes of the last meeting were read and approved. The members of the Council were referred to the Chronicle by Clerk Wiswell for a full and accurate report of the doings of yesterday. The Warden suggested to the members that they could have copies of the Chronicle sent to their constituents on application.

Councillor Stewart informed the Council that the Sherifi thought it would be better to adopt number 40 for the new District, as the number already chosen, 37, was already in use as a polling district number. The Council decided to make no on an average. During the past year exchange. penditures of this kind occurred and

Clerk Wiswell called for reports.

The Warden named Monday as the day for appointing district officers.

It was resolved to pay a visit to the County Poor Farm Friday afternoon and 22 members signified their intention of going.

#### New Roads.

Warden read the following resolution, moved by Councillors Wilson and Fleming:

Whereas, the Intercolonial Railway Department did, during 1901, build two new pieces of road and a steel bridge near Lily Lake-for the purpose of eliminating three grade crossings over the railway, which were a menace to life and limband the said change having been completed to the satisfaction of the Councillor and Supervisor of District 17:

Therefore resolved, that this Council approves of the change and approves of said new pieces of road being incorporated into the road system of the county.

Councilior Wilson explained thoroughly the object of this resolution, which passed.

#### Road Matters.

Coun. Wilson spoke at length on road matters. He said there were from \$20,-000 to \$25,000 spent each year on the roads in Halifax County, and a great deal of it was spent rather than expended. (Coun. McMullin-Hear, hear.) He referred to the system of statute labor, which allowed everybody to repair the road before his own door, owing to the smallness of the commissions and also the different methods of expending, to money on the roads and bridges. All the money granted is expended before September, and any repairs necessary after that must wait, as there are no funds with which to make them.

Very often extraordinary repairs are necessary owing to autumn floods or other cause, and to repair damage the only way to do is for the Councillor to go to the Treasurer and get an overdraft. But the Treasurer has really no authority to give funds in this fashion, even on the authority of the Warden.

The annual extraordinary expenditure of this kind would amount to about \$500 on an average. During the past year expenditures of this kind occurred and about \$200 is still owing, and the creditors are anxious to bave their pay at once instead of waiting until next May. I would suggest that the Council give authority to the Treasurer to pay these sums when duly authorized and charge them up to the different districts with interest at 6 per cent. until next May. In accordance with which Coun. Wilson moved the following resolution, seconded by Coun. Croucher:

#### To Pay Road Money.

"Whereas, the roads in various parts of the County suffered severely during the autumn of 1901 by washouts, broken bridges and other unforseen causes, and prompt repairs were absolutely necessary and were done under the pressing calls from the respective Councillots, Supervisors and others:

"And whereas, there was no money in the County Treasury which could be used for this service, the result is that a large portion of the incurred expense is still unpaid:

"Therefore resolved, that this Council authorize the Treasurer to pay out of the consolidated funds of the County such road warrants duly certified for such emergency repairs—not to exceed \$400 in all—and charge interest thereon at the rate of  $3\frac{1}{2}$  per cent. per annum from date of advance to 1st May next."

Coun. Wilson thought the roads were getting worse instead of better and thought it might be well to ask the Legislature either to give the Municipalities more power and funds or else take the matter off their hands altogether, and thought the attention of the Legislature should be called to it.

Coun. Ryan thought the rate of interest, 6 per cent., was too high to charge those districts which had suffered.

Coun. McMillan thought this money should be advanced without interest at all.

Coun. Bishop thought that the whole system was bad and the whole sum of money granted to the County should be put directly into the hands of the Council, and the Supervisor should see that it was properly expended. The original resolution was amended to read  $3\frac{1}{2}$  per cent. and the resolution passed.

The following resolution was moved by Couns. Wilson and Croucher, in reference to District No. 29:

Whereas, the roads in District 29 have suffered severely during the autumn of 1901, and the cost of repairs has been so heavy as to seriously handicap the District and the new Counciliors during the present year;

Therefore resolved, that this Council approves of one-half of the amount being carried over to be settled in 1903 unless assistance is not otherwise obtained.

The motion passed.

#### Petition From District 10.

Coun. A. F. Smith presented the following petition'

ratepayers of District 24 asked The the Council to grant a precept to lay out a new road from at or near John Frost's house, on the Ecum Secum post road, to a road on the west side of the Ecum Secum River. The new road would be about half a mile in length and the cost small. It would shorten the main post road and could easily be kept in condition. It is impossible to keep up present road, as it is through a the rough country. The petition asked that W. G. Smith and W. W. Smith be appointed to lay out the new road. It was signed by 36 residents.

It was moved by Coun. Lydiard, seconded by Coun. A. F. Smith, that the petition be referred to the Road and Bridge Committee. Carried.

The reports of the Health Boards in the various districts were read and referred to the proper committees.

Couns. Croucher and Wilson moved that Road Section No. 11, in District 11, be incorporated in Road Section No. 6, the two becoming one section, to be known hereafter as Section No. 6. The motion passed.

Killag Bridge in Councillor Hall's District, No. 25, was placed under the smaller Bridge Act.

On motion of Couns. Negus and McMullin the bills from the Board of Health of Distrirt 33 were referred to the Finance Committee.

On motion of Couns. Madill and Mc-Mullin the bridge known as Keys bridge, in District 19, was placed under the Small Bridge Act.

On motion of Couns. Croucher and Wilson the road leading over Croucher's Point will be made a separate road section, to be known as Road Section No.  $5\frac{1}{2}$ , in District 12, and Stephen Dauphinee was appointed overseer.

On motion of Couns. Milne and Kuhn the bridge section in District 20, known as Ogilvie bridge, was placed under the Small Bridge Act.

A letter dated December 17, 1901, was read from Secretary John A. Watters, of the Halifax Health Board, which stated that the City would accommodate smallpox patients at the Hospital. The cost for each patient could not he determined, but it would not be less than \$10 per week. On motion the letter was placed on file.

The Council adjourned at one o'clock, to meet on Saturday at 10 a.m.

#### SATURDAY MORNING.

The County Council resumed its sessitu on Saturday morning at 10 30. All Councillors but five being present. The Minutes of the previous session were read and approved.

#### N. S. Eastern Railway.

The chief item for discussion in the morning was the Railway Bill-to grant the right of way at the cost of the County.

Coun. Taylor moved the resolution, seconded by Coun. Fleming, but it did not pass.

Coun. Wilson thought there should be some restraint put on the Company so that they could not put the County to extraordinary expense.

Coun. McMullin proposed the following amendment to the resolution, which was seconded hy Coun. Whitman:

Resolved, that this Council vote a lump sum not to exceed five thousand dollars for such purposes as are mentioned in the resolution. That such sum shall be paid in five yearly instalments of one thousand dollars each. Such sums to be assessed upon the County in equal amounts for five consecutive years, and to be paid to the Nova Scotia Eastern Co. at the end of such five Railway if the work is then completed. years, No interest to be paid the Company on the sum named until five years after their commencing to build such line, and only to be paid in full when the line is completed and in running order.

And that the legislation necessary for this purpose be obtained from the Provincial Legislature.

He thought that the sum mentioned was sufficient to pay for a right of way.

Coun. Bishop proposed that the words "not to exceed" be added to Coun. Mc-Mullin's resolution.

Coun. Lydiard was bitten by the Stewiacke Railway and was very particular about what he supported. He thought the Council should decide on the best route for this line before granting any assistance.

Coun. Kuhn said that he had not been able to find out very much about this road and would like a little light on the subject.

Coun. Negus thought it hard that the districts along the shore should be asked to contribute to a line which would be no more use to them than a line in China.

Coun. Lydiard thought that this should be deforred until some of the promoters of the scheme came forward and explained the route.

Coun. Taylor said that a Company had been organized with sufficient capital, and a route projected, which he outlined to the Council. The probable cost of the right of way, he said, would be about equivalent to the sum mentioned in Coun. McMullin's amendment.

The estimated distance through this County is 55 miles, and twelve acres in every mile will be about the amount of land required, or in all, 660 acres. About one-fifth of this would be through cultivated lands; say, 132 acres at \$20 per acre, or \$2,640. The balance, 528 acres, would be cheap land, say, \$3 per acre, or \$1,584. An allowance for station grounds of 100 acres at \$10 per acre would make a further amount of \$1,000, or a total of \$5,224. Resolved, that the two directors (Messrs. Reid and Chisholm) of the Company present be heard 'rom.

Mr. D. W. B. Reid came before the Council and explained the route. He said that the right of way had been granted by all the Counties interested except Halifax.

Finally Coun. McMullin changed his amendment by adding the words "not to exceed" \$5,000 to his amendment, and in this form the motion carried.

#### Miscellaneous.

Couns. Bishop and C. E. Smith moved That Section 1, in District 13, be extended from what is known as thu Slough bridge to Butler's Hotel; also that a section he added on the Sambro road to commence at Fraser's road and extend south to George Merlin's, and to be known as Section 7, in said District.

The motion passed.

Coun. Hayes moved, seconded by Coun. Bishop:

That the following bridges in District No. 7 be placed under the Small Bridges Act, viz.: the bridge at the head of Herring Cove, the bridge on the road between Spryfield and Ferguson's Cove, and the bridge known as Long Pond bridge.

The motion passed.

Coun. Croucher moved, seconded by Coun. Smith:

That the bridge known as Flake bridge, in District 12, be put under the Great Bridge Act, and bridges known as Rogers bridge, Frost Fish Cove bridge and Eastern River bridge, in the same District, be placed under the Small Bridges Act.

The motion passed.

The Council adjourned at 1 o'clock to meet again at 2.30.

#### SATURDAY AFTERNOON.

The Council resumed its session at 2.30. After the clerk called the roll and read the minutes the business was proceeded with. The clerk read the following letter from John E. Shatford with respect to the South Shore Railway:

#### South Shore Railway.

To the Warden and Councillors of the Municipality of Halifax County:

During the present session of the Council you will in all probability be asked to vote the right of way through Halifax County for the contemplated South Shore Railway. Having given the entire question of this railroad a thorough investigation I venture to address this letter to you on your attiude towards the different issues volved. These are no less than the development or standstill of trade and the magnificent resources of a large al d promising section of the County. It is thus a matter in which it behooves everyone to exert his power to bring about the result which will most benefit municipality.

Now I beg to submit to your Honorable Council that it is right and lawful for you to grant the right of way for any railroad passing through the County for the benefit of its inhabitants. Onee this point is ascertained-i. e., that the railroad in question is for the benefit of the inhabitants-the right of way should be given, as it no doubt would be given, unanimously. But so far as the SOcalled South Shore Road is concerned there is evidence to show that unless the people exert every opposition it will be neither a shore road nor a road for the people as far as Halifax and east Lunenburg counties go. The line run by the surveyors leaves the I. C. R. near Rockingham and continues through the woods some distance into Lunenburg It lies seven to nine miles Co. from any part of St. Margaret's Bay and the same distance from Hubbard's Cove without any way for the people in either place or along the entire shore The country through which to reach it. this line passes is not at all adapted to agricultural purposes or any other. Hammond's Plains is the only settlement the line touches after leaving Halifax. On the other hand if the line touched the head waters of the bay it would open up railway communication for eighteen to twenty thriving villages, where farming is carried on successfully. The most of these villages have every requirement of the summer resort and already, despite the difficulty of reaching them, a number of them have a large tourist patron-

age which represents considerable profit and benefit. The fish industry needs only facilities for quick transit in order to increase its value to three or four times what it is at present. Think what this alone means to the County. In the face of the facts you will see at once that the woods road would be no road for the people whatever and that no benefit from it would ever accrue to the County.

For these reasons 1 would beg your Honourable Council to withhold voting any right of way until the route of said road be located. If it be understood will grant the right of way that you only to a shore line, and that you will sanction only a railroad for the people the County, your action will have and considerable weight in influencing the Government when the question is finally put before them.

It is just and lawful that the County should be taxed for the right of way for a railway that will be of some henefit to the residents of said County. But it is not meet at all that the municipality should bear taxation for a line of railroad running through the woods, when for about a distance of thirty miles there is not one settler to derive any benefit therefrom.

Would it not be an absurdity to ask the people of the eastern shore, the Musquodoboits and the southern and northern parts of the County to grant a right of way for such a road when it was no road at all for any part of this County. On the contrary, if the road embraces the head waters of St. Margaret's Bay and Hubbard's Cove the County and the whole County should join in paying for the right of wav. In like manner when the time comes for the eastern people or Musquodoboit people to have a road the western people should willingly pay their proportion of the right of way.

You will no doubt agree with me after considering the matter that it would be wise and prudent for the Council to withhold granting any right of way till the line is located beyond a doubt and receives the sanction of the Governor-in-Council which is called for under the McKenzie and Mann contract. I am sure you will readily grasp the situation and its importance to the County, and then act solely in the interests of the municipality. I feel that you will not be guilty of the injustice of taxing the residents of the County for the right of way for a line of railroad going through the woods as I have described. Believe me in addressing you in this manner I am acting only with a view to the interests of the County, a matter which has always been of prime importance to me as you know by past experience.

Any precaution you may take in this connection will not be an unnecessary one. The survey has been made through the woods, the route described, and every indication shows that this is the route McKenzie and Mann will submit to the Government.

Leaving the matter to the discretion of your Honourable Council, I am,

The Clerk explained that he wanted an expression of opinion from the Council on the matter.

Coun. Croucher asked if any one had applied to build such a road. He said he thought it rather better to put it on the shelf until permission was asked.

Coun. McLean said that there was a vast difference in the location of the road. One survey goes through the woods and the other along the shore.

Coun. Bishop said that this railway was through a wilderness.

In answer to the Warden, Coun. Mc-Lean said he could not say whether the Council would be approached in the matter or not.

On motion of Coun. Ryan the letter was placed on file.

Coun. Wilson said he did not think anything would be done in the matter until after the Legislature met.

#### Miscellaneous Matters.

Coun. Bishop said that there was some money collected for the poor of District 13, which had not been expended. The Clerk said that he thought the money Was in the Treasurer's hands.

Coun. Bishop said if it was not in the hands of the Treasurer the Overseers should pay it in.

In answer to Coun. Flemming the Clerk said that it was not necessary to pay this money in to the Treasurer. Couns. Hall and Crooks moved that Section 12 of Chapter 9 of the By-Laws be struck out. This section was in reference to a pound at Bedford.

Coun. Negus said that it should not be there. It was placed there in opposition to the committee. Stipendiary Mc-Dougall said that it was illegal and in opposition to his advice.

Coun. Canfield said that the District has not a legal pound. There is a private pound, which persons tried to operate under the law.

The Warden said there had been a lot of trouble in that district over cattle. It was illegal to allow cattle to roam at large. The clause related to Bedford only.

Coun. Canfield said that he leased the land where the pound was and no one can take it from him. He would like to see a close district made as far as the statute compelled.

The motion was put and carried.

#### Changes in Road Sections.

Couns. Lydiard and Wilson moved:

That Road Section Nos. 13, 19 and 22, in District No. 31, be placed under the Commission in accordance with the Act in such cases passed in 1900, said Commission to be composed of Edward Morash, with power to maintain said road as by such statute provided, for the period of one year.

The motion passed.

Couns. Lydiard and Wilson moved:

That Road Section Nos. 1 and 2, in District No. 31, be placed under Commission in accord and under the Act in such cases passed in 1900, said Commission to be composed of John Dillman and Geo. A. Tufts, with power to maintain said road as by such statute provided, for the period of one year.

The motion passed.

Coun. Darrah moved, seconded by Coun. Stewart:

That the Road Sections in District 21 A be as follows:

Section 1—From the Dam Bridge, socalled, to end of County road at Lake Lode Mine, also from end of Mooseland road at intersection of Carriboo road to District line south on Mooseland road.

Section 2-Beginning at Moose River Mines and joining Section 1.

The motion passed.

#### MONDAY MORNING.

The Council met on Monday moning at 10.30 o'clock and after roll call the minutes of Saturday's session were read and approved.

The Treasurer read his report which was adopted on motion of Councillors Lydiard and Negus.

Councillor Whitman wanted to know why the cost of criminal prosecutions increases year by year, and what proportion Halifax and Dartmouth bears of it. The County Stipendiary came to his district and it had a very beneficial effect. He would like to make him pay periodical visits to the various districts.

Councillor Lydiard thought the Legislature should be petitioned in the matter. He also referred to the Coroner's fees. In his own case he was coroner for Dartmouth, and in two cases of bodies found outside of Dartmouth and within his jurisdiction the bodies were ordered to be taken across to halifax.

Moved by Councillor Lydiard, seconded by C. Negus, that the report be received and adopted. Carried.

Councillor Homans brought before the Council the case of a road in his district which was being renewed as a consequence of the recent storms. It is a case somewhat the same as that in Councillor Kuhn's district and the Councillor felt he should have some assistance.

Clerk Wiswell said he thought the Government had granted \$100 to this road but that would not be sufficient.

#### Public Property Report.

The following report was submitted by the committee on Public Property:

#### January 16, 1902.

Your Committee on Public Property beg leave to submit the following report:

That during the year 1901 the Poor Farm has been managed in such a manner as to insure economy in expenditure, necessary repairs to everything requiring the same, and comfort to the inmates. The crops have been very good with the

exception of the potato crop, which has been a failure throughout the Province; yet we hope to have sufficient to supply the Institution until the new crop is grown. Some more land has heen broken up and partially cropped during the year.

The inmates of the Institution number about the same as last year. There has heen a slight increase in board of insane patients and a decrease in that of District paupers. Owing to the advance in prices of a number of articles necessary for the Institution, the tenders for the same were higher and consequently those items of expenditure are increased somewhat over previous years. Several implements required on the farm were purchased, such as mowing machine, plough, harrow, etc., and the necessary repairs to woodwork and plaster were attended to. The horses employed on the farm, becoming unsuitable, were disposed a new team purchased, which of and work satisfactorily.

The Superintendent and Matron have given perfect satisfaction and, to the Committee, have proved to be painstaing and untiring in the performance of the duties devolving upon them. At the close of the year 1901 your Committee are pleased to show, as well as for the previous years, a balance in favor of the Institution, making an actual surplus for the three years of \$1,326.07.

At the last Session of Council the Public Property Committee were authorized to construct a building for the accommodation of patients having contagious diseases. This, and more, has been accomplished.

Your Committee found that by having this building erected separate and apart from the others, the cost would be much greater than the funds at our disposal warranted; besides two extra attendants — a male and female—would have heen required, which would have added materially to the expense.

The building as it now stands, attached to the others, although exceeding the amount voted, supplies the needed wards, and greatly increased accommodation to the Institution at much less cost than it would have been necessary to expend in the near future.

#### Jail.

The jail has been run in a careful and judicious manner. It is clean and well ventilated. A small amount of remains were attended to during the past year. but it is probable some improvements will have to be made during the year 1902, and in view of the changes required your committee recommend that the Finance Committee make ample provision for doing the same.

Great credit is due Jailor Malcolm for the manner in which he performs the duties of his office.

We would refer the Council to the Jailor's and Surgeon's reports.

#### The Poor Farm.

The following report was read from J. M. Henneberry, Superintendent of the Poor Farm:

In presenting my report for the year 1901, there are at the Poors' Farm 60 inmates, of which 14 are sane women, 1 girl, 12 insane women, 16 are sane men, 3 boys, 14 insane men. Admitted during the past year, 19; discharged, 10; died, 7. There are six employees, 2 males, 3 females and night watchman.

The crops have been fairly good. Potatoes, 230 bushels; turnips, 250 bushels; carrots, 25 bushels; parsnips, 21 bushels; 00 b. beets, 13 bushels; sauer krout, 3 5 barrels; cabbage, green, 10 dozen; cucumbers, peas, beans plentiful.

Hay, 14 tons; fodder, 2 tons; live stock, 4 mileh cows, 1 heifer, 2 horses, 2 pigs, Killed on the Farm, 4 pigs, weighing in all 944 lbs.

# Miscellaneous Matters.

Councillors Canfield and Flemming moved the following:

That the line of the public landing at Prince's Lodge, on Pedford Basin be defined and that Coancillors Flemming, Bishop and Canfield be a committee for the same. The motion passed.

Councillors Flemming and Hall moved the following:

That Road Sections Nos. 1 and 14, in Disttict No. 17, be placed under Commission in accord and under the Act in such cases passed in 1900, said Commission to be composed of Harold Silver, Charles Peverill and Emerson Barrett, with power to maintain said road, as such statute provides, for the period of two years.

The motion passed.

The following bridges were placed under the Small Bridge Act:

On motion of Councillors Moren and Flemming, the hridge near Mason's, in District 16.

On motion of Councillors Hall and Moren, the bridge known as Lawrence Brook bridge, in District 25.

On Motion of Councillors McLean and Croucher, the hridges known as Hubbard's, Puddle, Ingram River and Indian River, in District 32 and 12.

On motion of Councillors Coolen and Ryan, the bridge at Indian Point, Prospect, known as Indian Point bridge.

On motion of Councillors Ryan and Milne, the bridge at Lower Prospect, known as Lower Prospect bridge.

On motion of Councillors Hayes and Billman, the bridge dividing Districts 7 and 14, heing half in each District.

On motion of Councillors Hayes and Coolen, the bridge at Purcell's Cove.

On motion of Councillors Johnson and Bishop, the hridge at the head of Ketch Harbor, in District 8, and the bridge known as Bear Cove hridge in said District.

The salary of the Treasurer, Parker Archibald, was increased from \$700 to \$800.

#### MONDAY AFTERNOON.

The session was resumed at 2.30. After the clerk read the minutes the business was proceeded with.

The first matter dealt with was an admentment to the resolution passed on Saturday in connection with the Nova Scotia Eastern Railway Company Councillor McMullin said that it was drawn up hy Stipendiary McDougall. In effect it was the same but the wording was a little different. The motion was as follows:

Moved by Councillor Bishop, seconded be Councillor Lydiard:

"That all the words after 'Therefore, Resolved' be struck out and the following substituted therefor: "That this Council vote a lump sum of \$5,000 to the Nova Scotia Eastern Railway Company, (Limited), for such purposes as are mentioned in the resolution, such sum to be paid in full to the said company when the said railway is completed and in rumning order and so certified to 'by the Provincial Engineer.

"Further resolved, that the County Treasurer be authorized to pay said sum upon the order of His Flonor the Warden and a production of such certificate."

Councillor Smith spoke of the sum mentioned, \$5,000, as being very large. The Warden said that need not cause any worry as the company would pay more than that.

The motion passed.

Councillor Leslie's request for the removal of the Commission in District 26 was then taken up.

Councillor McMullin suggested that it be referred to the Stipendiary.

Councillor Flemming expressed the same opinion.

Councillor Leslie said that he thought the Council had the power to rescind the motion, as the Legislature empowered them to take such action.

Councillor Lydiard also said he thought that it was in the power of the Council to rescind the motion.

On motion of Councillors Stewart and C. E. Smith it was referred to the Stipendiary.

S. Naylor, Crier of the County Court, made application for the \$50 increase in his salary that had been promised him.

Councillor Croucher said that he understood that when any official makes application for more salary he was to send in his resignation at the same time. The Councillor was informed that such was not the case. The application was referred to the Finance Committee.

Councillor stewart moved:

That Road Section No. 25. in District 22, be extended east to Dam bridge, 80called. Councillors Homans and Leslie moved: That the Government be asked to grant the sum of \$200 for the purpose of finishing a new piece of road in District 27.

The motion passed.

The following bridges were placed under the Small Bridge Act:

Bidges in District 20, known as Bayer's bridge and Dollar Brook bridge.

Bridge known as White's bridge, over Stoney Beach River, dividing boundary line between Districts 10 and 13.

Councillor Wilson introduced the following resolution in regard to road maintenance:

Whereas, the maintenance of the roads through the County of Halifax has hecome a matter of serious import to this Council in consequence of the inadequate revenue for this purpose at the disposal of the County authorities, and also that the present methods of dividing up the expenditure among some five hundred or persons does not result in the more greatest benefit being realized from such revenue as we have. And further, that this Council considers that better results would follow if a system of consolidation of the several sources of revenue and a corresponding consolidation of expenditure were inaugurated, whereby the several amounts now realized, or that may be realized, could be more efficiently expended than under the present diffuse system of insignificant amounts apportioned out among a large number of individuals, the majority of whom are and necessarily must be incompetent for the duty.

Therefore resolved, that this Council memorialize the Provincial Legislature asking them either to take over what funds we have and relieve us of the maintenance of the roads, or otherwise place all the revenues under the control of the Council with authority to raise such further necessary funds as the circumstances may demand.

It was intended, he said, to stimulate the Government to ask what can be done. By so being asked and an effort being made to answer it, some benefit might result. His idea was to reduce the number of persons expending money on the roads of the County to not more than one dozen. Councillar Lydiard referred to the immensely increased traffic on the roads during the past 15 years. He said the had been told by a gentleman driving into Dartmouth on Friday last that he had counted 265 teams in a distance of 5 miles.

Councillor Bishop thought a committee from the Council he appointed to wait on the Legislature in regard to this matter, as they are the better qualified to speak on the matter than the members themselves.

Councillor McLean referred to a grant of \$100 which he had secured for a road in his district, and he had to say that under the rules connected with the expenditure of that money that he could not understand how any misappropriation was possible under the system. He thought every penny of the special grants made by the Government had to be expended direct, y on the road.

Councillor McMullin thought the chief step was to appoint the best man in the district as Supervisor, apart from the question of politics altogether. In his own district he knew of a case where the majority of the grant went into the Supervisor's pocket.

**The** Council then adjourned to allow **the** various committees to proceed with their work.

# TUESDAY MORNING, Jan. 21.

The Council met at 10.30. Warden Madill being absent through sickness, Councillor C. E. Smith, the Deputy Warden, filled the chair. The Clerk read the reports of the Supervisors of Districts 9, 18, 21 and 27, which were adopted.

#### Bedford Tramway.

The matter of the Bedford Electric Tramway came up again for discussion, having been deferred until this day, and occupied the entire morning session.

Councillor Ryan urged upon the Council the great necessity for this road in view of the increasing importance of the tourist trade. He said there might be trouble about inducing manufacturers, but the tourist trade was right at our hands, and this road would be a necessary adjunct to that trade.

Councillor Flemming thought it would be impossible to have this tramway on the highroad, particularly in winter. If the road were widened he would agree and advise a small subsidy to the undertaking if necessary.

Councillor Bishop thought it would be a pity to do anything to burke the building of the tramway. It would he better he thought, to widen the road. He felt sure if the road were built many citizens of Halifax would move out and build along the line.

Councillor Canfield thought it would greatly improve the road in many places to have the tramway constructed. In many places the road is not more than 12 or 13 feet wide—that is of clear road —and the tram would have to cut into the bank.

The solicitor for the Company, Mr. Mc-Neill, informed the Council that the Company would prefer to build on the side, and on the eastern side for choice.

Councillor Bishop suggested they should keep to the east side as far as Birch Cove and then cross and recross as they like.

Councillor Wilson moved the following resolution which carried unanimously:

That this Council grant the Bedford Tramway Company, limited, the right to build their tramway along the highway fron. Halifax and Bedforá, provided such tramway shall he built on the side of the highway, but not in the middle thereof or upon any portion of the 21 feet clear for waggon traffic which said company shall leave for that purpose unencumbered for that purpose except whete crossings may be necessary.

That a committee composed of Councillors Canfield, Morien, Billman, Wilson, Flemming. Ryan and Bishop be authorized to confer with the Provincial Engineer in regard to the location of said tram ear line.

Also that the preceding resolution in reference to the foregoing he incorporated with this resolution.

The following motions were passed by the Council:

Moved by Councillor Taylor, seconded by Councillor Stewart, that A. F. Shaw be keeper of the weigh scales in District 21, omitted in list of officers. Passed.

Moved by Councillor Moren and Hall that road section No. 4, in District 16, On motion of Councillors Hayes and Smith the bridge between Dancing Rock and Herring Cove was placed under the bridge act.

On motion of Councillors McLean and Croucher Northeast River Bridge, dividing Districts 32 and 12, was placed under the Smaller Bridge Act.

#### TUESDAY AFTERNOON, Jan. 21.

The Council met at 2.30 o'clock with the Deputy Warden, C. E. Smith, in the chair. The Minutes were read and approved.

Councillor Whitman said that the Councillors for the different districts were the chairmen of the Board of Health, and it frequently happened that the Councillors were absent, and in comsequence the Board could not meet, as it would not be legally constituted without him. Some trouble had arisen during the past season. He suggested that the Sanitary Inspector act in the Councillor's absence.

Councillor Taylor explained that when the Councillor was absent the Board could not meet until the Warden and two Councillors approved of a man for chairman. Councillors Hall, Leslie and Lydiard also spoke on the subject. Stipendiary McDougall said that the Council could not pass any by-law to conflict with the Act. The Council could ask the Legislature to change the Act to suit the occasion.

Councillors Whitman and Hall moved the following:

That in the absence of the Councillor of the District the Sanitary Inspector be chairman of the Board of Health, and that the Law Amendments Committee ask for Legislation to that effect.

On motion of Councillors Lýdiard and Flemming, W. S. Bishop and S. S. Scott were re-appointed auditors.

On motion of Councillors Smith and Lydiard, the bridge on the main post road leading to Ecum Secum River, known as Smith's Brook Bridge, be placed under the Smaller Bridge Act, also the bridge on the road leading from Moser's River to the back settlement, known as Wilson's Falls Bridge, be also placed under the Act. The motion passed.

On motion of Councillors Flemming and Moren, the bridge on the Beaver Bank road, in District 17, was placed under the Smaller Bridge Act.

#### Statute Labor Work.

Councillor Lydiard brought up the road tax question which he said required changing The statute labor work has now to be performed between April and August 31. He thought that the limit should be July 31. The road masters take advantage of this and do not perform their work until the last r. nute, and in consequence of this the public are ohtiged to travel over bad roads. Councillor L4diard's suggestions met with the general approval of the Council.

Councillar Croucher asked what provision there was for fishermen who were away from home during this period. The Warden explained that there was special provision made for them.

Councillors Lydiard and McLean then introduced the following resolution, which passed unanimously:

That section 20 of chapter 67, of the Acts of 1898, he amended by striking out the word "August" on the fifteenth line thereof, and substituting therefor the word "July."

On motion of Councillors Taylor and Whitman, Councillor Lydiard's name was added to the committee on Law Amendments.

At the request of the Warden Stipendiary MeDougall was called upon to inform the Council as to what the duties of the Road Commissioners were under the existing law.

The Council then adjourned to allow the committees to proceed with their work.

#### Wednesday Morning, Jan. 22.

The Council met on Wednesday morning at 10.30. The Minutes of Tucsday's sessions were read and approved.

Board of Health reports were read from the following districts and the respective accounts passed. Districts 18, 21, 14 and 34. the following resolution regarding the collection of taxes:

That all taxes on real estate unpaid for three years past be collected by legal process, as by statute in such cases provided and that the Clerk prepare a list of such delinquent taxes and place same in hands of the County Stipendiary for his action, in accordance with this resolution.

## Taxing Church Property.

Moved by Councillor Hayes, seconded by Councillor Johnson, that the Church property at Herring Cove be exempt from taxation.

A general discussion regarding taxation and exemption therefrom followed.

Councillor Canfield asked if the property at Rockingham were exempt from taxation. If so he thought this should apply to the property of other denominations.

Councillor Negus said there was a movement on foot to tax the Sacred Heart Convent in the city, and if this were due the Mount St. Vincent property should be assessed also,

Councillor Bishop thought all money making institutions should be taxed.

The Clerk read the statute regarding exemptions, for the benefit of the Council.

The words of the statute exempting property "in connection with the church" came in for discussion and interpretation.

Councillor Leslie could see no reason why clergymen should not be taxed as well as other people. As a rule they had a greater income than the most of their people and should pay their tax.

Moved by Councillor Wilson and seconded by Councillor Billman, that the petition of the Herring Cove church be referred to the committee on Assessment. Carried.

## Changes in Council Room.

Some discussion arose over the poor arrangement of the Council room. Clerk Wiswell thought the Council should confer with the authorities and have it re-arranged. Several of the Councillors voiced the same sentiments and the general opinion was that a circular arrangement of the desks would be much better.

Moved by Councillors Connors and Mc-Lean that more tables be placed in the Council chamber, as better facilities are required in conducting the affairs of the sessions, and that the Commissioners of the Court House provide the same.

The motion passed.

#### Dispensary Grant.

The following communication from the Directors of the Halifax Dispensary was read:

To His Honor the Warden and members of the County Council:

Gentlemen,—The Directors of the Dispensary thankfully acknowledge your grant of \$25 in aid of its expenses last year and as a large number of persons from the districts outside the eity receive medical advice and treatment they respectfully request a similar favor for the present year.

Report of Committee on the Insane, Chargeable to the Municipality of Halifax County.

Your committee beg to advise you in regard to the insame persons maintained by this municipality, as follows:

First. There were maintained at the Provincial Insane Asylum during first quarter of the year, 22 patients; during the second quarter 25 patients; during the third quarter 25 patients; during the last quarter 22 patients, at a total cost to the County as per this bill of \$3,035.07, but out of this amount is a credit due the County of \$51.89. We fins also that the average cost per patient at the Asylum or Hospital is about \$133.00, as against \$104.00, which it cost us at the Poor Farm per year.

There were four males and four females admitted to the Hospital during 1901, and during same period three males and two females were discharged, and two females removed to the Poor Farm, and there are nine males and ten females there now chargeable to us. For the names of all of these we refer you to the accompanying list.

Second. At the Poor Farm there are fourteen male and twelve female insane patients being cared for and from the report of the keeper of that institution it appears they are very satisfactorily provided for there. So that in the two institutions this Municipality is providing for 45 insane persons, viz.: 23 males and 22 females.

The maintenance of those at the Poor Farm will be included in the estimates for that institution, but it will be necessary to make provision for those at the Hospital. The present number there will require something over \$2,500.00, but as the average yearly admissions are some three or four of each sex it would be judicious to place \$3,000.00 in the estimates for this purpose. Your committee advise a visit to the Hospital in the near future, and ascertain if any patients there could be advantageously removed to the Poor Farm.

#### Letter from H. V. Wier.

The Clerk read the following communication from H. V. Wier:

Halifax, N. S., Jan. 21st, 1902.

To the Warden and Councillors, Halifax County:

Gentlemen,—I notice in the public press that you have passed a resolution appointing a committee to define the line of the public dock at Prince's Lodge.

I beg leave to notify you that there is no public dock there, over which or with which your Council has any jurisdiction or control. That the original owners of Prince's Lodge reserved a water lot there as a public dock by plan only, but the title to that lot is still in the proprietor's hands, and they are the owners, and it has never been deeded by them to the public for public purposes. As my property adjoins it I beg leave to notify you that if any person authorized by you, interferes in any way with my property or my established lines thereof, I will hold him and the gentlemen who voted for the resolution, personally responsible for any interference with my rights. I trust therefore that your honorable body will be pleased under the circumstances not to interfere with the matter, especially as the object of the resolution is for the benefit or information of a person residing at Prince's Lodge, and who now is trespassing on private property and which he claims is the public dock referred to. If that gentleman desires to have the lines of the alleged public dock, upon which he has built a wharf, he should ascertain them at his own expense and not at the expense of the Municipality. If any such expense is paid or authorized the bv Municipality, 1, as one of the ratepayers, will take the necessary proceedings to have the amount repaid to the Municipality as an unauthorized expenditure.

The motion passed.

#### Miscellaneous Matters.

Councillors Taylor and Darragh moved:

Whereas, road section 15, in District 31, is now included in the line of road leading from the coach road to the County line via O'Connell's has not been laid off as a road section.

Resolved, that the road from said main road to the County line be a road section in District 21, and he numbered 15.

The motion passed.

Councillors Kuhn and Negus moved that a precept be granted to lay out a new piece of road in district 29, from Dyke bridge to the west end of present West Lawrencetown road, and that Simeon Hiltz and Charles Conrod be appointed a committee to lay out the same. The motion passed.

Councillors Homans and Negus moved that the property in District 27, known as the Gold Lake mining property be placed on the assessment roll of the above named district for the year 1902.

The motion passed.

On motion of Councillors Negus and Whitman, A. W. Smith was appointed a constable for the Court House or whereever required without remuneration except fees for such services.

Councillors Negus and Taylor moved: That the sum of \$50 be granted to defray the expenses of the clergyman officiating at burial and religious services at the Poor Farm for the year 1902. The motion passed.

Councillors Flemming and Moren moved:

That the bridge on the cross Beaver Bank road, in District 17, be placed under the Smaller Bridge Act.

The motion passed.

Thomas Green was appointed Sanitary Inspector for District 21.

The following were apointed commissioners for making out papers for admissions of patients to the lunatic asylum.

On motion of Councillors Hall and Moren, M. McFarlane and D. W. Archibald, J. P.'s, were appointed.

On motion of Councillors Stewart and Taylor, Walter McCurdy and Wm. Sedgewick, J. P.'s, were appointed.

On motion of Councillors Whitman and A. F. Smith, H. J. Balcom and John Kuhn, J P.'s, were appointed.

Moved by Councillor Negus, seconded by Councillor Charles McLean, that the resolution concerning the Sheet Harbor Mining Co. be referred to the assessment committee.

The motion passed.

The Council adjourned at 1 p. m.

#### Wednesday Afternoon, Jan. 22.

The Council met at 2.30, with Deputy Warden C. E. Smith in the chair. The Clerk read the Minutes which were approved.

Councillors Hall and McMullin moved that the rate of percentage for road tax be 35 cents per \$100 for 1902. The motion was passed.

Councillors McLean and Croucher moved that no poll tax be collected in this Municipality for the current mear. The motion passed.

Councillor Bishop, seconded by Councillor Lydiard, moved the following:

Whereas, the following resolution was on Jan. 16, 1897, passed by this Council:

Whereas, the rural sections of Halifax County, except those in the immediate vicinity of the Intercolonial Railway, are altogether without railway facilities;

And whereas, experience has shown that at the present day no large section of country can advance or prosper without ready access to such facilities; Resolved therefore, that in the opinion of this Municipal Council it is desirable and practically necessary that such facilities should be afforded by lines of railway connecting the eastern and western extremities of the County with the capital,

And resolved, that in order to encourage the construction of such lines of railway, this Council will undertake to provide the right of way for a raifway running from the eastern end of the County, near Upper Musquodoboit to the Harbor of Halifax, or to a point on the Intercolonial Railway no further north than Milford Station, and also for a railway running from the western end of the County, near Hubbard's Cove. to the Harbor of Halifax, or to a point on the Intercolonial Railway not further north than Windsor Junction; and that the legislation necessary for this purpose be obtained from the Provincial Legislature;

And resolved, that the Local Government and the members representing this County in the Dominion Parliament and the Local Legislature be and they are hereby requested and urged to use their best efforts to secure, by the guaranteing of subsidies and otherwise, the early construction of the lines of railways above indicated;

And resolved, that copies of these resolutions be forwarded to the Minister of Railways, the Minister representing Nova Scotia in the Dominion Government, to the members of the Provincial Government and to the members in both Houses of Parliament and of the Legislature who reside in the County of Halifax;

And whereas, no steps have been taken to obtain the necessary legislation to enable the Council to provide the rights of way aforesaid;

Therefore resolved, that the said resolution be and the same is hereby repealed.

# Location of the South Shore Road

Councillor Ryan then submitted the following:

Whereas, the people of the Western Shore of the Province have during the past half century contributed towards supplying the inhabitants of other por-

tions of Nova Scotia with railway facilities, but have themselves remained without satisfactory connection by rail with the capital or with the railway system of the Dominion,

And whereas, owing to the character of the country in the neighborhood the coast, the construction of such a railway as would accommodate the bulk of the inhabitants would be unusually expensive, so that although the region in is question has been long settled and fairly prosperous, endowed with many natural resources and likely to supply a large amount of traffic to a properly located railroad, it was found impracticable to secure the building of such a railroad, unless the Province offered unusual inducements therefor;

And whereas, the Legislature, desiring to secure to the people of the western shore the advantages to which they seemed entitled passed an Act at its last session, authorizing the **Provincial** Government to enter into a contract for the construction and operation of a railroad of the desired location and character; the terms of which contract were submitted to the voters of the Province at the late general elections and were approved of by an overwhelming majority of such voters.

And whereas, judging from the location of the surveys, between the eastern boundary of the County of Lunenburg and the city of Halifax, made by the engineers of the contractors, it would appear to be the intention of the said contractors, to locate the proposed line in the interior of the western portion of the County, where it would be of little or no value to the bulk of the populalation, a course of action which would be contrary to the spirit and interest the Act of 1902 and would defeat object which the Legislatdre had in view in providing for the liberal aid agreed to be given to the contractors.

Therefore resolved, that in the opinion of this Council it is the imperative duty of the Government to insist upon the iocation of the said railway being such that it will fulfill the intention of the Legislature and give the needed facilities to the people of Hubbard's Cove, Margaret's Bay and the country between the last named District and the eity; Resolved, that the members representing this County be urged to take the most decided steps in their power with a view to secure the desired end;

And resolved, that copies of this resolution be forthwith sent to the members of the Executive Council of the Province, to the Ministers of Finance and Militia and the members from this County in the Senate, House of Conmons, Legislative Council and House of Assembly.

Councillor Ryan asked the Council to fix a time to discuss the above.

Councillor MeMullin said that no discussion was necessary, it should pass the Council.

Councillor Bishop said that his resolution being introduced first it should be dealt with first.

Councillor Billman advised the Council to go slow in the matter. The Council should not commit itself to any right of way. He realized that the railway would be a good thing for the city.

Councillor Ryan said the railway was of the greatest interest to the whole city of Halifax. The Councillors from the east should take as much interest in this road as the Councillors from the west did over the Musquodoboit Railway.

The Warden said that it was only right that the opinion of the Council should be obtained as to the location of the road.

Councillor Taylor said that the Council should he free to deal with the matter as it sees fit when it comes up for discussion.

Councillor Ryan moved that the matter be taken up on Thursday morning.

Councillors Billman and Moren moved in amendment that consideration of the railway route on the western shore be deferred until the next meeting of the Council in April. The amendment on being put to a vote was lost. The original resolution was then put and carried.

The Council then adjourned until 10 o'clock Thursday morning.

# Thursday Morning, Jan. 23.

The Council met at 10 o'clock on Thursday, the early hour heing in order that more time might be allowed for discussion of the South Shore Mailway matter. The Minutes of Wednesday's meeting were read and approved.

Councillors Bishop and Lydiard's resolution which was submitted at Wednesday afternoon's sessian was put and passed unanimously. It was in connection with the South Shore Railway.

The Clerk read ex-Warden Shitford's letter, which has already been published

Councillor McLean said that he o'rjected to the present survey. The whole route along the shore is about II miles and crosses the road more than a dozen times. All the good the people along the shore would receive from the present route would be more than overbalanced by the harm.

# Western Shore Road.

Councillor Lydiard thought the people of the Western Shore should have sent in their names if they object to the route chosen so as to give the Council some light on their wishes.

Councillor Smith said the people of the Western Shore were practically unanimous on the subject. They have no coasting boats running regularly and have to depend on chance to get their goods to market. The Shore route is not favored by the people.

Councillor Ryan—The Government made a mistake in laying out the Western Counties railway. It ran through the woods and when the wood was cut the district through which it ran was valueless. The same thing will happen in the case of the present road if constructed as surveyed, whereas if run along the shore it will always he a benefit.

It is only a matter of time when all the fisbing will be done by steam trawling, and in such case it will be necessary to bave prompt sbipment and little handling If this road is run as now surveyed, through the woods it will only benefit those engaged in lumbering, which will not be a permanent industry in the locality in question.

Councillor Smith moved as an amendment that the matter be settled at once. He said if the western fishing had the facilities they could every one of them maintain a fishing fleet. They wanted facilities which would enable them to ship fish in carloads direct to any point which they desired to reach. Councillor Ryan said that within a few years the lobster fisheries would be exhausted unless a change occurred. They must have something to take its place and this could only be done by the encouragement of the fresh fish industry. This could best indeed, only be done by the building of the road in question along the shore.

Councillor McMullin thought the Council was simply asked to express an opinian on the best route, and for his part he thought the shore route the best one.

The motion of Councillors Ryan and Smith was then put and carried. It was published in Wednesday afternoon's proceedings.

Councillor Leslie wished a change made in the road commissioners in his district on account of the unsatisfactory nature of his returns. This caused a great deal of discussion as to the general power of Councillors to dismiss such officials, appointed by out-going Councillors. The general opinion was that the power of the Councillor to make appointments, and the appointees made, should end with his term of office.

Councillor Lydiard extended an invitation to all the Councillors to visit the Jail.

Moved by D. T. Leslie, seconded hy C. C. McLean, that the appointment of Samuel H. Hensley as commissioner of a road section known as Section A, in District No. 26, be rescinded, and that said section be re-arranged as follows: Section No. 3 to extend westerly to the Eastern Brook at the head of Spry

Bay, and two new sections numbered 15 and 16 be made of the remainder of Section A.

Section 15 to extend from the aforesaid Eastern Brook to Smelt Brook, and Section 16 to include the road between Smelt Brook and Bollong's Brook.

Also that the Gerrard's Island road section be known as Section No. 13, and the Mooseland section as Section No. 14. The motion passed.

#### Miscellaneous Matters

The Councillors remuneration was fixed at \$2 per day.

Thomas Irvin was appointed Sanitary Inspector for District 24.

On motion of Councillor Myette, the canal bridge in District 28, in road section 3, was placed under the Bridge Act.

Moved by Councillor Canfield, seconded by Councillor H. Hall, and resolved that Suring, Rutledge, Mitchell, Borden and Pleasant streets, together with all the remaining .: de streets of Bedford be one road section, called Section A, with Josiah Fisher road master.

The motion passed.

Councillors Wilson, Lydiard, Negus and Flemming were appointed a committee on arbitration with the city of Halifax and town of Dartmouth for the present year.

On motion of Councillors Milne and Myette, the road section formed by dividing section 12 was numbered 16, and that from Wyse's west line be known as section 16.

Moved by Councillor Lydiard, seconded by Councillor Negus, that road section No. 25, in District No. 31, be divided into two road sections, viz.: Section 25 A to extend from Dartmouth road to Edward Keelor's west line, and Section 25 B from Edward Keelor's west line to Dartmouth town boundary.

Moved by D. T. Leslie, seconded *by* Councillor Croucher, that a permit be granted to McLean Bros., Hubbard's Cive, to construct and operate a line of celephone from their store at Hubbard's Cove to connect with a line in Luuenhurg County, a distance of about oneeighth of a mile, with the same privileges and protection as telephone companies usually have.

C. E. Smith, Thomas Hamm was granted a liquor license.

The Council adjourned to meet at 2 o'elock.

#### Thursday Afternoon, Jan. 23.

met at 2 o'clock, with The Council Warden Madill in the chair. The Clerk read the Minutes which were approved.

The question of fixing the pay of road masters and laborers was then taken up and discussed at length. Some of the Councillors favored paying the road masters \$1.25 per day, and the laborers \$1.15 per day. Others thought the laborers pay should remain at \$1 per day. The discussion was participated in by Warden Madill and Councillors Flemming, Wilson, Hayes, Ryan, Lydiard, Croucher, Canfield, Taylor, Whitman and Negus. A series of resolutions were then submitted on the subject. The motion that carried was the one moved by Councillors Canfield and Hall. It was:

That the rate of pay be not in excess of the following: Road masters, \$1.25; laborers, \$1.15; single teams, \$2.00, and double teams \$2.50 per day.

Councillor Wilson's resolution re the maintenance of roads throughout the County was put and passed

Councillors Lydiard and Billman moved that the remuneration of Councillors for attendance at meetings of Council shall be \$3 per day for actual attendance in addition to allowance for travel, and that application he made to the Legislature to amend the Municipal Act accordingly.

The Warden said he did not think the resolution would be very popular outside, but he would have to put it.

Councillor Lydiard, in speaking in support of the resolution, said that the Councillors might put in more hours of work, and in consequence the session of the Council could be considerably shortened. The increase would be an inducement to the Councillors to get through the work quicker. Two dollars does not pay the Councillors for their time. Resolved, that the amount of the estimates for the year 1902, reported by the Finance Committee and received and adopted by this Council, be assessed upon the County, City and Dartmouth in the usual proportions, adding the cost of collections, the same to be County's proportion, and the County Treasurer is hereby authorized to have the same eollected.

# Report from Law Committee.

The Law Amendment Committee beg to submit the following report:

Since the passing of Chapter 186, Revised Statutes 1900, the amounts paid by the Treasurer on account of Crown Prosecutions has almost doubled from what was beretofore paid. The greater part of the increased expenditure was necessary for the due administration of justice. The committee, however, would suggest that application be made to the Legislature to change schedule of that Act relating to witness' fees by reducing the fee for each day's attendance from \$1.00 to 50 cents.

For the proper enforcement of the law relating to peddlers the committee would suggest that the Council appoint a number of assistant clerks of incense in different parts of the County, whose duty it would be to issue licenses to peddlers and enforce the by-law against delinquents.

They would recommend that \$1.00 be allowed said assistants out of each license fee respectively received hy them. The committee would call attention to the advisability of issuing posters in should be inserted the principal which sections of the by-laws and the fines and penalties to which offenders are subject; such posters to be distributed 2.5 widely as possible throughout County.

The committee have carefully examined the matter of the proposed change in the Board al Health Act. They have come to the conclusion that the word "chairman" means the presiding officer or executive head of the Board, and his absence from the District does not prevent a meeting being held and husiness

transacted if a quorum are present. Sec. 17 of the Act authorizes such a meeting being held and does not say the chairman must preside at the meeting. If the view of the committee is correct there is no need for any change being made in the Act.

The right of appointing Commissioners over Districts of the Public Highways for a term of five years seems to have been taken advantage of to the annoyand disadvantage of succeeding auce Councillors.

Your committee therefore recommend that the term of office of every officer appointed by the Council expire with the lifetime of the Council at that time.

That Section 20, of Chapter 67, of the Acts of 1898, be amended by striking out the word "August" on the fifteenth line thereof, and substituting therefor the word "July."

with regard to the application of Mr. Oakes they find that he has not the names of the required two-thirds of the total number of resident ratepayers in his dictrict attached thereto, and the committee cannot recommend that a license be granted to him.

The committee find that Mr. Hamm has the requisite number of signatures. No objection was made to his application except that his hotel was not jurnished at the time of the visit of the License Inspector. Assurances have been given to the committee that should a license be granted to Mr. Hamm, his hotel will be furnished so as to fully comply with the law in that respect, and the majority of the committee would therefore recommend that a hotel license be issued to him.

The letter of His Worship the Mayor of Dartmouth was considered, and the committee would recommend that a letter be sent in reply by the Clerk stating what efforts the Inspector has made to carry out the provisions of the Liquor License Act at the place complained of in His Worship's communication, and the readiness of the County authorities to assist in the prevention of the illegal sale of liquor in the vicinity of Dartmouth.

The committee would ask that the License Inspector in reporting on applications for license make a more detailed statement concerning the same, as required by Sec. 29 of the License Act.

The committee are pleased to find that during the past year strong efforts have been made to enforce the by-law relating to peddlers, and in consequence 29 licenses were issued as against 4 the previous year. It is hoped that the

same activity will be shown during 1902 to compel peddlers to conform with the law.

We find that where roads are placed in the hands of commissioners, as by Chap. 25 of the Acts of 1900, it is impossible

We may say in reference to petition from Bediord, District 15, that two of the commissioners appeared before your committee as well as about a dozen witnesses in the interests of the petitioners, and while it was shown that the commissioners were somewhat negugent and remiss in their duties, and in some cases the road was neglected and the bulk of the work done late in the season, the Road Act for the most part protected rather than condemned them. We learned that the majority of the petitioners were residents of the so-called side streets of Bedford, and as the commissioners were anxious to work only on the main road. the side streets received little or no attention. The committee have acknowledged that there has been delay in collecting road taxes and they say that in the future this will be overcome and next year be begun with a clean sheet. As these commissioners seem very desirious to continue the McAdam road on the main post road we would recommend that their commission continue, but only in so far as the main post road is concerned, i. e., to say that said commissioners only have control of the great road from the Tannery brook to the Tolson bridge, not including any of the side streets of Bedford whatever. And further, we would recommend that all of the side streets of Bedford be made into one road section and a roadmaster be appointed for same.

Appended herewith is a general summary of the different supervisor's reports.

Districts 10, 16, 19, 23 and 26 show no returns. Your committee would therefore ask that the returns from said districts be in by next meeting or be dealt with as the law directs.

The report from District 15 is very indefinite in that while it shows the amounts which have been collected and expended it does not show the total amount to be collected or the amounts still unpaid, which we would judge to be very large. One road section in this district was neglected altogether. No work was done and no money collected, and it appears that the roadmaster for

that section was never sworn into office. We find that where roads are placed in the hands of commissioners, as by Chap. 25 of the Acts of 1900, it is impossible to get at the amounts of money uncollected and thus you see it leaves matters in a very undesirable state. Some effort should be made by this Council to get better legislatior in this direction.

The commissioners from Bedford in their report called attention to important and serious encroachments made upon their road by the railway, and the support of the Municipal asked Council in having this matter rectified, so far as possible. They also said that il sufficient funds were available to make a good McAdam road in their district that there is sufficient available in taxes from the district to pay the interest on such a sum and be enough remaining to keep such a road in first class repair. and suggested that the Municipality ask the Legislature to provide such a fund for districts in a position to take advantage of it. This they thought would he somewhat similar to the road legislature of Ontario for last year.

# APRIL SESSION.

The Halifax County Council opened its semi-annual session at noon or. Tuesday, April 1st, 1902. Warden Madill presided. The Councillors absent were the following named: A. F. Smith, Jas. Billman, II. mail, F. D. Darragh, D. T. Leslie and Jas. H. Whitman. The minutes of the last session were read and approved, after which Warden Madill made a few remarks. He said the Legislature had passed nearly all the legislature proposed by the Council except that in regard to raising the Councillors pay.

He surmised that the present session would be a short one and should not occupy more than three or four days.

Clerk Wiswell reported on what he had done since the last session of the Council. An important part of his work had been keeping an eye on the proceedings of the Legislature so that no bills immical to the interests of the County should be rushed through. He had also made out and mailed all necessary papers for going to work on the roads.

Had sent lists of bridges to be attended to to the Provincial Engineer. Forwarded to the various members of Parliament and Cahinet Ministers a copy of the Council's resolution regarding route ifor South Shore Railway. Also made out jury lists and sent to Revisors their instructions. Arranged for treatment of a case of smallpox at Preston. These and other matters together with routine business had occupied the Clerk's time fully.

Councillor Wilson had a grievance to the effect that none of those to whom he had ordered papers sent had received them. He wanted to know if other Councillors had had a similar experience. None of them reported they had had such experience.

He said that in the discussion over the appointment of Supervisors he was reported as saying "that in his own District he knew of a case where the majority of the grant went into the supervisor's pocket." What he did say was, "that it seemed to be the aim of the supervisors to get as much of the money in their own pockets in place of putting it on the roads." He was under the impression that it was that way in his own district.

The clerk announced that the net Government grant for the roads and bridges in the thirty-two districts for the present year was \$8,400.06.

There was considerable discussion over the duties of the Board of Revisors of Assessment, participated in by Councillors Lydiard, Croucher, McMullin, Negus, Taylor, and Flemming. The majority of the Councillors thought that it was absolutely necessarv to have such a Board. Clerk Wiswell said that in nearly every district names were left off the assessment roll, and that changes are made after the lists are made up. lle thought that it was the duty of the assessors to make themselves more conversant with the law.

# HALIFAX, January, 1902.

To His Honor the Warden and Councillors of the Municipality of Halifax County:

Gentlemen,-In accordance with Section 38, of Chapter 73, of the Revised Statutes, the Board of Appeals consisting of J. Sprott Stewart, Samuel H. Henley and E. S. Hubley met at the Court Room at Halifax on Tuesday the 28th day of January, when the County Clerk submitted the names and statements of the several appellants who had also been notified by him to attend at 11.30 o'clock for the purpose of having their .ppeals considered and determined. J. Sprott Stewart was named chairman. The number of appeals amounted to 11, which were taken up and after the parties interested had been heard in person or by attorney, were decided in accordance with the evidence and explanations submitted, as under

#### Appeal No. 1.

The Dominion Lumber Company, assemed in District No. 32 on real aod personal property \$28,750 and complained of as excessive. Mr. Beardmore, principal owner, Mr. Beatty and Councillor Billman attended and urged for various reasons that a reduction to \$20,000 should he made. The Board were of the opinion from reliable information that the valuation was if anything too low and that it should be allowed to stand.

#### Appeal No. 2.

The Sheet Harbor Lumber Company, represented by Mr, D. Chisholm, had been valued at \$13,000 real and \$4,000 personal estate, claimed that  $$\psi,000$  real, and \$4000 personal estate would be a correct assessment. The Board found that the assessment of the previous year was \$18,500 in all and confirmed the valuation of the assessors for District 25 for the year.

## Appeal No. 3.

The Bank of Montreal at Amherst, represented by their solicitor, Mr. Townshend, against the valuation in District 25 of \$6000 real and \$1000 personal property. The bank claims that

both are overvalued. The Board found that there was no personal'property which could be valued, they therefore struck off the amount of \$1000 personal property, leaving the real estate as given in the roll of the which was accepted by the bank's solicitors.

#### Appeal No. 4.

The Bank of Montreal (as above). In this appeal the solicitor of the bank accepted and agreed to allow the \$2100 as the valuation of the property in District No. 22 to stand as in the rate roll.

#### Appeal No. 5.

In William Watt property, Sheet Harbor, the appeal was withdrawn.

## Appeal No. 6.

James A. R. Weir's appeal against valuation real estate in District 17. The appellant did not satisfy the Court in the evidence he presented and refused to make oath to the value of the property in said district. The Court therefore contirmed the valuation of the assessors of the property.

#### Appeal No. 7.

In re appeal of Dominick Farrell, represented by R. E. Finn, his solicitor, who confirmed the claim that the appellant owned no property in this Municipality, having transferred the same to Letitia and Theresa Farrell; also that the property so transferred was overvalued and gave evidence to that effect. On referring to former valuations of said property the Court decided that the valuation be \$700 (instead of \$850) to which Mr. Finn assented.

#### Appeal No. 8.

Halifax Sugar Refinery—The solicitor of the company, R. E. Harris, showed conclusively that the company was entitled to exemption on all property until September, 1905. The Board decided to accept the evidence and strike the valuation of the assessment roll of Dis\*rict 31.

#### Appeal No. 9.

The Halifax Electric Tramway Co .--The company was represented by W. J. DeBlois, and their solicitor, 11. B. Stairs, Esq. Mr. DeBlois stated the condition of the property at Fairview, District 14, and that it was depleted of all machinery and that the company would accept \$1800 for the property. The court decided the assessment value be \$2000, to which the appellants agreed.

#### Appeal No. 10.

Report of Jury Lists Committee.

## Road Supervisors' Pay.

Moved by Councillors Ryan and Hayes that the pay of the road supervisors for 1902 be \$1.50 in place of \$1.25 as at present Councillor Hays said that such sum was required to get the best men for the position. Councillor Ryan also expressed himself strongly in favor of the increase. Councillor Wilson spoke in favor of the resolution. He said that it was impossible to get the best men at a less igure.

Warden Madill said that he was in sympathy with the resolution. From his experience he knew that good men were worth \$1.50 a day.

Councillors McMullan, Lydiard and Negus contended that the matter had been disposed of at the last session, and therefore it could not be brought up again at this session. Councillors Ryan and Hayes said that they had given notice to reconsider the matter then, and that it was in order to bring it up again.

Councillors McMullan and Negus said that if the motion was pressed that they would move an amendment. They then submitted a motion that the pay remain at \$1.25, the same as at present.

Councillor Negus said the supervisors were getting sufficient pay.

Councillor Wilson asked why the Councillors got more money than the supervisors! Councillor Negus said that the Councillors were under greater expense in coming to the City. Councillor Casey thought that the majority of the Councillors attended by their own wish. It was not so with the supervisors.

Councillor Lydiard said he knew how difficult it was to get good men. In some districts it is almost impossible to get competent supervisors.

Councillor McMullan said that it would be as well to eat the whole fund up in salaries, and then stop. Good men will do the work for \$1.25, that is those who take an interest in the work. He did not think that the increase would result in getting hetter men.

Councillor Hayes thought that the road supervisors' knowledge was worth 25 cents a day more than that of the ordinary man.

Councillor Flemming said that in distriet 17 it was hard to get good men for \$1.25, as employers of labor in that vicinity pay their men \$1.25.

Councillor Madill said that he was willing that responsible men should be paid \$1.50.

Councillor Taylor said that it was generally understood that the pay was to he \$1.25 per day.

Councillor Casey said that in his distriet the supervisor had his bills out, and that he knew the pay was fixed at \$1.25.

Councillor Canfield thought that the matter had better be left as it was.

Councillors McLean, Stewart and Taylor suggested that the matter be deferred for the present.

Councillor Lydiard moved that the matter be deferred until Thursday morning, and the motion carried.

# Road Limits Discussed.

Councillor Bishop asked who has the power to deal with the road limits?

Councillor McMullan said that the supervisors have the power to remove fences, etc.

Councillor Bishop did not think the supervisors had the power to remove fences or define the road limits.

Councillor Canfield said that some supervisors have different views. One defines the limits one way and one another.

Councillor Croucher said that he was glad the matter was hrought up. It should be settled now. He did not think that there were any records of titles, etc.

Councillor McLean said that the roads in his district were being encroached upon.

Councillor Taylor said that property owners could be forced to set back their fences when the road had been used as a public highway, and when statute labor had been performed thereon.

Councillor Bishop said that the statute required the roads to he 60 feet in width, and that three supervisors must be appointed to define the road limits.

The Council met in session at 3.30 o'clock, and after the Clerk read the minutes of the morning's proceedings the C'ouncil adjourned so as to allow the Road and Bridge Committee to prepare its report.

# FRIDAY MORNING.

The County Council mot at 10.36 on Friday morning.

A communication was read from Preston regarding smallpox in that district and the measures taken to prevent its spread. A bill of \$84.34 for expenses connected with the above was presented as follows:

Moved hy Councillors Thomas and Stewart, that the report be received and referred to the Finance Committee.

Coun. Smith wished to know if there was any means of ascertaining what it is that is eating up the road grant from year to year. He referred more particularly to the \$2,000 granted to his own district and wanted to know if they were paying interest on it. He was referred to the Provincial Engineer's office.

Councillor Bishop asked for a ruling on the power of Supervisors of Roads. He thought some definite steps should he taken to secure to the Municipality the 66 feet of road which the law provides.

Councillor Smith thought the whole question of the fixing of road limits should be gone into and settled. The encroachment on the roads has been general and in many cases the owners of property will not even suffer trees to be cut down so as to give the roads a chance to dry up. Councillor Bishop then introduced a motion that the following three should be appointed Supervisors of Public Grounds for District 13: Geo. W. Mariott, Wm. Arnold, Wm. Graves. Passed. This was considered a precedent

which any Councillor could follow by introducing a similar motion with respect to his district.

Moved by Councillors Croucher and Whitman, that \$40 be assessed on District 12 for the support of the poor.

Moved by Councillors Canfield and Moren, that Alfred Le Brecq be Sanitary Inspector, in place of F. Wiltshire.

Moved by Councillors Hayes and Stewart, that \$20 be assessed on District 7 for the support of the poor.

Moved by Councillors Taylor and Stewart, that all sections of Chapter 97, Revised Statutes, relating to the measurements of logs, lumber, shingles and wood be printed for the information of the officers.

#### Loan for New Road.

Moved by Councillors Flemming and C. E. Smith, that this Council ask the Provincial Government for the loan of \$700 for the construction of a new road leading from Windsor Junction to Groves Siding, in District 17, County of Halifax. The motion passed.

The following resolution, moved by Councillors Wilson and Taylor, was passed:

"Whereas, the disbursements of the County often require ready cash in excess of the funds in hands of the Treasurer;

"And whereas, it has been customary to meet such deficiency by negotiating overdrafts from the Banks, obtained on a written order from the Warden;

"And whereas, such authority is not quite satisfactory to the Banks or just to the Warden;

"Therefore resolved, that this Council approves of granting authority for the Treasurer to overdraw his Bank account --In anticipation of increasing taxes-for pressing current expenses to an amount not to exceed \$3,500; provided always, that he shall first furnish the Bank with a written authority from the Warden in such sums within the ahove prescribed limit as from time to time may he necessary."

The Council then adjourned until 3.30 o'clock. In the meantime the Road and Bridge Committee proceeded to work on its report.

#### FRIDAY AFTERNOON.

The Council met on Friday afternoon at 3.30 o'clock. Warden Madill was in the chair.

A petition was read from the Laurencetown and vicinity setting forth the necessity of a road over the Cole Harbor Dyke to complete the road already laid to the bridge over the aboitcau. The road would be a very great convenience to the people of Laurencetown and Cow Bay and the traveling public generally. The petitioners asked for a preceipt to lay out the road. Councillors Kuhn and Lydiard moved the following resolution in connection with the above:

Resolved, that the precept and the report of the committee for laying out the road over the Cole Harbor Dyke be accepted. The motion passed. Moved by Councillors Flemming and Moran that the bridge on the Windsor Road at Augustus Fenerty's be placed under the smaller bridge act, and amendments thereto.

Moved by Councillors Lydiard and A. F Smith that \$150 be assessed on District 31 for the support of the poor.

Moved by Councillors Milne and Homans that the roads in District 20 be re-measured and that all costs in ecnnection therewith be at the expense of the District.

Moved by Councillors Croucher and Whitman that the motion made to assess District 12 \$40 be rescinded and that \$60 be assessed on the District for the support of the pocr.

Moved by Councillors Coolen and Johnson that the bridge known as flardiman's Bridge be placed under the smaller bridge act.

The following resolution was moved hy Councillors Lydiard and Wilson:

"Whereas the city of Halifax has given notice that they are desirous of reconsideration of the several amounts payable respectively by the city of Halifax and this Municipality, and a consideration of the several items be arranged during the session of the Council.

"Therefore resolved that this Council hereby authorize the committee appointed to confer with the city in regard to matters in dispute to deal with such matters."

## The Court House Grant.

In connection with the above Councillor Wilson said that a committee consisting of Councillors Lydiard, (chairman), Billman and himself (Wilson), had waited on the Local Government on Friday morning with the object of having the ernment allowance towards the support The only of the Court House increased. members of the Government present were Premier Murray and Hon. A. Drysdale, the Commissioner of Public Works and The representatives of the Mines. Council explained their case, Mr. Lydiard presenting figures, etc., to support their claim. The Dartmouth delegation, he said, did not know much about the matter. Aid. MacIlreith also appeared on behalf of the city and clearly stated the ease. The Premier was unaware that the Government paid anything toward the Court House. Mr. Wilson said that Premier Murray stated had a fairly good case, and that they that he would consult the Attorney-General on his return to the city. The delegation was favorably received and Mr. Wilson thought that there was a fair chance of getting an increase.

Councillor Wilson explained that the above resolution meant the delegating of the powers of the Council to the committee.

Moved by Councillors Wilson and Hayes that the Councillors pay for this session be \$2 per day and the usual travelling expenses.

Also, that such Councillors as were unable to be present at the opening session be exempt from the penalty for nonattendance.

#### Miscellaneous Matters.

Moved by Councillors McLean and Connors that S. W. Shankel, Thomas Kinnedy and Rand Gibhons be superviors of public grounds for District 30.

Moved by Councillors Taylor and Crooks that the bridge on the Guysboro Road, near Raymond Fisk's place, be placed under the smaller bridge act ant amendments thereto.

Moved by Councillors Kuhn and Johnson that Wen Conrod, John Beenner and Alex. Crook constitute a board of supervisors for eare of public grounds in District 24. Moved by Councillors Flemming and A. F. Smith that the Government grant for roads and bridges for the County of Halifax for the year 1902, be expended under the authority and inspection of the several supervisors of roads appointed by this Municipal Council, excepting those sections of roads under commission.

Moved by Councillors Canfield and Thomas that G. F. Sanford, G. E. Van-Buskirk and T. D. Knowles be supervisors of public grounds for District 15. Moved by Councillors Connors and Croucher that Joseph Tanner, James II.

Scott and Wm. Baker be supervisars of public grounds for District 38.

Moved by Councillors Bishop and Homans that the clerk of this Council notify all the road supervisors of the rate of pay to be paid for teams and at bis earliest convenience, also for labor in accordance with Councillors Lydiard's resolution passed previously. Moved hy Councillors Darragh and Milne that Thomas Lindsay be appointed electoral revisor for District 21 A.

Moved by Councillors Negus and Ryan that the chairman of Public Committee be paid \$50, and the vice-chairman of said committee \$25 for their services in connection with said committee.

Moved by Councillors Bishop and A. F. Smith, that the persons to be representatives of Districts 31 and 33 to determine the boundary line between said districts be for District 31 Councillors S. W. Lydiard and Hugh Grant, and for District 33 Councillors Negus and Provost Horne.

Moved by Councillors Taylor and Stewart that John B. Archibald, Raymond Fisk and M. H. Guild be supervisors of public grounds in District 21.

Moved by Councillors Stewart and Taylor that J. H. Chaplain, J. D. Henry and David Archihald, Jr., he supervisors for District 22 for public grounds.

Moved by Councillors Thomas and Johnson that John Wiseman, Joseph Misenier and Peter Clayton be a board of supervisors of public grounds for District 30.

Moved by Councillors Canfield and Taylor that the resolution asking for a change in paragraph I, Chap. XIV, of our by-laws, be rescinded. Moved by Councillors Canfield and Thomas that the taxes assessed on J. O. Lehwess for 1901 be remitted, and also the taxes on \$300 assessed on H. A. Roche.

Moped by Councillors C. E. Smith and Hayes that the resolution of Councillors Wilson and Flemming in reference to clerk of licence visiting districts for the Peddlers Act. lay on the table.

# The Railway Route. Easterno

Moved by Countillors Kuhn and Lydiard "That whereas, the sum of \$5,000 was granted by this Council at its January session for the purpose of assisting in defraying the cost of a right of way for a railway through the Musquodoboit Valley, and whereas, an agitation it now progressing and meeting with very general approval for the purpose of changing a part of that route and substituting therefore the route known as the shore route,

"Therefore resolved, that this Council grant the company the privilege of changing the route as in their discretion will be most advantageous to themselves and the public generally."

Councillor Lydiard explained that the resolution was brought up on account of a large delegation waiting upon the Legislature at the recent session, with the object of taking the line of railway around via the shore into Dartmouth. He said that the company was strongly impressed with the route and they may decide to accept it. The object of the resolution was to give the company the grant in case that they decided to adopt the shore route.

The following resolution was moved by Councillors Lydiard and Homans, as an interpretation of the one passed at the January session:

"That the rate of pay per day in regard to the Expenditure of the Government road grant be not in excess of the following: Road Masters, \$1.25; laborers, \$1.15; single teams, with driver, \$2, and that the rate per day for laborers in commutation of road tax be \$1."

The resolution evoked considerable discussion, those taking part being Councillors Lydiard, Kuhn, Croucher, Taylor, Bishop, McMullin, Hayes, Canfield and Wilson. It was finally decided to adopt the resolution.

Councillor C. E. Smith then brought up the case of the Commissioners in District 26. He said that it was desirous that something should be done about the matter as the Council did not want to be mixed up in a lawsuit.

Councillor Lydiard said that the Commissioner was appointed by law for four years, and that since the resolution passed at the January session he learned that the Commissioners could not be removed except for cause.

Councillor Kuhn said that charges would have to be preferred against the Commissioners and the Council hear the case before any such action was taken. After some further discussion the following resolution was passed:

Moved by Councillors Kuhn and Ryan that the resolution which passed this Council at the January session deposing Samuel Henley as Road Commissioner in District 26 be and is hereby resoluted.

The Road and Bridge committee informed the Council that they would probably have their report ready by 11 o'clock on Saturday morning.

The Council adjourned at 5.30 to meet on Saturday morning it 10.30.

#### SATURDAY MORNING.

The Council met on Saturday morning at eleven o'clock. The minutes of Friday's session were read and approved.

The request of Constable Burbidge for holidays during the summer was granted. The following resolution was moved by Councillors Kuhn and Flemming:

"Whereas the Government in its discretion has placed the care and maintenance of the highways under the supervision and control of the Council.

And whereas, the condition of the highways consequent upon increasing travel is steadily deteriorating in condition, until in some sections, at least, travelling has become laborious and exhaustive, and;

Whereas, up to the present, no system or plan has been devised which on application has proved efficient in ameliorating or improving this unsatisfactory condition of the said highways:

Therefore resolved, that this first year of the life of this Council presents a fitting opportunity for experimenting in repairing or reconstructing the highways, with the object of determining a plan which under existing circumstances will prove itself efficient for that purpose in a manner which will at once be a credit and source of advantage and satisfaction to the Municipality."

Councillor Kuhn's resolution regarding the making of roads aroused some discussion, Coun. Casey thinking that stone on roads in some cases was a great mistake. In his district they found brush and poles act better.

Coun. Lydiard instanced a good example of the benefit of stone for road building on the Dartmouth road, where a formerly bad place had been scientifically constructed with rock and stone and was now the best place on the road.

The resolution passed.

# Report of the Committee on Roads and Bridges.

We would further recommend that not less than one hundred and seventy-five dollars of this grant for district wo. 25 be expended on the Musquodoboit road, and also that allowance for district 15 be used on the roads other than the main post road.

Coun. for district 12 also throught he had been given too little, as they had the whole western counties traveily gover the district. He was \$108 shoth, and was afriad to go back to his district.

Councillors Kuhn and Billman moved that the report of the Road and Bridge committee be referred back to them to be divided equally among the districts in proportion to mileage. The resolution on being put was lost.

The following resolution was then submitted.

Moved by Councillors Bishop and Darragh that the report of the Road and Bridge committee be adopted. The resolution was carried.
