prospective students in addition to the campaigns carried on at the schools. The trustees are looking to the day when the schools will be staffed with selected and well-trained teachers.

Trustees were always willing to meet with the Inspector to discuss school matters. It will be recalled that combined Trustees' Meetings were held last year in five centres. This year one of the most stimulating meetings was held at Woodside which was attended by fourteen Boards from the adjacent Rural and Village areas. The discussions dealt with the following:

- 1. More thought should be given to the planning of the new school buildings so that they will incorporate in them space to carry on more activities than those conducted in the classroom.
- 2. Improved health facilities.
- 3. More easily accessible Health Clinics.
- 4. A travelling Dental Clinic for the County.
- 5. The formation of a Trustees' Association.

Mr. D. H. Montgomery, Secretary to Trustees at Falkland Village, who was appointed Vice-President of the Canadian Trustees' Association in August, 1946, explained at the above meeting what was being done by Trustees' Associations in the rest of Canada and urged the formation of an organization for the County. A committee was named to meet with other groups.

The School Registers and the Reports of the Annual Meeting show that there were very few schools not visited by the trustees while the schools were in session. The table which follows gives the number of residents who attended the Annual Meetings:

Contact with trustees was made either through individual or public meetings or through circulars. Whatever means was used emphasis was made on better sanitation, the payment of debentures on time, improved heating and the necessity of having a good stock of teaching supplies. In the Spring of 1947, a special list of supplies needed for one-room schools prepared by H. M. Nason, Inspector-at Large, was mailed to the Rural school sections. Each section was asked to put on a special improvement drive before the close of the year. The response was very encouraging. As a result more sections qualified for the Equipment Grant than previously.

Experiments in oil heating were carried on in the one-room schools at Pleasant Harbour, Portuguese Cove, Brookside, Shad Bay, and West Lawrencetown; Oakfield and Oyster Pond, two-room schools; and Rockingham, a school of four rooms. As far as can be learned the cost of operation was the same as wood. Imperoyal has used oil for years.

The Financial Reports showed that some \$12,000.00 was raised through community effort. This together with the amounts raised during the four preceeding years made a total of over \$59,000.00.

The improvement programme carried out by the trustees included attention to better sanitation, central heating, installation of electric lights, modern seating, more and better supplies, increased insurance and more adequate playgrounds. Armdale expropriated about two acres for a playground; South purchased one-half acre; the schoolgrounds were gravelled at Elmsvale; sketches were prepared by the agricultural representative at Truro for the improvement of the school grounds at Elderbank and Head Jeddore; Chaswood cleared almost an acre for play activities; a concrete wall was built to enclose the front of the grounds at Spryfield; and Quoddy has begun to terrace their grounds.

There was opened at Fall River West in September 1946, one of our most modern new schools, built by community effort. The building programme covered a one year period at the conclusion of which the residents of the western part of the area presented the building to the school section.

The trustees of the suburban areas have been confronted with the difficult problem of providing classroom space due to the rapid increase in population. Some idea of this growth may be gleaned from the following table representing the period - 1041 1047.

The suburban areas have one hundred and thirty-three departments which with their complex problems form a distinct unit separate and apart from the Rural areas which lie beyond.

It has been impossible for the trustees to provide space in many instances due to the shortage of materials, or because no tender could be obtained or because when a tender was received it was beyond the ability of the section to pay. The grand total includes over one hundred substitute teachers many of whom were Permissives who taught for only a short time. Seven hundred and nineteen schools were in session during the year. Two hundred and thirty teachers held University Degrees. On a percentage basis the distribution of teachers according to class of license is given below:

Besides the above list there were thirty-one specialists in Music, Handicrafts, Manual Arts, Household Economics, Vocational Guidance and Physical Fitness, making in all eight hundred and seventy teachers. At the present time there are three hundred and eight departments in the Rural and Village areas.

There was an attempt made generally in the County to improve the teaching. The Health Programme received special attention and there was a noticeable increase in the number and quality of books in the school libraries. Forty teachers qualified for the Library Grant.

A number of the teachers prepared their pupils for the Public Speaking and Music Festival held at Halifax, June 2nd, to 7th. Their efforts were well awarded since the students compared favourably with other competitors. A scholarship in Public Speaking was won by a pupil from the one-room school at Maroon Hill. A definite improvement has been noted in Reading, more particularly in zones where the local Festival movement is well established.

A circular was mailed to each teacher at the beginning of the year requesting that special attention be paid to the teaching of the fundamental operations in Arithmetic, particularly fractions. As a follow-up the Inspector tested some three hundred pupils of grades VI - IX in the smaller schools with fair to good results. The test consisted of five questions dealing with the fundamental operations in the solution of fractions. There was a distinct variation in the results from high to low depending upon whether the school tested was a village of two rooms, a one-room school on full time or a one-room school on double sessions. In order to publish the results which will give a picture of conditions more accurately the test will have to be lengthened, more pupils tested, and the programme will have to be continued again this year.

Teachers were urged to acquaint themselves with the great wealth of material available at the Central Library and to read regularly the excellent articles which appear in the Journal of Education. Lists of other free materials were made available.

There were five Teachers' Clubs and those who attended received ideas and inspiration through an interchange of experience and knowledge. In those areas served by the Clubs there was, with rare exception, a high standard of teaching.

A Teachers' Conference was held at Fairview in November, attended by over three hundred teachers and citizens. In addition to discussion groups and lectures,

the teachers received valuable help from the exhibits on display. These included books from the Central Library, the Knowlton Supply Co., the Home and School Association, the Junior Red Cross, Historical Murals loaned by the Canadian National Exhibition, and displays of the work of the schools. The staff of the Fairview School exhibited, progressively arranged, work to be expected from children of various ages and grades. Smaller Conferences, none the less successful were held at Sheet Harbour and at Middle Musquodoboit. The teachers' bursary for 1947 was won by a student from South Armdale.

#### DEPARTMENTAL

During the Summer and Autumn of 1946, Dr. Hugh MacKinnon assisted by Miss Constance Wade, R. N., and Miss Mary MacDonald, R. N., the two Public Health Nurses, carried on a vaccination campaign with the result that ninety-five percent of the pupils are now vaccinated. The medical doctors throughout the County gave valuable assistance in this undertaking. Both Miss Wade and Miss MacDonald, in addition to conducting regular physical examinations, urged the need for better sanitary conditions both in the school and in the outbuildings. They also discussed with the trustees better lighting and better playground facilities. A third nurse is needed if the health of the children is to receive adequate attention. Mr. Hugh Noble, Director of Physical Fitness, and his staff gave demonstrations

Mr. Hugh Noble, Director of Physical Fitness, and ms start gave childred with at the Autumn Conference of teachers. Several centres were also visited by this branch of the Department of Health. These demonstrations resulted in a better planned programme of Physical Education in both Rural and Village schools. Bedford and Dartmouth entered basketball teams in the Halifax and District League for dand Dartmouth entered basketball teams in the Halifax and District League for the first time. There was a tremendous increase in the after school activities in Physical Fitness. Schools particularly active were Sheet Harbour, Middle Musquodoboit, Bedford, Dartmouth, Imperoyal, Fairview, Spryfield, South Armdale, Oyster Pond, Head Jeddore, West Jeddore and Wellington. Representatives were sent from Dartmouth, Bedford and Armdale to qualify as official referees for girls' basketball.

The first Home Economics circuit in the County was established in September, 1947. Under Miss Ruth Binnie's guidance, Miss Shirley Morgan has been carrying 1947. Inder Miss Ruth Binnie's guidance, Miss Shirley Morgan has been carrying on classes at Partridge River, New Road, Lake Loon, The Nova Scotia Home for Coloured Children, and Upper Hammond's Plains. Special rooms for the teaching of this subject were provided in three of the centres. The circuit is unique in that it is the only one in the Province to serve the coloured schools.

Instruction in Manual Arts was made available to fifteen Rural and Village Schools in the Musquodoboit Valley through the operation of Shopmobile No. Four, under the direction of Mr. Earl Blackburn. There were classes in woodwork, electricity, sheet metal and forge work, farm and repair jobs. There were six centres to which the boys came, some travelling as much as six miles. The Instructor reported almost one hundred percent attendance and unusually keen interest. Woodside also continued classes in woodwork.

Exhibitions of the work done by the Garment Clubs organized by the Extension Department of the Department of Agriculture were displayed at the Spring Festivals held at Glen Margaret, Sheet Harbour, Oyster Pond and Middle Musquodoboit.

During the year the Adult Education Division conducted classes at Upper Hammond's Plains and Partridge River. These classes were well attended and the Ammond's Plains and Partridge River. These classes were well attended and the results achieved are a testimonial to the splendid planning and leadership given by this Division of the Department. Classes are also in operation at Murphy Cove and Sober Island.

The Film Library still continued to be popular and I am pleased to report that many schools are endeavouring to purchase projectors.

More schools installed electricity so that they might be able to participate in the Radio Broadcasts. The Inspector who was privileged to be present at several

schools during the Maritime School Broadcasts period found that there was careful preparation and follow-up work in connection with this phase of the school programme.

Much interest was shown at the Teachers' Conference in the display, of books arranged by Mrs. Myra Vernon of the Central Library. Not only the teachers but the representatives of the school boards were interested in learning how to provide and equip properly the school library. There is a great need in the smaller centres for more and better reading material which might be supplied by a Mobile Library.

The Rural Science Office provided Teachers' Clubs with magazines and pictures for the teaching of an Appreciation of Art. The members of this department gave liberally of their time in helping teachers when requested.

The number of Home and School Associations increased so that by the end of the year there were fifty-one. Within the County Council, in addition to the Sub-Council in the Musquodoboits, there was formed a Council of City Associations. This organization continued its good work not only in school improvement but also in stimulating a keen interest in the Rural High School programme, the Music and Public Speaking Festivals and in working for full-time classes in the congested areas. At the Spring Rally held at Fairview, the discussion on Health brought out the necessity for a Dental Trailer for the Rural and Village areas of the County.

An outstanding hot-lunch experiment was carried out at Sheet Harbour under the direction of Miss Marjorie Bell of the Canadian Red Cross, Nova Scotian Division. Miss Bell met the mothers of Sheet Harbour and the Local Auxiliary of the Red Cross showing the need for a more nourishing lunch at the noon hour for those who could not go home. Following this a meeting was held with the teachers and pupils where plans were laid for the serving of hot cocoa prepared by the teachers and served by the older pupils. The equipment was supplied by the Local Auxiliary of the Red Cross. There were between one hundred and twenty-five and one hunfred and fifty pupils served at a cost of fifteen cents per week per pupil. Miss Bell extended her efforts to all Local Auxiliaries along the Eastern Shore urging a similar plan.

The Junior Red Cross continued its efficient work. Miss Elizabeth Browne conferred with the teachers at the Autumn Conference and displayed material done locally as well as some received from foreign countries. The number of branches is given below.

One-ninth of the branches and one-eighth of the membership in the Province for the year just closed was in Halifax County.

#### , THE PEOPLE

There has been a gradual increase in interest in Education. The majority of the people are looking to the time when their children will have the privilege of attending a Rural High School or the Vocational High School in order to have the same opportunity of obtaining a higher education like those more fortunate in the Urban centres.

School sections are requesting better trained teachers, teachers who are willing to face the challenging situations which so often arise unexpectedly and teachers with a greater professional interest. The intermingling of the people due to the war, the emphasis which education officials have been placing on more and better education, the public meetings which were held during the campaign for the Municipal

Unit, and the discussions on the Rural and Vocational High Schools have left their mark so that now our people are asking for the best and only the best.

In most areas the people are willing to bear their share of the financial burden, and so progress results. Some few areas are reluctant to do this and so there, conditions remain almost static.

#### MISCELLANEOUS

The members of the Royal Canadian Mounted Police continued their talks on Safety on the Highways.

The Common Examining Board which was set up for the examination of the grade IX students of the St. Margaret's Bay area in 1945 - 1946, functioned again the structure of the St.

As in former years the I. O. D. E. distributed books, magazines, and flags to a selected number of schools. The gifts from this organization are very much appreciated and they fill a great need, Some of the school sections received assistance from the Women's Institutes and from the Service Clubs.

The Citizenship Cup for the Province was presented to Elderbank at a special meeting of the people in the Autumn of 1946.

A higher standard of school work was exhibited at the Halifax County Exhibition as well as at the smaller local centres.

#### CONCLUSION

I would like to thank all who in any way helped me during the year in trying to improve Education in the County. To the members of the Municipal Board I extend my sincerest thanks; to the Municipal Clerk my warmest gratitude; to the trustees appreciation of their unceasing loyalty; to the prople co-operation in their efforts to improve Education.

To you, Warden Dowell, and members of the Council, I extend my thanks for the interest you have shown from time to time. Keep the interest in your districts keen and high but all times stable. Good sound thinking is necessary, excesses keen and high but all times stable. Good sound thinking is necessary, excesses which we belong and which may be appropriately applied to our Municipality in our which we belong and which may be appropriately applied to our Municipality in our outlook for the future:

# REPORT OF THE TENDERS AND PUBLIC PROPERTY COMMITTEE RE HALIFAX COUNTY HOME AND MENTAL HOSPITAL

#### To His Honor the Warden and Members of the Municipal Council.

#### Councillors:

Your Committee on Tenders and Public Property has pleasure in submitting the report on the operations and activities of the Halifax County Home and Mental Hospital for twelve months ending December 31, 1947.

As usual, monthly meetings of the Committee were held and in addition sub-Committees met at various times in connection with special activities. Your Committee could hardly be expected to give a detailed account of all its work, as this would involve an extremely long report and probably a brief summary of what has been accomplished will be sufficient.

During the year fifteen acres of land were brushed and burned for pasture; four acres of new ground cleared and planted; five acres stumped, ready for spring planting; roadways and lawns greatly improved and a number of shrubs were planted. All the outside doors and windows in the main building, together with a number of bathrooms, hallways and dormitories, were re-painted, and the diet kitchen was renovated and re-painted. A well for the pig house was dug -15 feet x 8 feet - with a concrete top and we are happy to state there is a goodly supply of water. The road signs, hen house, pig house, barn, carpenter shop and two garages have been repainted. In order to keep the road between the Home and the Dartmouth Town limits in condition for safe and speedy travel, we spent twelve tractor hours on the road scraper; fifty-three tractor hours on the snow plow, which includes one hundred and six man hours labour on the snow plow and tractor.

Due to the explosion of 1946, which caused a number of cracks in the outside walls, temporary repairs were effected last fall and during 1948 this will have to be permanently repaired. Storm doors are required and have been ordered and in the meantime temporary storm doors have been used.

For several years we have been endeavouring to procure a generator, which could be used whenever our electric power might be cut off, and late in the year we received this machine, which will be installed as soon as the contractors are able to do the work. This will ease our minds to a very large degree, as in the absence of electric power, practically everything would be cut off – an impossible situation.

The farm operations were very gratifying and will be reported upon in a separate report. The total value of the produce raised was over \$20,000. During the first year of the farm, the value of the produce was slightly over \$3,000, so that there has been a decided improvement in this respect. The visit of the Councillors to the Institution last March was thoroughly enjoyed, not only by the patients, but by the staff as well, and suggestions made by Councillors at that time, as well as during the year, have been gladly received and have proven to be very helpful, and any suggestions or constructive criticism is welcome by your Committee at all times.

As usual, the Christmas festivities were probably the most outstanding event of the year, especially for the patients, and last December was undoubtedly the best we have yet had. The staff entered wholeheartedly into the occasion and gave up much of their own time towards the welfare and happiness of the patients. Useful gifts were purchased with the money contributed by the Districts and other interested and in addition to practical gifts, the patients received supplies of candies, oranges and other Christmas delicacies. A group of carol singers from the Kiwanis Club of Dartmouth entertained the gathering with a splendid selection of Christmas carols and a group of sixty-eight girls and four boys from the Glee Clubs of Hawthorne and Park Schools at Port Wallis and Cole Harbour also rendered a selection of Christmas carols.

The management of the Institution wish to record their appreciation and sincere thanks to all those who assisted in the festivities by contributions of various kinds. These include:

Mr. Stewart Harris officiated as Santa Claus to the delight of all the patients.

In addition to the Christmas festivities, the Kiwanis Club of Dartmouth exhibited ten Motion Picture Shows during the year. The Dartmouth Baptist B. Y. P. U. put on a play "Aunt Tillie goes to Town" and gave a year's subscription to the Religious Digest. The W. A. Sanctuary Guild of Christ Church contributed the baskets of flowers and during the summer Rev. Canon Ryder, accompanied by rev. Mr. Lavatte and the Christ Church Choir, visited the Institution. Gifts of Rev. Mr. Lavatte and the Christ Church Choir, visited at all times. The are gratefully received.

Religious services are held regularly and the sick are visited at all times. The Institution is greatly indebted to Rev. J. E. Willett, Rev. Father Hooper, Rev. Nelson MacDonald, Rev. Neil Hamilton and Capt. Sloues for their cooperation in these services and visitations.

Several years ago a Radio Fund was established; the object being to purchase a complete radio system for the whole Institution whenever financially possible and we gratefully acknowledge a contribution of \$15.00 from the Hon. Joseph Howe Chapter No. 20, Order of the Eastern Star, "In loving memory of their late brother and

sister, Frank and Mamie Smith," to be used for radio system at the Halifax County Home and Mental Hospital.

During the year your Committee gave consideration towards enlarging the present building or erecting an extra building for staff quarters.

After consultation with our Architect and Engineer, we believe that the building of outside staff quarters would be extremely expensive, and at the present time feel that it would be more desirable to add additional stories to the two wings of the building, which would give adequate staff accommodation, as well as seventy-five to one hundred additional beds, and permit a better segregation of patients. This would give us additional earning power, as we could then accommodate more private paying patients.

We feel that this is a matter that should receive the earnest consideration of the Council at the present session and your Committee given some definite suggestions in the matter.

During the year there have been many changes in the personel of our staff and the situation in this respect has not improved as much as we had hoped and it is still very difficult obtaining satisfactory assistance among the nursing profession. At times we have been under-staffed and we thoroughly appreciate the loyalty exhibited by our nurses and attendants, who so willingly assumed additional work whenever called upon.

We started the year with 238 patients and on December 31st there were 287 patients in the Institution, which cartainly indicate the absolute necessity for greatly increased accommodation, as the original building was only intended to house approximately 240 patients. The lowest number of patients at any time during the year was 237, while in December we had 292 patients for several days. The total number of patient days was 97,441, an increase of 11,802 patient days over last year It should be noted that the total number of patient days in 1941, the first year of our operation, was 77,085, so that last year shows an increase over 1941 of over 20,000 patient days.

The Committee wish to report that they have made arrangements with the Bell Bus Service to carry on their service daily to and from the Home by an arrangement of subsidy, which we feel will prove quite satisfactory.

We also wish to make comment on the very fine service rendered to us by Dr. Lamont at the Institution. He has made daily visits and this arrangement has been very satisfactory.

During the year we paid off the usual Serial Debentures and payments on the Dominion Loan. In 1947 we paid off \$2,000.00 of our Serial Debentures and \$5,546.54 on the Dominion Loan, making a total reduction from our original borrowings of nearly \$50,000.00.

Your Committee has pleasure in submitting the foregoing as a result of its efforts during the year and while other matters might possibly be mentioned, at the same time we would much prefer to have the Councillors see the Institution for themselves and judge of its value.

# REPORT OF MEDICAL HEALTH OFFICER COUNTY HOME

To His Honor the Warden and Members of the Halifax Municipal Council.

#### Gentlemen:

I beg herewith to submit a report as Medical Doctor for the Halifax County Home and Mental Hospital.

Throughout the year daily visits have been made; on such occasions all patients were visited, treatments given and inspection of the various wards, kitchens etc. carried out.

Electric Shock treatments have been continued with very satisfactory results. These are usually administered two or three times a week and the total number of treatments depend on the patient's condition and response.

Two Hundred and sixty-eight patients were innoculated against Typhoid Fever

All patients received Physical and Psychriatric examinations on admission.

There were One Hundred and Twenty-five admissions; Forty-four were discharged and Thirty-two deaths during the year.

As a Hospital is judged by its food and the recovery of the Patients, in many cases and the reputation of the Hospital in a large measure depend on the nutritious appetizing food and the care and treatment they receive; I feel those patients requiring Hospital care and treatment can enter our Institution confident that the treatment they receive there will be in full accordance with accepted and established practices.

In closing may I express my appreciation to Mr. and Mrs. Smith, Superintendent and Matron of the Home, and their Staff for the splendid work they are doing.

# REPORT OF COUNTY PLANNING COMMITTEE

Th The Warden and Councillors, Municipality of the County of Halifax.

#### Councillors:

Your Committee on County Planning have pleasure in submitting the following report.

At the Annual Session of Council a year ago the County Planning Board was created under the Town Planning Act and \$5,000.00 was set aside for the operation of the Board. The Board consists of: Chairman - Councillors Wm. A. Gates and Members - Councillors Settle and Chisholm, and Mr. R. S. Allen, Mr. R. F. Tolson, Mr. Wm. P. Anderson and Warden W. J. Dowell, Ex Officio.

On June 19th a meeting of the Board was held when Councillor Gates was 'chosen Chairman and Councillor Settle, Secretary of the Board.

Mr. R. M. Fielding, K.C., gave a resume of the functions and powers of the Board all of which are contained in the Nova Scotia Town Planning Act as adopted by the Council at its Annual Meeting.

A general discussion ensued covering various Control Acts such as the Building Act; the Metropolitan Area Act and the Town Planning Act and as to their cooperation and co-ordination to effect proper control.

It was decided to have the Warden contact Mr. George Bates with a view to having him attend a future meeting.

Mr. Fielding called attention to Section 21, Sub-sections 1 to 5 of the Act, whereby after a plan is adopted the Council must proceed with same or if the public interest requires the Minister can proceed to appoint the Board and, if necessary, exercise all necessary powers for and in the name of the Council giving notice in the Royal Gazette.

The next meeting was held on June 27th when Mr. Ira MacNab of the Halifax Public Service Commission, Mr. Dumaresq, the City's Town Planning Engineer and Mr. George Bates, Planning Consultant, were present.

There was a general discussion of the aims, objects and means and it was decided that the first thing was a preparation of zoning By-laws, then to proceed in accordance with the Act. In this connection we could either make plans for the whole County or for certain of the more congested Districts as in the so-called Metropolitan area. In this it is necessary to consider the City, Town, and Municipality as a whole so that the zoning for the whole County is most important.

The question of width of roads was discussed and it was felt that the width of streets should be determined by their length and use and where possible future development suggests, building lines could be set up. The size and shape of lots is very important in the County to assure proper filtration because of the use of wells, septic tanks and privies, in many places individual water and sewerage facilities could not be had and still maintain proper sanitation.

It was felt that health conditions and highways were important considerations so that co-operation with the Highway Department could be had. The sale of lots without a proper street layout must stop if this co-operation is to be had. Both Mr. MacNab and Mr. Dumaresq expressed their willingness to co-operate in every way possible to make this a success and suggested the possibility of using aerial surveys.

Tentative plans of the Metropolitan and some other congested areas was considered as the first step advisable. Mr. Bates was engaged to prepare data and plan also a base map for presentation to Council for its approval at a retaining fee of \$500.00. This map is not yet completed but in due course will be presented to Council for its approval.

It was decided to arrange a meeting with the Highway Department and Department of Municipal Affairs to seek their full co-operation.

On July 17th the Board again met and Mr. R. W. McColough of the Department of Highways, Mr. C. L. Beazley, K. C., of the Department of Municipal Affairs, Mr. Ira MacNab of the Public Service Commission and Mr. George T. Bates, Planning Consultant, were present. The Chairman stated that the purpose of the meeting was to secure the full co-operation and support of the Departments of Municipal Affairs and Highways and both Mr. Beazley and Mr. McColough assured the Committee of their support and co-operation conditioned only on our getting on with the job.

Mr. McColough felt the time had come to do something about narrow roads now existing, and preventing their recurrence in the future. He felt that 66 feet should be the minimum width if we wish the Department to take them over. In response to Warden Dowell he advised they would be reasonable in such as now

exist, and would deal with each case individually according to their needs and merits, taking over where deemed proper and feasible. Co-operation must be had in all future layouts. Chairman thought all legal points should be straightened out and then advertise the standards that must be maintained.

Discussing the question of co-operation and co-ordination with the City and Town, Mr. McColough felt that the County should have the same say within their boundaries as they have in the City. Mr. Bates wanted to know if the plans for individual sub-divisions could be approved before the master plan was set up. Mr Beazley believes that sub-divisions can be controlled as soon as the Board is organizde. Mr. Fielding felt that we should have the approval of the Municipal Council.

Mr. Anderson told of conditions in his District that led to the discussion of Building Lines, already set at 30 feet from road line. Mr. McColough did not think this practical as conditions varied and what suited one place might not suit another. Rather, each sub-division should have a proposed building line submitted with it.

Mr. Bates reported progress in the preparation of a topigraphical map of the County on a scale of ½ mile to the inch, from which rough plans can be made. Individual lots are details that must depend on existing conditions, contours of land, or dividual lots are details that must depend on existing conditions, contours of land, or dividual lots are details that must depend on the Aerial survey and maps mentioned in last roads, etc. Mr. MacNab reported on the Aerial survey and maps mentioned in last meeting, information on which would be available by the end of the year. The maps are being developed.

Regarding the title to streets to be taken over by the Highway Department, these must come from the Municipality. Mr. Fielding pointed out the situation at present attaining of roads that are public but no deeds attainable. Ownerships of these considered vested in the Province.

In view of the possibility of a Metropolitan Health Set-up for this area, Mr. Fielding wanted to know what co-operation we could expect from the Provincial authorities. Mr. Beazley could not speak for the Health Department but Mr. Ira MacNab felt that we could count on this. He has had full co-operation from them in his work on the Public Service Commission in the City.

Regarding granting permits for buildings, Mr. McColough advised that levels should also be considered.

It was suggested that building permits could be refused on any new road or extension of old roads that are less than 66 feet in width, as the Highway Department will not take over such roads or extensions.

During the summer and fall months Mr. Bates spent considerable time on the preparation of a Base Map, collection of statistics, graphs etc., and these will be submitted to Council at this Session.

On January 10th the Warden, the Chairman of this Committee, Mr. Bates and the Municipal Clerk had a conference with Dr. F. R. Davis, Minister of Health and Municipal Affairs in connection with the Shell Oil proposition at Woodside. As a result of this conference it was agreed by your representatives that in view of the location of the Nova Scotia Hospital with the proposed location of the Shell Oil was not destrable due to the fire hazards in connection with such an industry but that this will not preclude other types of industries from locating in that vicinity.

On January 14th the Board again met at which time there was a general discussion relating to sub-divisions, lot and street widths, building lines, permits for sub-divisions and for buildings etc., and it was finally agreed that lots in any subdivision should be not less than 60 feet in width and not less than 100 feet in depth and comprise an area not less than 6,000 square feet. will be given in cases where the width or depth may differ from these figures but the total area of the lot in question is not less than the required 6,000 square feet.

It was further decided that in view of the declared policy of the Department of Highways in this Province that we will not in future approve of any new sub-division or grant any building permit on any road of less width than 66 feet. It was also agreed that all land surveyors be notified by letter and through the Press that the approval of the County Planning Board is required for all plans of sub-divisions in Halifax County, a copy of such plans to be filed with the Municipal Clerk.

Mr. Bates submitted a hand made topographical map covering most of the County drawn to scale showing in detail the progress of the work to date and further detailed information will be added as his work progresses. After a thorough discussion of the whole situation it was decided to have Mr. Bates continue his work as from January 1st., 1948 at a remuneration of \$200.00 per month.

After the July meeting an advertisement was inserted in the Public press giving notice that the policy of the County Planning Board of this Municipality will be to refuse building permits to occupiers of lots on new roads or extensions of old roads unless such roads are 66 feet in width. Also to refuse approval of sub-divisions as required by the Town Planning Act unless provision is made for roads of the above referred width due to the fact that it is against the policy of the Department of Highways to take over new roads or extensions under 66 feet in width. Copies of this advertisement were also mailed to land surveyors, Trust Companies and others interested in sub-divisions.

In February an advertisement was inserted in the Press as referred to in the. meeting of January 14th.

Now that the Board is well established and the members becoming more familiar with their duties we believe that we should

- (a) Concentrate on consolidating our steps and position to date with regard to Sub-division practise in the County, and
- (b) Continue and expand the studies that have been started of land use, population distribution, industry, commerce, recreation and other related subjects in order to advise Council on matters relating to the welfare of the County.

We believe that the Board will be far busier in this second year in accomplishing (a) above than it was last year. It will be necessary for some consultations with our Solicitor in order to prepare necessary legislation. Regular monthly meetings must be held in accordance with the Town Planning Act. The work of the Municipal Clerk will be increased in degree dependent largely on Sub-division activity in the County.

We also recommend that your County Planning Board should become a sustaining member of the Community Planning Association of Canada, Nova Scotia Division, the fee being \$25.00 a year. We also recommend that provision should be made whereby members of the Board might attend important Planning conferences from time to time. We also recommend that the sum of \$2,500.00 be placed in the estimates for County Planning Purposes for 1948.

We also recommend that the duties of the Municipal Council under Part (3) of the Town Planning Act re Sub-divisions be delegated to the Town Planning Board in accordance with Section 27 Sub-section 4A of the Town Planning Act.

# REPORT OF PUBLIC SERVICES COMMITTEE `

To His Honor The Warden,

and Members of the Council,

Municipality of the County of Halifax.

#### Councillors:-

Your Committee on Public Services submits the following.

At the Annusl Meeting last year the Council, among other things, decided that a competent engineer should be engaged to make a complete survey of the Woodside District and prepare cost estimates of water and sewerage construction.

After inquiries had been made your Committee interviewed Major F. C. Wightman, Consulting Engineer of Amherst and engaged him to make the necessary survey. Major Wightman was formerly Town Engineer for Kentville and Amherst and has been engaged in supervising water and sewerage services in Antigonish and elsewhere. He also has had a wide experience in such matters and during the War was in charge of large Governmental projects.

On July 8th the full Committee met including representatives appointed by the ratepayers of Woodside. The Committee agreed with Major Wightman that the first step would be to review the report of Gore and Storrie which had been made about two years previously at the instance of the Federal Government. Mr. Wightman submitted a detailed report which is on file and recommended that answers be obtained to a number of questions which he submitted which would allow of some specific scheme being explored in some detail which would be based on facts and not assumptions.

A number of conferences were held dealing with water supplies namely with the Nova Scotia Waterways Commission, Imperial Oil and finally with the Town of Dartmouth. Your Committee feit that the logical source of water was from Dartmouth and on October 2nd, your Committee met with the Council of the Town of Dartmouth. A formal request was made to the Town Council to supply the Municipality with water through a master meter at the Town limits.

After considerable discussion it appeared that the Town Councillors were in sympathy with our request provided they could be assured that there was an ample supply of water to cover the present and future requirements of the Town and it was decided that our Engineer, Major Wightman, would meet with the Engineer of the Town and go over the whole proposition and submit a report. At that time it was anticipated that this meeting between the Engineers would be held within ten days of the meeting and we were to be notified when the Town Engineer would be prepared to meet our Engineer.

From time to time the Town Office was contacted to ascertain when the meeting could be held but we were unable to have a date fixed. It was subsequently learned that there was considerable leakage in the Town supply which caused their authorities considerable concern and they wished to overcome this trouble before making any future commitments and we understand that this situation has not been fully overcome at present time.

Upon the election of a new Council in Dartmouth in February a meeting was again held of your Committee with the new Council and the whole matter was again thoroughly discussed. At that time it was known that Dr. MacIntosh of the Rockfeller Foundation was to be in Halifax early in March to go into the whole question of health in the Metropolitan area. It is recognized that recommendation that may be submitted by Dr. MacIntosh in conjunction with the Department of Health of this Province will have a direct bearing on the water supplies in the Metropolitan area, and Town authorities felt that they could not give any direct promise to supply water until the whole subject has been thoroughly explored by the Health Department. It was, however, definitely ascertained that the Town of Dartmouth has ample water supplies and there is no question in our minds that they are able to supply all our requirements which of course would be at rates established by the Board of Public Utilities. One point was emphasized by the Town authorities, namely, that any water that they might sell to us would be only for residental consumption and not for industrial purposes. Should water be required for the latter purposes at a later date further agreements would have to be entered into.

We feel that it should be pointed out to Council that up to the present time the only request that Council has received for supplying of water was a delegation of ratepayers at a Council Session and no petition of ratepayers has as yet been presented either to the Council or to your Committee while, on the other hand, we understand that a petition of ratepayers of the Woodside area was submitted to the Town of Dartmouth for amalgamation with the Town.

We regret the long delay in securing information but your Committee has done its best and the delay has not been occasioned by us.

Your Committee at the request of the Councillor of District No. 14 attended a meeting of ratepayers of Tufts Cove and Albro Lake when the water situation was discussed with negligible results. The possibility of securing water and sewerage for this area will have to be investigated before any recommendations can be made. We recommend this investigation.

The question of water and sewerage in the Armdale District has also been discussed at various time and your Committee recommends that Major Wightman or some other qualified engineer be engaged to make a survey of that area for the purpose of water supply and sewerage disposal.

Your Committee cannot too strongly urge the absolute necessity of exploring all possibilities of supplying of water and sewerage disposal in the congested areas of the Municipality, realizing that these areas, as a rule, have large assessments which bring considerable revenues.

#### REPORT OF COMMISSIONERS OF COURT HOUSE

To The Warden.

and Members of the Municipal Council, Municipality of the County of Halifax

Councillors:-

The undersigned, having been appointed members of the Commission on the Court House, submit the following.

The Court House Commission was set up by an Act of the Legislature and the title to Court House and Jail is vested in the Commission. The Commission consists of the Mayor and three Aldermen from the City of Halifax, the Warden and

one Councillor from the Municipality of the County of Halifax, a representative from Dartmouth, a representative of the Law Society of Nova Scotia and two members appointed by the Gover-in-Council representing the Province. The affairs of the Court House are entirely in the hands of this Commission and the amount of money required to operate it is received through the Joint Expenditures.

For many years past, in fact, ever since the explosion in 1917 very little money has been spent on the up-keep of the building and as a result the building deteriorated badly. For the past fifteen years in making up estimates for the year's operations the Municipal Clerk always included an amount considered necessary to expend on general maintanance but owing to the opposition of these items from representatives of the City they were always deleted from the estimates.

Several years ago a certain amount of interior painting was done but beyond that, nothing was included in the estimates for real maintenance. Your representatives on the Commission have always urged that monies be made available to keep the building in condition but without success. About three years ago a substantial amount was placed in the estimates for general repairs but unfortunately it was not possible to secure a contractor to take on the necessary work and, in fact, no arrangements along this line could be made until last Fall. At that time a survey of the building was made and it was found that major repairs were absolutely necessary. The whole building had to be painted, new windows placed in the greater part of the building, a new roof installed, painting throughout and installation of new lights. Before the survey last Fall was made, it was estimated that it would cost approximately \$30,000.00 to put the building in shape but after the contractor went to work it was found that this estimate was entirely inadequate and at the present time it is believed that the total cost will be in the vicinity of \$60,000.00.

During 1947 we paid approximately \$15,000.00 on account of repairs and approximately \$5,000.00 is in the estimates this year for this work. This will leave a balance of approximately \$40,000.00 necessary to complete the work. The matter has been discussed with representatives of the City of Halifax and the Town of Dartmouth and at the last meeting of the Commission the motion was adopted requesting the Municipality to borrow \$40,000.00 yean issue of serial bonds over a period of ten years and the necessary resolution will be submitted at the present Session of this Council.

Up to the present time the contractor's bills amount to approximately \$35,000. 00. It is certainly very unfortunate that the building has been allowed to deteriorate so badly as by the expenditure of a comparatively small amount each year during the past thirty years the building could have been kept in good condition and work performed at moderate cost instead of the excessively high cost at the present time.

A detailed list of the work accomplished up to the end of December is on file in the Municipal Clerk's Office together with data relating to work still to be completed.

For many years the Provincial Government has made a grant of \$300.00 a year towards the maintenance of the building. For 1946 and 1947 the Commission was able to have this grant increased and,during those two years we received \$6,000.00 per year. At the present time arrangements are being made with the Province whereby the Province will contribute a certain percentage of the total cost of maintenance based upon the area of the building used exclusively for Provincial purposes and representing a large part the East Wing where the offices of the Supreme Court Judges are situated. The West Court Room which is now almost exclusively used by the Supreme Court of the Province, the library and all of the rooms on the north side of the building on the same floor which are used by the Barristers of the Province. If, at any time the Province should require more space it will increase the amount of its contribution accordingly. Arrangements have also been made whereby the Province will in future assume the salaries of the two Supreme Court Criera whose

work is altogether in connection with Supreme Court matters. The County Court, however, is for the use of the whole County including the City of Halifax and the Town of Dartmouth and these Corporations are still responsible for the maintanance of same as well as all of the other offices in the building generally known as Governmental offices including the Sheriff, Registrar of Probate, Registrar of Deeds, Prothonotory and Juvenile Court. Under the Legislation now in existence the County is responsible for supplying and maintaining such offices and as already stated the expenses of these come under the Joint Expenditures.

We have endeavoured to make this matter clear as we find that many of the Councillors and ratepayers have very little, if any, knowledge of our obligations and liability in connection with the Court House.

### REPORT OF THE MUNICIPAL BUILDING BOARD

To the Warden and Councillors of the Municipality of the County of Halifax.

#### Councillors:

We, W. J. Ward, R. E. Archibald and A. A. McArthur were appointed a Building Board, to hear and determine appeals under the Halifax County Building Act. Board (to this date Dec. 31st, 1947) and

Ten cases have appeared before this Board (to this date, Dec. 31st, 1947) and the majority of these appeals were under paragraph 5, page 10, of the County Building Act.

According to this paragraph (page 10) the minimum size of a building lot is 100' -200' while the maximum size of a lot in Armdale, Bedford and Woodside is 50' x'100', some lots of a lesser size with streets of 60' in width.

While we, the District Building Board consider a 50' lot little enough for up to date construction and Health regulations, and we would like to see 60' lots for suburban districts, still we are opposed to the regulation that a building must be at least 8 feet from any line.

We do not consider 8 feet enough for a car driveway. We suggest that not less than 11 feet be required on one side, and let the other side work out to whatever the building would allow, it being distinctly understood that 16 feet between buildings must be the minimum allowance. May we draw your attention to a decision rendered by this Board Dec. 20th, 1947 to Mrs. D. B. Stevens, Dutch Village Road. See Minute Book kept in Martin Archibald's Office.

Re - the 100' x 200' lot. We are at a loss to understand just what is meant. If a lot 200' x 100' was a corner lot in Armdale it could accommodate four houses and each have a lot of 50' x 100' or 5000 square feet. On the latest requirements of the Planning Board three houses could be built, giving each house a lot of  $60' \times 100'$ or 6000 square feet and still have a piece of land left of 20' x 100'. This should be clarified as it is too much for our Board to understand.

We suggest that Garages, when placed in the back of a lot may be allowed to come within three feet of any line provided that a distance of 16' be maintained

between said garage and any other building. The idea of this is to bring the garage more in line with the car driveway.

Page 10. We suggest that all chimneys have a verified lining. Chimneys should be built of single bricks and lining as we consider this construction far safer than plain brick.

In District No. 12 the Building Inspector would not think of passing a plain brick chimney - no matter how well built unless it was lined. Brick chimneys are built of single bricks and plastered inside with lime mortar and tempered with cement. District No. 12 has over 100 chimneys to be built at once (soon as weather permits) all of which will be lined chimneys.

Re the 66' street. The Board is in full accord with a 66' street, but we are not in agreement with the 30' requirement to be back from said street. We would like to see this minimum reduced to 20' and that buildings be kept in line with other buildings if any are already built. We find the average distance back from the street line to be about 20'. In cases of this kind we feel that all new structures be kept back the same specified distance. Worked out on this basis buildings 20' back on a 66' street would be actually 106' apart.

All of which is respectfully submitted for your approval, suggestions and correction.

# REPORT OF DR. MacRITCHIE

To His Honor the Warden and Councillors, of the Municipality of the County of Halifax.

#### Councillors:

You can readily appreciate that an account of the numerous details of public health problems that one encounters daily cannot be recorded in a brief submission such as this. Health problems, big and small, important and of lessor importance, significant and insignificant – all depending on viewpoint – are to be found in Halifax County. These proportionately, are no greater or no less than those in other counties and the proportionately are no greater or no less than those in other counties, and I suppose this can be considered a compensation and a consolation.

Glancing over the general situation the past year, I can say that we have been quite comfortably situated. As far as epidemics were concerned we came through another year without any great damage being done. Dr. MacKinnon in his report gave you a picture of conditions insofar as contagious diseases were concerned and from his report you learn that much progress has transpired in the effort to bring communicable disease incidence down to the irreducible minimum. I'm very sorry to note that during the year we have one death from disease of the Typhoid group. Down the years we have been very proud of our clean record in this disease field, so it is regrettable that this casualty has to be recorded. However, notwithstanding, our record sheet is quite clear. We have three cases during the year, with the above named result.

Briefly I shall touch on the subject of Tuberculosis. As usual this disease requires considerable attention. Efforts to curb this is still in progress and with progress that is more real than apparent. To bring this problem down to a generally satisfactory condition is a man sized job and will remain so for some time to come, and in this effort there must be no slackening. Our death rate is down. During the year a total of seventeen of our people died of Tuberculosis of all forms, a decrease of seven compared with last year. Thirteen died in Institutions and four at home. This number of Institutional deaths might probably indicate the tendency to early as possible hospital care. The ages ranged from seven months to seventy years. The lowered death rate from Tuberculosis probably reflects a lowering incidence of the disease. Case finding has been carried on as well as possible under conditions of shortage of staff.

In case you might be interested I am giving below the place of settlement of those who passed on. Deaths occurred in citizens whose places of settlement were scattered about the county with no one place showing a high district rate.

At the present time forty-one cases from the Municipality are undergoing treatment at the Nova Scotia Sanatorium and nineteen at the Halifax City Tuberculosis Hospital.

Our public health nursing system is not by any means a satisfactory one at the present time, but the only thing we can do is hope to have this rectified before too long. I refer to Halifax East which has no coverage at the present time and without service since early Fall. In Halifax West, Miss Wade is carrying on, giving yeoman service and trying to meet demands to the best of her ability.

Again to you Mr. Warden and Councillors, and to you Mr. Archibald, I say thank you, for your kindly interest in our common problems.

Gentlemen:

This is my first Annual Report as Building Inspector of District No. 12, Armdale, Halifax County, and I take great pleasure in submitting this report for your approval.

As you will notice this report is quite high in the building activity, but as you know this a large District with nine Sections including Beechville, and I worked to the best of my ability to make clear to you the work going on in this District, of course it must be understood, that it will take from two to three years for a great lot of this work to be finished and show any great increase on the Assessment Roll.

You will notice there has been \$821,591.00 in Permits and work done in 1947 was \$301,043.00. With these figures in comparison to other assessments there would be an increase of approximately \$60,000.00 but in 1948 there will be a great lot more of this work finished. I have covered this District every day and have taken a great interest in my work and the District at large. I have kept a close check on new work and Sub-divisions and watched them develop, and can see that before long District 12 will show a large increase in Revenue.

In my work during the year I have notified approximately 150 residents in regard to stove pipes out through the building in place of regular chimneys, in some cases new chimneys have been put up.

## REPORT OF COMMITTEE ON FINANCE

To His Honor the Warden and Members of the Municipal Council.

Councillors:-

Your Committee on Finance beg to submit the following:-

We have all noted with gratification our steadily increasing assessment, which is all the more gratifying when we realize the additional expenses for which we are now liable. In particular, we would like to call your attention to the fact that the amount payable to the Municipal School Board for the next three years will be approximately \$16,000 per year, more than for the past three years and approximately \$20,000 more than for the years 1942 to 1945. In addition to this additional expenditure, substantial appropriations have been made for Health and other Public Services, including Town Planning.

1. We recommend that each member of the Board of Appeal receive as remuneration for his services, the sum of \$5.00 per day, not including Sundays, together with actual travelling and hotel expenses.

2. We recommend that each member of Committees, other than those provided by Statute or by Resolution, when called together between sessions, receive the sum of \$5.00 per day and 10c. per mile travel one way.

3. We recommend that the Council of this Municipality subscribe to Journal of Public Affairs, a copy to be mailed to each Councillor.

4. We recommend that Districts be charged at the rate of 5% per annum on debit balances in their Current Accounts from January 1, 1948, and that they be allowed  $1\frac{1}{2}\%$  interest on the minimum quarterly credit balances.

5. We recommend that the Municipal Collector shall collect and pay over the amount of his rolls at any time between the first day of April and the first day of October in each year; providing that any moneys in his hands shall be paid over promptly to the Treasurer.

6. We further recommend that interest at the rate of 6% per annum shall be charged on any Rates and Taxes that are unpaid after the said first day of October.

7. We recommend that the Poll Taxes on persons not otherwise assessed shall be collected on or before the first day of June, after which date Warrants may be issued without notice.

8. We recommend that the Tax Bills, when printed, shall specify that remittances are to be made payable to the Municipality of the County of Halifax at par at the Municipal Office, Halifax, and that a summary of the 1947 expenditures shall appear on the back of the bills; also that the bills shall state that Taxes may be paid by installments.

9. We recommend that a Poil Tax of \$5.00 shall be levied for Municipal purposes upon every male person, whose age is more than 21 years but not more than 60, and who is a resident of the Municipality at any time after the 15th day of September, 1947, up to the 1st day of August, 1948, and who is not assessed in the Municipality on Real or Personal Property or Income to an amount of \$200 or more

10. We also recommend that an Annual Poll Tax of \$1.00 shall be levied for Municipal purposes upon every male person, whose age is more than 21 years but more than 60, and who is a resident of the Municipality or becomes a resident of the unicipality at any time after the 15th day of September, 1947, up to the 1st day of August, 1948, and who is not assessed in the Municipality on Real or dersonal Property or Income to an amount of \$200 or more. 11. In addition to a Grant to the Nova Scotis Home for Colored Children provided for in the Estimates, we recommend that the sum of \$500 be given the Nova Scotia Home for Colored Children as a contribution towards their new school this amount to be charged to our Surplus Account.

12. As the Assessment Survey, now in progress, is an extraordinary expense and should not be rated in full, at least, against the Current Year's Revenue, we recommend that the sum of \$5,000 be placed in the Estimates for this purpose and that the balance of the year's expenses in connection with the survey, be charged to our Surplus Account.

13. In view of the greatly increased and still increasing work in the Municipal Office, due in large measure to the steadily increasing number of ratepayers, as well as increased work in connection with the collection of Capital School Taxes, and also in connection with the Assessment, Survey, we realize that the time has arrived to provide more space to accommodate the Municipal Office and the necessaryincreased staff, and in view of the tremendous amount of work involved, believe that modern machines should be procured, which would facilitate the work of the office.

We recommend that the Commissioners of the Court House be requested to allow us to make certain alterations, which will enlarge the present office considerably and that a study be made of suitable machines and that these be purchased with the approval of the Finance Committee and the cost of any alterations and necessary machinery should be a charge upon our Surplus Account.

14. Your Committee has noted that pursuant to the provisions of Section 65 of the Assessment Act, the assessment roll, as finally passed by the Council and certified by the Clerk, has been laid by him before the Council.

AND WHEREAS the estimates of this Council show the sum of \$374,518.30 is required for the lawful purposes of the Municipality for the current year; and the estimated revenue is \$47,007.10, leaving a net requirement of \$327,511.20.

AND WHEREAS this Committee deems a rate of \$4.50 on the hundred dollars on the assessed value of the property on the Roll is sufficient to raise such sum required to defray the expenses of the Municipality for the current year;

THEREFORE, the Committee recommends that this Council do authorize the levying and collection of a rate of \$4.50 on the hundred dollars on the assessed value of the property assessed on the Roll.

# REPORT OF COMMITTEE ON ASSESSMENT FOR 1947

To His Honor the Warden and Members of the Council, Municipality of the County of Halifax.

Councillors:-

Your Committee on Assessment for 1947 has pleasure in submitting the following report.

In connection with a number of letters that were referred to your Committee, we have considered all and recommend as follows:

(1) THAT MRS. FANNIE MOREASH of Timberlea be relieved of taxes for the years 1945, 1946 and 1947 and that the assessors check this property for future assessment.

(2) THAT MR. T. A. BOYLE, Polling District No. 11, be advised that the Assessment Act of Nova Scotia provides for appeals to the Appeal Board for unfair or improper assessment and that further appeals can be carried to the County Court. The Committee suggests that if unsatisfied with his assessment that he take advantage of these avenues for redress.

(3) THAT MR. JOHN E. EISENER, Polling District No. 14, be refunded the sum of Three Dollars (\$3.00) Poll Tax for the years 1944, 1945 and 1946. The Committee finds that Mr. Eisener was improperly assessed for Poll Tax as he was over the age of sixty during these years.

(4) THAT a refund be granted to MRS. FLORENCE RICHARDSON of Polling District No. 14 provided it can be confirmed that the property mentioned by Mrs. Richardson has been assessed twice as she claims for the year 1940.

(5) THAT MRS. RUTH A. DAYE, Polling District No. 19 be notified that the Committee considered her case and have decided to refer the matter to the District Assessor and that if she is entitled to exemption under the Act that the Assessor grant such exemption.

THAT MR. ARTHUR MURPHY, Polling District No. 24, be refunded \$5.00 Poll Tax and \$2.00 Constable's Fees because of improper assessment.

THAT the assessment of a Poll Tax to Mr. Harold Jennex, Polling Dist-(7) rict No. 19, be confirmed as Mr. Jennex resided in the District in 1946, and is subject to tax under the Assessment Act.

(8) THAT MR. E. G. CUTLER, Polling District No. 8, be advised that the Assessment Act provides a method for appeal in cases of unfair assessment and that Mr. Cutler take the course provided by the Act.

(9) THAT MR. W. O. MASON, Polling District No. 14, be advised that his letter was considered by the Committee and recommends that the Assessor be advised to notify all ratepayers of assessment.

(10) THAT the real property now assessed to MRS. G. J. LESLIE, Polling District No. 20, be assessed to STANSFIELD LESLIE and ROBERT A. C. LESlie and that a \$50.00 exemption be granted to MRS. LESLIE for personal property for the year 1947.

During the year various numbers of your Committee met frequently with Mr. MacGlashen and last Fall the whole Committee met with Mr. MacGlashen and his assistants in the field and spent a whole day with them and obtained first-hand information as to how the work is being accomplished. Attached to this report is a report by Mr. MacGlashen which is very gratifying to your Committee. We feel that a great deal has been accomplished during the first year of the Survey which really only commenced on June 15th. We recommend that the Survey under the direction of Mr. MacGlashen be continued until completed and that Mr. Mac-Glashen be authorized to change the remuneration to be paid his assistants with the Approval of the Assessment Committee or the Chairman thereof.

Sirs:-

It is my pleasure to report on progress made the past year in the Assessment Survey of the Municipality of the County of Halifax.

The Actual Field work began in Port Dufferin in District No. 22 on June 16th. The work was held up at the start due to some delay in obtaining necessary amendments to the Assessment Act. The amendments were passed by the Legislature in the closing days of the Session. One of the amendments provided for the appointment of an Assessment Board for Nova Scotia, which would approve of appointments of chief assessors in municipalities.

I was assured that the Board would be appointed and functioning by July. On this understanding I proceeded with the field work. Armed with little or no authority the work proceeded, and fortunately the ratepayers of the Eastern Shore Districts were very co-operative and no legal difficulties were encountered.

It was my hope that we would be able to make a start this year in early May in the Musquodoboit Valley. But I have been informed that the Assessment Board has not yet been appointed and there is a question whether the Board will be in operation for some months.

This is an impossible situation insofar as reassessment work in this County is concerned and will have to be corrected immediately, or it will not be possible to continue this year.

# RATEPAYERS CO-OPERATIVE

The assessment work and the assessing staff was given a splendid reception in every District along the Eastern Shore. Difficulty was encountered in only one home in these eight Districts: (Districts 15, 16, 17, 18, 19, 20, 21 and 22). In this particular case the lady of the house objected to an assessor viewing the property. But later in the day when the owner was informed of the situation, we were invited back to make a practical and thorough assessment.

The fine spirit of co-operation that was found in these eight Districts can be attributed to several factors: (1) The realization by the ratepayer that a complete reassessment is necessary; (2) The fact that the Reassessment Survey had the unanimous support of the Council; (3) The letter from the Warden to all ratepayers which precedes the visit of the Assessor; (4) The unanimous support given by the newspaper; (5) The assistance given by the individual Councillor in each District and (6) The gentlemanly behaviour and business like approach of the special staff of assessors.

Considering the nature of assessment and its many difficulties, I think that it rais ther remarkable that we have encountered such a unanimous spirit of co-operation. Certainly we expected many difficulties along the way.

However, the individual councillors in the Districts that we have completed can speak for the ratepayers in this regard.

## EXCELLENT STAFF

I have been particularly fortunate in the selection of this special staff of assessors. I am sure that in the past year they have won many friends and made very few enemies by their work. Their behaviour at all times has been above reproach. They realized at the start that they were representatives of the Municipality and that they had considerable responsibility for the success or failure of the assessment project. With the exception of myself, all are residents of the County.

The District assessors have also been of assistance in this work. Wherever possible and practical, it has been my policy to hire the District Assessors, while we are working in their District. To date they have been most co-operative, and, I believe, very strongly in favour of complete re-assessment for the whole Municipality.

Members of the Assessment Staff during the past year have been: H. W. Carroll, George Leslie, Gordon Smiley, F. K. Andrews, Stanley Myers and Reginald Daye.

District Assessors and others who have assisted are: Harold Whitman, T. H. Romkey, Charles McDonald, William Rood, Boyd Prest, Frank Marks, Edward Spracklin, Edmund Webber, Wilfred LaPierre, Gibson Crawford, Howard Williams, Thomas Faulkner, Dennis Williams, Nelson Mitchell, Mitchell Sellars, Seymour LaPierre, Walter Mannette, Carl Evans and Russell Atkinson.

## DEEDS OFFICE

When the field work began last June 16th, we began to keep a complete record of property transfers from that date. A member of the Assessment Staff, Russell Atkinson, worked in the Municipal Clerk's office preparing and mailing the necessary Forms for our work as well as making complete copies of all deed of properties which were being transferred in the County. Mr. Harry Murphy, the Registrar, and his staff have been of assistance in this part of our work. As a result of this part of the assessment work we have a complete years record of all recorded transfers in the County, which is most essential for record purposes and an up to date assessment system.

In every District the assessors have been stressing the importance of ratepayers registering their deeds. This has brought some results and should bring additional results as time goes on. A great deal of property mixups in this Municipality can be attributed to two factors: (1) Failure to register deeds and (2) Failure to make a Will. This has resulted in many disputed properties and many undivided estates.

Complete assessment can never be achieved overnight or in a matter of a few years. It is a long process which will extend over many years, and the Registry of Deed office is a very important link in an adequate assessment system.

#### BOUNDARIES

Great difficulty has been encountered in plotting District and School Section boundaries in the whole Municipality.

It is impossible at the present time to determine a boundary line that separates Districts 13, 14 and 28. The other Districts have been plotted on the maps. In Districts 21 and 22, Lochaber and Malay Falls have for some years been assessed as part of District No. 21, but when the lines were plotted on the maps it was found that Lochaber and Malay Falls are not in District No. 21 but in District No. 22. We have assessed them to District No. 22 until changes are made in this District boundary line.

School Section descriptions in the whole County are hopeless in their present state, and this constitutes one of the assessor's greatest difficulties. It is my belief that School Sections are missing many thousands of dollars of assessment because of this situation and will continue to miss until changes are made.

The perfect solution of course, would be one school section for the whole Municipality.' This would certainly simplify administration of Municipal business and assessment, as well as result in additional revenue for school purposes. The second best move would be larger school sections to take in an area like the whole of the Musquodoboit Valley. Third best would be one school section in each District or area where it would be applicable.

In some sections the problem of school section boundaries is more acute than others. This is true in the fringe areas of Halifax. It is necessary that where there are sections in dispute, these lines would be settled without delay.

## WINTER WORK

Field work in assessment continued until November 15th when District 16 (Preston) was completed. During the months of fine weather every effort was made to cover as much ground as possible. From June 15th to November 15th we covered all properties from Ecum Bridge to Salmon River Bridge - 7 miles from the Town of Dartmouth.

Assessment cards were not completed in the field, but were left for the winter months. Since December and up until the present time, we have completed the work on the cards for Districts 15, 16, 17, 18, 20 and 21. The staff is now working on District 22. The one remaining District, 19, will be completed before the Spring.

An early start should be made in the Musquodoboit Valley in the Spring to complete Districts 23, 24, 25, 26 and part of 27. I believe that it would then be possible to complete 7, 9, 10 and 11 by the early Fall. This would leave the Fringe Areas 13, 28, 14, part of 27, 8 and 12 for the last. Part of this latter work could be completed in the favourable late Fall and Winter months and finished in the Spring of the following year. When the whole of the County is complete, of course, considerable back checking will be necessary because of property transfers and other changes of assessment. It is still possible to complete the whole of the County in culties appear.

#### FUTURE TAX RATE

It is still impossible to estimate with any degree of accuracy what the total assessment and the tax rate will be when the whole County is reassured. It must be remembered that only one complete section of the County is complete, and it would be unwise to attempt to make predictions on this basis.

It is safe to say that the Eastern Shore Districts will be assessed less than four times the present assessment, and there is a strong possibility that the tax rate for the whole Municipality will be approximately one dollar.

It is still my belief that the great majority of ratepayers in the Municipality will benefit by complete reassessment. It is true that a good many ratepayers will pay more tax dollars, but only because they have escaped for years from paying a fair share of taxes. But the majority will pay less because of the large number of ratepayers and property which will be added to the roll, and the increasing of assessment of many who have escaped without paying their fair share.

Another factor which should not be overlooked in the Municipality is the great amount of construction which is going on at present, and will continue for many years. The County is bound to benefit because of the lack of building space for housing and industrial development in the City of Halifax and the Town of Dartmouth.

Councillors of Districts where our work for the present has been completed have been invited to inspect the new assessment cards, so that they can obtain a complete picture of what reassessment means to their particular District. The same opportunity exists of course for all members of the Assessment Committee, who had the opportunity of inspecting the assessment work in the field while we were working in Porter's Lake, Chezzetcook and Lawrencetown.

If it is the wish of the Committee, I would like to appear before Council and discuss assessment work of the past and future.

In closing this brief report, I wish to acknowledge the assistance of the Municipal Clerk, Mr. Archibald, and his staff for the eplendid co-operation and assistance for the past year.

I also wish to thank the Warden, the Chairman of the Committee, Councillor Naugle, and all individual members of the Committee for the encouragement and the assistance that they have given.

## REPORT OF COMMITTEE RE CITY MARKET

To His Honor the Warden and Members of the County Council Councillors:

Your Committee appointed to keep in touch with the City Authorities in re market conditions in Halifax, finally met with the City Market Committee 10 a.m., Monday, the 25th. The restricted space in the Market Building, now available to the public for marketing purposes, inconveniences both buyers and sellers and has forced many who formerly made use of this service, to abandon same.

While regulations as to the method of handling meat and poultry have been complied with by the market people and live animals are sold outside the building only, the complaint of the users recurring from year to year as to adequate space and uncomfortable conditions remain unchanged.

City Authorities claim it not advisable to spend the \$30,000 on this building that would be required to put it in condition, at least, not at this time. They expect the Crane firm to be out in about three months or less and that space, along with what is still occupied by Reardon & Company, would then be available for Market purposes. This would remedy the main grievances of all concerned.

Their suggestion that we arrange through our local representatives, a joint meeting of City and County with the Government, or proper Department thereof, is not practical at this time.

We recommend that same Committee keep in touch with the situation, so that improvements noted may be implemented at earliest possible date and that a copy of this report be sent to the Chairman of the City Market Committee.

# REPORT OF COMMITTEE RE CONSTABLES

To His Honor the Warden and Members

of the Council, Municipality of the County of Halifax.

Councillors:

Your Committee on Constables has held several meetings during the present Session and have thoroughly considered the whole Constable situation.

We recommend that efforts be continued to have a room made available for the Chief County Constable in the Court House. -

Also, that the Chief County Constable be provided with suitable uniforms approved by the cnstables' Committee.

Also, that until the Assessment Survey is completed and in effect, provision be made in the estimates for payment to Constables for investigating old estates and assessment errors. Payment to be made upon receipt of a written report satisfactory to the Municipal Solicitor.

That the Chief County Constable receive a salary of 2,000.00 per year, plus mileage at .10 per mile.

Also that the services of the Deputy Chief Constable appointed last year be dispensed with at the end of April, and that provision be made in the estimates for funds with which to pay constables for special services under the approval of the Constable's Committee. We consider \$800.00 a sufficient sum.

Also, that the Chief County Constable be supplied by the Municipal Clerk with a list of all constables appointed by Council together with a blank form of Oath of Office for each constable which he shall deliver and return as quickly as possible to the Municipal Clerk.

Also that all County Constables be under the supervision of the Chief Constable.

We also recommend that a sufficient amount be placed in the estimates to provide adequate staff in the Municipal Office so that more warrants would be issued in future.

We recommend that the Chief County Constable come directly under the supervision of the Constable's Committee and that that Committee shall meet once a month beginning in June, and between meetings the Chief County Constable shall answer directly to the Chairman of that Committee.

We also recommend that all accounts and expenses incurred by the Chief Couty Constable's Office be approved by the Constable's Committee.

In order that Council may be fully informed as to the value and necessity of the Constable's Office we recommend that the Committee be furnished with a written report of the daily activities of the Chief County Constable.

We also believe that certain changes should be made in the By-law re Dogs and that the Municipal Solicitor be consulted in this respect.

Superintendent of the V. G. Hospital, who offered his cooperation on all points at issue – stating that he had two Commissioners of Oaths for taking Affidavits and if necessary he would have one of his Admission Staff appointed.

We recommend that the place of settlement be inserted in the V. G. Hospital Notice of Admission and the Municipal form of Notice be revised to conform with the V. G. Hospital Notice of Admission.

# REPORT OF ROADS AND BRIDGES COMMITTEE,

To His Honor the Warden and Members of the Municipal Council. Councillors:

We, your Committee, have considered the various matters referred to them and beg to report the following:

- . We recommend that the Minister of Highways be requested to list on the public roads maintained by the Province the following roads:
  - (a) Springvale Ayenue in Polling District No. 12, provided however that the owners of property on Springvale Ayenue will each, if required, agree to give sufficient land to the Municipality or the Department of Highways to bring the required width of 66 feet.
  - (b) The westerly branch road from the Conrod Settlement Road in Polling District No. 17.
  - (c) The 2,000 foot extension of the Conrad's Settlement Road in Polling District No. 17.
  - (d) That the letter dated March 2nd re Sunny Lea Road included in last year's recommendations be followed up.
  - (e) A road recently built to connect Albro Lake Road with the new Harbour View School.

- (a) With respect to a petition of ratepayers of Oyster Pond School Section No. 1 in Polling District No. 19, we recommend that the necessary steps be taken to set up a Pound District or Closed Section.
  - (b) With respect to a petition of School Sections of Ship Harbour, DeBay's Cove, Owl's Head, Clam Harbour and Little Harbour, all in Polling District No. 19, we recommend that in accordance with our By-laws a Committee of three be appointed to enquire into and report upon the propriety and expediency of creating such Pound District or Closed Section.
  - (c) With respect to a petition of ratepayers of Ketch Harbour in Polling District No. 11 for a Pound Section. We recommend that the necessary steps be taken to set up a Pound District or Closed Section.

# REPORT OF VISITING COMMITTEE RE COUNTY HOME

The Warden and Members of the Municipal Council, Municipality of the County of Halifax. Councillors:

I beg to submit the report of the Visiting Committee to the Halifax County Home and Mental Hospital for 1947.

#### 1. VISITS

2.

Your Committee made one visit to the Institution during the year, the Chairman, Mrs. A. C. Pettipas and Mrs. Frank Settle in attendance.

Mrs. A. C. Pettipas, a most interested member of the Committee, made a visit in September. Neither of these visits were announced before hand.

# 2. CONDITIONS AT THE HOME

From a careful inspection of the wards, dining rooms, kitchen, refrigerators, infirmaries, laundry and lavatories the members of your committee are satisfied that the same high standard of last year is being maintained. The food was inspected and sampled and found to be of good quality and palatable.

#### 3. FURNISHINGS

Your Committee noted with pleasure that some furniture had been provided for the common rooms and the dormitories. This furniture was bought from the R.C.M.P. when the Queen Hotel, Halifax, was closed. These furnishings give the institution a more home-like appearance, and must provide considerable comfort for the patients.

# 4. ENTERTAINMENTS & CHURCH SERVICES

Mention should be made of the fact that the inmates or patients have received regular church services and ministrations from the Clergy of the nearby parishes.

The Rev. J.A. Willett, Rev. Nelson MacDonald, Rev. G. N. Hamilton and the Rev. Fr. Hopper are to be commended for their ministrations and active interest in the County Home.

The Kiwanis, the Salvation Army, and the Choirs of the Dartmouth Church, have sponsored movies or choral evenings for the patients.

### 5. RECOMMENDATIONS

If it is in order the following recommendations are submitted by your Committee. for careful thought and where possible immediate action:

- (a) That a separate building or annex be provided for the indigent of whom there are sixty-five at time of reporting. This is the most important or urgent need at the moment. In several cases there are Old Age Pensioners, who because they have no other habitation must lodge in the County Home.
- (b) That by publicity more groups or organizations should be urged to contribute furnishings and other comforts for the patients.
- (c) That every effort should be made to inform the community about the Couny home and the work done there.

In closing this report your Committee wish to acknowledge the splendid cooperation and assistance they received from Mr. and Mrs. Smith and their Staff Respectfully submitted.

To His Honor The Warden and Members of the Municipal Council.

Councillors:

Your Committee on Poor beg to report the following:

We have examined the exhibits of amounts of the various Districts and find all in a healthy condition regarding Poor and District Credits, with three exceptions.

We recommend that the present system of District Rates be continued under which a District Rate is levied in each District to provide for all District charge including maintenance of the poor and other matters by law authorized to be rated on Municipal Districts. The funds thus raised for District Purposes, other than Poor, should be paid on the authorization in writing of the Councillor of the District and such annual expenditures should annually be reported to Council.

We recommend that the following Rates be assessed on the following Districts for Poor and District Purposes as designated by each Councillor:

# SPECIAL MEETING OF THE 29TH COUNCIL OF THE MUNICIPALITY OF THE COUNTY OF HALIFAX

## MORNING

Tuesday, July 6, 1948.

£

The Council met at 10 o'clock. Roll called. All councillors were present with the exception of Councillor Anderson who was reported ill at his home.

Warden Dowell, presiding, explained that the purpose of the special meeting was to deal with a policy that had been formulated in connection with the provision of water and sewer facilities not only to the village of Woodside but all the fringe areas of the Municipality, where required.

Councillor W. A. Gates, chairman of the Public Services Committee, outlined the steps that had been taken and gave the following Report as "Events Leading Up To The Present Situation Regarding Woodside:"

# EVENTS LEADING UP TO THE PRESENT SITUATION REGARDING

# WOODSIDE

At the 1946 Session of Municipal Council a delegation from Woodside was present consisting of Arnold J. Whitworth, Fred Pettipas and B. R. Cox. They asked to be heard with respect to the creation of a new District for that area. A special Committee was appointed to go into this matter and as a result Polling District No. 28 was set up. Prior to this meeting Councillor Settle had suggested to the people of Woodside that a petition should be brought in with the delegation to indicate how many ratepayers were in favour of a separate District. Water and Sewerage were mentioned at this meeting of Council but the delegation had definitely asked for the establishment of a new District.

It was pointed out to this delegation at this time that the Municipal Council was anxious to co-operate in any way it could and again suggested that a petition should be signed by the ratepayers to indicate how many people were in favour of installing public services in Woodside. Following this meeting Municipal Council did some preliminary investigating on the whole situation.

At the 1947 Session of Council on Tuesday, March 4th, the Municipal Council again heard a delegation from Woodside. The delegation was made up of Mr. A. J. Whitworth, A. A. McArthur and R. W. MacCarthy. This time the delegation reviewed in brief the water and sewer problems that confronted Woodside and a special committee appointed by the Warden met with the Woodside delegation to determine what the Municipality could do on this matter. There was still no petition presented at this meeting of Council. It was realized that no petition was actually necessary because under Section 130 of the Municipal Act, the Municipality itself may authorize a rating and collection of so much on the dollar in respect to any Polling District which requires a sum of money for District purposes, providing it is approved by the Council. However, it has always been pointed out to the Woodside delegation that it is highly desirable to have a petition, particularly where large expenditures may be involved. At this point Council was still dealing with the Woodside Committee and it had no definite assurances in that Committee that they represented the majority of the ratepayers. However, in spite of this the Council recognized the problems and decided to proceed.

As soon as the 1947 Session of Council was over the Municipality proceeded to take action on the Woodside situation through its Public Services Committee. Things did not proceed as quickly as the Municipality would have liked them to

proceed in many instances, but to give you a brief resume of just what the Municipal Council has been doing since that time it would be as well to submit a few facts as taken from the actual correspondence, minutes and other reports:

Decision of Council to have survey carried out in Woodside area re water and sewer:

Picked suitable Engineer with much experience along these lines;

April 1, '47 - Wrote Ottawa to obtain Gore and Storrie Reports;

April 10, '47 - Meeting of the Public Services Committee of Council;

April 17, '47 - Follow up on letter to Ottawa asking them to hurry;

Between April 10th and 17th – Visit to Amherst to talk with F. Carmen Wightman, the Engineer selected; He was engaged to carry out preliminary survey of Woodside area;

April 14, '47 – Letter from Wightman asking for meeting near end of month. May 7, 47 – Wightman comes – has meeting –goes over ground;

May 30, '47 - Letter to Wightman asking when his report will be ready:

June 20, '47 – Wightman report received – Meeting of our Committee on Woodside called for 25th June, 1947.

June 25, '47 – Letter to N. S. Waterways Commission re water rights for Mac-Donald (or Morris Lake) and/or Russell Lake.

June 27, '47 – Letter from Minister administrating the Water Act stating "authorizations have been granted on Morris Lake and Russell Lake" to Sugar Refinery, Imperial Oil and Air Force. There does not appear to be any other source of fresh water in the area close enough to be of use to the District of Woodside.

July 8, '47 - Meeting of Committee on Woodside, with Wightman in attendance.

July 29, '47 - Letter to Dartmouth on the matter and letters written to Imperial Oil and Sugar Refinery, asking them to consider selling water to the Municipality.

August 5, '47 – Dartmouth advises matter left in hands of Mayor to arrange meeting with Council.

August 20, '47 - Dartmouth Council had been approached again but no date set for meeting.

October 2, '47 – Meeting with Council of Town of Dartmouth. Some of Dartmouth Councillors were sympathetic but wanted to be assured that they had ample water to cover the present and future needs of the Town. Decided that Dartmouth Engineer and ours should meet together. The understanding was this meeting would be in about ten days.

October 6, '47 – Imperial Oil said "No" to our request to sell water to the Municipality. Several letters to and from our Engineer etc. Finally – November 27, 47' – "On October 2nd, it was arranged that you should meet with their engineer in a very short time. I have been in touch with the Town Office frequently but their engineer has been sick or still working on Town matters, and we have not yet been able to fix a date."

January 3, '48 – "Never able to get anywhere with Dartmouth."

Meeting with Mayor Pettipas and new Town Council – Complained of leaks in the Town Water System and unable to supply water at present time for Woodside.

February 25, '48 - Municipal Council met.

April 5, '48 – Meeting at Legislature – Mayor Pettipas stated then for the first time that Dartmouth had many leaks in its water supply system but that these were now in the process of being fixed, and that water might be made available before too long

April 29, '48 - Tired of waiting for Dartmouth - asked Engineer how soon surveys could be made of Tufts Cove, Albro Lake and on the Western side of the Harbor.

April 30, '48 - Letter to Dartmouth again asking them to sell water.

May 8, '48 - Dartmouth says impossible to give definite assurance.

May 20, '48 - Whole suburban areas gone over with Engineer. Decided that detail surveys should be carried on in Woodside area generally, Marion Heights, preliminary surveys at Tufts Cove, Albro Lake, Armdale, Bedford, Spryfield, Lakeside, Timberlea, Windsor Junction, with possible other areas, Actual work can start about the end of June.

May 21, '48 - Requests made to Water Commission re authorization to use various bodies of water for water supply for Municipality.

June 9, 48 -At last Dartmouth writes that it would sell water at the Town boundaries.

June 28, '48 – Engineer ready to start on ground allotted by the Council as scon as Air Force photographs that, have been ordered by him have been suplied.

In closing I would like to point out that Municipal Council has not been idle at all. This has been suggested by some, but it must be realized that costly undertakings like the provision of sewer and water cannot be entered into quickly. It takes time to work out the preliminary details.

As stated before our Engineer is ready to start working within a matter of days now in the County of Halifax. The Woodside area has the first priority if they want it. Otherwise, probably Tufts Cove and Albro Lake survey will be started.

That is the present situation with regard to the Municipality supplying services to the suburban areas generally and to Woodside in particular; but, I would like to point out the situation that would be created if Woodside were to be allowed to incorporate within the boundaries as stated by the Sheriff in his Notice of Polling on Incorporation within the Town of Woodside dated May 31st, 1947. These boundaries include the whole of the present Polling District No. 28 as described in the Provincial Statutes of 1946. This District comprises an area known as Woodside, having a population of approximately 3,000 and, in addition, the Imperoval Plant of the Imperial Oil Co. Ltd.

The Assessment of this whole District is 1,286,725 as compared with a total assessment in the County of 7,273,362. The Imperoyal Plant is assessed at 5750, ooo, leaving the remainder of the District assessed at 5536,725. Therefore, if the boundaries of the proposed Town of Woodside remain as fixed by the Sheriff the County Assessment will drop from 7,273,362 to only 5,986,637. This will leave the County with only 82.4% of its present assessment. It will increase the present County Tax from \$4.50 per one hundred dollars of assessment to \$5.47 per one

hundred dollars of assessment. This represents an increase of  $21\frac{1}{2}\%$  in the tax This increase in the tax rate will be imposed on 17,012 ratepayers by the rate. 610 catepayers of the Woodside area. In other words, leaving the Imperial Oil Plant within the limits of the proposed Town of Woodside will mean that 3.45% of the ratepayers of the County will be forcing 96.55% of the remaining ratepayers to pay practically \$1.00 more per hundred dollars of assessment on their present tax rate. Of the above 610 ratepayers in District No. 28, 134 pay taxes on Personal Property only, therefore, only 476 ratepayers actually pay taxes on real property, Compare this figure with 15,674 ratepayers on Real Property in the rest of the County and it will be seen that the percentage of Real ratepayers in the Woodside area drops to 3.03% of the total number of Real ratepayers. What fairness is there in giving this large base of assessment of the Imperial Oil Plant to 3.03% of real ratepayers when by so doing cost 96.97% of the real ratepayers to pay a rate increased by 211/2% or approximately \$1.00 per one hundred dollars of assessment. If this is done and by reason of giving the Imperial Oil Plant to the people of Woodside to be included in a separate incorporated town the increase in the general tax rate imposed on the ratepayers of the County will mean that it is much more difficult to provide water and sewerage so much needed in other areas of the County in addition to the area of Woodside.

In the report and recommendations of Dr. W. A. McIntosh and Dr. D. F. Milam of the International Health Division of the Rockfeller Foundation on Health Services for Halifax City, the Town of Dartmouth and the Municipality of the County of Halifax, they say in part "The principal sanitary problem in the Municipality is related to the suburban adjacent to the City of Halifax and the Town of Dartmouth. The insanitary status of the areas about Halifax Harbour and the North West Arm has for some time been a matter of deep concern to those cognizant of this potentially dangerous situation. The rapid extension in recent years of the built up areas about the city and town has been largely uncontrolled and unsupervised and sanitary conditions have developed that would not be tolerated in organized urban communities. This applies to all villages surrounding Dartmouth as well as to the settlements north of Halifax at Dutch Village Road and at the waterside of the South West Arm and on the heights above.

Dr. MacKinnon, the Medical Health Officer, can also state what communities there are in Halifax that need water and sewerage equally as much if not more so than the Woodside area. Also, I believe that the Provincial Health authorities such as Dr. Campbell, Dr. MacRitchie and others can also corroborate these statements.

The Municipality is ready and anxious to proceed with the providing of services in all of the needy areas of the County, but if the Imperial Oil Assessment is taken from the County, the County will be in no position to carry on with the installations of these services. There are other things also that enter into the picture, for example:-

The Equalization Fund of the Province of Nova Scotia fo. school purposes – Let us take the present Imperoyal School as an example. For instance, for the last school year the salaries of the teachers of that school amounted to \$5,85.08 and Maintenance for the same period amounted to \$1,200.00, making a total of \$7,058. 08. Now, on its present assessment the Imperial Oil Plant contributes to the Municipal School Board for purposes of education \$14,325.00. In other words, they contribute nearly \$7,300.00 towards maintaining other schools in the County of Halifax. Should this assessment be taken away from the Municipality, it will cost Provincial Government directly \$7,300.00 more in its contributions to the Municipal School Board through the Equalization Fund.

Councillor Gates concluded by stating that the Municipal Council fully realized its responsibility to provide services and was now in a position to formulate a

definite policy in this regard. The Public Services Committee had presented this policy at the Woodside meeting last night, subject to the ratification of the Council and would meet this afternoon with the Governer-in-Council.

Councillors Gates and Dauphinee moved:

"THAT this Municipal Council, after hearing a report from its Public Service Committee, doth hereby declare that sewer and water services are required in several parts of the County, including in alphabetical order Albro Lake, Armdale, Fairview, Kline Heights, Spryfield, Tufts Cove and Woodside and such services should be provided as a joint venture by the Municipality and the area concerned:

"FURTHER RESOLVED that this Council do offer to any Municipal District or part thereof, expressing a willingness to participate in such joint venture, the following proposal:-

1. That the Council shall provide a survey of such district for such services.

- 2. That the Council shall borrow on the credit of the Municipality a sum sufficient to provide water and the consumer shall pay rates fixed by the Public Utilities Board.
- 3. Any costs not covered by such rates shall be borne by the Municipality.
- 4. The costs of provision of sewers shall be borne 50% by the Municipality and 50% by the District or area concerned and rates thereon.
- 5. Costs of administration of such service, including engineering, shall be borne by the Municipality.

In reply to a question by Councillor Burris the Deputy Clerk gave financial figures relating to assessment and tax rate, which would be affected by installation of water and sewer in District 28. The Deputy Clerk stated that the assessment and tax rate in the Municipality would be adversely affected by the loss of the Imperial Oil Plant. The complete financial picture could not actually be given until the detail survey had been completed.

In reply to Councillor Archibald, Councillor Gates said that the maximum increase in rate to complete the Woodside improvement would be 14 cents, but pointed out that if the oil plant was lost the rate would jump approximately \$1.00.

Councillor Lomas agreed with Councillor Gates in this regard and declared that the loss would make it difficult to give needed services.

Councillor Bond said that he believed that the Council should know what Wood side was going to do before Council adopted the resolution committing itself to possibly a number of projects. Councillors Gates said that if something progressive was not done then there would be other Districts which would follow the lead of Woodside.

Councillor Lomas said that former Councils should not be abused too freely for not taking steps because the problem of services had only become acute in the past few years.

Councillor Naugle stressed the seriousness of the situation in District 28. He pointed out that this loss in revenue could make it very difficult in providing water and sewer and other services to other communities which needed these services as badly as Woodside.

In making his position clear to Council as representative of District 28, Councillor Chisholm stated that he was always strongly in favor of providing these services to Woodside, but that he was opposed to separating the, oil plant property from

his District. He said that personally he was in favor of remaining in the Municipality if these services were provided.

Councillor Cruikshank stressed the importance of the cost of large projects and the financial affect this would have on other Districts in the Municipality. He recalled that the first Committees from Woodside had not asked for financial assistance, but were willing to pay. He said that he would have to have more facts and figures before he could support the resolution.

Warden Dowell in reply to Councillor Cruikshank said that he recalled when hard surfaced roads were proposed for Nova Scotia about 50 percent of the people were opposed because they felt they would be unable to pay for them.

Councillor Gates said that it might be wise to deal with expenditures in each District as they came up and proposed the following addition to the resolution with the consent of the seconder, Councillor Dauphinee: "This proposal is made subject to the Imperial Oil property remaining within the Municipality."

Councillor Naugle urged that this final clause be deleted from the original and that it read as originally proposed. Councillor Naugle felt that the Council should not shirk its responsibility to its ratepayers even with the loss of the oil plant assessment. He pointed out that improvements and services in the Districts would greatly enhance the value of property and that the Municipality and the people would both benefit in the final analysis.

Mr. Fielding, the solicitor, felt that the additional clause did not tie the hands of Council. It simply stated that as the County existed today we can do these things, but that if the financial ability of the Municipality was impaired by the serious loss of a valuable section then the Council would give further consideration at a later date.

Councillor Archibald favored the additional clause because of the importance of the oil plant assessment and its possible affect on the Municipality if it was lost.

Councillor Gates declared that he had proposed the additional "oil plant" clause because of the possibility of too large a development at the same time and that he did not wish to tie Council's hands in the future. He pointed out that he took this stand in fairness to all and did not wish to take advantage of the heavy pressure that was being exerted on Council by the Woodside problem.

Councillor Fraser suggested that the financial burden be spread over a period of years so that a great hardship be not imposed on present atepayers.

The Warden said that he believed the life of the project determined the period of years for financing and thought that the water and sewer projects could be financed over 30 years.

Councillor Slaunwhite felt that the proposal to provide essential services was a most important one for the future betterment of the County and favored the resolution.

Councillor Lomas also felt that something must be done, stating that already there was evidence that the city and town were looking hungrily at the more valuable sections on the fringe areas.

Councillor Ferguson said that what previous Councils had accomplished or not accomplished was "water under the bridge". The important thing was that the Council must take definite action if the County was to remain intact. He felt that the Council had been fair with Woodside in the past.

Councillor King said that she was in favor of the resolution.

Councillor Spracklin said that he had weighed the advantages and the disadvantages and had reached the conclusion that there was nothing the Council could do expect assist in providing these essential services. He said that it was important that the mistakes of the past that had been created by too rapid growth in certain areas were not duplicated in the future.

Councillors Turner and Webber favored the resolution.

Councillor Dauphinee pointed out that if Woodside was lost it was possible that other Districts would follow if the Council failed in its duty. This would result an an impossible situation insofar as the provision of services are concerned. He urged that the Council act immediately.

Councillors Myers and Isenor said they favored the adoption of the resolution, and Councillor Evans said that he always felt that the Municipal Council should do all in its power to provide essential services for the metropolitan area as well as other services to the rural areas.

Councillor Settle declared that the big question in the present problem was who should have the oil plant assessment, the village of Woodside of the Municipality as a whole. He reviewed the history of the Woodside problem and stated that it was his opinion that one certain section should not benefit to the disadvantage of the whole. This would happen if the oil plant property was lost to the County assessment rolls.

Councillor Settle said that it was an important fact that the extent to which the Municipality could go in providing services is dependent on the assessment of the oil plant property, but despite this fact the County has a great responsibility insofar as the health and happiness of the people are concerned. This could not be measured in dollars and cents, but the lack of resources which might be created by the loss of a valuable assessment would hinder other progressive steps which the County might consider.

Councillor Myers said that he believed that the great majority of Woodside people were favorable to remaining in the County if water and sewer facilities were provided. He favored the adoption of the resolution.

Councillor Naugle again urged the deletion of the final clause "This proposal is made subject to the Imperial Oil property remaining within the Municipality." Councillor Naugle felt that this clause would create a wrong impression of Council's progressive policy and intention to provide improved conditions. Councillor Gates said that the suggestion of Councillor Naugle had merit and that he realized that Councillor Naugle had struck upon a very important point in connection with the whole proposal. With the consent of Councillor Dauphinee the clause was struck out.

Warden Dowell then put the motion as follows:

"THAT this Municipal Council, after hearing a report from its Public Service Committee, doth hereby declare that sewer and water services are required in several parts of the County, including in alphabetical order Albro Lake, Armdale, Fairview, Kline Heights, Spryfield, Tufts Cove and Woodside and ach services should be provided as a joint venture by the Municipality and the area concerned;

"FURTHER RESOLVED that this Council do offer to any Municipal District or part thereof, expressing a willingness to participate in such joint venture, the following proposal:-

1. That the Council shall provide a survey of such district for such services.

That the Council shall borrow on the credit of the Municipality a sum sufficient to provide water and the consumer shall pay the rates fixed by the Public Utilities Board.

- 3. Any costs not covered by such rates shall be borne by the Municipality.
- 4. The costs of provision of sewers shall be borne 50% by the Municipality and 50% by the District or area concerned and rated thereon.
- 5. Costs of administration of such service, including engineering, shall be borne by the Municipality.

Councillors Naugle and Ferguson asked for a recorded vote.

Warden Dowell then put the motion and declared it carried. The roll call vote was as follows:

Councillors Dauphinee, Warden Dowell, Fraser, Slaunwhite, Spracklin, Gates, Myers, Settle, Naugle, Evans, Lomas, Webber, Ferguson, Turner, Burris, Isenor, King and Chisholm.

#### Against

Councillors Bond, Archibald and Deputy Warden Cruikshank,

On motion of Councillors Spracklin and Naugle the Council adjourned until 2 o'clock.

#### AFTERNOON

Thursday, July 6, 1948

The Council met at 2 o'clock. Roll called,

Councillors Naugle and Ferguson moved that the Council adjourn to reconvene after the conference this afternoon with the Government. Carried.

#### EVENING

Council reconvened. Roll called,

Councillors Archibald and Bond and Deputy Warden Cruikshank stated that they had opposed the resolution passed this morning not because they were opposed to the principal of providing services to the fringe areas but because the last clause re the oil plant had been deleted from the resolution.

The minutes of the day's session were read.

Councillors Lomas and Gates moved that the minutes of the day's session be adopted. Carried.

On motion of Councillors Myers and Turner the Council adjourned sine die. God Save the King.
