MINUTES OF THE JULY SESSION OF THE SECOND YEAR COUNCIL OF THE THIRTY-SIXTH COUNCIL OF THE MUNICIPALITY OF THE COUNTY OF HALIFAX.

The July session of the Halifax County Municipal Council convened at 10:00 a.m., Tuesday, July 15, 1969, with Warden I. Settle presiding.

Following the Lord's Prayer, the Clerk called the Roll.

It was reported that Councillor Granville Snair was sick at home and Councillor Colin Baker was in the Halifax Infirmary and would not be present today.

The Clerk read a "Thank You" letter from the Bedford Basin Yacht Club. Council agreed that this letter be filed.

The Clerk read a letter of resignation from Councillor T. Tonks from the County Board of Health.

Councillor Tonks recommended that the Board of Health be abolished and read from Chapter 30 of the Public Health Act, outlining the powers of the Board for the benefit of the press who the Solicitor felt should be excused from the Health Board meeting during discussions on the Ettinger and Beaver Subdivision problem. He felt that the press should not be under the impression that the Board did not have powers to act. He said that on July 8th., and 9th., only a week ago, a homeowner in that Subdivision did not have water from 1:15 p.m., and although the sewage disposal system is working, the chlorinator has not been installed and the Board of Health at the meeting when he resigned had agreed to a seven (7) day deferral and if the situation were not rectified, they call a special meeting the next week, he asked if that had been done?

Mr. Bensted advised that he had received a report from Dr. Cameron saying that the services had been corrected in a satisfactory manner and for this reason the special meeting was not thought necessary.

Councillor Tonks said he had brought before the Department of Highways three (3) times the problem of the bus turnaround in Eastern Passage being a health hazard with the accumulation of daily debris and stagnant water and quoted from a letter to Dr. Cameron from the Provincial Health Inspector, but despite this, he said, no further action had been taken. He also read from paragraph 3 of the Health Act pointing out that the Board had sufficient powers with which to act and in his opinion they had done nothing in the six (6) months he was on the Board.

Solicitor Cox ruled that the Health Board is a requirement under Provincial Legislation and the Council has no authority to abolish this body.

Councillor P. Baker said he had moved the motion to give Mr. Nicolls seven (7) days to rectify the services in the Subdivision because it was his thinking that some of the people complaining were not entitled to the services because they were not Mr. Nicolls tenants and he was not obligated to them. He felt it was only fair to the people because it would take at least two (2) weeks to get it before the Courts and he had information that the problem had been rectified. He did not believe that the Board of Health is an ineffective body and had personal experience of many problems resolved by Dr. Cameron and his staff. He felt that

Councillor Tonks should reconsider his resignation or else that the County should not accept his resignation.

It was moved by Counciller Tonks:

"THAT the Board of Health of the Municipality of the County of Halifax be abolished and that a Sanitary Inspector be appointed to carry out the duties of the Board". (No seconder - the Solicitor advised that Section 11 of the Public Health Act requires Council to appoint a Board of Health and Council has no powers to abolish the Board).

It was moved by Councillor P. Baker, seconded by Deputy Warden Nicholson:

"THAT the resignation of Councillor Thomas Tonks as a member of the Board of Health not be accepted". (Motion defeated).

Councillor Giles felt that Councillor Tonks should reconsider his resignation because on the Board he could do more even though at times it gets frustrating.

Councillor Tonks said he could not be forced to act. He said that without counting special meetings, \$500 a year was spent for mileage and \$1,680 was spent for Health Board members attending meetings each year and he did not feel the cost was justified by the amount of action they took.

Councillor McCabe said that although the Board of Health had had many criticisms many times, he had occasion to contact Dr. Cameron and his staff and they have been very quick in trying to correct problems he brought to them. He said that if all Councillors resigned from the Boards, then their positions could be filled with those of the type attending the lie-in.

Councillor Giles asked Councillor Tonks to reconsider his resignation because with his attitude "We will get the desired action and without him it will go back to an inactive Board. I think he can serve the Board and the people of this County better by staying on".

Deputy Warden Nicholson felt that the purpose of this Board was to try to solve problems, not to prosecute necessarily because in many cases this just prolongs the solution. He did voice concern, however, in the lack of knowledge or advice of Inspectors who went out and did percolation tests. They either approved or condemned, but gave no advice as to how the soil could be remedied to pass regulations and almost any land can be brought up to regulations. He charged that they did not know the difference between a cesspool and the Eiffel Tower and he had taken this up with Dr. Cameron asking for more co-operation from the Inspectors.

The Warden called for a vote on the motion. (Motion defeated).

It was moved by Councillor Tonks, seconded by Councillor P. Baker:

"THAT the resignation of Councillor Tonks from the Board of Health be accepted". (Motion carried).

It was moved by Councillor P. Baker, seconded by Councillor Moser:

"THAT the Nominating Committee meet sometime today to bring in a recommendation for a member of the Board of Health to replace Councillor Tonks". (Motion carried).

Councillor Tonks said that he had been on four (4) committees or Board of Council, three (3) of which were not active and with the reduction in Council members, it was now required that he be on seven (7) Boards and that if he did not get more co-operation in the other Boards he would feel obliged to resign from those too. He said that at the Welfare Committee meeting yesterday he moved that the expense for comforts for Halifax County patients in the Halifax County Hospital be paid by the Nova Scotia Hospital Commission and did not get any support.

It was moved by Councillor Tonks, seconded by Councillor Giles:

"THAT Council make representation to the Hospital Insurance Commission for that Commission to assume the cost of of \$15.00 per month, comfort money for patients at the Halifax County Hospital who have no money of their own". (Motion carried).

Councillor P. Baker explained that they had approached the Nova Scotia Hospital Commission on several occasions regarding the payment of the \$15.00 a month for needy patients but they did not feel that this was medical and they are being generous now in paying the operational expenses of the mental hospitals with no cutbacks in the budgets. Councillor Baker explained that many of the patients received old age pensions or disability pensions, from which \$15.00 was allocated to the patient each month for comfort money; other patients receive an allowance from relatives or have other sources but some do not receive anything and it is for these that the comfort allowance is requested. He said that if the patient had any money left in his fund at the end of the month, he would not get any more until it was used up, and that this had been presented by the Board of Management of the County Hospital to the Welfare Committee as to other Municipalities in the Province.

Councillor Tonks felt that this \$9,000 was an expense that the County could not afford, that it should come from the Nova Scotia Hospital Insurance Commission and their 7% sales tax because it would affect the patient's outlook and thus his health and the cost would be shared by everyone including tourists who were in a better position to pay this than the homeowners.
