## Fisheries, Eastern Shore - Councillor Smiley

Councillor Smiley said the federal cuts to the Eastern Shore fishery are no less devastating than what has happened in Nfld. The full impact of the quota cuts to inshore fishermen are rapidly becoming evident. The stress, frustration and disbelief are beginning to create serious strain on those in the industry. The quota allocated this year, from Lewisburg to Sambro, was the amount taken last year in Mushaboom and Jeddore. There is an 80% decrease. The people need real assistance to adjust to the reality that current stock levels are dangerously low and must be rebuilt. Her concern is a lack of action by the federal government to provide assistance and income relief through this necessary period of adjustment. Last year the ground fish fishery generated \$30 million in her region. There will be a tremendous backlash in the local economies of the Eastern Shore when the effect is felt in the grocery stores, the oil and gas delivery service, motor repairs, etc. She said she can only hazard a guess as to the impact on the Social Services department. In one small fishing community alone sixty on shore jobs will be lost - baiting trawl and support to the fishermen. This supplementary income for the seasonally employed, the single parent families, the widows and students has kept many families from financial ruin through the years. Our province recently mourned for the communities that lost five fishermen to the perils of the sea. It is well acknowledged that the dangerous and honourable work of the fishermen is a harsh and demanding way of making a living and then to expect them to personally absorb the economic aftermath of the cuts to the fishery is unthinkable. A relief program similar to that provided by the Northern Cod Adjustment and Recovery program in Nfld. is greatly needed to soften this economic impact.

She said the money was going to be used for computers and televisions and a big She said what has frustrated the people in district 14 is screen. the advertisement was for C.P. Allen and feeder schools which means the areas of Hammonds Plains, all of district 14 and 17 as well as Bedford, who have children going to that senior high school are affected by the area rate. She said she has people in Oldham and Grand Lake paying an area rate, in Bedford, paying for a number of computers. She said she is concerned with the fact that all it takes to set an area rate is 7 people ask the trustees to have an area rate meeting, 30 people can attend that meeting and then 70% of those 30 people can effect an area rate on schools. She said she feels this is very archaic and very outdated. She said she would like to have this re-examined because in form it is taxation by the school board through their trustees and ends up with a two tier system of education. She said it ends up with the Bedford schools having a great deal more than other schools that don't have an area rate. She said she has been advised by the School Board that if twenty or thirty of these computers go into C.P. Allen then they will not be up for a computer allotment which means you are paying for your education tax and you won't get them because it's by allotment. If thirty computers are put in through an area rate and yet thirty computers were supposed to go in on the next years agenda you won't get them. She said the people in effect are paying twice. She said she feels it is a very outmoded system.

## MINOR VARIANCE APPEAL MVC 34-92-06

Dorothy Cartledge made the staff report. She said an application had been received to permit the location of a dwelling 11 ft. from MacKay Road in Eastern Passage instead of the required 20 ft. setback. The property in question is a vacant piece of land on the South side of the road. It measures 50 ft. wide by 40 ft. deep and is capable of being serviced within the existing sewer and water lines on the road. The proposed dwelling measures 30 ft. by 21 ft. and it's intended position on the lot will meet all other setback and lot coverage requirements. Where the requested variance was a setback from the road the proposal was sent to and approved by the Department of Transportation.

She said in evaluating a minor variance they are relegated by the provisions of the Planning Act in that a variance may not be granted if it's not minor, if the difficulty is general to properties in the area or results from the intentional disregard for the Land Use By-law. Upon review of the application it was

determined that none of these restrictions apply to this particular application. The requested variance is 45% reduction of the required setback and is relatively common in most minor variance applications. The property is very narrow and a minor variance is the only means by which the lot could be developed given the 20 ft. dwelling width of the C-2 zone.

She said existing dwellings on this road are built within 10 to 12 ft. of the road right of way and the proposal would fall within the established building line. An application for another variance further North on this street for a 10 ft. setback was approved in October, 1992 without any appeals being received. All these factors resulted in a decision to approve the variance request. As the approval was appealed the decision rests with council. She said they have a petition signed by four individuals, within 100 ft. of the variance, who support approval as well as the original appeal notification signed by three property owners within 100 ft. of the variance.

Ms. Cartledge said the actual appeal letter did not give a reason for the appeal just that he was not in favour of the variance.

RA-PD5-21-92-05 - APPLICATION BY MARITIME HOUSING TO REZONE PROPERTY AT 123 VILLAGE ROAD IN HERRING COVE FROM VR (FISHING VILLAGE RESIDENTIAL) ZONE TO R-2 (TWO UNIT DWELLING) ZONE IN ORDER TO ENABLE A DWELLING WITH A ROOF LINE PITCH OF LESS THAN 10 OVER 12 BE PERMITTED (40 PERCENT) TO REMAIN ON PROPERTY.

Mr. Jim Donovan presented the staff report. The application is an application to rezone property at 123 Village Road in Herring Cove. He said on September 21, 1992 an application for a development permit was taken out by Maritime Housing for permission to construct a single unit dwelling a lot located at this address. According to the permit application the dwelling was intended to have a minimum roof pitch of 10 over 12 or a 40% slope which is a requirement of the present VR (Village Residential) zoning. A development and building permit were issued subject to compliance with the applicable municipal requirements which included the compliance with the roof pitch requirement for the VR zone.

He said on October 28, 1992 a building inspection, undertaken by municipal staff, revealed that the building that was in place on the property had a roof pitch that did not comply with the zoning requirements. Maritime Housing was advised of this in a letter dated November 3, 1992 and also advised that no further work should proceed. On November 9, 1992 municipal Planning Advisory Committee requested staff to initiate a rezoning application which would enable municipal council to consider alternative zoning for the

property so that the building could be brought into compliance.

A review of the applicable provisions of the Planning Strategy and the site itself determined that an equitable zone in this particular case, which could apply to the property, would be the R-2 zone. He said the property is generally level although it is well below the roadway. He proceeded to show council slides of the property. He said the property is situated within the Village Centre designation for Herring Cove and is zoned Village Residential under the Planning Strategy and Land Use By-law for Planning District 5.

According to the Planning Strategy the Village Centre designation encourages the retention of the fishery and preservation of the physical character of Herring Cove. He said there is a strongly expressed desire, by the residents of Herring Cove, to preserve the historic character of the fishing village in that community. He said there is an interest in ensuring that planning in Herring Cove should enhance the coexistence of the village with the adjacent developing residential areas. To implement the objectives the Village Residential zone has been applied to properties within the established portions of Herring Cove particularly more to properties along both sides of the Shore Road, Village Road, and Hebrideen Dr. The zone permits single and two unit dwellings, existing mobile dwellings and existing multi unit dwellings, fishery and open space uses as well as some home occupation and home based day care facilities.

The zone specifically provides for the control of roof line pitch for any houses constructed within it. He said the requirements are almost exactly those of the R-2 zone. The use is permitted in the R-2 zone the same as those permitted in the Village Residential zone. The building setback requirements are the same. The only exception, in comparing the two zones, is that of the roof line pitch which is required in the Village Residential Zone and not required in the R-2 zone. Although the Planning Strategy doesn't specifically provide for rezoning to an R-2 zone within this particular designation, the property is situated adjacent to existing R-2 zoned properties. It is at the edge of the designation boundary and there is a specific policy in the Planning Strategy which allows council to consider a rezoning to permit zoning on an abutting property to permit a use that would be permitted in the abutting zone. In this case the evaluation of this application was undertaken and, in view of that provision and the criteria outlined in Policy 120 of the Planning Strategy, it is staff's opinion that rezoning this property to R-2 would not conflict with the intent of the Village Centre designation. The property is not situated within the main developed portion of the Herring Cove where more traditional forms of housing are more prevalent. The properties in the immediate vicinity of the site are developed with dwellings that have more contemporary roof designs. He said the proposed rezoning would not create any

conflict in terms of adjacent land uses.

Since the R-2 zone is the same as the Village Residential zone, except for the roof pitch requirement, the overall impact of the rezoning is negligible and staff is recommending the application be approved.

#### OUESTIONS FROM COUNCIL

Councillor Ball asked Mr. Donovan had heard from any community residents with regards to this application.

Mr. Donovan said they heard from one individual who phoned objecting to the application.

Councillor Sutherland asked Mr. Donovan if the roof pitch is something that is common in the community.

Mr. Donovan said most of the older homes along the cove have steep pitched roofs. He said this is the only architectural requirement that is in this zone.

Councillor Deveaux asked if Mr. Stanbrook's questions answered by Mr. Calda.

He said Mr. Calda's response is in Mr. Meech said they were. direct relation to the questions raised by Mr. Stanbrook. He said there is a fair amount of information flowing on a regular basis on the project to provide people with updates; however, they do not make the minutes of the corporation public. He said what gets into the information circulars is a reflection of what decisions have been made. He said he and the other two CAO's were given the responsibility of overseeing the development of this particular information base and report. He said it is a tool to assist in making some decisions on how it should be structured with regards to ownership and ongoing operations and maintenance in the future. He said there are no decisions reached in the report. He said Mr. Wdowiak was in attendance to provide a status report with regard to the implications of connecting the Eastern Passage Waste Water Plant to the new regional system.

Councillor Deveaux said he has heard that when the plant is built there will be no extra capacity allowed for the Eastern Passage Treatment Plant. He said Mr. Calda indicates that there will be extra capacity for the Eastern Passage Plant.

Mr. Meech said when the regional system goes into operation there would probably be adequate capacity to take the Eastern Passage capacity; however, there would not be sufficient capacity, based on what is presently being proposed and designed, to take the Mill Cove waste. He said there is the ability to expand the capacity of

the plant built into the plans.

Mr. Wdowiak said staff are preparing the financial implication report, for council's consideration, on that question. He said a letter is being sent to Halifax Harbour Clean Up Inc. to get confirmation of what the full financial implications will be once the regional treatment facility in place.

Mr. Meech said once the information is received it will be brought to council. He said in relation to the maintenance and operations study the Federal and Provincial Review Panel has written to himself and the CAO's of Halifax and Dartmouth raising a number of questions about this study. He said they asked if they would attend, specifically, at one of the sessions to deal with this particular issue. He said they have examined it and he is having difficulty understanding why there is so much time and focus on this issue. One of the key questions raised is who is going to own and be responsible to operate and maintain it. He said if there is only one municipal unit it will be in the ownership of that unit and it will be their responsibility to operate and maintain it. He said there have been no final decisions.

It was moved by Councillor Deveaux, seconded by Councillor Ball:

"THAT A COPY OF THE LETTER BE SENT TO MR. STANBROOK"

#### MOTION CARRIED

Councillor Cooper said a map has been provided but it does not show where the channel is going across the end of the island. He said he would like to request that the map be redrawn specifically showing where the channel will go, whether across the land or between the land and the island. He said he has other concerns with regards to hook up to the Eastern Passage plant. He said with the hook up will come realignment of dollars and he said he would be concerned with the impact it would have on all users of the Eastern Passage Treatment Plant. He feels it will have many implications. He asked Mr. Meech why the decision was made not to have the minutes public after approval.

Mr. Meech said the corporation is a private corporation that was created by the province and the decision was taken collectively that the minutes of the corporation were not going to be open to the public. He said anything, in terms of a decision, that is reflected in the minutes has been communicated to the public in other formats.

Councillor Cooper said if there is going to be a major project involving tax dollars there should be sufficient or justifiable reason for keeping those minutes secret. He suggested that parts that must be kept secret deleted and have the rest available to the public.

## TERMS OF REFERENCE - SET ASIDE PROGRAM MONITORING COMMITTEE

Mayor Lichter informed council that in the last five or six months he and Mr. Meech have had meetings with members of the Black Business Consortium, Black United Front, WADE and other black organizations to discuss the topic of program monitoring committee. He said he is recommending to council approval of the terms of reference in order to, with the help of that kind of committee, assure that the Set Aside program will be as successful as it could He said the Set Aside Committee that is presently in place, be. approves all projects and awards the tenders. He said this committee would be set up to advise council on the procedures that may need to be amended, from time to time, according to this particular terms of reference as it is laid out. He said it would not in any way interfere with the Set Aside Committee's work. This would be an advisory committee to council.

Councillor Bayers asked what is the function of the present Set Aside Committee.

Mayor Lichter said it is a staff committee headed by Beverley Clahane, Purchasing Coordinator, to screen tenders and to accept potential applicants for the Set Aside Program and when there is a project, to award those tenders through recommendation to the Executive Committee.

Councillor Bayers said he has a problem with setting up a new committee to monitor the committee already in place.

Mayor Lichter said this council has no knowledge of how a black business operates nor do they have the same knowledge at the Set Aside Committee level or how to obtain that kind of knowledge. He said sometimes there difficulties with contractors and, if Halifax County knew how to assess a contractor, then Halifax County would be in a better position to assure that the contracts are going to be properly fulfilled once the tender is given. He said the job of the Set Aside Committee, which is a staff committee, is to look at all the people who apply to get on the list for the Set Aside Programs and then, when there is a project, to sort this out. He said this proposed committee, with the makeup that is being proposed, would be able to suggest to council that there is a way to ascertain the financial ability of the groups of companies that exist so that there would be a greater assurance of success. He said they if they could do this without interfering with the awarding of the actual tenders, he would prefer this. He said they would only report to council when policy changes are needed to the Set Aside Program. He said they cannot say who receives a tender.

He said there was a time, before the Set Aside Program was set up, when requests were made by the Black Business Consortium that they be the exclusive delivery agent and only their members be allowed to receive Set Aside programs. He said Halifax County had informed

them that if it was going to help a minority group then it would be any minority group.

Councillor Bayers asked for clarification on the number of members who would be serving on the committee.

Mayor Lichter said the committee would consist of one person appointed by the Black United Front, one person to be appointed by the Watershed Associated Development Enterprises Ltd., two persons from the Black Business Consortium - one of these to be female, two persons recruited from the public to represent the Black Business Community and two members from Municipal Council.

Councillor Peters asked how are the municipal councillors to be selected and what is the term of office to be for the members of the committee. She said she would like to see it set up with an annual review or a term of office being one year.

Mayor Lichter said the councillors could be chosen either by volunteering or nominations depending on the level of interest. He said he has no difficulty with inserting a one year term for all members.

Mr. Meech said that there is a policy in place, at the present time, on Set Aside which council has endorsed. He said this is suggesting that there be a committee that would review that policy from time to time, make recommendations to council and it will be council's decision as to whether or not to make changes to that He said the staff committee function is existing policy. essentially to administer the policy that has been approved by council. He said with this there would be a group of people that would have the opportunity to sit down and focus on what that present policy and criteria are and maybe come to some conclusion that there should be some changes to it. He said recommended changes would come to the council and it would be up to council to decide whether or not it wants to make any changes to the existing policy.

Councillor Adams said he feels it is a responsible thing to do, as a municipal government, to monitor the program that is presently in place. He said he felt perhaps there should be a member of the non black business community because that is who the black business community is dealing with.

Councillor Giffin said he does not like the composition of the committee. He feels there should be a representative from district 18 as he has two small black communities in his district and there are small companies in the district which he feels should be represented in the committee. He said he would like to see a two year term with half to be changed in the odd year so there is some continuity in the committee.

Councillor Ball said he does not have difficulty with the monitoring committee. He said this committee could be a monitoring device.

It was moved by Councillor Ball, seconded by Councillor Peters:

"THAT THE COMMITTEE STRUCTURE AS PRESENTED BE ENDORSED AND FURTHER THAT THE COMMITTEE INCLUDE A REPRESENTATIVE FROM THE NON BLACK BUSINESS COMMUNITY"

Mayor Lichter said in order to search out the suitable representation on that committee, he would suggest that council approve the terms of reference with the direction to the committee to, at their first meeting, address the issue of who would be an asset from the white community.

Councillor Ball said he would amend his motion to reflect this as well as the suggestion that committee members have no more than a years mandate and come up for review and appointment by council on an annual basis.

The amended motion to read:

It was moved by Councillor Ball, seconded by Councillor Peters:

"THAT THE COMMITTEE STRUCTURE AS OUTLINED BE ENDORSED BY COUNCIL. FURTHER THE COMMITTEE MEMBERSHIP TERM BE ONE YEAR WITH REVIEW AND APPOINTMENT BY MUNICIPAL COUNCIL AFTER THAT TIME AND AT THE FIRST MEETING THE COMMITTEE MAKE A DECISION WITH RESPECT TO A REPRESENTATIVE OF THE NON BLACK BUSINESS COMMUNITY"

Councillor Taylor asked Mr. Meech if the Set Aside program also take into consideration other visible minorities.

Mr. Meech said it is specifically targeted to the black business community.

Councillor Taylor said this looks as if the competency of staff was being questioned with regards to administering the Set Aside program.

Mayor Lichter said that is not being done. This is asking if there is some way to improve it and, if advice can be received to improve it, why not consider that advice. He said this type of committee, knowing local situations much better, could recommend such things as "sub contractors have to be paid by the municipality or issued joint checks with the main contractor". He said it is those type of policy decisions that council is not able to consider and why not benefit from their advice.

Councillor Taylor said he would be more comfortable if the whole

Set Aside program took into consideration other minorities.

Councillor Cooper said he has difficulty with the theory behind the terms of reference. He said council is setting up a monitoring committee to monitor a program where policy recommendations will be made to their own best interest. He said he feels there may be some danger here of self interest creeping into this process. He said there are members from the Black Business community and the Black Business Consortium who are the main beneficiaries of this program. He said he feels this should have been brought to council for discussion before looking at these terms of reference. He said he has nothing against having a committee to assist in the Set Aside program, because the Set Aside program is designed to assist the black community business achieve the experience and financial experience necessary to strike out on their own and be competitive He said is not sure that with these terms of in the market. reference Halifax County would be helping them do this to any great He said he hopes these terms of reference are just a extent. He said if the chairman is to be a person with starting point. extensive experience in the business or construction industry will this open the door to abuse of the system.

He said was disappointed that there was not members of senior staff on the committee. He said it also does not give a definition of costs and support required for the committee. He said the reports and recommendations that would come to municipal council could be slanted towards the benefit of committee members and he feels that council should be very careful. He said he feels these terms of reference need to be reviewed and brought back to council before they are approved.

It was moved by Councillor Cooper, seconded by Councillor Bayers:

"THAT THIS BE REFERRED TO EXECUTIVE AND SENIOR STAFF FOR REVIEW AND BRING THEM BACK FOR FURTHER DISCUSSION"

Councillor Bates said he agrees with Councillor Cooper. He said if the Set Aside program is going to work then there is some risk taking on the part of Halifax County that is beyond what you do when you are involved under a normal contractual arrangement because they are starting out and need guidance and direction. He said he though it would be better with more staff involvement to look over and deal with these contracts and ensure that from start to finish, or until the contractor can operate on his own, he may need more guidance and direction. He said he agrees with the motion to put it back with staff to take a second look at this.

Mayor Lichter said that he would like council to understand that it is not the Set Aside program which is being looked at but the policy that directs that program. He said there is a big difference between the two.

# CLEAN AIR - COUNCILLOR HARVEY

Councillor Harvey said there are deaths each year caused by the use of tobacco. He said it is widely recognized that the use of tobacco is the major cause of such diseases as lung cancer and is a major factor in heart disease and stroke. He said there has also been a lot of concern with "second hand" smoke. He said he would consider this to be a serious health matter especially to the 75% of the population which are non smokers.

He said there is a growing acceptance that smoking is a serious health hazard not only to the smoker but also to many of the people that the smoker comes in contact with.
