INDEX TO THE
DARTMOUTH CITY COUNCIL MINUTES

Indexing begins with January 1977. The minutes will be indexed as they arrive in the Library. Cumulations will appear semi annually and annually.

The index is alphabetical under subject which may be place, person or simply a term describing in general terms the content of the minute. An entry may appear more than once in the index. This to enable readers to track down a particular minute from more than one viewpoint.

READING THE INDEX

The index is read from the centre "gutter" of the page and all information for one entry is on the same line. Therefore, if an entry is not completed at the right hand side of the page, it is continued to the far left of the gutter on the same line (see example 'A' which reads: TRAFFIC-ENGINEER, FEASIBILITY-STUDY-TO-BE-CONDUCTED-INTO-HIRING-FULL-TIME-MC.

The start of an entry is indicated by an asterix (*). The asterix maybe either to the left or the right of the gutter. Each asterix is followed by six numbers indicating month, day and page of the minutes. Using example 'A', once again the indexed word is 'TRAFFIC-ENGINEER', but the entry begins to the left of this with the first two digits in the series of numbers to the far right. The rest of this number is for use by the computer only.
