Town Council met this day at 5 p.m. Present Mayor Notting, Councillors Hitchie, Lynch and Graham, also Town Bolicitor Foster. On motion Messrs. H. S. Congdon and S. Sutherland were appeinted Presiding Officer and Poll Clerk respectively, for the plebiscite to be held on Monday next. In the event of Mr. Sutherland not being able to act Mr. Burpee Wallace was appointed as substitute.

Dartmouth, N. S. Friday, January 3, 1913.

Town Council met this day at 5 p.m. Present Mayor Notting, Councillors Hitchie, Lynch and Graham, also Town Solicitor Foster. On motion Messrs. H. S. Congdon and S. Sutherland were appointed Presiding Officer and Poll Clerk respectively, for the plebiscite to be held on Nonday next. In the event of Mr. Sutherland not being able to act Mr. Burpee Wallace was appointed as substitute.

Mayor Notting reported that on the 23rd day of December, 1912, in company with the Town Treasurer, they destroyed two Town of Dartmouth Forry Bonds, Nos. 24 and 25, dated June 1, 1897, issued under the authority of the Legislature of Nova Scotia, Acts 1895, for \$1000. each, bearing interest at four and one-half per cent. per annum. Said bonds having been paid off by the Dartmouth Ferry Commission. Filed.

Dartmouth, N. S. Monday, January 28th, 1913.

Town Council met this day at 5 p.m. Present Mayor Notting. Councillors Ritchie, VanBuskirk, Mosher, Lynch and Douglass, also Town Solicitor Foster.

On motion the order of business was suspended and a deputation from the Dartmouth League for the Protection of the Feeble-Minded, consisting of Rev. S. J. Woodroofe and E. K. Walker, were heard in support of a resolution, draft of which was laid before the Council, and after a brief discussion, on motion of Counors. Ritchie and Lynch, adopted as follows;-"Whereas, feeble-mindedness is now well recognized to be a common affliction, prejudicing the interests of every family in which a case develops, menacing the morality of communities in which unprotected feeble-minded children live, and tending to cause a gradual deterioration of the race and a corresponding increase in the unfit and dependent classes; ... And whoreas, it is generally conceded that the interests of the feeble-minded as well as of the community at large demand that the feeble-minded should be segregated, and trained and cared for in specially equipped institutions; And whereas, no proper attempt is being made to segregate and protect those who are so afflicted in our Province, Therefore resolved, that the attention of the Government and Legislature of

Nova Sootia be directed to the present deplorable state of feebleminded persons in this Province, with the recommendation that active steps be at once taken to ameliorate their condition. Further resolved, that a copy of this resolution be sent to each member of the Provincial Government."

Minutes of last three meetings were read and confirmed.

Letter was read from Mrs. H. O'G. Baker, Secy. Victorian Order of Nurses, Dartmouth Branch, asking for a grant of \$200. towards their work in Dartmouth, which was proving of great benefit to the town. On motion of Councrs. Ritchie and VanBuskirk, Resolved, that legislation be obtained at the next session of the Legislature to authorize the assessment of \$200. annually towards the Victorian Order of Nurses, Dartmouth Branch.

Letter was read from the Steadfast Circle, Kings' Daughters, Dartmouth, asking the Council to have signs placed about Sullivan's Pond warning persons who go upon the ice that they will be fined for so doing. They did this in view of the late drowning accident and on account of children who still persist in going upon the pond. On "motion of Counces. Nosher and VanBuskirk, Resolved, that the clerk be instructed to reply to the letter to the effect that the Council regret that they have not the power to comply with the request, as the pond is almost all surrounded by private property, and suggesting that they place their views before the owners.

On motion of Councr. Ritchie, Resolved, that the polling places and presiding officers and poll clerks for the election to be held in the Town of Dartmouth on the 4th day of February, 1913, be as follows;-Ward One. At or near R.L.Wambolt's shop, Portland Street. Dr. B. H. Eaton. F.W.Bailey. Ward Two. At the Town Hall. H. S. Congdon. S. Sutherland Ward Three. At the Engine House.

On motion of Councrs. Douglass and VanBuskirk, Resolved, that the Assessment Court of Appeal, which is to meet on February 25, 1913, be held at the Town Hall at 7.30 p.m.

The Auditors submitted their annual report for the year ended December 31, 1912. They reported having sudited all the books, vouchers

and accounts of the Town Clerk and Treasurer, including the books, vouchers and accounts of the Board of School Commissioners of Dartmouth, for the year ended December 31, 1912, and found all in order and correct. The securities belonging to the town were placed before them for inspection, which they found agreed with the details as set forth in the account. They handed in certified statements showing the different services of the town.

On motion of Councrs. VanBuskirk and Douglass, Resolved, that the accounts of the Town Clerk and Treasurer for the financial year ended December 31, 1912, having all been reported to be in order and correct by the Town Auditors, to the satisfaction of this Council, are hereby passed and allowed, and that 400 copies of the Mayor's Report, with the Auditors' Report and Statements, be printed and distributed to the ratepayers.

The Mayor called attention to the need that seems to exist to have that part of the northern boundary of the town which extends from the Windmill Road to the Harbor, better defined. The matter was referred to the Committee on Public Property to have attended to.

A number of bills were passed for payment.

The Clerk reported that at the plebiscite Held on Jan. 6, 1913 on the question of the town borrowing upon debentures of the town a sum not exceeding \$35000. for terminal facilities for the Dartmouth Ferry Commission; 165 voted for, 131 against, majority in favor 34. As to the question of the town obtaining legislation at the next session of the Legislature to authorize the issue of \$75000. of debentures for the purpose of acquiring a site for and the construction of a school building, there were 123 votes in favor, 164 against, majority against 42. Received and ordered filed.

The following award of arbitrators between the County of Halifax and Town of Dartmouth, held under the provisions of the Assessment Act (Board of Health account), was read, also statement of account from the County with interest added to the amount of the award, making a total claim of \$2179.08. Referred to Finance Committee to report upon.

We, the undersigned, Sir Charles J. Townshend, Umpire, and Thomas Notting and William F. O'Connor, Arbitrators, respectively, appointed on behalf and to represent the Town of Dartmouth and the Municipality of Halifax, respectively, upon a certain arbitration held pursuant to provisions 67 and 68 of The Assessment Act, being Chap. 73 of the Revised Statutes of Nova Scotia, in connection with certain expenditures made by the said Municipality as joint expenditure for matters affecting the public health of the Municipality and Town respectively, pursuant to the provisions of The Health Act do AWAPD AND DECIDE that

the public health of the Municipality as joint expenditure for matters allect the public health of the Municipality and Town respectively, pursuant to the provisions of The Health Act, do AWARD AND DECIDE that WHEREAS the joint expenditures for the years 1908. 1909 and 1910 were respectively \$2129.28, \$5771.90 and \$2504.21, in all \$10405.39, AND WHEREAS, the said Town has paid on account of such joint

expenditures the sum of \$1871.64, AND WHEREAS, said Municipality has been claiming from the said Town payment of a further sum of \$3123.08 as the proper balance due by the

said Town upon said joint expenditure account; AND WHEREAS, the umpire and arbitrators have been appointed to decide the proportion of such joint expenditure which, having regard to a uniform standard of assessment, should be borne by the Municipality and Town respectively.

NOW THEREFORE the said Umpire and Arbitrators DO DECLARE, DECIDE AND AWARD that the proportion of such expenditure which, having regard to a uniform standard of assessment, should be borne by the said town, taking into account and orediting the said sum of \$1871.64 so paid by the said Town, is \$1863.49, which said sum is now payable by the said Town to the Municipality, and the balance should be borne by the Municipality. The Umpire and Arbitrators do not deal with the matter of interest, the same not having been referred to them, but it having been represented that an arrangement existed between the Town and the Municipality respecting interest.

From Secctaries, Summer School of Science, be to held in Halifax July 7 - 30, 1913, requesting that some plan be made by which the members of the school can visit Dartmouth in a body and be entertained by the town. Referred to School Board.

From Mrs. D. McClelland, St. John, one of the heirs of the McQuarrie property, sold at Tax Sale of Dec. 27, 1912, requesting that the surplus proceeds of the sale be paid to her mother, Mrs. Gec. McQuarrie. Referred to Town Solicitor to report. A number of bills were passed for payment.

On motion of Councies. Graham and Tobin, Resolved that the Electric hight Plant, in future, be placed under the management of the Street Com.

The Mayor requested that all Standing Committee prepare their ostimates for the current year.

On motion of Councr. Tobin, Resolved, that, in future, the Council have regular monthly meetings, and it was agreed that the third Monday of each month be the date. Adjourned.

Dartmouth, N. S. Monday, February 17, 1913.

Present Nayor Williams, Town Council met this day at 7.30 p.m. Councillors Nosher, Lynch, Graham, Russell, VanBuskirk and Tobin, also Town Solicitor Foster.

Ninutes of last meeting were read and confirmed.

The Committee on Police, to whom was referred the application from Policemen Wirrell and Johnston for an increase in salary, reported that they could not recommend that their request be granted, in view of the fact that their salaries were increased each year for the past two years, and that a considerable increase is expected in the estimates for the current year, to provide for the towns' requirements. Adopted.

Letter was read from A. C. Johnston, calling attention to the unnecessarily prolonged ringing of the fire bell at alarms of fire, which he thought was very objectionable, especially to those who were ill, and asked that some steps be taken to prevent this in future. A long discussion took place on this subject as well as on the control of the apparatus at the Engine House. On motion of Councrs. Tobin the letter of Mr. Johnston was referred to a committee consisting of the Fire Com. the Fire Wards and the Street Committee, to draw up regulations for the control of the apparatus, including the fire bell when alarms are given.

Councies. Graham and Nosher moved the following, which was adopted, Councr. Lynch dissenting;-

"Whereas, it is generally understood that the Dominion Government intends erecting a new Post Office Building on the site now occupied by the present office, and

Whereas, we believe such action not to be in the best interest of the people of Dartmouth,

Therefore Resolved, that in the opinion of this Council the best site for a new Post Office is on the property known as the Barrack Square, and

Further Resolved, that the Rt. Hon. R. L. Borden, Prime Minister, be requested to defer final action until the views of the people of Dartmouth are properly placed before him. "

On motion of Councrs. Tobin and Graham, Resolved, that the regular monthly meeting of the Town Council be held on the fourth Tuesday of each month, instead of the third Wonday.

On motion of Councrs. Tobin and VanBuskirk, Resolved, that the placing of street lights on Wyse Road be taken up by the Electric Light Committee and roport at the next regular meeting.

Councrs. Russell and VanBuskirk gave notice of motion as follows;-"Resolved, that the Legislature be asked to so amend the Ferry Act as to substitute for the present commission a commission of three members consisting of the Mayor and two members elected by the people."

The Mayor handed in a letter from Premier Borden, acknowledging the representations of the Town Council with respect to the location of the new Post Office in Dartmouth, that the matter would receive the careful and earnest consideration of the Government. Ordered to be filed.

Letter was read from Clarence A. Short, applying for a five year lease of the public dock situate between the Eastern Paint Co. and the Marine Slip, for the purpose of erecting a machine shop and carrying on a general gasoline business, with the option of renewing the lease. Referred to the Public Property Committee with Town Solicitor to deal with.

The matter of the Town Plan, prepared by Engineers Johnston and Carson, was taken up and referred to the Committee on Town Plan to report upon.

On motion of Councrs. Tobin and Nosher, Resolved, that Police Officers Wirrell and Johnston be granted an increase of \$50. each in their salary.

On motion of Councrs. Russell and VanBuskirk, Resolved, that in compensation for services in connection with the superintendence of the electric lighting of the town, the Superintendent of Streets be paid an annual amount of One Hundred Dollars (\$100.) to be charged to the Electric Light Account.

Town Council met this day at 7.30 p.m. Present Mayor Williams, Councrs. Mosher, VanBuskirk, Lynch, Graham and Tobin.

Minutes of last two meetings were read and confirmed.

Petition was read from ratepayers, Prince Street, complaining of the condition of the street and sidewalk south of Portland Street. Referred to Street Committee to deal with.

Petition was read from a large number of ratepayers praying that the Council take steps to acquire the Macnab property on the Eastern Passage Referred to Street Com. to report. Road for purposes of a public cemetery.

Petitions were read from ratepayers praying for concrete sidewalks and curbs to be laid down on the west side of King Street from Ochterlony to Quarrell Street, and on the south side of Ochterlony Street from Water to King Street. The Street Committee having reported that the petitions had the required number of names, under the Act, it was resolved that the sidewalks be constructed, and the petitions were referred to the Street Committee to deal with.

Mr. A. NoColl, C.E. being present, was given a hearing at his request. He asked the Council to support the bill entitled "An Act to incorporate the Halifax and Suburban Tramway Co., Limited", now before the Legislature. He said that anything the company proposed having done they wanted to do with the entire consent of the Town Council. After considerable discussion it was resolved, on motion of Counors. Graham and VanBuskirk, "That the Town Solicitor examine the draft of bill to be presented to the Legislature by the Halifax Development Co. in regard to the introduction of Hydrp-Electric Power into the town, and if said bill is found to contain no objectionable or binding features, this Council expresses its hearty approval of same."

Re. water_lot applied for by N. Evans, this matter was taken up and discussed and on motion of Councrs. Tobin and Graham, Resolved that the clerk be instructed to inform the Marine and Fishery Dept. that the Town Council has no objection to the proposed grant of a water lot to Mr. Evans.

The Finance Committee to whom was referred the letter from Mrs. John Hunt, complaining that she was erroneously assessed for certain property, and that she had not been allowed the widow's exemption, reported that they had looked carefully into her complaint, and found that she is entitled to a refund of taxes for amounts overpaid from 1904 to 1912, amounting to \$16.03, and recommend that she be refunded this amount, also that she be allowed the fireman's widows' exemption, and that the item in the Assessment Roll of 1913 "Land Oathill, Bock & Barss, \$250." be struck out. BOARD OF HEALTH.

Dr. Payzant, Health Officer, being present was given a hearing, and suggested that the following additional and changes be made in the Health Regulations;-

A temporary quarantine card not to specifydiscase but to read "This house is quarantined, no one but Nurse, Doctor and Minister to be admitted."

Tuberculosis, to be notified and fumigation of the same after death therefrom.

Scarlet Fever. the quarantine to last until desquamation is completed, the minimum period to be three weeks.

Diphtheria. the quarantine period to last at least three weeks.

Smallpox, the quarantine period to last at least three weeks or until scabs have entirely gone.

Measles, card to be put up on house.

After some discussion, on motion, the matter was referred to the Town Solicitor to confer with Dr. Payzant and submit draft of the proposed changes.

Re. claim of Starr Mfg. Co. for exemption from taxation in the year 1910 as per correspondence with them that year, your committee referred the matter to the Town Solr., and submit herewith his opinion thereon;-

"On Jan.30,1907 the Council, in response to a request from this Company adopted the following resolution;- 'Resolved, that in answer to the request of the Starr Mfg. Co. this Council agrees not to increase the assessment valuation for a period of ten years from time of agreement on any properties now owned by these two companies, (Starr Co and Rolling Mills) or to be purchased by the amalgamated companies before this agreement comes into effect, on the condition of course, that no exemption will be made on other than industrial plant, and that no agreement shall affect the terms of the present exemption enjoyed by the Rolling Mills, etc.etc.' As this resolution did not satisfy the Starr Co. the Council on the llth

As this resolution did not satisfy the Starr Co. the Council on the 11th February, following, adopted a further 'Resolution, That the request of the Starr Mfg. Co. be granted, and that the present assessment on manufactured and unmanufactured stock shall not be increased for a period of ten years from the date of the agreement. Further resolved, that if necessary, legislation to carry out this be obtained."

Under these resolutions the Council is bound to give the Starr Co. the exemption asked for. It is no fault of the Co. that legislation empowering was not obtained. It is the neglect of the Council and they should not... take advantage of their own wrong to exact from the Co. moneys which could never have been claimed had the Council fulfilled their obligation. As to the 1903 Act, I did not cite and did not express an opinion upon it. It is up to the Council to have such an act as will give them authority to carry out their agreement with the Starr Co. In the meantime let matters between the parties remain as they are."

Reven tenders for horses were received, and after some discussion, Councr. VanBuskirk moved, seconded by Councr. Present Mayor Williams, Councra Town Council met this day at 7.30 p.m. Russell, Mosher, VanBuskirk, Lynch, Tobin and Graham, also Town Solicitor Foster.

Street and Public Property Committee reported as follows re. matters referred to them; -

Dwelling for town drivers. Your committee have consulted a competent builder for an opinion as to the feasability of converting the present town workshop into dwellings, and submit herewith a rough sketch of what can be done in this respect. It is shown that two comfortable dwellings can thus be provided for, but inasmuch as no provision has been made in the current years' estimate for this work, and the fact that the year is so far advanced, we recommend that the work be deferred for action by next years' Council.

Complaint by Est. J.R. Graham re. obstruction to door of house, Och. St. by new concrete sidewalk. This matter has been satisfactorily adjusted

by the town raising the door to admit of its opening outward ffeely. Letter from Andrew Forsyth re. washing wagons on Coleman St. Your Com. find that sidewalk and street level on Church St. required grading up thus providing a gutter that would properly carry off the drainage; this work has been done and we recommend that Mr. Forsyth be allowed the privilege of washing wagons on Coleman St. as heretofore. We further recommend that a catchpit be installed at the corner of Church and Water Streets next spring when the weather conditions admit of working concrete.

Work on repairs to Rink progressing favorably.

Following matters attended to;-

Changing of light on Victoria Road near Stairs Street.

Fence and light at east end of Fairbanks Street.

Line fence between property owned by town and F. G. Misener; Letter from P. F. Ring re. light, Stairs Street. Extra light on Thistle Street.

Sidewalk in front of C7H.Harvey's property on Pleasant St.Work in progress In addition to the foregoing matters your committee have accomplished a large amount of street work not referred to them thru the council in the usual manner, and expect to do considerably more before the year closes. Adopted.

Water Committee reported as follows; - Re. appligation of Harry Young for exemption on sewer frontage, Water Street, your committee find that an-exemption has been already granted to Water Street properties in that district, and that the Council have no power to act further in the matter. This report being objected to by the Mayor as being out of order it was not received.

Leslie for \$500. be purchased subject to Veterinary Surgeon's examination, and that the black horse at present owned by the town be disposed of to the best advantage. The amendment was put and negatived on the casting vote of the Mayor, the mover and seconder with Councr. VanBuskirk voting for, the others against. The motion was then put and carried on the same vote reversed.

Letter was read from NoInnes, Mellish & Co. solicitors of Mrs. Mary Lindsay, stating that their client was injured by falling over an embankment on Victoria Road, upon a recent occasion, and stating that if the town wished to defend the suit to name a solicitor who would accept service of a writ. Referred to Mayor, Town Solicitor and Clerk to report upon. Letter was read from F. Treiber, Nontreal, quoting prices for street signs and numbers. Referred to Street Committee to report upon.

Mayor reported up agreement recently made between the City of Halifax the Municipality of Halifax County and the Town of Dartmouth, in reference to the share of municipal expenditure on joint account each corporation should bear. The agreement was dated December 25th, 1913 and was to continue in force for five years, and it was agreed that Dartmouth's share should be 35/520ths. Ordered filed.

A number of accounts were passed for payment and the Council adjourned.

Special meeting of the Town Council was held this day at 8 p.m. Present Mayor Williams, Councillors Mosher, Russell, VanBuskirk, Lynch, Tobin and Carter, also Town Solicitor Foster.

Town Solicitor Foster's opinion re. Dartmouth Park was read as follows;-"Having looked into this matter I am of opinion that the Town Council has no authority to apply to the Legislature for permission to alienate any portion of the Park. An application of this nature must come thru the Park Commission who are vested with the title and hold the property in trust "for the purpose of a public Park and such other public uses as the Commissioners shall. determine, and shall not be by them alienated or encumbered."

Mr. A. C. Johnston, being present, was given a hearing, and submitted a petition signed by some thirty ratepayers of the town objecting to any portion of the Dartmouth Park being used as a site for the proposed new school.

On motion of Councrs. that whereas it has been brought to the attention of this Council that there is a measure now before the Legislature of Nova Scotia which proposes to amalgamate the Halifax Electric Tramway Company to a certain Power Company, And whereas this Council believes that such an act will be prejudicial to the best interests of the people of Dartmouth as it is to the people of the City of Halifax, And whereas, it is the legitimate aspiration of the citizens of Dartmouth that in the near future the two communities will be joined by a bridge across the Narrows, and we would then look forward to the extension of the Tram Service on this side of the water. Therefore Resolved, that this Council strongly protests against the passing of such an act by the Legislature which in our opinion is detrimental to the best interests of both communities.

Councrs. Russell and VanBuskik moved in amendment the following;-Resolved, that in view of the fact that a charter is being sought by a largely capitalized company conferring rights to own and operate tram lines thrucut the province, and that said company may soon be asking the privilege of operating a tram system in the Town of Dartmouth, and in view of the fact that it may be found practical and advisable for the town to own and operate its own tram system, that a special committee be appointed and empowered to get all information possible respecting the cost of constructing and operating a tram line in the town, also all data respecting the probable earnings of such a line, and the route best suited to such a line, and further resolved, that an amount of \$100. be authorized to be spent for the purposes herein named, and further resolved, that this Gouncil protest against the granting of any charter conferring upon a company the privilege of owning and operating a tram line in the Town of Dartmouth without the formal concent of the Town Council.

On motion the Town Solicitor was instructed to prepare a draft bill and embody therein the legislation asked for.

Application was read from S. Sutherland for the position of Poll Clerk at the vote to be taken on the 25th instant. On motion he was appointed Poll Clerk and C. W. Waterfield, Presiding Officer.

Letter was read Secy, Union N. S. Municipalities, calling attention to Bill No. 113 now before the Legislature. This Bill proposed to amend the Towns Incorporation Act by doing away with the payment of taxes as a qualification in town elections. Referred to Committee on Legislation.

Letter was read from Thos. Lisson, caretaker at Engine House, asking for certain repairs to be done to his premises in that building. Referred to Public Property Committee. On motion of Councrs. Brightwood, 18 acres. acres, comprising the following properties, viz, Brightwood, 18 acres, the Wolfe Farm 36 acres, MacKinlay and Ritchie 14 acres, James F. Lahey Mount Thom lot 21 acres, Mrs. Catherine DeBay, Mount Thom lot 21 acres; to be exempt from all municipal rates and taxes, excepting water and sewer rates, for the period of twenty years, beginning May 1, 1914, provided, however, that the said Brightwood, Limited, shall pay to the Town of Dart-mouth the sum of One Hundred and Fifty Dollars yearly after the period of five years, and Three Hundred Dollars yearly after the period of five years for the further period of fifteen years, in lieu of said rates and taxes, and provided further that such properties are used solely for solf taxes, and provided further that such properties are used solely for golf purposes.

This exemption shall only apply to such portions of said properties as are actually used for golf purposes; and if at any time within the next twenty years the whole or any part of the property now owned by the said Brightwood, Limited, shall be sold, transferred or disposed of in any way, the said Company shall pay to the said Town of Dartmouth, upon any such part so sold, transferred or disposed of in any way, an amount of money equal to the taxes which the Town would have received upon any such part under the general assessment of the town from the year 1914 down to the date of such sale, transfer or disposition, first being credited with the just proportion of any moneys it may have already paid by way of commutation.

After discussion, Councr. VanBuskirk moved, seconded by Councr. Russell, "That the draft of legislation as submitted by the Town Solicitor to this Council, granting Brightwood, Limited, certain exemptions from taxation, be approved, and that the Town Solicitor be authorized to secure the necessary legialation. "Whenever thereto requested by the Dartmouth Ferry Commission the Mayor of the Town of Dartmouth shall issue, under the seal of the Town, in the form "A" to Chapter 56, Acts of 1902, debentures to such amount as the Board of Commissioners shall name, but not exceeding in the aggregate the sum of Fifteen Thousand Dollars, such debentures to be for the sum of One Hundred Dollars each, or any multiple thereof, and bear interest at such rate, not exceeding five per centum per annum, as the said Commission shall determine, and be redeemable in twenty years from the date thereof, andsuch debentures when so issued shall form a lien and be a charge upon all the real and personal property within the Town of Dartmouth, and on all the revenues of the Town. The said debentures when so issued shall be handed over to the Chairman of the said Commission and shall be sold by such Commission for the highest price that can be obtained therefor, and the proceeds thereof shall be placed in some chartered bank to the credit of the said Dartmouth Ferry Commission, and shall be withdrawn from time to time as directed by resolution of the Commission on the cheque of the Secretary and Treasurer, countersigned by the Chairman. Before any of said debentures in this section mentioned are issued, the expenditure thereof shall be approved by a vote of the ratepayers, in the manner provided for by Chapter 56, Acts of 1902."

On motion of Councrs. Russell and Mosher, Resolved, that the draft of legislation for the borrowing of \$15000. for the Ferry Commission as prepared by the Town Solicitor be approved.

The Acting Mayor reported that a meeting of the Park Commission had been held this day and a resolution passed by them in favor of the town applying for legislation to enable the Town to lay out a portion of the Park property in building lots and to sell same. After some discussion, on motion of Councrs. Lynch and Carter, Resolved, that the Town Solicitor be instructed to prepare the necessary legislation regarding the sale of the Park Property as approved by the Park Commission.

The Clerk submitted the following and advocated that the same be embodied in the town bill now before the Legislature;- "Towns Consolidated Act, Chap 56, Acts of 1902, Sec. 104, is hereby amended by striking out the words in the 8th, 9th and 10th lines as follows;- Assessment Roll of the next following year applied to the rate for the year for the unexpired portion of which the same are so payable." and inserting in lieu thereof the following;- "Assessors valuation made in advance of the regular assessment whenever such dwellings are in a condition to be occupied." On motion of Councrs. Mosher and Russell, Resolved that the tender of Austen Bros. for a Seagrave Ladder Wagon, at #3255. be accepted.

On motion of Councrs. Russell and Carter, Resolved that the Street Committee be authorized to proceed with construction of concrete curb and gutter on the following streets;-

Dundas Street, Portland to Quarrell, both sides. Wentworth Street, Portland to Quarrell, both sides. Water Street, between Quarrell and Ochterlony, one side, """" Ochterlony to North, both sides. Ochterlony Street, King to Dundas, both sides. """Water to King, one side. Portland Street, continued to Pleasant Street, both sides.

On motion of Counces. Russell and Nosher, Resolved, that the Town Solicitor be instructed to prepare and introduce legislation to enable the Town to borrow a sum not to exceed Twelve Thousand Dollars, for permanent sidewalks.

Town Council met this day at 7.30 p.m. Present Mayor Williams, Councrs. Russell, Mosher, VanBuskirk, Lynch, Tobin and Carter, also Town Solr. Foster. Ninutes of last six meetings were read and confirmed.

Petition was read from property owners on Stairs Street calling attention to the great need of a catchpit on that street at the corner of Wentworth St. to carry off storm water, which overflows the roadway and their properties in the spring of the year. They also requested that the "Reservoir Pond" so called, be filled in and seeded down. Referred to Street Committee to

report upon.

Petition was read from ratepayers residing on Portland Street, between P.A.Road and Maitland Street, requesting that a concrete sidewalk (boulevard) be laid down under the usual terms and conditions. Referred to Street Committee to carry out.

Petition was read from ratepayers on the south side of Ochterlony Street from King to Wentworth Street, requesting that a concrete sidewalk and ourb be laid down under the usual terms and conditions. Referred to Street Com. to carry out.

Petition was read from property owners on King Street, between Quarrell and Ochterlony, asking for a concrete sidewalk and ourb on that street. This was objected to by the Mayor as not being properly signed, and was deferred.

The Water Committee reported as follows;-

1. That the agreement with James R. Douglass, which has been standing for some years, by which the town pays him \$15. per annum as rental for the pipe line going down his wharf, be cancelled, and that the pipe which fed the water boats be disconnected. Mr. Douglass to consent to allow the hydrant on his premises to remain free of charge.

8. Re. letter from Calder & Fraser, that as the Supt. reports they have no injector or pump in use, therefore the town is not responsible that the water pressure does not drive the water supply to their boiler.

3. That meters be placed on the supply pipes to the following users;-

J.P.Mott & Co. 6 inch. Consumers Cordage Co. 6 inch. Starr Mfg.Co. 6 inch. N.Evans & Son 2 inch. Judge's water boats 3 inch, meter to be placed at North Street dock.

4. Sylvester Beazley, Upper Water Street, having applied for water and sever connection for his house, your committee recommend that the extension be made, as they consider he is entitled thereto having paid \$66.34 as sever rates in 1908, altho the sever fronts on his property but beyon feet.

5. That an enumeration and inspection of all water fixtures be made a s soon as possible, to include animals supplied with town water, list of houses having two or more families, etc.

6. That a rate of \$35. per annum be fixed for the supply of water to the Halifax Dredging Co. to date from May 1, 1914.

7. That two catchpits be placed at the corners of Wentworth and Stairs Sts.

also that two catchpits be placed at the corners of James and Portland Sts. 8. Your Committee recommend that the tender of Messrs. Austen Bros. agents, for six inch C.I.Water Pipe at \$34.50 net. per ton, and \$63. for fittings f.o.b.cars Dartmouth, be accepted.

9. Your Committee hand you herewith statement of the Receipts and Expenditure for the year ended April 30, 1914, for your information, and submit herewith estimate of the Receipts and Expenditure for the year ending April 1,1915 by which it will be seen that there is no increase in the rates, and your committee recommend the adoption of these estimates and rates.

10. Your Committee recommend that October 22nd, 1914, be the last date for payment of water rates for the six months due to Nov. 1, 1914, after which the water to be turned off delinquent householders, and that this date be stamped on all the water bills.

11. Your Committee would recommend that the following supplies be ordered;-

Water meters, "Lambert" two 6 inch, one 2 inch. Four steamer hydrants with frost proof jackets. Water pipe, 1200 feet of 6 inch; six 6 inch "T" connections. Gate valves, six 6 inch, left handed, brass fitted. Pig lead, hew, 300 lbs. Sewer pipe, 800 feet of 9 inch, 100 feet of 6 inch, 500 feet of 4 inch.

The following letters were read; - From Board of Trade enclosing resolutions adopted by them requesting the Council to obtain legislation to restrict the erection of bill boards in the town, and requesting that trees be planted on both sides of Quarrell Street between the curb and outside of the sidewalk. Referred to Street Committee to report.

From Mrs. Catherine M. Morrison, objecting to the street lines of her property, corner of James and Erskine Streets, as shown on the Town Plan. Referred to Committee on Town Plan.

From Halifax Branch of Brotherhood of Locomotive Engineers, requesting

a donation towards their funds, required for the entertainment of their order during the week of July 20th, when they expect 4000 people, members and friends of their order, to visit "Greater Halifax". A decision was deferred, on motion of Councrs. Russell and Lynch, Resolved that a committee be appointed to consult with the Banook Canoe Club in order to arrange an entertainment for the Brotherhood of Locomotive Engineers, and to report to the Council. Councrs. Carter, Lynch and Tobin were appointed as the Com.

From Dartmouth Baseball League asking that necessary repairs be made to the grounds of the C.A.A.Club to make them suitable for ball games. Referred to Public Property Committee.

From J. P. Simon and E. E. Coats, objecting to the assessment on personal property charged them on the ground that they were members of the Canadian Permanent Force. Referred to Town Solr. for his opinion.

From S. Jenks, Commr. of Municipal Sinking Funds, stating that the Govt. had made arrangements to supply towns thrubut the Province with debentures required. Action deferred.

From Alox. Findlay, teamster, requesting an increase in his wages. Referred to Street and Fire Committees.

From Chief of Police asking whether or not the Council would indemnify the Dartmouth Police Officers against loss by reason of costs or damages being taxed against them in consequence of any conviction made by the Stip. Magistrate being removed to the higher court by appeal or otherwise. Referred to Town Solicitor to report upon.

From S. Cunard & Co. stating that the dock between the wharf occupied by them and W.C.Bishop was filling up considerably and asking the Council to do some dredging for them. The clerk was instructed to inform them to apply to the Ferry Commission.

From Dr. Payzant, Health Officer, recommending that the Council compel property owners to abolish all privies and connect their premises with the public sewer, and urging that some action be taken in the interests of public health, to enforce the law where sewers are laid. Received.

From Halifax Dredging Co. claiming there was a mistake in the assessment them of \$700. Real Estate to Exazian Eron. and that it should be assessed to **THEM**. Beazley Bros. who are the owners. Referred to Assessors. From J. W. Willis, D. S. Hart and Robert Stanford, all with regard to their assessment and taxation. Referred to Town Solicitor to report.

From Civic Improvement League calling attention to the need of enforcing the law with respect to the removal of ashes and garbage not later than May 18th, and recommending that immediate steps be taken to secure an efficient sanitary inspection of the dairies from which the town receives its milk supply, and the abolition of all privies and closets which exist within the town limits. After some discussion a motion was passed instructing the Chief of Police to furnish the Council with the names of property owners on whose premises there are outside closets, where the property fronts on a main sewer, with the assessed valuation of each property.

Application from Jacob Tynes for water and sewer connection with the proposed dwelling to be erected by him on Wentworth Street, between Quarrell and Ochterlony Streets, was referred to the Water Committee to report.

The Mayor reported that \$2000. Ferry Bonds had been recently paid off. On motion the Mayor and Town Treasurer were authorized to destroy same.

On motion of Councrs. VanBuskirk and Russell, Resolved, that the Street Committee beauthorized to construct concrete curb and gutter on Edward Street (Chapel Lane) between Ochterlony and Quarrell Streets. Passed four to two.

On motion of Councrs. Russell and Tobin, Resolved, that before the catchpit is placed on Stairs Street the Water Committee report on the cost of extending the sewer to the Christie property.

On motion of Councrs. Tobin and VanBuskirk, Resolved, that the tender of the Starr Manufacturing Co. for 4 steamer hydrants with frost proof jackets, at \$48. each, be accepted.

A Number of accounts were passed for payment.

The resolution with regard to the revision of the Rate Book, deferred from the meeting of April 20th, last, was taken up and upon objection being made by the Mayor, was again deferred to give the Council an opportunity to meet with the Assessors with regard to their method of placing certain names on the Assessment Roll.

Councr. Lynch called attention to the encroachment on the public dock

at the foot of North Street, by a pile of old iron, and moved, seconded by Councr. Mosher, that the clerk be instructed to notify the owners thereof, C. Brister & Son, Halifax. to remove the old iron deposited there by them, adjoining their property, within thirty days, otherwise the Town would take action to compel them to do so.

Dartmouth, N. S. Thursday, June 18th, 1914.

Town Council met this day at 8 p.m. Present Mayor Williams, Councrs. Mosher, VanBuskirk, Lynch and Tobin, also Town Solicitor Foster.

Minutes of last meeting were read and confirmed.

Petitions were read from ratepayers asking for concrete sidewalks on (north side) Ochterlony Street from Water to Edward Streets; on Ochterlony Street, south side, between Victoria Road and Pine Streets; on Water Street, between Ochterlony and Stairs Streets. Councrs. Tobin and VanBuskirk moved as follows;- "Resolved, that the petitionars asking for permanent sidewalks be granted and that the Street Committee be instructed to have the sidewalks laid if they have the funds at their disposal for the completion of same. Upon being put, the mover and seconder voted for the others against, and the resolution passed on the casting vote of the Mayor.

A delegation consisting of Messrs. W. C. Bishop, J. L. Wilson and Richard Williams from the Banook Cance Club, being present were given a hearing with regard to the Regatta to be held at the celebration of Natal Day in connection with the entertainment of the visiting Brotherhood of Locomotive Engineers in Halifax during the week of July 20th.

The Committee on Licenses reported having received the opinion of Town Solicitor Foster and recommended that the following clause be added to the Byelaws relative to Hackney Carriages after clause 134;- "Any hackman shall be permitted to carry parcels to the extent of one hundred pounds in weight, with or without a passenger." On motion of Coungr. Lynch resolved that the above bye-laws be sent to the Governor-in-Council for approval.

The Mayor and Town Treasurer reported that they had destroyed Town of Dartmouth bonds as follows;-

2 Ferry Bonds, \$1000. each. Nos. 28 and 29, dated June 1, 1897, 4 per cent. payable in seventeen years from the date thereof, the same having been paid off by the Dartmouth Ferry Commission, June 1, 1914. Ordered to be filed.

The Water Committee reported as follows;-

 Mr. Roderick Marvin, having made application to be supplied with water from the main on the Eastern Passage Road, south of the water meter, for domestic uses, your committee recommend that he be given connection and that a special rate of \$6. per annum be fixed.
 Your Committee, having considered the matter of extending the sewer main from Water Street west thru the Symonds property, to the Harbor, recommend that the extension be made, the estimated cost being about \$800.
 Your Committee recommend that the sewer outlet at the foot of Jameison Street be extended out to low water mark, so that it will be under water at low tide.

Clauses one and three were passed. On motion clause two was deferred until the next meeting.

On motion of Councrs. Lynch and Mosher, Resolved that the Acadia Sugar Refining Co. be notified that the Council has granted Roderick Marvin permission to connect with the town water system.

Town Solicitor Foster reported on matters referred to him as follows;-L.Letter from J.P.Simon. Members of the Permanent Force are liable to taxation for personal and real property as other tax payers. 2. Letter from J. W. Willis. Mr. Willis did own property in Halifax up to March 1914 at which date he claims to have sold. The assessment had been made on the property already. He is therefore liable. With regard to his claim that he hasbeen overtaxed on his property in Dartmouth I can as a matter of course have nothing to say. That is for the Assessors. 3. Letter from D. S. Hart. This is in connection with the Keelor property and The Canadian Investment Company. Sometime about last October some property was bonded to Mr. Hart as Trustee, or rather an option was obtained



No transfer of title has taken place and therefore the property is not assessable to him but to the party in whom the title is vested. 4. Letter from Robert Stanford. Mr. Stanford is living at Cow Bay, consequently I do not care to report on his case at present. 5. Letter from Wm. McKenzie, Chief of Police. The Chief of Police is the official representative of the Town in all matters regarding the peace of the Town. He should have the unqualified support of the Council while in the discharge of his duties, and in my opinion is entitled to to be indemnified against any prosecutions which might be brought against him for any act or acts omitted or performed by him in good faith and within the scope of his authority.

On motion of Councrs. Lynch and Mosher, Resolved that the assessment on the property of D. S. Hart be transferred to the right owner.

The following letters were read; - From Banook Cance Club asking for the grant towards the Natal Day celebration. This was discussed at some length together with the plans outlined by the delegation previously heard. Referred to the committee already appointed, viz, Councrs. Carter, Lynch and Tobin.

From Dartmouth Engine Co. asking that certain repairs intended to be made at the Engine House be completed before August 3rd. Referred to Public Property Committee.

From V. F. Farrell, agent for Misses L. & T. Farrell, complaining that they did not receive a valuation notice of their assessment, and that the amount charged them, \$4500. was excessive. Resolved that Mr. Farrell be given a hearing under the provisions of the Assessment Act.

From Dominion Trust Co. calling attention to the fact that the Town can invest its Sinking Funds in securities issued by them, under the provisions of the Municipal Debentures Act 1914. Referred to Finance Com.

From the publishers of the MunicipalJournal, Montreal, asking for subscriptions to their paper. Ordered filed.

Application was read from Messrs. Waterfield, Warner and Bailey for re-appointment as Revisors of Electoral Lists. On motion Resolved that they be appointed at the same salary, collectively, as last year. On motion of Counces. VanBuskirk and Lynch, Resolved, that the Mayor be authorized to issue, under the seal of the town in the form "A" to Chapter 56, Acts of 1902, debentures not to exceed in the whole the sumof Ninety Thousand Dollars, such debentures to be for the sum of One Hundred Dollars each, or any multiple thereof, and to bear interest at five per cent per annum, redeemable in thirty years from the date thereof, the proceeds of the sale of such debentures to be paid over to the Board of School Commissioners for the Town of Dartmouth, to be used by such Board for the purpose of constructing and equipping new school buildings in the said Town and for no other purposes whatsoever.

Mr. V. F. Farrell, of Halifax, being present was given a hearing in reference to the valuation of the property of Misses L. & T. Farrell, near the northern boundary of the town. (six acres and water lots.) On motion it was resolved that the case be taken up at the next meeting of the Council and that the Assessors be notified to attend.

The Committee on Public Property reported recommending that certain alterations and repairs to be done at the Engine House, as asked for by the Fire Company. On motion of Counces. Russell and Lynch the following resolution was unanimously adopted;-

"Whereas, purusant to an Act of the Legislature of Nova Soctia, being Chapter 97 of the Acts of 1914, the Town of Dartmouth was authorized to berrow on the eredit of the town a sum not exceeding \$90000 and to issue debentures therefor, and to pay over to the Beard of School Commissioners for the said Town the proceeds of such debentures, to be used by such Beard for the purposes of constructing and equipping new school buildings in the said Town and for acquiring lands upon which to construct the same, and Whereas, it was a condition precedent to the issue of such debentures as aforesaid that the said expenditure should be approved by a vote of the ratepayers of the said Town in the manner provided by Chapter 56 of the Acts of the Legislature of Nova Soctia for the year 1902, and

Whereas, the said ratepayers at a vote duly called and hold on the third day of October, A. D. 1914, approved of said expenditure,

NOW THEREFORE BE IT RESOLVED that debentures of the said Town be issued for the sum of \$90000. being the amount authorized by Chapter 97, that such debentures be issued in denominations as follows;-

> 50 bonds, \$1000. each, numbered from 1 to 50. 80 " \$500. " " 1 to 80.

and bear date the 1st day of July, A.D. 1914, payable thirty years from said date, and bearing interest at five per centum per annum, payable halfyearly and be otherwise in the form "A" to chapter 56 of the Acts of 1902, and that the Mayor and Town Clerk be authorized to sign and countersign the said debentures, and to affix the corporate seal of the Town thereto, and subsequently to sell the same as this Council may direct, and pay over the proceeds of such sale to the Board of School Commissioners for the said town, to be used by such Board for the purpose of constructing and equipping new school buildings in the said town, and for acquiring lands upon which to construct the same, and for no other purposes whatsoever." Town Council met this day at 7.30 p.m. Present Mayor Williams, Councrs Mosher, Lynch, Tobin and Carter, also Town Solicitor Foster.

Minutes of last four meetings were read and confirmed.

The assessment appeal of the Misses Farrell was taken up and the affidavit of Vincent F. Farrell was read, to the effect that he was the duly authorized agent of the Misses Farrell and that they had not received any notice of the assessment of their property fronting on the harbor front at the northern boundary of the town, for the current year. Mr. Farrell, being present, stated that the valuation of \$4500. placed on the property was excessive and that the frontage of said property was considerably less than it was supposed to be by the Assessors when they made the assessment. Mr. Congdon, one of the Assessors, was present and was heard in rebuttal to the statements of Mr. Farrell. After discussion it was decided to defer a decision until the town boundary lines leading from Windmill Road to the Harbor were defined.

Petition was read from property owners on Thompson Street, praying that one or more electric lights be placed on that street. Referred to Street Committee to report.

Petition was read from property owners on Upper Water Street, praying that a sewer be constructed on that street in front of their properties. Referred to Water Committee to report upon.

The Auditors reported that they had examined the books and accounts of the Town Clerk, and Treasurer to September 30th, and found everything in order and correct, and submitted duly certified statements of the several services of the town to that date. Ordered filed.

The Mayor and Town Treasurer reported that they had destroyed Town of Dartmouth School Bonds, being Loan for Construction of Schools, 7 debentures, \$1000, each, Nos. 1⁴ to 7, both inclusive, dated July 1, 1894, twenty years, 4½%. Said bonds were paid July 1, 1914 from funds received from insurance paid on loss of Greenvale School by fire. Ordered filed. Re. Symonds Property. The following opinion of Town Solicitor Foster was read;- "I have looked into the question of the right of the town to excavate and lay pipes thru the property formerly known as the Symonds property and find that the town acquired the right to convey by a special Act passed in 1873 -- at the same time the town was incorporated -- There was no question of reservation in the Act but in the deed which bears date January 29, 1873 full right and power was reserved to the town to enter upon the land, make the necessary excavations for sewer and water purposes, without let or hindrance. This deed was not recorded until October 24,1884 and will be found in Book 248, page 539." Ordered filed.

The following letters were read;-

From Miss M. H. Smith, Portland Street, complaining that teams were constantly being placed in front of her place of business on that street which was a source of annoyance and inconvenience, and an encumbrance on the street as well. Referred to Police Committee.

Minutes of last meeting were read and confirmed.

The Committee to whom was referred the appeal of the Misses Farrell, per their agent, V. F. Farrell, re. assessment of their property for 1 914, reported that they had gone carefully over the town plans and description

of the town boundary, and also visited the property in question, and found that whereas the various plans of the town show the northern boundary line diverging northward after crossing the Bedford Road, the Act describes the line as a projection of the south side line of the Crichton Road, and that when so projected the plan shows a frontage of about 360 feet of the Farrell lot within the town. As it appears that the assessment was based on the frontage shown by the plans, your committee recommend a reduction in the assessment of the Farrell lot to an amount based on the corfect frontage, and further recommend that a competent surveyor be employed to determine the northern line and set a proper monument at the shore of the harbor. Adopted.

The Street Committee reported as follows;-

1. Re. John Nichols request to be relieved of the work of replacing broken lights, your committee beg to recommend that he be relieved of this work from Nov. 1st to April 1st, each year, and that the work be attended to under the supervision of the Supt. of Streets.

2. Re. claim of Richard Walsh for damages for injuries sustained by his son due to falling over a curbing block on Ochterlony Street, your committee with the Town Solicitor, beg to recommend that Mr. Walsh be compensated to the amount of the doctors' and druggists' bills incurred in consequence of injuries thus sustained.

3. Re. request for light on Thompson Street, your committee beg to recommend that a light be placed on this street.

4. Re. letter of Board of Trade asking that trees be planted on Quarrell Street, your committee beg to recommend that they be authorized to purchase twenty-five trees to be planted early next spring on Quarrell Street and to replace trees broken or dead in other parts of the town. Adopted.

The Water Committee reported making the following recommendations;-1. That a special rate be fixed for P.Judge & Sons, (water men) for water supplied to their boats, at \$400. per annum, with a minimum rate of $.10\phi$ per 1000 gallons, to date from November 1st, 1914.

2. With regard to the building on Water Street owned by Peveril & Beck and used as a printing office, your committee recommend that a special minimum rate of \$12.50 per annum be fixed for supply of water to their motor, with a rate of $.15\phi$ per 1000 gallons for water used, to date from the occupation of the building by the said printing company, and also that a meter be installed at once.
