Thursday, January 10th, 1918.

The Town Council met this day at 7.30 p.m. Present: Mayor Williams, Councillors Mosher, Molean, Lynch, Tobin and Carter; also, Town Solicitor Foster.

Letters were read from the following:

<u>HENDRY LTD.</u>, Halifax, asking that they be supplied with water, for their two water boats from the Town Pipe at Moseley's Wharf. On motion of Councillor Tobin, seconded by Councillor Mosher, it was

"RESOLVED, That they be supplied with water for their water boats during the hours from 7 a.m. to 5 p.m., Sundays excepted, at the rate of ten cents (10¢) per thousand gallons, payable monthly as per meter reading, with a minimum rate of three hundred dollars per year, with an additional charge of ten per cent (10%) per annum on the cost of meter to cover interest and depreciation, payable half-yearly".

W.N.FORBES, Plumbing Inspector, reporting that the specification for plumbing for the temporary houses to be built for the Relief Committee is not according to the Plumbing By-laws of the Town. This being a special case, he asked whether he would allow the plumbing to be done according to specifications or insist that the work be carried out in accordance with Town By-laws. After some discussion, on motion, it was

"RESOLVED, That Mr. Forbes be instructed to confer with Chairman Tobin of the Water Committee and the Superintendent, and report thereon".

The Mayor read draft of proposed letter to Prime Minister, Sir Robert Borden, re reparation to owners of property damaged by the "Great Explosion". On motion,

"RESOLVED, That the Mayor, with Town Solicitor Foster and Councillor Tobin, be a Committee to draft proposed letter and have it forwarded to the Frime Minister as soon as possible".

There having been numerous complaints of the stoppage of water at certain hours at houses on the higher levels of the Town, caused by the water being allowed to continuously run in a great many houses to prevent freezing, this matter was discussed and referred to the Water Committee to have the practice stopped.

Letter read from <u>A.C.PETTIPAS</u>. He stated he had applied, on behalf of J.A.Edwards, to Miss Forbes, one of the ladies in charge of Relief stores at Greenvale School, for some oilcloth for his house damaged by the "Explosion", and that his request was refused. On motion, he was heard in support of his complaint, and after some discussion, on motion of Councillor Tobin; seconded by Councillor Mosher, it was

"RESOLVED, That an order for oil-cloth, asked for by Mr. Pettipas, on behalf of J.A.Edwards, John St., be given him, and that a bill therefor be sent to the Relief Committee".

A number of accounts were passed for payment and the Council adjourned to meet at 7.30 p.m. tomorrow, Friday.

The Town Council met this day at 7.30 p.m. Present: Mayor Williams, Councillors Mosher, Tobin, Garter and McLean; also, Town Solicitor Foster.

The Mayor spoke, recommending that some action be taken to find out the Loss of Assessment in the Town. Councillor Tobin moved, seconded by Councillor Carter,

"That a Committee be appointed, with Town Solicitor Foster, to-take up the matter of Assessment to ascertain the loss of real and personal property in the Town of Dartmouth, caused by explosion of munitions on board Steamer "Mont Blanc" in Narrows of Halifax Harbor on December 6th last, and any other matter with regard to Assessment for current year, and report to Council at next meeting. FURTHER RESOLVED, that the present Council, with Town Solicitor Foster, be the Committee".

Letter from <u>A.C.PETTIPAS</u> was read and received, and Councillor Mosher moved, seconded by Councillor Tobin,

"That the Clerk be instructed to write the Executive of Relief Committee, requesting an interview with Mayor and Council in regard to opening up a Supply Depot in

the North End". Las

Carried.

Councillor Carter reported that the Consumer's Cordage Co. had asked him for the use of the Town's Steam Fire Engine "Lady Dufferin" to pump water to test their boilers, and that they agreed to pay the costs incurred. Request granted.

The Town Council met this day at 7.30 p.m. Present: Mayor Williams, Councillors Mosher, Lynch, Carter, McLean, Herman and Tobin.

Re <u>ASSESSMENT OF 1918</u>: This matter was taken up and, on motion of Councillor Lynch, seconded by Councillor Mosher, the following resolution was adopted:

"RESOLVED, That the Assessors be instructed to make an appraisal of the amount of damage done to both real and personal property within the Town and report to Council. ALSO, That three competent builders be employed to assist the Assessors.

ALSO, That, in respect to remunération for their services, the matter be left with the Mayor and Finance Committee to arrange".

Re <u>WATER SUPPLY to HENDRY, LIMITED</u>; On motion of Councillor Tobin, seconded by Councillor Lynch, the following resolution was passed:

"RESOLVED, That a 3" meter be placed immediately to supply Hendry Ltd. with water, and that the Council reserve the right, by giving one month's notice, to cut off water, in case of shortage taxing the water system". Letters were read from the following: <u>THE MAYOR of DARTMOUTH, ENGLAND</u>, dated December 19,1917, addressed to Nayor Williams. The letter follows:

"Dear Sir,

On behalf of the Citizens of this ancient and historical Borough, in the old country, I beg to express to the people of your town, bearing the same name, our heartfelt sympathy in the dreadful catastrophe that has occurred in connection with the recent explosion.

The present terrible war has indeed brought grave affliction to the homes of many of our countrymen and women, also out brothers and sisters in the Colonies, whose kith and kin are courageously fighting shoulder to shoulder with our home forces to uphold the grand old flag of the British Empire, but this additional calamity, so appalling in its results, is indeed awful to contemplate.

I feel it my common duty therefore to ask you to convey an expression of our most sincere sympathy to the inhabitants of your town and district in this grievous hour of trouble and suffering.

d district _____ I beg to remain, Yours most sincerely, (Rd.) J. Wilton, Mayor of Dartmouth, England.

On motion, the Clerk was instructed to send a suitable reply expressing the appreciation and thanks of the Council for his kind letter.

<u>A. C. JOHNSTON</u>, Chairman Dartmouth Relief Committee, stating that it was the unanimous opinion of that Committee that, at the present time, it would not be advisable to have a. Relief Depot established at the North End of the Town, it being their policy to concentrate the work as much as possible. Councillor Mosher moved, seconded by Councillor McLean, that the letter be filed. Councillor Lynch moved in amendment, seconded by Councillor Carter,

"That the Council regret that the Relief Committee refuse to have a conference with the Council, and are glad to note that arrangements will be made in the near future for better disposition of relief in the North End".

The amendment was put and carried.

Re <u>NEW CEMETERY</u>: A description of the "Kuhn" lands purchased by the Town for a Cemetery was laid on the table. On motion the same was referred to Town Solicitor Foster with instructions to procure a suitable plan of the property in question from the vendors, to-be attached to the deed of the purchased property, and to advise the Council whethere the description as sent in was correct. The Clerk was instructed to ask the Minister of Finance for permission to issue Town Depentures for the sum of Eleven Thousand Dollars (\$11000.), required for purchase of New Cemetery.

Re WATER SUPPLY: A discussion took place on this subject, caused by numerous complaints of an inefficient supply in certain districts of the Town. The matter was referred to the Mayor and Water Committee to consult with Mr. Johnston, Acting City Engineer of Halifax, with a view to having some improvement made in the Water Supply for the Town, and to report thereon to the Council.

It was decided that the Electric Light Superintendent be ... notified to put out lights at 6 a.m. and also on moonlight nights, to aid in conserving the Water Supply.

The Clerk was instructed to ask the Department of Naval Service to confine the time for drawing water for their waterboats between the hours of 7 a.m. and 5 p.m. as far as it was possible for them to do so.

<u>GEORGE FOOT</u> and <u>WALTER CREIGHTON</u> were reappointed Town Auditors for the ensuing year at the same salary as last year.

The Town Council met this day at 7.30 p.m. Present: Mayor Williams, Councillors Mosher, MoLean, Herman and Carter. The members of the Dartmouth Board of Trade met in joint session with the Council. The Board of Trade members present were: R. L. Graham, Chairman, John Forsyth, W. C. Bishop, Dr. McKay and J. Lorne Allen.

The meeting was called to consider what action should be taken in view of the recent "Disaster" to Halifax and Dartmouth and the probability of other accidents occurring owing to inefficient administration of the Harbor and Pilotage Regulations.

Chairman Graham of the Board of Trade submitted the following resolution, which, upon being read, was moved by Councillor Herman and seconded by Mr. Graham, and being put to the meeting passed unanimously:

"Whereas, the citizens of Halifax and Dartmouth following whereas, the citizens of Halliax and Dartmouth forlows the disaster of December 6th, last, were given positive assurance by the Minister of Marine that every precaution would in future be taken in the movement of munition laden ships entering and leaving Halifax Harbor, and that a repetition of the disaster would be impossible, and Whereas, we learn with amazement from the evidence of Capt. Wyatt at yesterday's session of the Court of Enquiry new being held in Halifar, that the orders governing the

now being held in Halifax, that the orders governing the movement of munition ships are wantonly disregarded, and

Whereas, through such neglect a collision between a

whereas, through such neglect a collision between a munition ship and an oil tanker was narrowly averted a day or two ago within a short distance of the scene of the "MONT BLANG" disaster, <u>BE IT RESOLVED</u>, That in the opinion of this meeting the lives and property of the citizens of Halifax and Dartmouth are still being unwarrantably exposed to the gravest danger and menace menade. FURTHER RESOLVED, That the following protest be telegraphed

to the Prime Minister, Sir Robert Borden at once. - At yes-terday's session Court of Enquiry "IMO"- "MONT BLANC" collision, Capt. Wyatt's evidence conclusively indicates harbor regulations governing movement of munition ships are being flagrantly disregarded, and repetition last month's disaster narrowly averted two days since. In the interest of lives and property of our citizens, the Dartmouth Town Council and Board of Trade in joint session strongly protest against such gross negligence and demend instant analysis. against such gross negligence and demand instant appointment of competent official to control Halifax Harbor traffic."

It was decided to wire copies at once to Prime Minister Sir Robert Borden and the County Members, Honorable A.K. McLean and Peter F. Martin, and that the telegram be signed by the Mayor and the Chairman of the Board of Trade.

The Town Council met this day at 7.30 p.m. Fresent: Mayor Williams, Councillors Mosher, McLean, Lynch, Herman, Tobin and Carter.

The members of the Halifax Relief Commission, Messrs. T.H.Rogers,K.C., Judge Wallace and F.L.Fowke, were present and conferred with the Council, explaining their work and asking the co-operation of the Council and the united support of the people of Dartmouth in administering the great trust placed in their hands. The Commission suggested that the Council meet with them and appoint a couple of citizens of the Town, or the Council could have a separate body consisting of three members of the Council, to act as an advisory Committee, whereupon the Relief Commissioners then retired, and, after some discussion, on motion of Councillor Carter, seconded by Councillor Herman, the following Committee were appointed, viz., Councillors Mosher, Lynch and Tobin.

The matter of the shortage of water on the higher sections of the Town was then taken up and on motion of Councillor Herman, seconded by Councillor Carter, it was resolved that the Water Committee be authorized to go ahead at once and put in one additional six (6) inch and one additional twelve (12) inch valve to divert all the water in the main pipes, so that water users on the higher levels of the Town, north and south, would get a more efficient supply; and the Committee were further authorized to purchase the necessary valves and pipes required. The estimated cost of the work was given as Four hundred dollars (\$400.).

Surveyor of Lumber:-Caretaker at Engine House:-Foreman of Streets:-

The Town Auditors submitted their annual report for the financial year ending December 31, 1917. Upon being read, Councillor Lynch moved, seconded by Councillor Mosher, that the same be received and accepted. Councillors Herman and McLean moved in amendment that the report be received and the financial tables be read. The amendment was put and carried.

A petition was read, signed by thirty ratepayers residing on Rose and Thistle Streets, complaining that they are without water thirteen hours a day, and asking that the Council give this matter their careful consideration and devise some means to give them better service. The Clerk was instructed to aoknowledge the same and to inform the petitioners of the action taken by the Council to relieve the situation. On motion of Councillor Tobin, seconded by Councillor Lynch, the Water Committee were authorized to prepare a notice to the ratepayers, to be published in the Newspapers, calling upon the ratepayers to do all in their power to prevent the waste of water in their dwellings. (See notice appended hereto)

DARTMOUTH WATER USERS.

"The Town Council urgently requests you not to waste your "water supply by allowing taps to run continuously day or "night, as this prevents house-holders on the higher sections "of the town getting sufficient water for domestic purposes. "Persons having leaky taps are requested to have them made "tight at once. While the Council understand the conditions "in many dwellings caused by the "Great Explosion," at the "same time feel that steps should be taken to stop the great "waste of water caused by taps constantly running. The "Plumbing Inspector will inspect dwellings with a view to "having the waste stopped. Your co-operation in this matter "is earnestly requested. The Council have taken steps to "improve the supply, work for which will be done as soon as "it can be considering the severe winter weather now prevailing. E. F. WILLIAMS, Mayor.

On motion of Councillor Lynch, seconded by Councillor Mosher, the Town Clerk was authorized to institute prosecutions against all Plumbers not promptly taking out the necessary permits required for plumbing work.

Letters were read from the following:

THE DARTMOUTH ENGINE COMPANY, complaining that a lot of their hose was being used for watering steamers on the Marine Railway, which leaves them at times with a very scant supply. They desired to know whether the Town Workmen had permission to use their apparatus in this way. Referred to Fire Committee to report on.

THE CAPTAIN SUPERINTENDENT, H.M.C. DOCKYARD, requesting that their watchman at Wentzell's Wharf in charge of the water supply to Naval Vessels be allowed to check the amount of water taken by various vessels taking water there by reading the Town Meter. On motion, permission was granted.

Application from <u>THOMAR GRAY</u> for the position of Electrician, which situation is now vacant. Referred to Public Property Committee to report on.

THE DARTHOUTH MANUFACTURING COMPANY, claiming ownership of the "Gun" off the S.S. "Mont Blanc" cast by the "Great Explosion" on their land, which they offered as a gift to the Town provided same was put on some site within the Town. On motion,

"RESOLVED, That their writer be informed that it was the intention of the Council to preserve the "Gun" referred to as suggested by them: "

At the request of the Manager of The Royal Bank of Canada, Dartmouth, the following resolution, moved by Councillor Lynch, seconded by Councillor Mosher, was adopted:-

"RESOLVED, That the Mayor and Town Treasurer be and hereby authorized to effect an additional sum of Five Thousand Dollars (\$5000.) as a temporary loan, for the purpose of further defraying the annual current expenditure of Town of Dartmouth for the financial year 1917, from The Royal Bank of Canada, in addition to the sum of \$12,000. referred to in the resolution, authorizing the annual overdraft, adopted by the Council on March 9, 1917. "

The tender of the Dartmouth Printing & Publishing Co., Ltd. for 400 copies of the Town Report at \$1.50 per page, including publication of the Financial Statement in the Paper, was accepted, upon their guarantee to complete the work before the end of April.

A large number of accounts were passed for payment, and the Council adjourned to meet next Monday at 7.30 p.m.

THE FINANCE MINISTER, in reply to the Council's letter to him asking for permission to issue \$11,000. Town Debentures for purchase of land for a Public Cemetery, stating that there would be no difficulty in connection with granting the necessary certificate, and forwarding form to make application therefor. Action on this matter was deferred until the next meeting.

POLICEMEN JOHNSTON, MACKAY and WORRELL, asking for an increase of salary. Referred to the Police Committee to report upon.

The Town Clerk submitted a memorandum in regard to the Ernest Richards Lot on Rose Street, which had been bid in by the Town at the Tax Sale of January 13, 1913. Mr. Richards wanted to know what price the Town would accept for the property as he wished to buy it back again. This brought up the question of selling some other" lots which had been bought in at different times by the Town. It was resolved to carry out the resolution of March, 1917, that such lots be sold, whereupon, on motion of Councillor Herman, seconded by Councillor NcLean, it was resolved that the Town Clerk be instructed to offer all lots owned by the Town bought in at Tax Sales for sale by Public Auction to be held on Saturday, March 9th next at 3 p.m., the advertisement to be published in the "Dartmouth Patriot" and to contain a description of each lot; the price at which each lot would be put up to be the sum of all Taxes, Water Rates, Newer Rates and Interest, due to date on each lot, together with cost of Sale.

Circular letter read from <u>THE BOARD OF TRADE, ANNAPOLIS</u> <u>ROYAL, N.S.</u>, calling attention to a movement to change the "Rule of the Road" in Nova Scotia, and that a resolution had been passed by their Board in favor of the proposal, and inviting the co-operation of Town and Municipal Councils and other influential bodies in the movement to bring about this much needed reform. After a brief discussion, on motion of Councillor Lynch, seconded by Councillor Mosher, it was unanimously (1985)

"RESOLVED, That this Council views with favour the proposal to change the rule of the road, requiring vehicles to drive to the left, so as to bring the practice in Nova Scotia into uniformity with that prevailing in other parts of Canada, and North America generally, in which the rule and custom is to pass to the right."

A deputation of the Dartmouth Development Company, con-'sisting of W.C.Bishop, Secretary, Jame's G. Burchell and H.O'C. Baker, on motion were given a hearing in regard to the opening of a proposed street on their property on Erskine Street, offered by that Company to the Town as a public street on condition that the street was continued northerly through the Town property to Prince Albert Road. After considerable discussion, the matter was referred to the Council in Committee to be taken up on Monday next at 7.30 p.m.

A petition was read from some twenty-five ratepayers of the eastern end of Portland Street, one of the most elevated districts of the Town, complaining of the shortage of water in their dwellings. A deputation from the petitioners, consisting of George Foston and Charles Bonang, being present, were given a hearing. They stated that for some weeks past they could not obtain water at their houses, which was quite a deprivation for them, as well as very inconvenient and unsanitary. A discussion then took place as to the best methods of overcoming the difficulty complained of. On motion of Councillor Mosher, seconded by Councillor Lynch,

"RESOLVED, That the Superintendent be instructed to send out a Water Cart every day to supply house-holders with water in that district, who are unable to obtain water from the town pipes; and further, that he arrange with the larger users, such as the Water Boats, Ferry, Railway, Marine & Fisheries, etc. that the water should be turned off their supply pipes for an hour, between 8 and 9 p.m., some night to be agreed upon, and the pressure gauges then be examined to test the water supply to the higher levels of the Town."

Letter read from <u>THE DARTMOUTH ELECTRIC LIGHT COMPANY</u>, offering to furnish power for our Street Lighting Plant at a special rate of three cents per Kilowatt Hour, in a contract for five or ten years. This, they said, on a 40 watt lamp basis, would cost approximately \$5.25 per lamp per year, and the Town would be getting more candle power per lamp than is furnished by the present plant. After discussion, this matter was referred to a special Committee, consisting of the Mayor, Councillors Tobin, McLean and Lynch, to consider and report upon.

Estimates of the Street Committee and Police Committee for the current year were submitted and referred to the Finance Committee.

On motion of Councillor Tobin, seconded by Councillor

"RESOLVED, That the salary of W.N.Forbes, Plumbing Inspector, be Fifty Dollars (\$50.00) per month to date from January lst, 1918, for one year; and that all Plumbers doing business in the Town be notified of Mr. Forbes' appointment."

On motion of Councillor Tobin, seconded by Councillor NcLean, it was

"RESOLVED, That a Smoke Testing Outfit for Plumbing be purchased for the use of the Inspector."

Report of Plumbing Inspector Forbes read in regard to the conditions at the "Merlebank" house, Dartmouth, in respect to plumbing, etc. This was referred to the Town Solicitor to report on for the meeting next Monday evening.

Letters were read from the following:

THE MUNICIPAL CLERK, stating that the County Council had decided to increase the board of inmates at the County Home

to fifty cents (50¢) per day, to go into effect commencing April 1st, 1918. Ordered filed.

<u>DARTMOUTH SCHOOL BOARD</u>, asking the Council to write the Minister of Finance to authorize the issuing of Town Debentures not to exceed \$100,000., for the purpose of erecting New Schools; also asking for a payment of \$4,000. on account of the estimates for the gurrent year. Ordered that both requests be complied with.

THE STARR MANUFACTURING CO., LTD., stating that the entrance to their Rolling Mill on King Street was being used as a Public Dump, and asking that this be stopped, as it was causing them inconvenience and trouble. Referred to the Street Committee to report on.

<u>R.J.MARVIN</u>, offering to dedicate a part of his land, being a part of Lot #5 in Prince Arthur Park, as a public street. The proposed street will run off Pleasant Street right through his property until it meets Lot #4 in said Park. He suggested that the street be known as "Cameron Street." Referred to the Street Committee to report on.

On motion of Councillor Lynch, it was

"RESOLVED, That the Town Solicitor be instructed to draft legislation to enable the Town to collect a Poll Tax from non-residents coming to and employed in the Town."

"The Mayor of the Town of Dartmouth shall, upon resolution of the Town Council of said Town, issue debentures not to exceed in the whole the sum of Twenty-five Thousand Dollars; such debentures shall be for the sum of One Hundred Dollars each or any multiple thereof, and shall bear interest at such rate, not to exceed six per centum per annum, as the Council shall determine, and be redeemable within a period not to exceed twenty years from the date thereof; and such debentures when so issued shall form a lien and be a charge upon all the real and personal estate situate within the Town of Dartmouth, and upon the revenues thereof, and the proceeds of the sale of such debentures shall be paid over to the Board of School Commissioners for the Town of Dartmouth, and shall be used by such Board for the purposes of constructing and equipping new school buildings in the said Town, and for acquiring lands upon which to construct the same, and for no other purposes whatever.

the same, and for no other purposes whatever.
Notwithstanding the provisions of Section 105, Chapter 56, Acts of 1902, the Mayor of the Town of Dartmouth shall, upon resolution of the Council of the said Town, issue debentures under the seal of the Town in the form as given in the Municipal Debentures Act, 1914, to an amount not to exceed Twenty-five Thousand Dollars; such debentures shall be for the sum of One Hundred Dollars each or any multiple thereof, and shall bear interest at such rate, not to exceed six per centum per annum, as the Council shall determine, and be redeemable within a period not to exceed twenty years from the date thereof, and the same shall be payable at such places as the Council shall determine. The proceeds of such debentures shall be used for the purpose of extending and improving the water and sewerage system of the Town, and for no other purpose whatever.
The two preceding sections of this Act shall not take effect until the same shall have been submitted to a vote of the ratepayers; duly held and convened in accordance with Chapter 56 of the Acts of 1902, and any amendments

thereto. 4.4. A certificate under the hand of the Mayor and Town Clerk and under the corporate seal of the said Town of Dartmouth of a resolution passed at a setting held in pursuance of the next preceding section of this Act shall be conclusive evidence of the dompliance with the provisions of the said two preceding sections and of the passing of the resolution requiring and the approval of the proposed borrowing and issuing of debentures."

The letter from the Dartmouth Development Company was taken up re proposed new street. The Mayor said it would be good policy to take over the street and continue it through the "Walker" property, that is owned by the Town, and at the same time open a street through the "Findlay" property. This would give a frontage on these new streets for a large number of good building lots, all of which would, no doubt, be built upon within a few years, and the assessment thereon would recoup the Town for the outlay. After some discussion, the matter was deferred for further consideration.

AND WHEREAS, the Tufts Cove site owned by the Imperial Government is of comparatively unlimited area and unobstructed water frontage and approach; AND WHEREAS the expense of acquiring the land and water frontage at Tufts Cove will be merely nominal,

On motion of Councillor McLean, seconded by Councillor Carter, their recommendation was adopted, with the proviso that the appointment be for one month and if his services proved satisfactory that the appointment be for the balance of the year to February next.

Letter read from C. H. HARVEY, offering to dedicate to the Town a new street on property purchased by him from the Estate of the late Thomas Ritchie, situate to the eastward of the "Marvin" property, through which the new proposed street to be called "Cameron Street" was laid off. He submitted a plan of the proposed street and pointed out that the direction of the proposed street on the "Marvin" property, if extended, would be harmful to his interests, and his offer was made provided the direction of "Cameron Street" was changed to the northward. This would give easier grades than the present line of "Cameron Street". He also would grant a street from the boundary of the present lane at north of Lot #4, intersecting the above mentioned new street to meet Johnston Avenue. He further asked that water and sewerage be laid down on these streets when practicable. This estimate shows that the service can be maintained for this year at the same rates as last year, viz:- for DOMESTIC RATE 35 ϕ and for PIPE RATE 10 ϕ per \$100.

These rates were authorized to be levied by a resolution adopted by your Council on Sep. 27th, last.

The estimate shows that the surplus will be about \$1500.00 this is well to have to help meet the coupon interest on our bonded debt due on 1st of January next, which is about \$4500.

Your Committee would recommend that a minimum rate of \$15. be charged PUBLIC GARAGES, that meters be placed and a charge of 15 cts. per thousand gals. be collected.

Your Committee recommend that further Special Rates be fixed as follows:-

- (1) For the <u>NEW POST OFFICE BUILDING</u> a fixed minimum rate of \$40 per year to date from opening of building. (paid
- (2) For each <u>AUTOMOBILE</u> (private Owners) \$2.00 per year to date from Jan. 1, 1918.
- (3) For PUBLIC GARAGES a minimum rate of \$15.00 with 15¢ per 1000 gals. for water used. To date from Jan.1/18.
- (4) For WATER DRIVEN WASHING MACHINES \$2.00 per year to date from Jan. 1, 1918.
- (5) For <u>OI.D PARK SCHOOL</u> and adjoining dwellings \$100 per year.
- (6) For <u>CENTRAL SCHOOL</u> including use of water for building purposes. \$75. per year.

These two buildings are being used solely by the Halifax Relief Commission.

Clauses 5 & 6 to be for the period the buildings will be in use by the Relief Commission.

Letter read from H. R. Mallison, Director of Dartmouth Electric Light Co., (dated Dec. 16th, 1918,) offering to supply current for the Town's Street lighting plant on any of the following terms:- 1st. We will supply all the lighting which the City may order from time to time at the rate of \$15.00 per lamp per year for each 40 or 60 candle power lamp. This offer covers the supply of current and the renewal of the lamps but does not include any repairs or maintenance to the poles, lines or lamp fixtures. As the City owns the poles, lines and fixtures any maintenance thereto would necessarily have to be borne by the City.

We sill supply the current necessary to light any or all lamps that the City may from time to time install at the rate of \$8.50 per lamp per year for each and every 40 or 60 candle power lamp. This price does not include lamp renewals or any repairs whatsoever.

We will supply all the current that the City may require for Street lighting delivered at any one point within the City limits that the City may designate, at a rate of 3¢ per kilowatt hour of the current consumed.

If this latter alternative was accepted by the City they would then be in a position to economize on the use of the current as they would only be called upon to pay for the current actually delivered to them and would thus obtain the advantage of the shorter hours of burning. We would under this arrangement be agreeable provided the City's apparatus was moved into the Company's Sub-station, to assume responsibility for turning on and off the Street Lighting System in accordance with the instructions received from the City.

I beg to further state that this offer remains open only until the 31st instant and if not then accepted by the City, same shall be considered cancelled.

A decision was deferred until after the Fublic Meeting to be held on the 8th of January. The Company to be asked to allow their offer to remain open until after the question had been submitted to the Rate Payers.
